POLITICAL DISABILITIES

AYERS, ROY WESLEY, JR. Convicted on December 1, 1969 in the Corporation Court of Lynchburg, Virginia of statutory burglary and sentenced to two years—suspended—placed on probation for two years. Probation was revoked on May 4, 1970 and was discharged June 10, 1971. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release from probation supervision, granted removal of political disabilities, June 20, 1973.

BELT, THOMAS LEWIS. Convicted on February 3, 1964, July 1, 1963, July 24, 1963, September 27, 1963, June 10, 1963, May 10, 1963, April 4, 1963, and June 15, 1964, respectively, in the Circuit Court of Lunenburg County, Circuit Court of Nelson County, Circuit Court of Waynesboro, Circuit Court of Augusta County, Circuit Court of Amherst County, Corporation Court (now Circuit Court) of Charlottesville, Circuit Court of Albemarle County and Superior Court of Rockingham County, North Carolina, respectively, of housebreaking and sentenced to a term of five years suspended—placed on probation for 18 months; breaking and entering and sentenced to a term of two years suspended for five years; breaking and entering and grand larceny and sentenced to a term of three years—suspended—placed on probation for five years; breaking and entering and sentenced to a term of three years; statutory burglary and sentenced to a term of two years suspended—placed on probation; statutory burglary and sentenced to a term of two years—placed on probation for four years; breaking and entering (five counts) and sentenced to a term of two years—suspended and placed on probation for four years; breaking and entering and sentenced to a term of three to five years—suspended and placed on probation for five years, respectively. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, September 6, 1973.

BERNSTEIN, IRVIN. Convicted on June 26, 1968 in the Hustings (now Circuit) Court of the City of Richmond of pandering and sentenced to a term of two years—suspended for ten years and fined \$2,500.00. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, January 3, 1974.

BRANSCOME, ELI GOAD. Convicted on September 18, 1961 in the Circuit Court of Carroll County of grand larceny and sentenced to a term of five years—suspended, placed on probation. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release from probation, granted removal of political disabilities, June 14, 1973.

BROOKS, ALLEN J. Convicted on October 1, 1969 in the United States District Court, Eastern District of Virginia, Richmond Division of income tax evasion in violation of 26 U.S.C. 7201 and sentenced to a term of five years—suspended. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, May 30, 1973.

CHAPPELL, JACK HARMON. Convicted on May 3, 1966 in the Middle District Court of North Carolina — Winston Salem Division of violating internal revenue laws relating to distilled spirits and sentenced to a term of 15 months — suspended, placed on probation. Relying on recommendations of reputable citizens who are familiar with this man's conduct since his release from probation, granted removal of political disabilities, February 8, 1973.

CHINAULT, JERRY LEE. Convicted on June 14, 1968 and October 17, 1968, respectively in the Circuit Court of Pulaski County and the Circuit Court of Montgomery County, respectively of breaking and entering, and forgery, respectively and sentenced to terms of five years and three years, respectively. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, June 20, 1973.

CLAGGION, HOWARD STEPHEN. Convicted on June 23, 1967 in the Corporation Court of Norfolk, Virginia of statutory burglary and imposition of sentence suspended—placed on probation supervision for a term of three years, conditioned upon his good behavior. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release from probation supervision, granted removal of political disabilities, April 10, 1973.

CLARK, DENNY R. Convicted on December 21, 1965 in the Corporation Court, Part Two, Norfolk, Virginia of robbery and sentenced to seven years—suspended; placed on probation for three years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release from probation, granted removal of political disabilities, May 2, 1973.

COLEMAN, JAMES FRANKLIN, JR. Convicted on September 28, 1970 in the Circuit Court of Orange County of housebreaking and larceny and sentenced to a term of two years—suspended and placed on probation for two years. Discharged from probation on September 27, 1971. Relying on the recommendation of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of his political disabilities, July 9, 1973.

COLEMAN, WARREN SAM. Convicted on October 22, 1971 in the Circuit Court of Caroline County of statutory burglary and sentenced to a term of six months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, July 5, 1973.

DEATON, GEORGE P. Convicted on October 2, 1956 in the Corporation Court of Lynchburg of forgery and sentenced to a term of two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, November 15, 1973.

DEERFIELD, EDWARD CHARLES. Convicted on June 16, 1965 in the Corporation Court of Norfolk City of robbery and sentenced to a term of five years—commuted 9-16-67 to four years eight months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, November 30, 1973.

DELANO, WILTON GARNETT. Convicted on March 9, 1939 in the Circuit Court of Richmond County of embezzlement and sentenced to a term of five years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, October 1, 1973.

DIANA, MARJORIE ESTELLE HARRELL (now MRS. HERBERT). Convicted on January 4, 1967 in the United States District Court for the Eastern District of Virginia of conspiracy and imposition of sentence suspended—placed on probation for three years. Released from supervision July 21, 1968. Relying on the recommendations of reputable citizens who are familiar with this person's conduct since her release from

probation supervision, granted removal of political disabilities, July 10, 1973.

EARLY, WILLIAM GLEN. Convicted on August 12, 1968 and July 30, 1968, respectively in the Circuit Court of Rockingham County and the Circuit Court of Augusta County, respectively of grand larceny and statutory burglary and sentenced to terms of three years—suspended—placed on probation for five years; five years—suspended—placed on probation for five years, respectively. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, December 19, 1973.

EATON, ARTHUR R. Convicted on April 6, 1953 in the Circuit Court of Page County of receiving stolen property sentenced to a term of eight years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, June 19, 1973.

EREXON, GARLAND EDWARD. Convicted on October 3, 1951 in Hustings Court (now Circuit Court) of Richmond, Virginia of grand larceny and sentenced to a term of two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, August 2, 1973.

EUNICE, DONNA M. Convicted on December 6, 1968, in the Hustings Court of Roanoke of forgery and uttering, embezzlement and sentenced to a term of two years—suspended—placed on probation for six years—released from probation July 21, 1971. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her release, granted removal of political disabilities, November 21, 1973.

FERGUSON, THOMAS E. Convicted on July 31, 1956 in the Anderson Air Force Base, Guam of grand larceny and sentenced to a term of two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, September 28, 1973.

FIRESTONE, JOSEPH BENNETT. Convicted on June 29, 1972 in the Circuit Court of Botetourt County of involuntary manslaughter and sentenced to a fine of \$1,000.00—motor vehicle operator's license suspended for twelve months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, September 10, 1973.

FLYNN, JOHN GILBERT. Convicted on August 6, 1959 in the Circuit Court of Warren County of unlawful, malicious, and felonious throwing of a missile at or against a motor vehicle carrying passengers and sentenced to a term of two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, February 22, 1973.

GAINES, FRANK DONALD. Convicted on March 18, 1965 in the Circuit Court of Augusta County of uttering a forged instrument and sentenced to a term of two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, December 14, 1973.

GALYEAN, HENRY FRANKLIN. Convicted on September 19, 1960 in the Circuit Court of Carroll County of manufacturing illegal alcoholic beverage and sentenced to a term of three years—suspended for five years and placed on probation. Probation was revoked December 4, 1961 and was

discharged December 4, 1963. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, June 21, 1973.

GAULDIN, ROBERT WILLIAM. Convicted on July 31, 1959 in the Circuit Court of the City of Martinsville of grand larceny and sentenced to twelve months—suspended—placed on probation for three years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, December 17, 1973.

GOLDMAN, HAROLD L., M. D. Convicted on November 9, 1964 in the Circuit Court of Norfolk, Virginia of abortion and sentenced to a term of two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, July 31, 1973.

GROSSCOPE, KIM STANSFIELD. Convicted on May 11, 1970 in the Circuit Court of Colonial Heights of attempted armed robbery and sentenced to a term of twenty years—suspended. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, December 5, 1973.

HAMMER, WILLIAM BOYD. Convicted on April 9, 1970 in the Circuit Court of Page County of grand larceny and sentenced to a term of twelve months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since release, granted removal of political disabilities, June 19, 1973.

HARRIS, BYRON COLBY. Convicted on October 22, 1971 in the Circuit Court of Caroline County of statutory burglary and sentenced to a term of twelve months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, July 5, 1973.

HARRIS, ELMORE. Convicted on October 21, 1971 in the Circuit Court of Caroline County of statutory burglary and sentenced to a term of twelve months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, July 10, 1973.

HAYES, GERALD. Convicted on October 17, 1967 in the Circuit Court of Dickenson County of grand larceny and sentenced to a term of three years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, June 20, 1973.

HERBERT, CLAUDETTE (now CLAUDETTE HERBERT COOK). Convicted on June 23, 1964 and July 23, 1964, respectively in the Hustings Court (now Circuit Court) of Portsmouth and the Circuit Court of Chesapeake City, respectively, of forgery and uttering and sentenced to a term of a total of ten years. Relying on the recommendations of reputable citizens who are familiar with this person's conduct since her release, granted removal of political disabilities, September 6, 1973.

HUDDY, KEVIN LEIGH. Convicted on March 8, 1972 in the Circuit Court of Virginia Beach, Virginia of statutory burglary and sentenced to a term of three years—suspended, placed on probation for three years—released from probation May 15, 1973. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release from probation supervision, granted removal of political disabilities, May 31, 1973.

HUTCHINSON, PHILLIP L., SR. Convicted on January 17, 1963 in the Circuit Court of Fairfax County of armed robbery and sentenced to a term of ten years—paroled April 4, 1966, discharged from parole supervision December 23, 1968. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release from parole supervision, granted removal of political disabilities, November 2, 1973.

JENKINS, HARRY W. Convicted on January 15, 1943 in the Corporation Court (now Circuit Court) of Lynchburg City of voluntary manslaughter and sentenced to a term of two years—paroled August 16, 1944 and returned January 13, 1945 for parole violation; discharged May 25, 1945. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of his political disabilities, August 20, 1973.

JENKINS, HUGH E. Convicted on May 25, 1955 in the Circuit Court of Page County of embezzlement and sentenced to a term of two years—suspended—placed on probation for two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, January 3, 1974.

JONES, LEON. Convicted on October 22, 1971 in the Circuit Court of Caroline County of statutory burglary and sentenced to a term of six months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, July 9, 1973.

KEIDAISH, STEPHEN L. Convicted on June 19, 1970 in the Circuit Court of Fairfax County of possession of a narcotic drug and sentenced to five years—suspended—placed on probation for five years. Released from probation supervision July 21, 1972. Otherwise terms of said sentence to remain in full force and effect until June 19, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release from probation supervision, granted removal of political disabilities, April 10, 1973.

KITE, GLENN R. Convicted on September 26, 1939 in the Circuit Court of Page County of manufacturing ardent spirits and sentenced to a term of one year—suspended. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, October 10, 1973.

KITE, GROVER PAGE. Convicted on December 15, 1953 in the Circuit Court of Page County of grand larceny and sentenced to a term of 30 days and fined \$50.00. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of his political disabilities, October 10, 1973.

KOJAK, MARY E. Convicted on June 26, 1969 in the Corporation Court, Part Two, of Norfolk, Virginia of possession and sale of heroin and sentenced to four years—released on parole September 8, 1971, discharged from parole supervision March 21, 1973. Relying on the recommendation of reputable citizens who are familiar with this person's conduct since her release from parole supervision, granted removal of political disabilities, June 26, 1973.

LEWIS, WALTER MERRILL. Convicted on July 3, 1958 in the Norfolk Corporation Court of grand larceny and sentenced to a term of ten years; paroled July 5, 1960 and released from parole supervision on Sep-

tember 28, 1964. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, I am granting removal of political disabilities, July 20, 1973.

LINTECUM, JOHN ARCH. Convicted in May, 1968 in the Circuit Court of Carroll County of breaking and entering and sentenced to a term of three years—suspended and placed on probation for three years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, June 14, 1973.

LLOYD, ISSAC MONROE, JR. Convicted on August 5, 1963 in the Circuit Court of Shenandoah County of grand larceny and sentenced to a term of two years—suspended—placed on probation for three years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release from probation, granted removal of political disabilities, January 18, 1973.

LOVING, JAMES EDWARD. Convicted on December 1, 1969 in the United States District Court for the Eastern District of Virginia, Richmond Division, Richmond, Virginia of receiving and possessing firearms and conspiracy and manufacturing firearms without a license and imposition of sentence suspended and placed on probation for five years; discharged from probation on May 8, 1972. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, August 23, 1973.

LOWE, LONNIE C. (Alias CLARENCE L. LOWE). Convicted on March 29, 1960 in the Circuit Court of the City of Norfolk of second-degree murder and sentenced to a term of 18 years—paroled November 15, 1965—discharged from parole supervision March 10, 1972. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, October 11, 1973.

LYNCH, JAMES WILBERT. Convicted in 1958 and on December 12, 1960, respectively in the Circuit Court of Franklin County of illegally manufacturing whiskey, and sentenced to a term of two years suspended and illegally manufacturing whiskey, sentenced to twelve months, respectively. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, May 30, 1973.

MAJORS, NATHAN A. Convicted on August 27, 1958 in the Corporation (now Circuit) Court of Norfolk, Part Two of second degree murder and sentenced to a term of fifteen years—paroled June 5, 1962—discharged from parole December 29, 1967. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release from parole supervision, granted removal of political disabilities, November 7, 1973.

MARTIN, MARSHALL GATES. Convicted on December 27, 1961 in the Middle District of North Carolina of conspiracy to violate internal revenue laws; December 15, 1960 of removing, concealing, transporting and selling nontaxpaid distilled spirits; December 3, 1957, convicted of violation of Title 26 Sec. 5008,5642. Convicted on September 13, 1957 in the Western District of Virginia of violation of 26 U.S.C.A. 5632. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, February 8, 1973.

MARTIN, ROBERT WADE, JR. Convicted on March 23, 1966, March 23, 1966 and February 25, 1966, respectively, in the Circuit Court of Botetourt County, Circuit Court of Botetourt County and Hustings (now Circuit) Court of Roanoke City, respectively of sodomy, breaking and entering, and statutory burglary, respectively, and sentenced to terms of six months, twelve months and twelve months, respectively. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, January 3, 1974.

MASON, ROBERT LEE. Convicted on May 17, 1939 in the Corporation Court, Part Two, (now Circuit Court), City of Norfolk of storebreaking and sentenced to a term of two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, January 4, 1974.

McNAMEE, KENNETH EUGENE. Convicted on November 14, 1960 in the Circuit Court of Campbell County of burglary and sentenced to a term of five years—suspended except for four months—placed on probation for five years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his discharge, granted removal of political disabilities, January 9, 1974.

MEADOWS, ROBERT LEE. Convicted on July 18, 1962 in the Circuit Court of Rockingham County of falsely communicating peril of bombing and sentenced to a term of six months—suspended, placed on probation for two years—fined \$50.00. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, September 5, 1973.

MIDKIFF, EURAL. Convicted on January 4, 1949 in the United States District Court, Western District of Virginia, Roanoke, Virginia of four counts of illicit distilling and sentenced to a term of six months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, April 25, 1973.

MORRIS, CHARLES EDWARD. Convicted on February 28, 1961 in the Circuit Court of Smyth County of grand larceny and sentenced to a term of twelve months, \$250.00 fine; time suspended, placed on probation. Convicted on March 27, 1961 in the Circuit Court of Washington County of grand larceny and sentenced to a term of twelve months, \$250.00 fine, time suspended and placed on probation. Convicted on April 24, 1961 in the Circuit Court of Smyth County of two counts of statutory burglary and sentenced to a term of six months and \$50.00 fine on first count; six months and \$50.00 fine on second count, time suspended and placed on probation. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, May 29, 1973.

MORRIS, McARTHUR LEE. Convicted on October 22, 1971 in the Circuit Court of Caroline County of statutory burglary and sentenced to a term of twelve months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, July 9, 1973.

MURPHY, JOHN RUSSELL. Convicted on September 4, 1963 in the Circuit Court of Fauquier County of felonious and malicious burning and sentenced to twelve years; paroled in May, 1968 and discharged from parole supervision in April, 1971. Relying on the recommendations of

reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, May 2, 1973.

MURRAY, DONALD ROGER, JR. Convicted on May 5, 1961 in the Circuit Court of Fairfax County of statutory burglary and sentenced to a term of three years; convicted on February 21, 1962 in the Circuit Court of Goochland County of second-degree murder and sentenced to a term of ten years; paroled October 10, 1968 and discharged from parole supervision June 23, 1970. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, September 5, 1973.

OUTTEN, WALTER RUSSELL, JR. Convicted on March 5, 1963 in the Corporation Court, Part Two, of Norfolk of grand larceny and sentenced to a term of nine years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, September 5, 1973.

OZMENT, ALBERT FLETCHER, III. Convicted on October 1, 1963 and October 8, 1963, respectively in the Hustings (now Circuit) Court of Portsmouth City and the Circuit Court of Chesapeake City, respectively, of statutory burglary and grand larceny and sentenced to a term of twenty years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, October 29, 1973.

PARLETT, HAROLD. Convicted on February 9, 1949 in the Circuit Court of Page County of throwing stone at and against a motor vehicle carrying passengers and sentenced to a term of six months and fined \$100.00—sentence suspended and placed on probation for two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, granted removal of political disabilities, July 25, 1973.

PEARSON, EDWARD SAMUEL, JR. Convicted on April 11, 1961 in the Circuit Court of Buckingham County of possession of burglary tools; June 9, 1961 in the Circuit Court of Fauquier County of statutory burglary; convicted on June 16, 1961 in the Circuit Court of Albemarle County of breaking and entering; convicted on July 3, 1961 in the Circuit Court of Warren County of breaking and entering; convicted on September 11, 1961 in the Circuit Court of Clarke County of breaking and entering; convicted on October 2, 1961 in the Circuit Court of Shenandoah County of statutory burglary; convicted October 16, 1961 in the Circuit Court of Rockingham County of breaking and entering and grand larceny and sentenced to a term of a total of 17 years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, granted removal of political disabilities, July 25, 1973.

PETERS, JESSE LAWRENCE. Convicted on January 7, 1937 and May 9, 1957, respectively in the United States District Court, Western District of Virginia, Roanoke, Virginia of (1) Criminal Action No. 3081, violation of the Internal Revenue Laws and was sentenced to three years probation. On 7-6-37 said probation was revoked and received two years imprisonment (2) Criminal Action No. 5803, violation of Internal Revenue Laws and was sentenced to a term of one year and one day (3) December 31, 1941 convicted in the United States District Court of the Southern District of West Virginia, Charleston, West Virginia of violation T18, Sec. 88 USC and sentenced to a term of 18 months. MURRAY, BENJAMIN REGINALD, JR. Convicted on October 26, 1971 in the Hustings Court of Richmond City of grand larceny (5 yrs.—2 yrs. susp. GB) and sentenced to a term of three years (three years sentence is to run concurrent to Federal time which inmate was serving at the time that he was borrowed for trial under the Interstate Compact). Because of the progress he made at the Federal Reformatory, Governor Holton believes that no further good would come from this man serving the rest of the Virginia sentence, subject is granted a conditional pardon, effective May 25, 1973 and will be under supervision, May 25, 1973.

SARGENT, JACKIE LARRY. Convicted on March 21, 1966 and August 4, 1966 in the Hustings Court of Roanoke City and Corporation Court of Martinsville City of robbery by viol.—seven years and forgery—four years and sentenced to a term of eleven years. In view of the recommendation of the Superintendent of Southwestern State Hospital, the manner in which this man has applied himself in the various rehabilitative programs and particularly by attending the Community College in Wytheville, Virginia, he is granted a conditional pardon effective October 19, 1973, and will be under supervision, October 17, 1973.

SCOTT, TERRY R. Convicted on September 6, 1962 in the Corporation Court, Part II, Norfolk City (now Circuit) of murder first degree and sentenced to a term of life. In view of his extraordinary progress in utilizing educational opportunities afforded him in developing a real sense of responsibility toward society and in maintaining an excellent record during his period of incarceration, subject is granted a conditional pardon, effective December 21, 1973 and will be under supervision, December 20, 1973.

SILVERS, RALEIGH. Convicted on December 6, 1967 in the Hustings Court (now Circuit) of Portsmouth City of robbery and attempted robbery and sentenced to a term of forty years. In view of the recommendation of the Probation and Parole Board, the recommendation of officials at the Penitentiary, the sentencing Judge not objecting, and his good institutional record and adjustment, subject is granted a conditional pardon, effective January 15, 1974 and will be under supervision, January 11, 1974.

VEST, ROGER WAYNE. Convicted on February 20, 1968 in the Hustings Court (now Circuit Court), City of Roanoke of grand larceny—two counts and statutory burglary and sentenced to a term of two years—

suspended except for six months—placed on probation for two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, I am hereby granting him a pardon, July 17, 1973.

VIA, EUGENE BECKWITH. Convicted on March 26, April 5, April 16, April 24, May 15, May 28, June 11, and May 14, 1962 in the Circuit Court of Augusta County, Corporation Court of Staunton City, Rockingham County Circuit Court, Circuit Court of Amherst County, Circuit Court of Rockbridge County, Circuit Court of Nelson County and the Circuit Court of Waynesboro City of breaking and entering—twelve charges; possession of burglary tools—two charges; grand larceny—two charges and sentenced to a term totalling 53 years. In view of this man's good institutional record, his outstanding progress on work-release, and the future home and job plan already guaranteed to him, subject is granted a conditional pardon, effective December 21, 1973 and will be under supervision, December 20, 1973.

WILLIAMS, JAMES. Convicted on November 7, 1967 in the Hustings (now Circuit) Court of Petersburg City of robbery and sentenced to a term of 99 years. In view of subject's outstanding record during his incarceration, the fact that the Commonwealth's Attorney, who prosecuted the case, has no objection to the pardon, and the recommendation of the Probation and Parole Board, he is granted a conditional pardon, effective January 15, 1974 and will be under supervision, January 11, 1974.

WILLIAMS, JAMES PALMER. Convicted on July 28, 1960 in the Circuit Court of Henry County of murder first degree and sentenced to a term of life. In view of this man's good record while imprisoned, no objections received from the Judge or Commonwealth's Attorney, upon the recommendation of the Probation and Parole Board, and being of the opinion that further rehabilitation could not be gained by additional incarceration, subject is granted a conditional pardon, effective October 25, 1973 and will be under supervision, October 23, 1973.

WILLIAMS, RUFUS, JR. Convicted on January 14, 1964 in the Circuit Court of Sussex County of murder first degree and sentenced to a term of life. In view of this man's exemplary performance since he has been incarcerated, his successful effort to reach a higher educational level, and his demonstrated ability to assume responsibility he is granted a conditional pardon, effective January 11, 1974 and will be under supervision, January 9, 1974.
