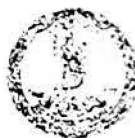



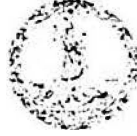

### CONDITIONAL PARDONS

ANDERSON, PATRICIA ELIZABETH. Convicted November 9, 1971, in the Circuit Court of Frederick County of first-degree murder and sentenced to twenty-eight years in the Penitentiary. In view of Subject having no prior criminal record, her exemplary institutional record, the fact that she has served five years of her sentence and has gained the maximum benefit of incarceration, the recommendation of the Parole Board, and there being no objection by the sentencing judge and prosecuting attorney, she is granted a conditional pardon, effective November 16, 1976, and will be under supervision for five years. This pardon dated November 12, 1976.

CHERNAULT, JOHN HENRY. Convicted February 26, 1964, in the Circuit Court of Prince Edward County of first-degree murder and sentenced to life in the Penitentiary. In view of this man's good institutional adjustment, his advanced age, the Judge and Commonwealth's Attorney not objecting, and pursuant to the recommendation of the Parole Board, he is granted a conditional pardon, with the special condition that he not return to Prince Edward or Appomattox Counties, effective January 20, 1976, and will be under supervision for three years. This pardon dated January 15, 1976.

GARRETT, ROOSEVELT. Convicted October 10, 1962, in the Circuit Court of Accomack County of first-degree murder and sentenced to life in the Penitentiary, and on October 10, 1973, in the Circuit Court of Chesterfield County of escape and sentenced to six months in jail. In view of this man's good institutional adjustment, and the recommendations of reputable citizens and the Parole Board, the Prosecuting Attorney, the present Judges and Commonwealth's Attorneys of Accomack and Chesterfield Counties, respectively, not objecting, (the Sentencing Judge being deceased), Subject is granted a conditional pardon, effective March 3, 1976, with a special condition that he shall participate in such alcohol treatment programs as directed by his parole officer, and will be under supervision. This pardon dated February 27, 1976.

STOKES, EDITH LOUISE. Convicted August 5, 1975, in the Circuit Court of York County of distribution of heroin and sentenced to ten years. In view of Subject's unusually good response to the institutional programs, to the unusual community support awaiting her, the recommendations of the Parole Board and the Commonwealth's Attorney, there being no objection by the sentencing judge, she is granted a conditional pardon, effective October 7, 1976, and will be under supervision for a three-year period. This pardon dated September 29, 1976.

#### COMMUTATION OF SENTENCE

GOOCH, EDWIN ALLEN. Convicted June 5, 1976, in the Circuit Court of Chesapeake of murder for hire and sentenced to death. Granted commutation of sentence to life imprisonment on October 20, 1976.

JEFFERSON, MALCOLM MARVIN. Convicted December 1, 1972, in the Circuit Court of Powhatan County of murder of a prison guard and sentenced to death. Granted commutation of sentence to life imprisonment on October 20, 1976.

JOE, VERNON LEE. Convicted June 9, 1976, in the Circuit Court of Southampton County of murder of a prison guard and sentenced to death. Granted commutation of sentence to life imprisonment October 20, 1976.

LEWIS, TONY EDWARD. Convicted April 12, 1976, in the Circuit Court of Southampton County of murder of a prison guard and sentenced to death. Granted commutation of sentence to life imprisonment October 20, 1976.

WASHINGTON, JAMES EDWARD. Convicted August 14, 1974, in the Circuit Court of Virginia Beach of murder of a prison guard and sentenced to death. Granted commutation of sentence to life imprisonment October 20, 1976.

#### REVOCAION OF PARDON

MASON, LEROY. Convicted April 2, 1965, in the Circuit Court of Southampton County of armed robbery and sentenced to thirty years in the Penitentiary. Subject was paroled on May 31, 1972. On January 11, 1974, he was granted a conditional pardon removing him from supervision with the condition that should he at any time prior to January 11, 1979, be found guilty of the violation of any of the penal laws of the Commonwealth, the pardon shall become null and void and he shall be required to serve the remainder and unserved portion of his sentence. On February 27, 1975, in the Circuit Court of Charles City County, Subject was convicted of two counts of murder for which he received two sentences of forty years each, a total of eighty years. The conditional pardon which was granted to him on January 11, 1974 was revoked on February 26, 1976.

## PARDONS WITHOUT CONDITIONS

BEALS, PATTI A. aka Patricia A. Cox. Convicted November 4, 1971, in the Richmond Police Court, Part II, of shoplifting and sentenced to thirty days in jail suspended for twelve months plus costs. Relying on the recommendation of the Parole Board, the sentencing judge and prosecuting attorney not objecting, Subject was granted a pardon dated May 28, 1976.

BOOTON, ROLLIN DANIEL. Convicted February 22, 1972, in the Hustings Court of Richmond of 1) possession of LSD, and 2) possession of marijuana with intent to distribute, with imposition of both sentences being suspended and placed on probation, and 3) distribution of marijuana for which he received eight years suspended. Relying on the recommendations of the Parole Board, the sentencing judge and prosecuting attorney not objecting, and reputable citizens, Subject was granted a pardon dated January 28, 1976.

CHAFFIN, ROBERT MILTON. Convicted January 19, 1965, in the Circuit Court of Campbell County of involuntary manslaughter and sentenced to ten years. He was paroled on July 18, 1967, and discharged from parole on June 23, 1971. Relying on the recommendation of the Parole Board, the sentencing judge, the prosecuting attorney and the present Commonwealth's Attorney not objecting, Subject was granted a pardon dated November 23, 1976.

DAVIS, DOUGLAS C. Convicted May 4, 1971, in the Circuit Court of Charlottesville of possession of controlled drug, to-wit: cocaine and sentenced to three years suspended and placed on probation which terminated February 15, 1973. Relying on the recommendations of the Parole Board, the sentencing judge and prosecuting Commonwealth's Attorney concurring, and reputable citizens, Subject was granted a pardon dated January 23, 1976.

GRAF, JAMES G. Convicted April 19, 1963, in the Circuit Court of Chesapeake of armed robbery and sentenced to eight years suspended and placed on probation which terminated in March of 1970. Relying on the recommendations of the Parole Board and reputable citizens, the sentencing judge and prosecuting attorney not objecting, Subject was granted a pardon dated June 21, 1976.

HANDY, ALBERT GUY. Convicted September 10, 1947, in the Circuit Court of Patrick County of rape and sentenced to five years. Relying on the recommendation of the Parole Board, the sentencing judge and prosecuting attorney being deceased, and the present Commonwealth's Attorney not objecting, Subject was granted a pardon dated August 12, 1976.

HOLT, JOEL H. Convicted June 28, 1973, in the Circuit Court of Rockbridge County of 1) distribution of hashish, a Schedule I Drug, 2) distribution of marijuana, a Schedule I Drug for accommodation, 3) distributing marijuana, a Schedule I Drug, 4) distributing marijuana, a Schedule I Drug for accommodation, 5) distributing marijuana, a Schedule I Drug and 6) distributing marijuana, a Schedule I Drug. He received sentences

totaling seventeen years with sixteen years suspended and a fine of \$5,000. His probation was terminated by the Court on December 5, 1975, and his suspended sentences were terminated on September 20, 1976. Relying on the recommendations of the Parole Board and reputable citizens, the sentencing judge and prosecuting attorney not objecting, Subject was granted a pardon dated June 3, 1976.

LACY, HOWELL KENT. Convicted July 27, 1964, in the Hustings Court of Richmond of statutory burglary and sentenced to three years. He was paroled on July 21, 1965, and discharged on February 6, 1967. Relying upon the recommendation of the Parole Board, and the prosecuting Commonwealth's Attorney not objecting, the presiding judge being deceased, Subject was granted a pardon dated January 20, 1976.

McKENNEY, FRANK DARGAN, III. Convicted June 3, 1974, in the Circuit Court of Franklin County of three counts of distribution of marijuana as accommodation and sentenced to five years on each count to run concurrently. He was to serve three months after which the balance of the sentence was suspended for three years. His suspension was terminated by Court Order on April 7, 1976. Relying on the recommendations of the Parole Board and reputable citizens, the sentencing judge and prosecuting attorney and present Commonwealth's Attorney not objecting, Subject was granted a pardon dated June 21, 1976.

McNEAL, HORACE PHILLIPS, JR. Convicted May 9, 1972, and April 6, 1973, respectively, in the Circuit Court of Virginia Beach of possession of hashish and Violation of Drug Control Act, respectively, and sentenced to three years suspended and placed on unsupervised probation, and three years suspended and placed on supervised probation, respectively. Relying on the recommendation of the Parole Board, the sentencing judge and prosecuting attorney not objecting, Subject was granted a pardon dated June 3, 1976.

MILLER, PETER MARSHALL. Convicted May 13, 1971, in the Circuit Court of Rockingham County of two counts of burglary and sentenced to five years on each count to run concurrently. He was paroled on June 27, 1972, and discharged July 10, 1974. Relying on the recommendations of the Parole Board and reputable citizens, the sentencing judge, prosecuting attorney and present Commonwealth's Attorney not objecting, Subject was granted a pardon dated November 10, 1976.

MOSS, BERNARD HARTWELL. Convicted July 22, 1955, in the Circuit Court of Pittsylvania County of selling mortgaged property and sentenced to six months with five months suspended for one year and fined \$10.00. Relying on the recommendations of the Parole Board, the sentencing judge, the prosecuting attorney, the present Commonwealth's Attorney of Pittsylvania County, the Judge of the General District Court of Pittsylvania County, the Commonwealth's Attorney of Danville and reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted a pardon dated December 7, 1976.

PACKETT, IRVING DAVID, JR. Convicted January 29, 1973, in the Circuit Court of Franklin County of three counts of violation of the Drug Control Act and sentenced to six years suspended for three years on Counts 1 and 3, and to five years suspended on Count 2. His suspended sentences were terminated by the Court on August 16, 1976. Relying on the recommendation of the Parole Board, the sentencing judge, the prosecuting attorney and the present Commonwealth's Attorney not objecting, Subject was granted a pardon dated September 24, 1976

PARKER, ALLEN LEON, JR. Convicted April 20, 1972, in the Circuit Court of Virginia Beach of possession with intent to sell a quantity of marijuana and sentenced to three years suspended and placed on probation which terminated July 24, 1974. Relying on the recommendation of the Parole Board, the prosecuting attorney and sentencing judge not objecting, Subject was granted a pardon dated June 3, 1976.

POFFENBARGER, WILLIAM HUNT. Convicted July 5, 1962, in the Circuit Court of Montgomery County of unauthorized use of an automobile and sentenced to six months in jail suspended and fined \$250. Relying on the recommendations of the Parole Board, the sentencing judge, the present Commonwealth's Attorney, the prosecuting attorney being deceased, and reputable citizens, Subject was granted a pardon dated September 24, 1976.

RUSSELL, ANCIL ELBERT, JR. Convicted October 7, 1958, in the Hustings Court of Roanoke of malicious bodily injury and sentenced to two years. Relying on the recommendations of the Parole Board and reputable citizens who are familiar with this man's conduct since his release, Subject was granted a pardon dated April 5, 1976.

SANDERS, ROBERT C. Convicted June 19, 1969, in the Circuit Court of Salem of two counts of sale of a narcotic drug and sentenced to three years suspended and placed on probation which terminated July 1, 1971. Relying on the recommendations of the Parole Board, the sentencing judge and prosecuting attorney, who is also the present Commonwealth's Attorney, Subject was granted a pardon dated September 8, 1976.

SMITH, MARY CORRINE. Convicted October 27, 1968, in the Norfolk Police Court of petty larceny and sentenced to thirty days in jail suspended for twelve months and fined \$25. Relying on the recommendations of the Parole Board and reputable citizens, the sentencing judge and prosecuting attorney not objecting, Subject was granted a pardon dated March 25, 1976.

WOODS, WILLIAM GLENN. Convicted April 23, 1973, in the Circuit Court of Portsmouth of possession of an explosive device and sentenced to one year suspended and placed on unsupervised probation. Because of this man's valuable assistance to the Commonwealth and relying on the recommendations of the Parole Board, the sentencing judge, the prosecuting attorney, and the Commonwealth's Attorney of Southampton County, Subject was granted a pardon dated August 5, 1976.

## REMISSION OF FORFEITED RECOGNIZANCE

LEFTWICH, JEFFREY DONALD AND ARNOLD W. Judgment entered July 22, 1974, in the Circuit Court of Carroll County against Arnold W. Leftwich for failure of his son, Jeffrey Donald Leftwich, to appear in court to answer criminal charges on a specified day and was forfeited for non-appearance of the son on that day. The son was subsequently apprehended in North Carolina, returned to Virginia, tried and convicted of the offense charged. Since the father did aid court officials in locating and apprehending his son, and the sentencing judge and prosecuting attorney have both recommended relief, it is thought that the ends of justice and the dignity of the judicial system can appropriately be served by reducing the amount of the forfeiture to the sum of \$250 plus costs incurred in the apprehension and trial of Jeffrey Donald Leftwich. This document dated April 9, 1976.

## REMOVAL OF POLITICAL DISABILITIES

ACREE, DAN, JR. Convicted February 16, 1954, in the Superior Court of Atkinson County, Georgia, of manslaughter and sentenced to three to five years. He was paroled on April 22, 1955, and discharged from parole March 17, 1958. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on December 22, 1976.

AGNESE, CARLOS E. Convicted May 24, 1974, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 371 (conspiracy), and sentenced to eighteen months, to serve one month with remaining sentence suspended for two years and fined \$2,500. Probation commenced June 27, 1974, and terminated September 2, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on June 21, 1976.

ALLEN, DONALD WILLIAM. Convicted November 2, 1951, in the United States District Court for the District of Columbia of robbery and sentenced to one to three years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on June 14, 1976.

ALLEY, WILLIAM GLENN. Convicted August 31, 1964 and sentenced December 13, 1968, in the Circuit Court of Tazewell of involuntary manslaughter and sentenced to twelve months suspended. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on August 25, 1976.



ALSING, GEORGE. Convicted July 29, 1968, in the Law and Chancery Court of Hampton of grand larceny and sentenced to two years. He was paroled May 20, 1969, and discharged on November 20, 1970. Relying on the recommendations of the Parole Board and reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on February 12, 1976.

ANDERSON, CYRUS T. Convicted February 2, 1973, in the United States District Court of the District of Columbia of violation of Title 18, USC, Section 4208(a)(2), (aiding and abetting and bribing a public officer), three counts. He was sentenced to not less than six months nor more than 18 months and fined \$10,000 on each count, with sentences to run consecutively. On April 11, 1975 the above sentences were vacated and were ordered to be run concurrently. He was discharged June 25, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on October 19, 1976.

BAYLY, FRANK ALFRED, JR. Convicted January 3, 1972, in the Circuit Court of Warren County of breaking and entering for which he received two years suspended, and of grand larceny for which he received a suspended sentence of 12 months. He was placed on probation which terminated on January 3, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on May 18, 1976.

BENSON, GENE TUNNEY. Convicted March 2, 1971, in the Circuit Court of Fredericksburg of voluntary manslaughter and sentenced to five years. He was paroled on May 16, 1972, and discharged on January 16, 1974. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on November 1, 1976.

BLACK, THEODORE R., JR. Convicted September 26, 1968, in the Hustings Court of Richmond, Part II, of statutory burglary and sentenced to twelve months suspended for two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 22, 1976.

BLANCHE, JAMES ANTHONY, JR. Convicted March 27, 1961, in the Circuit Court of Page County of statutory burglary and sentenced to two years suspended for five years. His probation terminated March 27, 1966. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on September 24, 1976.

BLAND, JAMES CONRAD. Convicted February 4, 1971, in the Hustings Court of Richmond of possession of heroin. Imposition of sentence was suspended for ten years and he was placed on probation for an indefinite period of time. His probation terminated on May 24, 1972, and imposition of sentence was terminated by order of the Court on December 16, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on March 30, 1976.

BLANKS, RYLAND THOMAS. Convicted January 23, 1975, in the United States District Court, Western District of Virginia, Lynchburg, of violation of Title 18, USC, Sections 1001 and 1002 (mismarketing tobacco). Imposition of sentence was suspended and he was fined \$2,000 and placed on probation for one year which terminated January 23, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on April 22, 1976.

BOOTON, ROLLIN DANIEL. Convicted February 22, 1972, in the Hustings Court of Richmond of 1) possession of LSD, and 2) possession of marijuana with intent to distribute, with imposition of both sentences being suspended and placed on probation, and 3) distribution of marijuana for which he received eight years suspended. Relying on the recommendations of the Parole Board and reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on January 28, 1976.

BRIDGETT, KAREN ELIZABETH. Convicted February 4, 1975, in the United States District Court, Western District of Virginia, Lynchburg, of violation of Title 18, USC, Sections 1955 and 2 (conducting and owning illegal gambling business). Imposition of sentence was suspended and she was placed on probation for 18 months and fined \$750. Her probation terminated August 3, 1976. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her conviction, Subject was granted removal of political disabilities on December 22, 1976.

BROOKS, CHARLES HERBERT. Convicted February 17, 1965, in the Corporation Court of Norfolk, Part II, of unlawful wounding. Imposition of sentence was suspended and he was placed on probation for three years. Probation terminated February 17, 1968. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on October 25, 1976.

BROWN, NORMAN LEE. Convicted October 17, 1967, in the Hustings Court of Richmond of statutory burglary and sentenced to two years suspended for five years. His probation supervision terminated on April 17, 1969, and his suspension expired November 14, 1973. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on September 24, 1976.

BROWN, WARREN HARDING, SR. Convicted May 13, 1949, in the Circuit Court of Buckingham County of unlawful wounding and sentenced to two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on December 22, 1976.

BYRNE, VIRGINIA MARIE. Convicted January 19, 1971, in the Circuit Court of Norfolk of arson. Imposition of sentence was suspended and she was placed on probation for three years. Probation terminated January 19, 1975. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her conviction, Subject was granted removal of political disabilities on April 5, 1976.

CAHILL, GUY S. Convicted April 10, 1963, in the United States District Court, Western District of Virginia, Abingdon, of violation of Title 18, USC, Section 1711 (misappropriation of postal funds). Imposition of sentence was suspended, he was fined \$500 and placed on probation for three years which terminated April 10, 1966. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on March 25, 1976.

CARROLL, ROY EUGENE. Convicted on 1) September 27, 1957, in the Circuit Court of Warwick City of two counts of obtaining money under false pretense and sentenced to one year on each count to run concurrently. He was discharged March 29, 1958; and 2) January 21, 1972, in the Circuit Court of Norfolk of four counts of forgery and sentenced to four years on each count to run concurrently. He was paroled August 27, 1974, and discharged August 27, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on July 6, 1976.

CASON, CARL FREDERICK. Convicted February 10, 1954, in the Circuit Court of Augusta County of rape and sentenced to eight years. He was paroled on April 2, 1956, and discharged January 30, 1959. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on October 4, 1976.

CATRON, ROBERT EDWARD, JR. Convicted May 26, 1972, in the Circuit Court of Smyth County of larceny of calf and sentenced to three years suspended and placed on probation which terminated June 2, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on October 1, 1976.

CAUSEY, JAMES CAMPBELL, III. Convicted April 26, 1973, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 876 (extortion). Imposition of sentence was suspended and he was placed on probation for three years which terminated on April 25, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on May 28, 1976.

CHADDUCK, CHARLES WILLIAM. Convicted March 27, 1961, in the Circuit Court of Page County of malicious assault and sentenced to three years suspended for five years and placed on probation which terminated March 27, 1966. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 1, 1976.

CHAFFIN, ROBERT MILTON. Convicted January 19, 1965, in the Circuit Court of Campbell County of involuntary manslaughter and sentenced to ten years. He was paroled July 18, 1967, and discharged on June 23, 1971. Relying on the recommendations of reputable citizens and the Parole Board, Subject was granted removal of political disabilities on November 23, 1976.

CLAIBORNE, JAMES D. Convicted February 10, 1936, of housebreaking and sentenced to two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on May 28, 1976.

COLES, DAVID EVERETTE, aka David Coles. Convicted 1) August 1, 1955, in the Circuit Court of Albemarle County of grand larceny and sentenced to four years with three years suspended; 2) October 1, 1956, in the Circuit Court of Albemarle County, sentence of August 1, 1955, revoked and ordered to serve four years. Paroled August 19, 1957 and discharged from parole February 25, 1959; 3) October 16, 1961, in the Circuit Court of Culpeper of two counts of statutory burglary and sentenced to five years on each count to run concurrently; 4) November 27, 1961, in the Circuit Court of Orange County of three counts of statutory burglary and sentenced to five years on each count; 5) November 28, 1961, in the Corporation Court of Charlottesville of statutory burglary (three counts) for which he received five years, four years, and five years with three years suspended, respectively; a total of 31 years. He was paroled June 30, 1971, and discharged from parole April 18, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on February 27, 1976.

COURTNEY, HADWEN BREWSTER. Convicted December 7, 1971, in the Circuit Court of Carroll County of being a habitual offender and sentenced to one year. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on October 1, 1976.

CRAIGHEAD, LAYNE W. Convicted January 24, 1950, in the Hustings Court of Roanoke of seven counts of uttering and sentenced to two years suspended on each count which were to run concurrently, and placed on probation. His suspension was revoked on April 21, 1950, and he was required to serve two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on April 14, 1976.

CRAIGHEAD, RUTH. Convicted January 24, 1950, in the Hustings Court of Roanoke of seven counts of forgery and sentenced to two years suspended on each count which were to run concurrently, and placed on probation. Her suspension was revoked on April 26, 1950, and she was required to serve two years. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her release, Subject was granted removal of political disabilities on April 14, 1976.

CRAWFORD, FRED E., JR. Convicted August 2, 1973, in the Circuit Court of Virginia Beach of manslaughter and sentenced to twelve months suspended. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 24, 1976.

CROCKETT, JACK K. Convicted in 1961 of first-degree murder in the Circuit Court of Tazewell County and sentenced to twenty-five years. He was granted a retrial and on January 6, 1967, was resentenced to serve twenty years. He was paroled on May 22, 1967, and discharged from parole on January 19, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on May 18, 1976.

CUSIC, DARLENE BRIDGET, now Darlene Cusic Shell. Convicted August 5, 1969, in the Hustings Court of Richmond of possessing a narcotic drug, to-wit: marijuana, and sentenced to three years suspended for five years and fined \$500. Her probation terminated April 19, 1971, and her suspension expired August 5, 1974. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her conviction, Subject was granted removal of political disabilities on November 26, 1976.

DANIEL, DANNY LEE. Convicted September 30, 1966, in the Corporation Court of Danville of two counts of grand larceny and sentenced to twelve months on each count to run concurrently and which were suspended for three years. His probation terminated September 30, 1969. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on July 22, 1976.

DARNELL, KELLY RALPH. Convicted April 3, 1975, in the Circuit Court of Montgomery County of sodomy and sentenced to two years. He was paroled on November 10, 1975, and discharged November 10, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on December 22, 1976.

DAVIDSON, FREDDIE DeLAIETE. Convicted January 18, 1973, in the Circuit Court of Wythe County of statutory burglary and sentenced to twelve months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on November 22, 1976.

DAVIS, DOUGLAS C. Convicted May 4, 1971, in the Circuit Court of Charlottesville of possession of controlled drug, to-wit: cocaine, and sentenced to three years suspended and placed on probation which terminated on February 15, 1973. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on January 23, 1976.

DAVIS, JERI L. aka Jeri L. Reid. Convicted January 7, 1971, in the Corporation Court of Norfolk of forgery, uttering and grand larceny and sentenced to three years suspended and placed on probation which terminated January 7, 1974. Relying on the recommendations of the Parole Board and reputable citizens, Subject was granted removal of political disabilities on July 29, 1976.

DAVIS, ROY FULTON. Convicted March 8, 1954, in the Circuit Court of Carroll County of forgery and sentenced to twelve months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on April 13, 1976.

DEAN, WELLINGTON J. Convicted November 25, 1974, in the Circuit Court of Lynchburg of three counts of malicious wounding and sentenced to three months on each count to run concurrently and fined \$300. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on October 8, 1976.

DeMARCO, PASQUALE, JR. Convicted 1) January 24, 1966, in the Hustings Court of Portsmouth of four counts of forgery and uttering and sentenced to four years; 2) March 10, 1966, in the Corporation Court of Norfolk, Part II, of five counts of forgery and sentenced to four years; and 3) March 22, 1966, in the Corporation Court of Norfolk of attempt statutory burglary and sentenced to two years; a total of ten years. He was paroled on June 16, 1969, and discharged July 6, 1972. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on July 22, 1976.

DUKE, DAVID LEE. Convicted January 24, 1973, in the Circuit Court of Henry County of 1) attempted grand larceny and sentenced to three years suspended; and 2) breaking and entering and sentenced to three years with two and one-half years suspended and placed on probation which terminated May 23, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on July 29, 1976.

DUNN, ARNOLD THOMAS, JR. Convicted July 8, 1971, in the Circuit Court of Nansemond County of distribution of marijuana and sentenced to four years suspended and placed on probation which terminated July 8, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on February 12, 1976.

EPPS, ALVIN GILBERT. Convicted January 17, 1966, in the Corporation Court of Charlottesville of malicious assault and sentenced to two years suspended. On April 27, 1967 in the same court he was convicted of three counts of forgery and sentenced to six years with four years suspended. The sentence imposed in January of 1966 was revoked. He was paroled on April 1, 1969, and this too was revoked in October of 1970. He was discharged

from the Penitentiary in March of 1971. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on February 6, 1976.

EUBANK, CECIL RAY. Convicted December 28, 1972, in the Circuit Court of Franklin County of manufacturing illegal whiskey and sentenced to one year suspended for three years and placed on probation which terminated December 28, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on March 3, 1976.

EVANS, WESLEY LEE. Convicted March 29, 1973, in the Circuit Court of Dinwiddie County of voluntary manslaughter and sentenced to four years. He was paroled on December 9, 1974, and discharged June 11, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on September 24, 1976.

FLOWERS, JAMES RONALD, aka James Ronald Whetstine. Convicted 1) December 23, 1969, in the Circuit Court of Salem of uttering a forged instrument and sentenced to twelve months suspended and placed on probation for three years; 2) January 7, 1970, in the Circuit Court of Roanoke County of three counts of uttering a forged instrument and sentenced to twelve months on each count which were suspended for three years; 3) April 14, 1970, in the Circuit Court of Franklin County of breaking and entering and sentenced to five years. He was paroled on November 3, 1970, and discharged from parole May 27, 1972; 4) April 14, 1970, Circuit Court of Franklin County of breaking and entering and sentenced to eighteen months suspended and placed on probation for three years after release from Penitentiary; and 5) April 27, 1970, in the Hustings Court of Roanoke of four counts of uttering and sentenced to six months on each count which were suspended after serving thirty days in jail. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on April 20, 1976.

FLOYD, RICHARD WAYNE. Convicted May 27, 1971, in the Corporation Court of Danville of 1) selling LSD with imposition of sentence being suspended for five years and placed on probation; 2) illegal possession of LSD with imposition of sentence being suspended for five years. Probation terminated and imposition of sentence expired on October 23, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 24, 1976.



FROST, RALPH EDWARD. Convicted March 25, 1974, in the Circuit Court of York County of voluntary manslaughter and sentenced to two years. He was paroled September 8, 1975, and discharged September 6, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on October 4, 1976.

GIBSON, WILLIAM SARAH. Convicted March 19, 1973, in the United States District Court, Western District of Virginia, Harrisonburg, of violation of Title 18, USC, Section 656 (misappropriation of funds of a national bank), four counts. Imposition of sentence was suspended and she was placed on probation for four years which terminated April 8, 1976. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her conviction, Subject was granted removal of political disabilities on May 12, 1976.

GRAF, JAMES G. Convicted April 19, 1963, in the Circuit Court of Chesapeake of armed robbery and sentenced to eight years suspended and placed on probation which terminated in March of 1970. Relying on the recommendations of the Parole Board and reputable citizens, Subject was granted removal of political disabilities on June 21, 1976.

GRAHAM, MICHAEL EDWARD. Convicted July 11, 1972, in the Circuit Court of Hanover of statutory burglary and sentenced to twelve months with ten months suspended for two years and placed on probation which terminated in May of 1974. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on February 6, 1976.

GREENE, JOHN BERNARD. Convicted April 10, 1973, in the Circuit Court of Norfolk of possession with intent to distribute and distribute a controlled substance, to-wit: hashish, an accommodation sale. Imposition of sentence was suspended and he was placed on probation for three years. His probation terminated April 10, 1976, and imposition of suspension was terminated by Court Order on July 20, 1976. HANKINS, PEERY. Convicted May 20, 1940, in the Circuit Court of Tazewell County of malicious wounding and sentenced to one year. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on November 19, 1976.

HARRIS, JAMES CLEABORN. Convicted February 12, 1962, in the Circuit Court of Martinsville of embezzlement and sentenced to nine months in jail suspended for three years and fined \$200. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 1, 1976.

HARRIS, RUSSELL. Convicted February 27, 1953, in the Hustings Court of Richmond of grand larceny and sentenced to one year. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on August 5, 1976.

HELMS, JERRY ALLEN. Convicted November 7, 1973, in the Circuit Court of Floyd County of attempted rape and sentenced to three years suspended and placed on probation which terminated June 2, 1975. His suspension expired November 7, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 22, 1976.

HERBERT, GEORGE WILLIAM, JR. Convicted June 1, 1973, in the Circuit Court of Westmoreland County of perjury and sentenced to three years suspended and placed on probation for two years.

His probation terminated June 1, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 19, 1976.

HERRELL, ROBERT WILLIAM. Convicted January 27, 1972, in the Circuit Court of Frederick County of grand larceny and sentenced to twelve months in jail with ten months suspended for three years upon his release from the two-month jail sentence. His probation supervision terminated on November 11, 1974, and his probation period terminated on October 27, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on March 8, 1976.

HICKSON, CHARLES EDWARD. Convicted October 31, 1969, in the Circuit Court of Salem of malicious wounding and sentenced to eight years suspended and placed on probation which terminated in September of 1974. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on March 22, 1976.

HILL, WALTER, JR. Convicted 1) September 15, 1958, in the Corporation Court of Norfolk of attempt statutory burglary. Imposition of sentence was suspended and he was placed on probation for three years; 2) June 17, 1959, in the Corporation Court of Norfolk. Probation imposed September 15, 1958, was revoked and he was ordered to serve twelve months in jail; 3) December 13, 1960, in the Circuit Court of Princess Anne County of grand larceny and sentenced to three years; 4) December 14, 1960, in the Corporation Court of Norfolk of grand larceny and sentenced to four years. Convicted July 14, 1972, in the United States District Court, Eastern District of Virginia, Alexandria, of violation of Title 18, USC, Section 1341 (mail fraud), and sentenced to three years with two and one-half years suspended and placed on probation which terminated on April 13, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on September 24, 1976.

HODGES, HERMAN EDWARD. Convicted 1) September 13, 1957, in the United States District Court, Western District of Virginia, Danville, of violation of Title 18, USC, Section 371 (conspiracy to violate Internal Revenue Laws), and sentenced to six months; 2) June 12, 1961, in the Circuit Court of Franklin County of obtaining money under false pretense, two counts, and sentenced to two years on each count to run concurrently; 3) July 18, 1961, in the Circuit Court of Halifax of illegal manufacture of alcoholic beverage and sentenced to one year to run concurrently with June 12, 1961 conviction. Convicted March 6, 1969, in the Circuit Court of Roanoke County of two counts of child molesting and sentenced to six years suspended for seven years and placed on probation which terminated March 6, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on October 1, 1976.

HOLDREN, EDGAR THOMAS, JR. Convicted April 23, 1959, in the Circuit Court of Bedford County of manslaughter and sentenced to two years suspended for three years after serving four months in jail and fined \$25. His probation was terminated April 23, 1962. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on May 12, 1976.

HOLMES, WALTER LAWRENCE. Convicted June 12, 1945, in the Circuit Court of Buckingham County of break and enter and sentenced to ten years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on November 22, 1976.

HOLT, JOEL H. Convicted June 28, 1973, in the Circuit Court of Rockbridge County of 1) distribution of hashish, a Schedule I Drug, 2) distribution of marijuana, a Schedule I Drug for accommodation, 3) distributing marijuana, a Schedule I Drug, 4) distributing marijuana, a Schedule I Drug for accommodation, 5) distributing marijuana, a Schedule I Drug, and 6) distributing marijuana, a Schedule I Drug. He received sentences totaling seventeen years with sixteen years suspended and a fine of \$5,000. His probation was terminated by the Court on December 5, 1975, and his suspended sentences were terminated on September 20, 1976. Relying on the recommendations of the Parole Board and reputable citizens, Subject was granted removal of political disabilities on June 3, 1976.

HUMMER, WILLIAM GARDNER. Relying on the recommendations of the Parole Board and reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on October 5, 1976.

IVES, WILLIAM SIDNEY. Convicted 1) April 1, 1957, in the Circuit Court of Princess Anne County of robbery and sentenced to eight years suspended and placed on probation which was revoked on December 17, 1957; 2) July 12, 1957, in the Corporation Court of Norfolk of unauthorized use of auto. Imposition of sentence was suspended and he was placed on probation for three years; 3) December 2, 1957, in the Corporation Court of South Norfolk of unauthorized use of auto and sentenced to one year (revoked sentence imposed on April 1, 1957, to run concurrently with this sentence). He was paroled on July 5, 1961 and discharged from parole on March 5, 1964. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on August 11, 1976.

JACKSON, JAMES H. His sentence was suspended and he was placed on probation for three years. In June of 1966, his probation was revoked and he was ordered to serve time. He was paroled on September 14, 1967, and discharged from parole on April 3, 1969. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on April 19, 1976.

JAMES, FLEMING. Convicted February 23, 1962, in the Hustings Court of Richmond of two counts of grand larceny and imposition of sentence was suspended for ten years. He was discharged by order of the Court on November 1, 1963. Relying

on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on April 13, 1976.

JOHNSON, ROBERT LEE. Convicted May 23, 1961, in the Corporation Court of Norfolk of rape and sentenced to twelve years. He was paroled on June 24, 1968, and discharged from parole on December 29, 1969. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on November 1, 1976.

JONES, BRENDA CLELL now Brenda Jones Weatherman. Convicted July 17, 1969, in the United States District Court, Eastern District of Virginia, Newport News, of violation of Title 18, USC, Section 641 (theft of Government property), and sentenced to three years. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her release, Subject was granted removal of political disabilities on April 1, 1976.

JONES, IRA FULTON. Convicted April 10, 1964, in the Circuit Court of Roanoke County of first-degree murder and sentenced to twenty-five years. He was paroled on June 22, 1970, and discharged from parole on September 6, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on October 25, 1976.

JONES, SAMUEL G., SR. Convicted June 8, 1959, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 26, USC, Sections 145(b) and 7201, Internal Revenue Code (Income Tax Evasion), and sentenced to five years and fined \$30,000. On August 3, 1961, his sentence was reduced to two years and a fine of \$30,000. He was paroled November 20, 1961, and discharged from parole on April 7, 1963. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on September 24, 1976.

JORDAN, WILLIAM SPENCER. Convicted March 6, 1969, in the Circuit Court of Virginia Beach of 1) storebreaking and sentenced to three years suspended for three years with the exception of ninety days; and 2) statutory burglary with three years suspended for three years with the exception of ninety days, to run concurrently with previous conviction. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his convictions, Subject was granted removal of political disabilities on April 5, 1976.

KING, THELMA L. Convicted June 12, 1961, in the Corporation Court of Norfolk, Part II, of unlawfully shooting and wounding and causing bodily harm with intent to maim, disfigure, disable and kill, and sentenced to eight months suspended for twelve months and fined \$100. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her conviction, Subject was granted removal of political disabilities on July 22, 1976.

KNIGHT, DANIEL HADLEY. Convicted May 24, 1974, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 371 (conspiracy). He was sentenced to eighteen months with seventeen months suspended and placed on probation which terminated September 2, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on August 25, 1976.

KNOTT, JOHN DAVID. Convicted 1) November, 1963, in the Circuit Court of Page County of eleven counts of statutory burglary, two counts of grand larceny and sentenced to six years on each count to run concurrently; 2) November 19, 1963, in the Circuit Court of Rappahannock County of four counts of breaking and entering, and sentenced to three years on each count to run concurrently and to be served consecutively with previous convictions; 3) December 12, 1963, in the Circuit Court of Rockingham County of grand larceny and three counts of statutory burglary, and sentenced to five years on each count to run concurrently; and 4) March 11, 1964, in the Circuit Court of Fauquier County of statutory burglary and sentenced to three years to run concurrently with other convictions. He was paroled on April 1, 1968 and discharged from parole on November 3, 1972. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on February 6, 1976.

KOOP, STEPHEN CASTLE. Convicted March 11, 1974, in the Circuit Court of Radford of statutory burglary and sentenced to two years suspended and placed on probation which terminated on March 11, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on October 8, 1976.

KUUSE, LAURA RUTH now Laura Kuuse Sisson. Convicted 1) March 18, 1971, in the Circuit Court of Virginia Beach of statutory burglary and sentenced to three years suspended; and 2) June 26, 1972, in the Circuit Court of Chesapeake of statutory burglary and sentenced to two years. She was paroled on February 15, 1973, and discharged from parole on March 5, 1974.

Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her release, Subject was granted removal of political disabilities on August 5, 1976.

LACY, HOWELL KENT. Convicted July 27, 1964, in the Hustings Court of Richmond of statutory burglary and sentenced to three years. He was paroled on July 21, 1965, and discharged on February 6, 1967. Relying on the recommendations of the Parole Board and the Honorable Bernard Levin, Subject was granted removal of political disabilities on January 20, 1976.

LARGE, ARVLE ROSCOE. Convicted May 20, 1975, in the United States District Court, Western District of Virginia, Danville, of violation of Title 18, USC, Sections 922(m) and 924(a), Federal Gun Control Act. Imposition of sentence was suspended, and he was placed on probation for four months. His probation was terminated on September 19, 1975, and imposition of sentence was terminated by the Court on February 9, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on March 8, 1976.

McCORMICK, SIDNEY JAMES. Convicted May 15, 1958, in the Corporation Court of Lynchburg of 1) two counts of malicious wounding and sentenced to twenty years; 2) murder and sentenced to forty-five years; 3) robbery and sentenced to ten years; and 4) burglary and sentenced to ten years; a total of eighty-five years. He was paroled on May 26, 1971, and discharged from parole on February 14, 1974. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on June 21, 1976.



McDANIEL, RONALD STEVEN. Convicted May 18, 1970, in the Circuit Court of Rockbridge County of breaking and entering with intent to commit larceny and sentenced to two years suspended and placed on probation which terminated on May 18, 1972. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on January 28, 1976.

McKENNEY, FRANK DARGAN, III. Convicted June 3, 1974, in the Circuit Court of Franklin County of three counts of distribution of marijuana as accommodation and sentenced to five years on each count to run concurrently. He was ordered to serve three months after which the balance of the sentence was suspended for three years. His suspension was terminated by Court order on April 7, 1976. MILLER, PETER MARSHALL. Convicted May 13, 1971, in the Circuit Court of Rockingham County of two counts of burglary and sentenced to five years on each count to run concurrently. He was paroled on June 27, 1972, and discharged July 10, 1974. Relying on the recommendations of the Parole Board and reputable citizens, Subject was granted removal of political disabilities on November 10, 1976.

MILLER, THOMAS JACKSON, JR. Convicted April 15, 1966, in the Corporation Court of Lynchburg of 1) burglary and sentenced to five years; and 2) six counts of forgery and sentenced to two years on each count which were suspended for five years upon his release from the Penitentiary. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on April 5, 1976.

NOWELL, LONNIE PRESTON, JR. Convicted December 23, 1968, in the Circuit Court of Hanover County of statutory burglary and sentenced to two years suspended for five years and placed on probation which terminated on March 30, 1971. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on April 5, 1976.

PACKETT, IRVING DAVID, JR. Convicted January 29, 1973, in the Circuit Court of Franklin County of three counts of Violation of the Drug Control Act and sentenced to six years suspended for three years on Counts 1 and 3, and to five years suspended on Count 2. His suspended sentences were terminated by the Court on August 16, 1976. Relying on the recommendations of the Parole Board and reputable citizens, Subject was granted removal of political disabilities on September 24, 1976.

PACKETT, RALPH WAYNE. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on January 23, 1976.

PAINTER, JOHN LLOYD. Convicted March 25, 1974, in the Circuit Court of Page County of grand larceny and sentenced to twelve months suspended for two years and placed on probation which terminated March 25, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on October 25, 1976.

PARKER, ALLEN LEON, JR. Convicted April 20, 1972, in the Circuit Court of Virginia Beach of possession with intent to sell a quantity of marijuana and sentenced to three years suspended and placed on probation which terminated July 24, 1974. Relying on the recommendations of the Parole Board and reputable citizens, Subject was granted removal of political disabilities on June 3, 1976.

PARKER, RAYMOND HOWARD. Convicted March 3, 1975, in the Circuit Court of Gloucester County of breaking and entering and sentenced to two years. He was paroled to Alabama in September of 1975, and discharged from parole on September 2, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct, Subject was granted removal of political disabilities on December 22, 1976.

PATTERSON, HARVEY LEE. Convicted May 13, 1959, in the United States District Court, Eastern District of Virginia, Norfolk, of four counts of violation of Sections 5174, 5606,

5216, 5686(b) and 7302 of the Internal Revenue Code of 1954 (illicit distillery), and sentenced to two years with a penalty of \$500 and a fine of \$1,000, to stand committed for the non-payment, on Count 1; two years to run concurrent with Count 1, fined \$1.00, not to stand committed for non-payment on Count 2; two years to run concurrent with sentences on Counts 1 and 2, fined \$1.00, and not to stand committed for non-payment on Count 3; one year to run consecutively with Counts 1, 2, and 3, fined \$1.00 and not to stand committed for non-payment on Count 4. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on July 29, 1976.

Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on November 22, 1976.

PENN, JOHN HENRY. Convicted 1) September 10, 1946, in the Hustings Court of Richmond of two counts of robbery and sentenced to twenty-five years. He was paroled on March 9, 1954, and his parole was revoked in 1955; and 2) March 22, 1955, in the Hustings Court of Richmond of grand larceny and sentenced to two years. He was paroled on March 30, 1959, and discharged on February 28, 1966. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction and release, Subject was granted removal of political disabilities on November 1, 1976.

PENNINGTON, GRADY LEE. Convicted January 27, 1954, in the Circuit Court of Fairfax County of rape and sentenced to ten years. He was paroled in July of 1957, and discharged from parole in June of 1960. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on July 8, 1976.

PERRY, THOMAS WAYNE. Convicted 1) February 10, 1958, in the Circuit Court of Law and Chancery of Caroline County, of two counts of breaking and entering, and sentenced to five years on each count to run concurrently; and of grand larceny and sentenced to five years; 2) February 17, 1958, in the Circuit Court of Fredericksburg of two counts of breaking and entering and sentenced to five years on each count to run concurrently; 3) March 3, 1958, in the Circuit Court of King George County of three counts of breaking and entering and sentenced to five years; and 4) April 25, 1958, in the Circuit Court of Stafford County of three counts of breaking and entering and sentenced to four years; a total of nineteen years. He was paroled on September 15, 1964, and discharged on June 15, 1970. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on November 22, 1976.

PICKLER, EDGAR L., Jr. Convicted May 25, 1974, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 371 (conspiracy), and sentenced to ninety-one days in confinement, probation for two years upon release and fined \$6,000. His probation terminated November 29, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on December 10, 1976.

POFFENBARGER, WILLIAM HUNT. Convicted July 5, 1962, in the Circuit Court of Montgomery County of unauthorized use of an automobile and sentenced to six months in jail suspended and fined \$250. Relying on the recommendations of the Parole Board, the sentencing judge, the present Commonwealth's Attorney, the prosecuting attorney being deceased, and reputable citizens, Subject was granted removal of political disabilities on September 24, 1976.

POTTER, CLINTON. Convicted March 22, 1966, in the Circuit Court of Dickenson County of grand larceny and sentenced to three years. He was paroled on January 23, 1967, and discharged from parole on July 30, 1968. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on April 14, 1976.

PRINCE, JAMES BARTON. Convicted July 13, 1948, in the Corporation Court of Newport News of grand larceny and house-breaking with intent to commit larceny and sentenced to six months and placed on probation for one year which terminated on September 17, 1949. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on September 24, 1976.

PUCKETT, VIRGINIA HUTCHERSON. Convicted March 22, 1973, in the Hustings Court of Roanoke of 1) two counts of forgery and uttering and sentenced to six months suspended for three years and placed on probation on each count; and 2) forgery and sentenced to six months suspended for three years and placed on probation. Probation on all counts terminated on March 22, 1976. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her conviction, Subject was granted removal of political disabilities on March 30, 1976.

PUGH, STEVEN WAYNE. Convicted October 12, 1970, in the Circuit Court of Wythe County of manslaughter and sentenced to three years suspended and placed on probation for two years, which terminated on July 17, 1972. His suspension expired on October 12, 1973. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on December 22, 1976.

QUALLS, SILAS MARTIN. Convicted September 2, 1970, in the Circuit Court of Scott County of rape and sentenced to six years. He was paroled on April 20, 1972, and discharged from parole on September 10, 1974. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on November 22, 1976.

QUELLAND, BARRETTE Lee. Convicted August 12, 1971, in the Circuit Court of Charlottesville of possession of cannabis with intent to distribute and sentenced to ten years with six years suspended. He was paroled on June 26, 1972, and discharged from parole in February of 1974. His remaining six-year suspended sentence was terminated by the Court on May 12, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on May 18, 1976.

QUELLAND, JUDITH WILSON, now Judith Quelland Pascarosa. Convicted August 12, 1971, in the Corporation Court of Charlottesville of possession of cannabis with intent to distribute and sentenced to five years suspended and placed on probation for three years which terminated on August 12, 1974. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her conviction, Subject was granted removal of political disabilities on April 5, 1976.

RAGLAND, DAVID W. Convicted July 16, 1963, in the Circuit Court of Halifax County of malicious wounding and sentenced to ten years. He was paroled on October 22, 1968, and discharged on October 26, 1970. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on December 2, 1976.

RICHITT, LAWRENCE JULIAN. Convicted 1) March 4, 1960, in the Circuit Court of Fairfax of seven counts of forgery and sentenced to two years on each count to run concurrently; and 2) March 9, 1960, in the Circuit Court of Arlington of forgery and sentenced to two years to run concurrently with conviction in Fairfax; a total of two years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on October 25, 1976.

RIDDICK, JAMES WILLIS. Convicted September 19, 1973, in the Circuit Court of Isle of Wight of grand larceny and sentenced to one year suspended and placed on probation for three years which terminated June 15, 1976. His suspension expired on September 19, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 22, 1976.

RIDDICK, THOMAS. Convicted October 19, 1971, in the Hustings Court of Portsmouth of statutory burglary and sentenced to two years suspended and placed on probation which terminated on January 30, 1973. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on December 10, 1976.

ROBINSON, ANTHONY. Convicted on July 12, 1970, in the Hustings Court of Richmond of statutory burglary. Imposition of sentence was suspended for five years and he was placed on indefinite probation which terminated on July 1, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on October 8, 1976.



ROPER, GEORGE W., II. Convicted May 14, 1974, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 371 (conspiracy), and sentenced to three years with two years and eight months suspended for two years, and fined \$10,000. ROPER, JOHN LONSDALE, 2d. Convicted April 29, 1974, in the United States District Court, Eastern District of Virginia, Norfolk, of seven counts of violation of Title 26, USC, Section 7201 (Income Tax Evasion), and sentenced to three years suspended and placed on probation and fined a total of \$17,500 (\$2,500 each count). Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 24, 1976.

RUNYON, AVERY. Convicted May 13, 1963, in the Circuit Court of Wyoming County, Mullens, West Virginia, of voluntary manslaughter and sentenced to five years suspended and placed on probation which terminated on March 17, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on August 5, 1976.

RUSSELL, ANCIL ELBERT, JR. Convicted October 7, 1958, in the Hustings Court of Roanoke of malicious bodily injury and sentenced to two years. Relying on the recommendations of the Parole Board and reputable citizens, Subject was granted removal of political disabilities on April 5, 1976.

SANDERS, ROBERT C. Convicted June 19, 1969, in the Circuit Court of Salem of two counts of sale of a narcotic drug and sentenced to three years suspended and placed on probation which terminated July 1, 1971. Relying on the recommendations of the Parole Board, the sentencing judge and prosecuting attorney, who is current Commonwealth's Attorney, Subject was granted removal of political disabilities on September 8, 1976.

SATTERWHITE, GRANVILLE EUGENE. Convicted 1) July 10, 1944, in the Circuit Court of Chesterfield of assault. Imposition of sentence was suspended for ten years; and 2) February 28, 1947, in the Circuit Court of Chesterfield at which time the aforementioned sentence was revoked and he was ordered to serve eighteen months. SETLIFF, JAMES ARLEN. Convicted June 25, 1962, in the Circuit Court of Westmoreland County of statutory burglary and sentenced to twelve months in jail suspended for five years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on December 22, 1976.

SEYMORE, DAVID LEE. Convicted March 9, 1972, in the Circuit Court of Orange County of violation of Section 18.1-213, Code of Virginia, (Enticing, etc., child to enter vehicle, etc., for certain purposes), and sentenced to three years with two and one-half years suspended. Probation terminated on May 27, 1974, and his suspended sentence expired on March 9, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on November 23, 1976.

SHIELDS, THEODORE ROOSEVELT. Convicted January 5, 1966, in the Circuit Court of Chesapeake of second-degree murder and sentenced to fifteen years. He was paroled on June 30, 1969, and discharged from parole on July 23, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on March 16, 1976.

SHIPE, GEORGE EDWARD. Convicted 1) June 15, 1971, in the Circuit Court of Warren County of grand larceny and sentenced to two years; and 2) September 13, 1974, of perjury and sentenced to two years. He was paroled on August 26, 1975, and discharged from parole on August 25, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities October 1, 1976.

SITKO, GARY LEE. Convicted June 2, 1971, in the Corporation Court of Norfolk of uttering. Imposition of sentence was suspended and he was placed on probation for three years. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities June 25, 1976.

SKILLMAN, KENNETH HOWARD. Convicted 1) September 9, 1968, in the Circuit Court of Rockingham County of three counts of forgery and sentenced to two years on each count suspended for five years; 2) September 18, 1969 of grand larceny and sentenced to four years; and 3) September 26, 1969, at which time the six-year sentence imposed on September 9, 1968, was revoked; a total of ten years. He was paroled on October 7, 1971, and discharged from parole on July 23, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on November 24, 1976.

SLYE, DAVID EUGENE, SR. Convicted February 26, 1973, in the Circuit Court of Rockingham County of grand larceny and sentenced to two years suspended for three years and placed on probation which terminated on May 19, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on May 28, 1976.

SMITH, JERRY WAYNE. Convicted September 22, 1964, in the Corporation Court, Part II, of Norfolk of unauthorized use of motor vehicle and sentenced to twelve months in jail and fined \$250. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on January 4, 1977.

SMITH, WAYNE ROSSITER, III. Convicted April 6, 1964, in the 1) Corporation Court of Charlottesville of two counts of forgery and sentenced to eighteen months suspended for four years, probation terminated on November 4, 1966; and 2) in the Circuit Court of Albemarle County of two counts of forgery and sentenced to twelve months suspended for four years, probation terminated on November 10, 1966. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities June 14, 1976.

SPROUSE, CLARENCE E. Convicted October 16, 1945, in the Circuit Court of Chesterfield of larceny of automobile and sentenced to twelve months. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on June 22, 1976.

STENNETT, MARGARET MADAGAN. Convicted August 27, 1968, in the Circuit Court of Staunton of two counts of forgery and sentenced to two years suspended for five years. In May of 1969, her probation was revoked and she was ordered to serve her term. She was paroled on August 12, 1971, and discharged from parole on April 12, 1972. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her release, Subject was granted removal of political disabilities on September 24, 1976.

TAUSS, BRIAN LEE. Convicted February 18, 1972, in the Circuit Court of Fairfax County of shooting into an occupied dwelling and sentenced to three years suspended. His probation was terminated by court order on September 12, 1973. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on April 15, 1976.

THOMPSON, GLENN G., JR. Convicted June 22, 1971, in the Circuit Court of Albemarle of three counts of selling and distributing drugs. On Counts 1 and 2 he received a sentence of four years suspended for five years after release from confinement; and on Count 3 he received four years with two years suspended, to be on supervised probation for five years upon release. He was paroled on March 28, 1972, and discharged from parole on September 28, 1973. His suspended sentences were terminated September 28, 1973. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities on May 18, 1976.

TILLET, BEULAH VIRGINIA. Convicted May 5, 1953, in the Corporation Court of Norfolk of voluntary manslaughter and sentenced to one year suspended for five years. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her conviction, Subject was granted removal of political disabilities on May 13, 1976.

TOMLIN, HAROLD LEE. Convicted October 12, 1973, in the United States District Court, Western District of Virginia, Roanoke, of violation of Title 18, USC, Section 1955 and 2 (supervising and owning an illegal gambling business). Imposition of sentence was suspended, and he was placed on inactive probation for one year, and fined \$750. His probation terminated on October 11, 1974. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities May 12, 1976.

TORRECH, RAFAEL, III. Convicted May 24, 1974, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 371 (conspiracy), and sentenced to eighteen months with seventeen months suspended and placed on probation for two years which terminated on August 22, 1975, and fined \$3,000. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on August 11, 1976.

TURNER, KENNETH LEE. Convicted May 10, 1972, in the Corporation Court of Lynchburg of distribution of a Schedule I Controlled Drug, LSD, and sentenced to two years suspended and placed on probation which terminated April 30, 1973, and fined \$5,000. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities April 21, 1976.

WALDRON, CLARENCE DAVID. Convicted January 11, 1973, in the Circuit Court of Bedford County of two counts of statutory burglary and sentenced to four years on each count to run concurrently, suspended upon the condition that four months on each count were to be served in jail (concurrently), and that he be placed on probation for five years, which terminated on November 7, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities January 28, 1976.

WALLACE, JOSEPH MILLS, JR. Convicted 1) October 20, 1964, in the Circuit Court of Newport News of burglary and sentenced to six months in jail and fined \$50; and 2) April 19, 1968 of burglary and sentenced to twelve months in jail and fined \$100. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities November 22, 1976.

WARREN, EMMA C. Convicted July 28, 1970, in the Circuit Court of Surry County of second-degree murder and sentenced to seven years. She was paroled on October 29, 1973, and discharged from parole on October 29, 1974. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her release, Subject was granted removal of political disabilities January 23, 1976.

WHEELER, JAMES RONALD. Convicted January 9, 1964, in the Circuit Court of Roanoke County of grand larceny and sentenced to twelve months suspended and placed on probation for three years which terminated on January 7, 1966. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities on August 16, 1976.

WHITE, CLEVELAND. Convicted June 20, 1950, in the Corporation Court of Lynchburg of robbery and sentenced to twenty years. He was paroled on July 8, 1955, and discharged from parole on September 30, 1963. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities May 12, 1976.

WHITE, GEORGE EDWIN. Convicted July 7, 1953, in the Corporation Court of Norfolk of first-degree murder and sentenced to life. He was paroled on April 29, 1968, and discharged from parole on April 3, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities September 24, 1976.

WHITLOCK, ERNESTINE KYLE. Convicted January 14, 1963, in the Hustings Court of Roanoke of 1) embezzlement and sentenced to two years; 2) six counts of forgery and sentenced to two years on each count to run concurrently with the embezzlement conviction; and 3) two counts of forgery and sentenced to two years on each count suspended, to run consecutively. She was discharged from the Penitentiary on April 1, 1964. Relying on the recommendations of reputable citizens who are familiar with this woman's conduct since her release, Subject was granted removal of political disabilities August 25, 1976.

WILLIAMS, ELLIOTT EDMOND, III. Convicted July 15, 1971, in the Circuit Court of Virginia Beach of statutory burglary and sentenced to four years suspended and placed on probation which terminated on October 7, 1974. His suspension expired on July 15, 1975. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities November 1, 1976.

WILSON, JOHN WILLIAM. Convicted February 21, 1975, in the United States District Court, Western District of Virginia, Danville, of violation of Title 18, USC, Sections 922(m) and 924(a), 922(d) and 924(a) and 2 of the Federal Gun Control Act. Imposition of sentence was suspended, and he was placed on probation for two years which terminated on April 15, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities May 13, 1976.

WOODALL, ROBERT EDGAR, JR. Convicted December 6, 1972, in the Circuit Court of Portsmouth of possession of a controlled drug. Imposition of sentence was suspended and he was placed on probation for two years which terminated on January 4, 1974. Suspended sentence was terminated by Court Order on August 13, 1976.

Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities September 8, 1976.

WOODS, WILLIAM GLENN. Convicted April 23, 1973, in the Circuit Court of Portsmouth of possession of an explosive device and sentenced to one year suspended and placed on unsupervised probation. Relying on the recommendations of the Parole Board, the sentencing judge, the prosecuting attorney and the Commonwealth's Attorney of Southampton County, Subject was granted removal of political disabilities August 5, 1976.

WRIGHT, WILBUR JUNIOR. Convicted November 30, 1971, in the Corporation Court of Charlottesville of five counts of sale of controlled drug and sentenced to fifteen years with nine years suspended. He was paroled July 3, 1973, and discharged on February 13, 1975. The nine-year suspended sentence was terminated by Court Order on August 9, 1976. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his release, Subject was granted removal of political disabilities August 16, 1976.

YOUNG, RONALD HENRY. Convicted February 27, 1970, in the Corporation Court of Norfolk of grand larceny. Imposition of sentence was suspended and he was placed on probation for three years which terminated on February 26, 1973. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, Subject was granted removal of political disabilities June 14, 1976.
