ABSOLUTE PARDON

MILLS, CLYDE EDWIN. Convicted July 16, 1975, in the Circuit Court of Isle of Wight County of attempted robbery and sentenced to twenty years, and felonious shooting in the commission of a felony and sentenced to five years to run concurrently; a total of twenty years. In light of after-discovered evidence exonerating the participation of Clyde Edwin Mills in the above offenses and upon the recommendations of the Parole Board, the sentencing Judge and prosecuting Commonwealth's Attorney, I am hereby granting him an Absolute Pardon and ordering that the offenses be removed from any and all records upon which they may appear. This pardon dated March 8, 1977.

TURNER, JOSEPH V., III. Convicted June 9, 1975, in the Circuit Court of Richmond, Division II, of three counts of grand larceny and sentenced to six years suspended for ten years and placed on probation. His probation terminated January 26, 1977. Relying on my own personal knowledge of this individual and a reasonable understanding of the crimes involved and the recommendation of Deputy Attorney General Reno S. Harp, III; and in the absence of any objection by the prosecuting attorney, the Honorable Aubrey M. Davis, Jr., and the presiding judge, the Honorable Frank A. S. Wright, I am granting an absolute pardon to this man. This pardon dated November 14, 1977.

CONDITIONAL PARDO

ETHERIDGE, DAVID. Convicted September 19, 1972, in the Corporation Court of Norfolk of possession and distribution of controlled drug and sentenced to forty years in the Penitentiary (forty and forty concurrently). In view of the lengthy sentence imposed, the fact that Subject has taken advantage of every opportunity and has responded to all such opportunities as offered by our penal system, and has now received the maximum benefit from the system and his incarceration therein, the recommendation of the Parole Board, and there being no objections from the sentencing judge and prosecuting Commonwealth's Attorney, Subject is granted a conditional pardon effective August 22, 1977, and will be under supervision for five years. This pardon dated August 16, 1977.

LOISEAU, ANDRE. Convicted October 5, 1976, in the Fauquier County Circuit Court of break and enter and grand larceny and sentenced to five years on each count to run concurrently; on January 4, 1977, in the Loudoun County Circuit Court of three counts of grand larceny and sentenced to ten years (fifteen years with five years to run concurrent), and two counts of breaking and entering and sentenced to five years (ten years with five years to run concurrently); on April 8, 1976, in the Albemarle County Circuit Court of two counts of breaking and entering and sentenced to five years on each count; a total of twenty-five years. Upon the request of the Belgian government and the recommendation of the Parole Board, I am granting this man a conditional pardon on the provision that he be deported by the United States government to the Kingdom of Belgium and that he not return to the Commonwealth of Virginia prior to February 27, 1986, which is the current expiration date of his sentence. This pardon dated January 12, 1978.

McWATERS, DALLAS CLIFTON, JR. Convicted June 19, 1967, in the Circuit Court of Roanoke County of first-degree murder and sentenced to life. Based on the very commendable record this man has achieved while incarcerated, upon my impressions of him gained from personal interviews in my office with him and the members of his family, and upon the recommendations of Mr. Jack Davis, former Director of the Department of Corrections, Mr. Kyle Purvis, Superintendent of Southampton Correctional Center, and other reputable citizens, and upon the assurance of the trial judge and prosecuting attorney that they have no objection, I am granting this man a conditional pardon, conditioned upon his continuing to serve for a period of five years in his present capacity as a licensed physician's assistant at Southampton Correctional Center, so long as the State Correctional authorities desire him to be so employed; upon the condition that he be of good behavior and that he be placed under the supervision of a probation and parole officer for a period of five years. This pardon effective January 16, 1978. This pardon dated January 13, 1978.

ROLLINS, EUGENE WILLIAM. Convicted April 27, 1967, in the Circuit Court of Arlington County of first-degree murder and sentenced to life in the Penitentiary. Because of the terminal illness of this man and based upon a favorable recommendation of the Parole Board, and the fact that there is no objection from the sentencing judge and the prosecuting attorney, and with the conditions that Subject is transferred to a Maryland hospital, that his sister be responsible for his continuing care, and that he not return again to the Commonwealth of Virginia, Subject is granted a conditional pardon, effective October 26, 1977, and will be under supervision for five years. This pardon dated October 25, 1977.

THOMISON, IDA MAE. Convicted October 21, 1976, in the Newport News Circuit Court of voluntary manslaughter and sentenced to ten years in the Penitentiary. In view of her present physical condition, her minimum prior record, the recommendations of the Parole Board and the sentencing judge, the Commonwealth's Attorney not objecting, Subject is granted a conditional pardon effective December 23, 1977, and will be under supervision for three years. This pardon dated December 22, 1977.

PARDONS WITHOUT CONDITIONS

BERRY, BETTY ANN, aka Betty Ann Berry Bronson. Convicted January 2, 1970, in the General District Court of Fairfax County of shoplifting (concealment) and sentenced to one hundred days in jail with ninety days suspended. Relying on the recommendation of the Parole Board, the sentencing judge and prosecuting Commonwealth's Attorney not objecting, Subject was granted a pardon dated July 8, 1977.

BUNNER, ROBERT KEITH, II. Convicted May 6, 1974, in the General District Court of Norfolk of worthless check (\$30, misdemeanor) and sentenced to thirty days suspended and fined \$25. Relying on the recommendations of the Parole Board and the sentencing judge, the prosecuting Commonwealth's Attorney not objecting, Subject was granted a pardon dated December 12, 1977.

CLARK, ROBIN. Convicted July 14, 1970, in the Corporation Court of Alexandria of illegal possession of narcotics and statutory burglary and sentenced to five years on each count to run concurrently, suspended and placed on probation for five years. His probation terminated by Court Order on November 13, 1973, and his suspended sentence expired July 14, 1975. Relying on the recommendations of the Parole Board, the sentencing Judge and Commonwealth's Attorney, Subject was granted a pardon dated January 5, 1978.

COSING, ARTHUR P., JR. Convicted November 17, 1975, in the Fairfax County General District Court of concealment of merchandise and fined \$100 and thirty days in jail suspended. Relying on the recommendation of the Parole Board, the sentencing judge and prosecuting Commonwealth's Attorney not objecting, Subject was granted a pardon dated August 1, 1977.

DAVIS, JAMES ROBERT. Convicted November 18, 1964, in the Circuit Court of Hopewell of accessory after the fact of armed robbery (misdemeanor) and sentenced to twelve months in jail suspended for two years and placed on probation. His probation terminated December 14, 1965. Relying on the recommendations of Mr. Ernest Bartha, Regional Administrator for the Division of Probation and Parole Services, and reputable citizens, the sentencing Judge and Commonwealth's Attorney not objecting, Subject was granted a pardon dated January 11, 1978.

DENISON, FRANCES LEE, aka Mrs. Stanley L. Denison. Convicted July 18, 1975, in the Waynesboro General District Court of shoplifting and fined \$25.00. Relying on the recommendation of the Parole Board, the sentencing judge and Commonwealth's Attorney not objecting, Subject was granted a pardon dated January 5, 1978.

FITZGERALD, WALTER G. Convicted March 6, 1973, in the Circuit Court of Fairfax County of statutory burglary and sentenced to twelve months in jail suspended. Relying on the recommendations of the Parole Board and reputable citizens, the sentencing judge and prosecuting Commonwealth's Attorney not objecting, Subject was granted a pardon dated July 8, 1977.

GRAHAM, MICHAEL EDWARD. Convicted July 11, 1972, in the Circuit Court of Hanover County of statutory burglary and sentenced to twelve months with ten months suspended for two years. His probation was terminated in May of 1974. Relying on the recommendation of the Parole Board, the sentencing judge being deceased, and the prosecuting Commonwealth's Attorney and current Commonwealth's Attorney not objecting, Subject was granted a pardon dated January 5, 1978.

HARRELL, C. LYDON, JR. Convicted June 1, 1976, in the Circuit Court of Norfolk of forgery and grand larceny and sentenced to two years, and conspiracy and larceny of books of accounts and sentenced to six months in jail and fined \$1,000. His sentence was suspended with exception of five days and he was placed on unsupervised probation for three years. Acting out of a sense of mercy and compassion and from personal knowledge of this man and his family and their circumstances, the sentencing judge and Commonwealth's Attorney not objecting, Subject was granted a pardon dated January 13, 1978.

HUMMER, WILLIAM GARDNER. Convicted June 15, 1973, in the Circuit Court of Rockbridge County of seven counts of distribution of Schedule I drugs and sentenced to seventeen years with sixteen and one-half years suspended. His suspended sentences were terminated by Court Order on April 2, 1975. Since this man has demonstrated that he has been rehabilitated and has become a productive member of society, and in view of the recommendation of the Parole Board, the sentencing judge having no objection, Subject was granted a pardon dated January 6, 1978.

LLOYD, WILLIAM HUNTER. Convicted January 5, 1972, in the Circuit Court of Virginia Beach of forgery and sentenced to three years suspended. His probation and suspended sentence terminated January 5, 1975. Relying on the recommendations of the Parole Board, the sentencing judge, the Commonwealth's Attorney not objecting, and reputable citizens, Subject was granted a pardon dated January 22, 1977.

McCLUNG, JAMES W. Convicted July 6, 1970, in the Circuit Court of Rockingham County of trespassing and sentenced to nine months in jail and fined \$1,000. I am granting a simple pardon to James W. McClung and directing his release on Friday, November 13, 1977, contingent upon the payment of any fines. The sole effect of this pardon is to release him from the balance of the penalty lawfully imposed upon him by the Commonwealth following his conviction in 1970 for violation of Virginia law growing out of incidents which transpired at Madison College. I concur completely in the actions of Judge Robinson in refusing to suspend the sentence imposed by the Circuit Court of Rockingham County and in denying motion for stay of execution of sentence - actions deemed by him to be indispensable to the preservation of the integrity of the judicial process. I further believe, at this time, that the period already served suffices to vindicate the integrity of the judicial process. Therefore, and in light of the fact that this individual has become a useful and respected citizen in his community, executive clemency is deemed to be appropriate. This pardon dated November 17, 1977.

MALLOY, WILLIAM. Convicted July 11, 1975, in the General District Court of Fairfax County of concealment of merchandise and sentenced to thirty days in jail suspended and fined \$50.00. Relying on the recommendation of the Parole Board, there being no objections by the sentencing judge and Commonwealth's Attorney, Subject was granted a pardon dated March 24, 1977.

MAYS, ERIC. Convicted January 14, 1972, in the Circuit Court of Lancaster County of possession of controlled drug - marijuana, and sentenced to six months in jail, and possession of controlled drug - LSD, and sentenced to two years suspended and placed on probation. His probation and suspension expired January 14, 1974. Relying on the recommendation of the Parole Board, the sentencing judge and present Commonwealth's Attorney not objecting, and the prosecuting Commonwealth's Attorney being deceased, Subject was granted a pardon January 6, 1978.

MILLER, LAWRENCE I., JR. Convicted October 19, 1970, in the County Court of Sussex of contributing to delinquency of minor and sentenced to ninety days suspended and fined \$250. Relying on the recommendations of the Parole Board, the sentencing Judge, the present Commonwealth's Attorney who was also the prosecuting attorney, and reputable citizens, Subject was granted a pardon dated January 26, 1977.

NEWELL, JOHN GOODWIN. Convicted January 25, 1973, in the Circuit Court of Newport News of possession of heroin with intent to distribute and sentenced to four years suspended for four years. His suspended sentence expired January 25, 1977. Relying on the recommendations of the Parole Board, the sentencing judge and reputable citizens, the Commonwealth's Attorney not objecting, Subject was granted a pardon dated October 11, 1977.

PATTERSON, STEVEN FORREST. Convicted September 8, 1967, in the County Court of Arlington of concealment of merchandise and sentenced to six months in jail suspended for one year and fined \$100. Relying on the recommendations of the Parole Board and reputable citizens, the sentencing judge being deceased, the prosecuting attorney being unable to respond due to illness, and the present Commonwealth's Attorney having no objections, Subject was granted a pardon dated May 23, 1977.

RAINEY, JAY GARLAND. Convicted July 6, 1970, in the Circuit Court of Rockingham County of trespassing and sentenced to six months in jail and fined \$500. I am granting a simple pardon to Jay Garland Rainey and directing his release on Friday, November 18, 1977, contingent upon the payment of any fines and outstanding court costs in the amount of \$42.58. The sole effect of this pardon is to release him from the balance of the penalty lawfully imposed upon him by the Commonwealth following his conviction in 1970 for violation of Virginia law growing out of incidents which transpired at Madison College. I concur completely in the actions of Judge Robinson in refusing to suspend the sentence imposed by the Circuit Court of Rockingham County and in denying motion for stay of execution of sentence - actions deemed by him to be indispensable to the preservation of the integrity of the judicial process. I further believe, at this time, that the period already served suffices to vindicate the integrity of the judicial process. Therefore, and in light of the fact that this individual has become a useful and respected citizen in his community, executive clemency is deemed to be appropriate. This pardon dated November 17, 1977.

ROCHELLE, STEPHEN BAYLES. Convicted July 6, 1970, in the Circuit Court of Rockingham County of trespassing and sentenced to six months in jail and fined \$500. I am granting a simple pardon to Stephen B. Rochelle and directing his release on Friday, November 18, 1977, contingent upon the payment of any fines and of outstanding court costs in the amount of \$42.58. The sole effect of this pardon is to release him from the balance of the penalty lawfully imposed upon him by the Commonwealth following his conviction in 1970 for violation of Virginia law growing out of incidents which transpired at Madison College. I concur completely in the actions of Judge Robinson in refusing to suspend the sentence imposed by the Circuit Court of Rockingham County and in denying motion for stay of execution of sentence - actions deemed by him to be indispensable to the preservation of the integrity of the judicial process. I further believe, at this time, that the period already served suffices to vindicate the integrity of the judicial process. Therefore, and in light of the fact that this individual has become a useful and respected citizen in his community, executive clemency is deemed to be appropriate. This pardon dated November 17, 1977.

WHITT, GARY WAYNE. Convicted December 15, 1971, in the Hustings Court of Newport News of violation of Drug Control Act (LSD), two counts, and sentenced to four years on each count to run concurrently. He was to serve one and one-half years with the remaining two and one-half years suspended upon his release and was to be under probation supervision until December 1, 1974. Relying on the recommendations of the Parole Board and reputable citizens, the sentencing judge and prosecuting Commonwealth's Attorney not objecting, Subject was granted a pardon dated September 6, 1977.

WOOD, WENDELL MASSIE. Convicted May 14, 1973, in the Circuit Court of Campbell County of receiving stolen goods and sentenced to two years suspended, to serve twelve months in jail and probation for two years. He began serving his jail sentence April 28, 1975, and on July 18, 1975, this time was suspended. He was ordered to remain on probation which terminated April 28, 1977. Relying on the recommendation of the Parole Board, the judges and Commonwealth's Attorney not objecting, Subject was granted a pardon dated January 5, 1978.

PARDON TO OWN, POSSESS AND TRANSPORT A FIREARM

TAUSS, BRIAN LEE. Convicted February 18, 1972, in the Circuit Court of Fairfax of shooting into an occupied dwelling and sentenced to three years suspended and placed on probation. His probation was terminated by Court Order on September 12, 1973. The Parole Board recommended a simple pardon for this man, taking no position regarding the request for specific permission to own, possess and transport a firearm. Because of the Board's generally favorable report, and the fact that neither the trial judge nor the prosecuting Commonwealth's Attorney have any objection, Subject was granted this pardon so that he could qualify for Federal permission to own, possess and transport a firearm. This pardon dated November 16, 1977.

REVOCATION OF PARDON

KOST, ARTHUR THOMAS. Convicted on July 27, 1964, in the Circuit Court of Wise County of armed robbery and sentenced to sixteen years in the Penitentiary. Subsequently, he was tried in the Circuit Court of Goochland on charges of abduction and escape and was sentenced on January 16, 1967, to five years for abduction and two years for escape. On January 4, 1973, he was granted a conditional pardon with the stipulation that he be under the supervision of the Probation and Parole Board for a period of five years and that should he at any time prior to September 24, 1979, be found guilty of the violation of any of the penal laws of the Commonwealth, or should he violate any of the conditions of parole, then this pardon should become null and void, and he should

be required to serve the remainder and unserved portion of his sentence. On March 29, 1977, Kost was found guilty of kidnapping in the Ramsey County District Court, St. Paul, Minnesota. He was sentenced to forty years imprisonment, and the Judge directed that this sentence be served consecutively to any prior sentence. Kost was also convicted April 13, 1977, in the United States District Court for the District of Minnesota on a charge of willfully and knowingly making a false statement in applying for passport with intent to induce or secure issuance of passport for his use contrary to the laws and rules regulating issuance of passports. A sentence of two years was imposed for this charge, and the Court recommended that the sentence be served in the State Prison at Stillwater. After a hearing before the Parole Board on June 17, 1977, the Board recommended that the conditional pardon granted to Arthur Thomas Kost be revoked. After reviewing the transcript of the hearing, the recommendation of the Parole Board, and the Answer by Kost's counsel to the recommendation of the Parole Board, it was found that Subject had violated the conditions of pardon by committing two separate criminal offenses. Having found this, the conditional pardon granted Arthur Thomas Kost on January 4, 1973, was revoked on August 15, 1977.

REMOVAL OF POLITICAL DISABILITIES

Relying on the recommendations of parole officers and reputable citizens who are familiar with the conduct of these individuals since their release, I have granted removal of political disabilities to the following:

ADAMS, GERALD WESLEY. Convicted November 30, 1967, in the Hustings Court of Roanoke of second-degree murder and sentenced to five years. He was paroled April 5, 1969 and discharged from parole February 16, 1971. Subject was granted removal of political disabilities on January 18, 1977.

ANTHONY, ROBERT LORNE. Convicted June 9, 1976, in the Circuit Court of Frederick County of perjury and sentenced to twelve months and fined \$200. He was to serve ten days after which the twelve months was suspended for one year and he was placed on probation. His probation terminated June 9, 1977. Subject was granted removal of political disabilities on August 24, 1977.

BALDWIN, VAN HERBERT. Convicted January 18, 1972, in the Circuit Court of Virginia Beach of violation of Uniform Narcotics Drug Act and sentenced to three years suspended, fined \$500, and placed on probation which terminated June 28, 1973. Subject was granted removal of political disabilities on February 8, 1977.

BATEMAN, LEWIS BATTLE. Convicted June 6, 1960, in the Princess Anne Circuit Court (now Virginia Beach Circuit Court) of burglary and sentenced to eighteen months. He was paroled October 17, 1960, and discharged April 17, 1962. Subject's political disabilities were removed August 24, 1977.

BEALE, ROBERT WALTER. Convicted May 26, 1964, in the Hustings Court of Portsmouth of robbery and sentenced to five years. He was paroled August 30, 1965, and discharged from parole June 26, 1967. Subject was granted removal of political disabilities on May 6, 1977.

BEVERLY, DANIEL F. Convicted April 14, 1975, in the United States District Court, Western District of Virginia, Abingdon, of violation of Title 18, USC, Section 111 and 114 (Federal Gun Control Act). Imposition of sentence was suspended and he was placed on probation for two years. His probation terminated December 27, 1976. Subject was granted removal of political disabilities on April 29, 1977.

BIRCHETT, JAMES. Convicted April 27, 1954, in the Hustings Court of Petersburg of grand larceny and sentenced to one year. Subject was granted removal of political disabilities on August 19, 1977.

BLANKS, LUTHER C. Convicted January 23, 1975, in the United States District Court, Western District of Virginia, Lynchburg, of violation of Title 18, USC, Sections 1001 and 1002 (mismarketing tobacco). Imposition of sentence was suspended and he was placed on inactive probation for one year and fined \$1,000. His probation terminated January 23, 1976. Subject was granted removal of political disabilities on March 14, 1977.

BOWSER, HARRY A., SR. Convicted November 19, 1945, in the Ca hoon County Court, Battle Creek, Michigan, of voluntary manslaughter and sentenced to seven and one-half years to fifteen years. He was paroled February 9, 1951, to Virginia and discharged from parole February 9, 1954. Subject was granted removal of political disabilities on February 24, 1977.

BOYETTE, ROSA LEE. Convicted March 17, 1972, in the Circuit Court of Chesapeake of involuntary manslaughter. Imposition of sentence was suspended and she was placed on probation for five years. Her probation terminated March 17, 1977. Subject was granted removal of political disabilities on April 22, 1977.

BRICKHOUSE, VIRGIE LEE. Convicted February 27, 1973, in the Corporation Court of Norfolk, Part II, of involuntary manslaughter and sentenced to four years suspended and placed on probation for three years. Her probation terminated February 27, 1976, and her suspended sentence expired February 27, 1977. Subject was granted removal of political disabilities on March 3, 1977.

BROWN, JAMES LEMUEL. Convicted September 25, 1972, in the Hustings Court of Richmond of voluntary manslaughter and sentenced to two years. He was paroled May 10, 1973, and discharged from parole November 4, 1974. Subject was granted removal of political disabilities on May 6, 1977.

BROWN, THOMAS KIM. Convicted July 31, 1970, in the Circuit Court of Fairfax County of selling a narcotic drug, heroin, and sentenced to five years with three years suspended. His suspended sentence expired January 10, 1974. Subject was granted removal of political disabilities on April 1, 1977.

BURRIS, MARVIN LAWRENCE. Convicted July 24, 1968, in the Hustings Court of Roanoke of malicious wounding and sentenced to two years suspended and placed on probation. His suspended sentence expired July 24, 1970. Subject was granted removal of political disabilities on May 23, 1977.

BURROUGHS, RANDOLPH CARROLL. Convicted November 15, 1966, in the Circuit Court of Hampton of statutory burglary, eight counts, and sentenced to ten years to serve, with twelve years to run concurrent; on December 15, 1966, in the Corporation Court of Newport News of grand larceny of auto and sentenced to twelve months to run concurrent with Hampton sentence, burglary and statutory burglary for which he received twelve months on each count to run concurrently. He was paroled August 10, 1970, and discharged from parole November 14, 1973. Subject was granted removal of political disabilities on August 19, 1977.

BURTON, EDWARD. Convicted July 29, 1963, in the Circuit Court of Alexandria of second-degree murder and sentenced to eight years suspended and placed on probation which terminated December 13, 1966. His suspended sentence expired July 29, 1971. Subject was granted removal of political disabilities on April 1, 1977.

BURTON, JOHN LYNWOOD. Convicted September 11, 1971, in the Circuit Court of Tazewell County of five counts of embezzlement and sentenced to seven years. He was paroled April 5, 1963, and discharged December 20, 1965. Subject was granted removal of political disabilities January 10, 1978.

CARDEN, WILLIAM DAVID. Convicted June 19, 1972, in the Circuit Court of Richmond, Division 1, of possession of morphine and possession of demerol. Imposition of sentence was suspended and he was placed on probation which terminated July 13, 1973. Imposition of suspended sentences terminated by Court Order on January 3, 1977. Subject was granted removal of political disabilities April 1, 1977.

CARR, CHARLES FERRELL. Convicted January 13, 1964, in the Circuit Court of Campbell County of five counts of grand larceny and sentenced to nine months in jail on Count 1, five years suspended upon release from confinement and placed on probation on Count 2, and five years suspended to run concurrently with Count 2 on Counts 3 through 5. Subject was granted removal of political disabilities on February 8, 1977.

CARROLL, ROGER A. Convicted April 24, 1972, in the Circuit Court of Salem of grand larceny and sentenced to three years suspended for five years and placed on probation. His probation terminated by Court Order on December 13, 1974. His suspension expired March 17, 1977. Subject was granted removal of political disabilities on January 10, 1978.

CHEWNING, SHARI LYNN CAUDLE. His probation terminated June 18, 1972. Subject was granted removal of political disabilities on May 12, 1977.

CLARK, RANDY SCOTT. Convicted November 29, 1971, in the Circuit Court of Wythe County of two counts of distribute a controlled hallucinogenic drug, LSD, and sentenced to ten years (five years each count), to serve twelve months with remaining nine years suspended for five years. Probation and suspension terminated November 20, 1975. Subject was granted removal of political disabilities on November 16, 1977.

CLARK, ROBIN. Convicted July 14, 1970, in the Corporation Court of Alexandria of illegal possession of narcotics and statutory burglary and sentenced to five years on each count to run concurrently, suspended and placed on probation for five years. His probation terminated by Court Order on November 13, 1973, and his suspension expired July 14, 1975. Subject was granted removal of political disabilities on January 5, 1978.

CLEMENTS, RODNEY JACOB. Convicted February 3, 1975, in the Circuit Court of Lynchburg of two counts of grand larceny and sentenced to twelve months in jail on each count, suspended for one year and placed on probation which terminated February 2, 1976. Subject was granted removal of political disabilities on September 6, 1977.

COLEMAN, ISAAC, aka Oscar Coleman. Convicted January 11, 1937, in the Circuit Court of Barren County, Glasgow, Kentucky, of voluntary manslaughter and sentenced to eight years. He was paroled in 1941. Subject was granted removal of political disabilities on October 11, 1977.

COLLIER, STANLEY WILLIAM. Convicted September 13, 1973, in the Circuit Court of Norfolk of grand larceny. Imposition of sentence was suspended and he was placed on probation for three years. Probation terminated September 13, 1976. Subject was granted removal of political disabilities on May 19, 1977.

COMBS, JOHN FRANKLIN. Convicted April 11, 1950, in the Circuit Court of Grayson County of breaking and entering and sentenced to one year, to serve four months with remaining time suspended and placed on probation for three years. Subject was granted removal of political disabilities on January 10, 1978.

COMER, BRUCE WAYNE. Convicted November 20, 1972, in the Circuit Court of Page County of statutory burglary and sentenced to two years, and grand larceny and sentenced to twelve months in jail. All of the sentence was suspended and he was placed on probation for four years. His probation and suspension terminated November 20, 1976. Subject was granted removal of political disabilities on January 4, 1978.

COOK, FRANKLIN I. Convicted March 19, 1952, in the Circuit Court of Dinwiddie County of unlawfully manufacture alcoholic beverages without being licensed to do so and sentenced to two years, to serve one year with remaining one year suspended for five years. Subject was granted removal of political disabilities on December 13, 1977.

COPELAND, CLYDE W. Convicted September 13, 1946, in the Corporation Court of Norfolk of robbery and sentenced to five years; and on September 27, 1946 in the Corporation Court of Norfolk of grand larceny and sentenced to two years to run concurrently with September 13, 1946, conviction. Subject was granted removal of political disabilities March 23, 1977.

CORWITH, ALAN DEWSNAP. Convicted June 4, 1973, in the Circuit Court of Rockbridge County of distribution of a controlled drug, LSD and sentenced to five years with four years suspended after serving one year; fined \$3,000. His suspended sentence and probation terminated by Court Order on December 14, 1976. Subject was granted removal of political disabilities on June 3, 1977.

COURNOW, WILLIAM MARVIN. Convicted July 28, 1965, in the Circuit Court of Chesterfield County of armed robbery and sentenced to five years with three years suspended. Subject was granted removal of political disabilities on September 9, 1977.

COX, DOUGLAS WAYNE. Convicted May 6, 1974, in the United States District Court, Western District of Virginia, Roanoke, of violation of Internal Revenue Laws (sale and transportation of illegal whiskey). Imposition of sentence was suspended and he was placed on probation for three years and fined \$650. His probation terminated May 6, 1977. Subject was granted removal of political disabilities on July 8, 1977

CUSTER, CECIL HARDING. Convicted January 11, 1962, in the Circuit Court of Roanoke County of involuntary manslaughter and sentenced to ninety days in jail and fined \$1,000. Subject was granted removal of political disabilities on January 17, 1977.

DANIS, RICHARD PAUL. Convicted June 16, 1972, in the Corporation Court of Norfolk of possession with intent to distribute and distribute a controlled drug, marijuana, two counts. He was sentenced to three years on each count suspended and placed on probation for three years. His probation terminated May 27, 1975, and his suspension expired June 16, 1975. Subject was granted removal of political disabilities on January 28, 1977.

DAVENPORT, JOHN WESLEY. Convicted February 8, 1972, in the Circuit Court of Newport News of violation of drug control act and sentenced to four years suspended for five years and placed on probation. His probation supervision terminated September 5, 1973, and his suspended sentence expired February 8, 1977. Subject was granted removal of political disabilities on January 10, 1978.

DICKERSON, EVERETT. Convicted June 22, 1973, in the United States District Court, Western District of Virginia, Danville, of violation of Title 26, USC, Section 7206(2) (fraudulent income tax return), eleven counts, and sentenced to two years suspended, to serve thirty days after which time remainder of sentence was suspended for three years, and fined \$1,500. His probation terminated December 16, 1975. Subject was granted removal of political disabilities on October 3, 1977.

DILLARD, MARVIN ALLIE. Convicted October 14, 1957, in the Circuit Court of Amherst County of statutory burglary and sentenced to two years suspended and placed on probation for five years. His probation terminated August 9, 1961. Subject was granted removal of political disabilities on October 3, 1977.

DOGGETT, THOMAS, JR. Convicted June 21, 1972, in the Circuit Court of Hampton of unlawful wounding and sentenced to three years suspended. Subject was granted removal of political disabilities on April 15, 1977.

DOMINY, WILLIAM ROBINSON. Convicted November 9, 1973, in the Circuit Court of Fairfax County of manufacturing a controlled drug and sentenced to three years suspended and placed on probation which terminated June 23, 1975. His suspended sentence expired November 9, 1976. Subject was granted removal of political disabilities on May 6, 1977.

DOSS, JAMES CARLTON. Convicted November 9, 1964, in the Circuit Court of Appomattox County of arson and sentenced to five years with four years suspended for five years. Subject was granted removal of political disabilities October 5, 1977.

DOUGLAS, JAMES. Convicted April 10, 1939, in the Corporation Court of Norfolk of attempted robbery and sentenced to ten years; and on September 26, 1962, in the Corporation Court of Norfolk of first-degree murder and sentenced to thirty years. He was paroled February 16, 1971, and discharged May 20, 1977. Subject was granted removal of political disabilities on October 27, 1977.

EDWARDS, HEPMAN ROY, JR. Convicted May 25, 1970, in the Circuit Court of Carroll County of three counts of breaking and entering and sentenced to three years on each count suspended and placed on probation which terminated May 21, 1973. Subject was granted removal of political disabilities on February 1, 1977.

EIERMAN, STEVEN JOHN. Convicted May 16, 1974, in the Circuit Court of Lynchburg, of distribution of LSD for accommodation and sentenced to two years suspended upon the condition that one year be served in the Penitentiary and that he be placed on probation for two years. He was paroled November 12, 1974, and discharged November 5, 1975. His probation terminated May 15, 1976. Subject was granted removal of political disabilities on September 12, 1977.

EMERSON, HARVEY. Convicted April 15, 1953, in the Circuit Court of Franklin County of breaking and entering and larceny and sentenced to two years; on April 27, 1953, in the Circuit Court of Prince Edward County of three counts of housebreaking and sentenced to eight years to run concurrently; on May 19, 1953, in the Circuit Court of Pittsylvania County of statutory burglary and sentenced to five years; on May 23, 1953, in the Circuit Court of Appomattox County of housebreaking and grand larceny and sentenced to five years to run concurrent with conviction of April 27, 1953; and on June 15, 1953, in the Circuit Court of Dinwiddie County of breaking and entering and sentenced to five years to run concurrent with conviction of April 27, 1953. He was paroled November 21, 1956 and discharged December 17, 1961. Subject was granted removal of political disabilities on October 28, 1977.

FANE, ALFRED ERNEST, JR. Convicted January 6, 1972, in the United States District Court, Eastern District of Virginia, Richmond, of violation of Title 18, USC, Sections 1709 and 2 (embezzlement of U.S. Mail while being a postal employee), three counts, and sentenced to three years on Count 1, three years suspended on Count 2, and three years suspended to run concurrently with Count 2 on Count 3. He was placed on probation for five years upon his release from confinement on Count 1. His probation terminated January 18, 1977. Subject was granted removal of political disabilities on April 1, 1977.

FARBER, JUDITH ROASE. Convicted October 11, 1972, in the Corporation Court of Norfolk, of possession with intent to distribute LSD and two counts of possession with intent to distribute marijuana. Imposition of sentence was suspended and she was placed on probation for three years. Her probation terminated July 9, 1975, and her suspension terminated October 11, 1975. Subject was granted removal of political disabilities on January 18, 1977.

FERRIS, ROBERT AIKMAN, aka Robert Aikman Faris. Convicted November 20, 1973, in the Circuit Court of Norfolk of seven counts of oral sodomy, and sentenced to two years on each count to run consecutively. He was to serve two years with remaining twelve years suspended and placed on probation for three years. His probation and suspension terminated November 20, 1976. Subject was granted removal of political disabilities on November 16, 1977.

FIRTH, WELDON ELLIOTT. Convicted October 8, 1968, in the Circuit Court of Hampton of arson and sentenced to three years suspended and placed on probation for three years. His probation terminated December 1, 1970, and his suspension expired October 8, 1971. Subject was granted removal of political disabilities on October 11, 1977.

FISHER, NANCY ELIZABETH, now Nancy Elizabeth Fisher Hudson. Convicted June 3, 1974, in the United States District Court, Middle District of North Carolina, Greensboro, of violation of Title 18, USC, Section 3651 (receiving money from bank robbery) and sentenced to three years, to serve six months with balance of sentence suspended and placed on probation for five years to commence upon release; and on June 10, 1974, in the Superior Court of Guilford County, North Carolina, of accessory after the fact of armed robbery and sentenced to six months to run concurrently with conviction of June 3, 1974. Her probation terminated June 27, 1977. Subject was granted removal of political disabilities on September 12, 1977.

FITZGERALD, WALTER G. Convicted March 7, 1973, in the Circuit Court of Fairfax County of statutory burglary and sentenced to twelve months in jail suspended. Subject was granted removal of political disabilities on July 8, 1977.

FIX, JOYCE P. Convicted December 7, 1966, in the Circuit Court of Washington County of embezzlement by an officer of public funds and sentenced to five years, to serve six months with remaining four and one-half years suspended for ten years. Probation supervision terminated November 9, 1972, and suspended sentence expired April 5, 1977. Subject was granted removal of political disabilities on July 8, 1977.

FLUKER, EDDIE LOUIS. Convicted October 22, 1974, in the Circuit Court of Norfolk of grand larceny and sentenced to twelve months with six months suspended and placed on unsupervised probation for one year. His suspension expired October 22, 1975. He was convicted on February 28, 1975, in the Circuit Court of Norfolk of two counts of unlawful cutting and sentenced to twelve months on each count to run concurrently. Subject was granted removal of political disabilities on February 25, 1977.

FONVILLE, OLIVER LEE. Convicted April 23, 1970, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 287 (presenting a false claim) and sentenced to three years, to serve two months with remaining time suspended and placed on probation for three years, and fined \$200. Subject was granted removal of political disabilities on March 2, 1977.

FRONT, SAMUEL EDWARD. Convicted June 26, 1972, in the Corporation Court of Norfolk of possession with intent to distribute and distribute controlled drugs; two counts of marijuana, one count of phencyclidine hydrochloride and one count of hashish. Imposition of sentence was suspended and he was placed on probation for three years. He was convicted on August 10, 1972, in the Circuit Court of Hampton of possession of marijuana with intent to distribute and sentenced to fifteen years suspended. His probation terminated June 26, 1975, and his suspended sentence was terminated by Court Order on January 11, 1978. Subject was granted removal of political disabilities on January 11, 1978.

GARDNER, LARRY. Convicted October 8, 1970, in the Hustings Court of Portsmouth of felonious assault and sentenced to thirty days suspended and fined \$100; on May 6, 1971, in the Hustings Court of Portsmouth of robbery and sentenced to six years. He was paroled May 22, 1972, and discharged from parole on October 4, 1974. Subject was granted removal of political disabilities on January 25, 1977.

GARDNER, WILLIE. Convicted May 24, 1934, in the Circuit Court of Carroll County of forgery and sentenced to two years. Subject was granted removal of political disabilities on March 2, 1977.

GEE, JOHN WILLIAM, JR. Convicted April 3, 1959, in the United States District Court, District of New Jersey, Trenton, of interstate transportation of stolen motor vehicle and sentenced to three years. He was paroled and discharged from parole on April 2, 1962; on June 10, 1960, in the United States District Court, District of New Jersey, Newark, of conspiracy and interstate transportation of stolen motor vehicle, nine counts. Imposition of sentence was suspended and he was placed on

probation for two years to commence upon his release from prison, either by discharge or parole completion. His probation terminated September 9, 1963. Subject was granted removal of political disabilities on October 3, 1977.

GIVENS, DONALD F. Convicted May 15, 1974, in the United States District Court for the District of Columbia, Washington, D. C., of violation of Title 18, USC, Section 37 (conspiracy) and Section 1006 (fraud and false statements). He was sentenced to not less than twenty months nor more than five years on each count to run concurrently, suspended, with the exception of three months, placed on probation for three years and fined \$1,000. His probation terminated November 4, 1976. Subject was granted removal of political disabilities on March 15, 1977.

GODWIN, JOSEPH HENRY, JR. Convicted February 27, 1973, in the Circuit Court of Norfolk of embezzlement. Imposition of sentence was suspended and he was placed on probation for three years which terminated February 27, 1976. Subject was granted removal of political disabilities on April 7, 1977.

GORDON, CHARLES LEON, JR. Convicted November 30, 1961, in the Circuit Court of Page County of statutory burglary and sentenced to two years; on March 23, 1970, in the Circuit Court of Orange County of larceny and sentenced to five years with three years suspended for five years after release from confinement. His suspension expired March 23, 1977. Subject was granted removal of political disabilities on April 7, 1977.

GRAY, PERRY JENNINGS. Convicted January 22, 1973, in the Circuit Court of Page County of breaking and entering and sentenced to three years suspended for four years and placed on probation, and of grand larceny and sentenced to twelve months with ten months suspended and placed on probation for four years. His probation supervision terminated September 22, 1975, and his suspended sentence expired January 22, 1977. Subject was granted removal of political disabilities on March 4, 1977.

HAIRSTON, CLARENCE JUNIOR. Convicted November 7, 1973, in the Circuit Court of Martinsville of attempt grand larceny and sentenced to four years. He was paroled November 25, 1974, and discharged June 4, 1976. Subject was granted removal of political disabilities on February 1, 1977.

HALL, GROVER WILLIAM. Convicted October 2, 1973, in the Circuit Court of Appomattox of unauthorized use of auto and sentenced to three years suspended and placed on probation which terminated April 6, 1976. His suspension expired October 2, 1976. Subject was granted removal of political disabilities on April 7, 1977.

HALL, WILLIAM BOYD. Convicted June 8, 1967, in the Circuit Court of Albemarle County of breaking and entering and sentenced to two years suspended and placed on probation for five years. Probation and suspension terminated January 12, 1971. Subject was granted removal of political disabilities on January 4, 1978.

HANDY, CHARLIE GILMER. Convicted March 7, 1959, in the Circuit Court of Patrick County of breaking and entering and larceny and sentenced to three years, to serve six months with remaining two and one-half years suspended for three years. His probation terminated June 26, 1962. Subject was convicted on December 8, 1966, in the Circuit Court of Patrick County of malicious wounding and sentenced to five years, to serve ten months with remaining four years two months suspended for three years. His probation terminated August 4, 1970. Subject was granted removal of political disabilities on October 31, 1977.

HANKINS, DWIGHT. Convicted July 1, 1970, in the Corporation Court of Norfolk of attempt to commit statutory burglary. Imposition of sentence was suspended and he was placed on probation for three years. His probation terminated July 1, 1973. Subject was granted removal of political disabilities on June 29, 1977.

HARRELL, C. LYDON, JR. Convicted June 1, 1976, in the Circuit Court of Norfolk of forgery and grand larceny and sentenced to two years, and conspiracy and larceny of books of accounts and sentenced to six months in jail and fined \$1,000. His sentence was suspended with the exception of five days and he was placed on unsupervised probation for three years. Subject was granted removal of political disabilities January 13, 1978.

HILL, SHIRLEY. Convicted July 18, 1974, in the Circuit Court of Alexandria of two counts of grand larceny and sentenced to two years suspended on each count, to run concurrently and placed on probation; and of attempt grand larceny and sentenced to two years suspended and placed on probation. Her probation terminated July 18, 1976. Subject was granted removal of political disabilities on January 17, 1977.

HETTINGER, FRANCIS RUSSELL, III. Convicted June 19, 1970, in the Circuit Court of Fairfax County of possession of narcotic drug, cocaine, and sentenced to five years suspended and placed on probation for five years. His probation terminated December 6, 1973. His suspension expired June 19, 1975. Subject was granted removal of political disabilities on January 26, 1977.

HOLLAND, RICHARD BERNARD, III. Convicted June 27, 1974, in the Circuit Court of Roanoke City of statutory burglary with intent to commit murder and attempted murder and sentenced to five years on each count to run concurrently. He was paroled on August 5, 1975, and discharged June 30, 1977. Subject was granted removal of political disabilities on September 9, 1977.

HOLT, PURCELL. Convicted March 23, 1950, in the Corporation Court of Newport News of housebreaking and sentenced to five years. He was paroled July 15, 1952, and discharged April 15, 1954. Subject was granted removal of political disabilities on May 20, 1977.

HOWELL, MICHAEL RAYMOND. Convicted April 3, 1973, in the Circuit Court of Bedford County of distribution of a controlled substance and sentenced to five years suspended after serving twelve months and placed on probation for five years. His probation and suspension terminated May 3, 1977. Subject was granted removal of political disabilities on November 16, 1977.

HUNT, ALBERT THOMPSON. Convicted April 21, 1972, in the Circuit Court of Fairfax County of conspiracy to distribute a controlled drug and sentenced to seven years. He was paroled July 2, 1974, and discharged June 26, 1976. Subject was granted removal of political disabilities on September 9, 1977.

HURD, JACK WARREN. Convicted February 21, 1974, in the Circuit Court of Franklin County of five counts of distributing a controlled drug and sentenced to seven years suspended for ten years and placed on probation, which was terminated by Court Order on May 9, 1977. His suspension was terminated by Court Order on July 11, 1977. Subject was granted removal of political disabilities on August 24, 1977.

HUTTO, CHARLES VERNON. Convicted September 15, 1967, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 2113(a), (bank robbery) and sentenced to ten years; on December 17, 1968, in the United States District Court, District of South Carolina, Columbia, of violation of Title 18, USC, Section 2113(a), (bank robbery) and sentenced to twenty years to run concurrently with conviction of September 15, 1967. He was paroled November 23, 1970, and discharged September 22, 1976. Subject was granted removal of political disabilities on September 6, 1977.

JACKSON, GERALD HAYWOOD. Convicted March 14, 1958, in the Circuit Court of Princess Anne County (now Circuit Court of Virginia Beach) of statutory burglary and sentenced to three years suspended and placed on probation; on May 12, 1959, in the Circuit Court of Princess Anne County, at which time the three-year sentence imposed on March 14, 1959, was revoked and he was sentenced to serve three years; on May 27, 1959, in the Circuit Court of Princess Anne County of two counts of forgery and sentenced to two years on each count to run concurrently. He was paroled on August 10, 1960, and discharged September 27, 1962; on April 11, 1963, in the Circuit Court of Norfolk of two counts of statutory burglary and sentenced to eight years (four years

on each count to run consecutively), and two counts of grand larceny and sentenced to four years on each count to run concurrently. Subject was granted removal of political disabilities on January 18, 1977.

JACOBSON, JACK BURT. Convicted November 8, 1973, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 641, four counts, (possession of stolen government property). Imposition of sentence was withheld and he was placed on probation for two years which terminated November 12, 1974, and fined \$10,000. Subject was granted removal of political disabilities on February 23, 1977.

JONES, ELIZABETH ANN aka Elizabeth Ann Harvey Jones. Convicted June 12, 1974, in the Circuit Court of Lynchburg of embezzlement and sentenced to three years suspended after serving ninety days in jail and placed on probation. Probation terminated December 2, 1975, and suspended sentence expired June 12, 1977. Subject was granted removal of political disabilities on July 8, 1977.

JOURNIGAN, LLOYD C., JR. Convicted August 4, 1960, in the Circuit Court of Southampton County of unlawful manufacture of illegal liquor and sentenced to twelve months in jail suspended for three years and placed on probation, and fined \$300. Subject was granted removal of political disabilities on April 22, 1977.

KELLY, FRANK GRAYSON. Convicted April 21, 1967, in the Corporation Court of Norfolk of burning a motor vehicle. Imposition of sentence was suspended and he was placed on probation for three years. Probation terminated December 4, 1968, and his suspended sentence expired April 21, 1977. Subject was granted removal of political disabilities on May 6, 1977.

KING, MARGARET DIANNE. Convicted July 23, 1973, in the Circuit Court of Wythe County of embezzlement and sentenced to three years suspended and placed on probation for three years. Probation supervision terminated by Court Order on July 21, 1975. Suspension and probation period expired July 23, 1976. Subject was granted removal of political disabilities on September 12, 1977.

KISSINGER, MERCER THEODORE, JR. Convicted August 13, 1976, in the Circuit Court of Norfolk of false statement to obtain property or credit and embezzlement and sentenced to three years on each count, suspended with the exception of ten days on each count to run concurrent, placed on probation for three years. Probation terminated June 20, 1977. Subject was granted removal of political disabilities on January 13, 1978.

KNOTT, RAY M. Convicted March 12, 1954, in the Circuit Court of Rockingham County of housebreaking and sentenced to two years suspended and placed on probation. Subject was granted removal of political disabilities on September 12, 1977.

LANGLEY, STANLEY STEVEN. Convicted April 12, 1974, in the Circuit Court of Fairfax County of uttering and delivering a forged check and sentenced to one year suspended and placed on probation which terminated April 12, 1975. Subject was granted removal of political disabilities on August 19, 1977.

LEWIS, ENNIS OLIVER, JR. Convicted October 19, 1973, in the Circuit Court of Fredericksburg of operating a lottery and sentenced to three years suspended, with the exception of thirty days and fined \$2,500. Subject was granted removal of political disabilities on February 25, 1977.

LEWIS, James. Convicted November 15, 1966, in the Corporation Court of Norfolk of malicious shooting and sentenced to ten years with five years suspended and placed on probation for five years after release from confinement. He was paroled February 19, 1968, and discharged from parole November 5, 1969. His probation terminated by Court Order on December 9, 1969, and his suspension terminated in 1973. Subject was granted removal of political disabilities on January 26, 1977.

LLOYD, WILLIAM HUNTER. Convicted January 5, 1972, in the Circuit Court of Virginia Beach of forgery and sentenced to three years suspended. His probation and suspension terminated January 5, 1975. Subject was granted removal of political disabilities on July 22, 1977.

LOTZ, PETER EDWARD, III. Convicted November 8, 1972, in the Corporation Court of Norfolk of possession with intent to distribute and distribute a controlled drug, to-wit: marijuana. Imposition of sentence was suspended and he was placed on probation for three years. Probation terminated November 8, 1975. Subject was granted removal of political disabilities on August 24, 1977.

LUSHER, IRENE D., now Irene D. Lusher Rosenberry. Convicted August 27, 1971, in the United States District Court, District of Columbia, Washington, D. C., of violation of Title 22, DCC, Section 2405. (manslaughter), and sentenced to not less than two years nor more than nine years; and violation of Title 22, DCC, Section 502 (assault with a dangerous weapon), and sentenced to not less than two years nor more than six years to run concurrent with above. She was paroled August 31, 1973, and discharged May 3, 1976. Subject was granted removal of political disabilities on September 9, 1977.

McGOWENS, JAMES ISAAC, JR. Convicted June 22, 1973, in the United States District Court, Western District of Virginia, Danville, of violation of Title 26, USC, Section 7206(2) (fraudulent preparation of income tax returns), five counts. Convicted July 12, 1951, in the Hustings Court of Richmond, Part I, of grand larceny and sentenced to two years; on July 21, 1951 in the Hustings Court of Richmond, Part II, of two counts of larceny by check and sentenced to two years. Subject was granted removal of political disabilities on October 13, 1977.

MASON, JOHN RUFUS, JR., aka Rufus Junius Mason, Jr. Convicted January 24, 1964, in the Corporation Court of Norfolk, Part II, of grand larceny. Imposition of sentence was suspended and he was placed on probation for three years. His probation terminated January 24, 1967. Subject was granted removal of political disabilities on December 14, 1977.

MASON, JOHN YORK. Convicted March 27, 1972, in the United States District Court, Western District of Virginia, Abingdon, of violation of Title 18, USC, Sections 2312; 2; 2313 (Dryer Act), and sentenced to two years on Count 1, two years suspended and placed on probation for three years on counts 2, 3, and 4. His probation has now been terminated. Subject was granted removal of political disabilities on January 17, 1977.

MATYAS, PAUL EDWARD. Convicted October 27, 1971, in the Corporation Court of Norfolk, of possession with intent to distribute and distribute a controlled drug, LSD, and sentenced to one year. He was paroled May 2, 1972, and discharged March 8, 1973. Subject was granted removal of political disabilities on January 25, 1977.

MAYS, ERIC. Convicted January 14, 1972, in the Circuit Court of Lancaster County of possession of controlled drug, marijuana, and sentenced to six months in jail, and possession of controlled drug, LSD, and sentenced to two years suspended and placed on probation. Probation and suspension expired January 14, 1974. Subject was granted removal of political disabilities on January 6, 1978.

MILLER, BENJAMIN WORTH, JR. Convicted June 11, 1965, in the Hustings Court of Portsmouth of statutory burglary, thirteen counts, and sentenced to twenty-nine years, to serve six years with remaining twenty-three years to run concurrent; of

possession of burglarious tools and sentenced to two years to run concurrent with other sentence imposed this day. He was paroled August 21, 1967, and parole revoked September 16, 1968. He was discharged from the Penitentiary after serving the remainder of his term on September 15, 1969. Subject was granted removal of political disabilities on July 8, 1977.

Probation terminated September 29, 1968. Subject was granted removal of political disabilities on August 24, 1977.

MOORE, CLARENCE CARTER. Convicted April 16, 1952, in the Hustings Court of Richmond of storebreaking and sentenced to three years; on November 29, 1966, in the Hustings Court of Richmond of second-degree murder and sentenced to twenty years. He was paroled November 3, 1971, and discharged March 20, 1975. Subject was granted removal of political disabilities on March 14, 1977.

MUNDEN, WILLIAM FORREST, JR. Convicted March 7, 1975, in the Circuit Court of Virginia Beach of possession of marijuana with intent to distribute and sentenced to five years suspended and placed on probation. Sentence terminated by Court Order on December 15, 1976. Subject was granted removal of political disabilities on February 14, 1977.

MURDOCK, JAMES CAYWOOD. Convicted February 14, 1974, in the United States District Court, Eastern District of Virginia, Newport News, of violation of Title 18, USC, Section 659 (theft from interstate shipment), and sentenced to three years. Paroled April 22, 1975, and discharged March 12, 1977. Subject was granted removal of political disabilities on August 24, 1977.

MYERS, GEORGE DENNIS. Convicted December 3, 1963, in the United States District Court, Eastern District of North Carolina, New Bern, of violation of Title 18, USC, Section 2113(a), (Bank Robbery), and sentenced to twelve years; on July 31, 1964, in the United States District Court, Eastern District of Virginia, Alexandria, Virginia, of violation of Title 18, USC, Section 2113(b), (Bank Robbery), and sentenced to five years with three years suspended. To serve two years to run consecutively with December 3, 1963, conviction; on May 12, 1967, in the United States District Court, Eastern District of North Carolina, Fayetteville, of violation of Title 18, USC, Section 2113(b), (Bank Robbery), and sentenced to eighteen years to run consecutively with July 31, 1964, conviction; and on January 11, 1968, in the United States District Court, Middle District of Pennsylvania, Scranton, of violation of Title 18, USC, Section 751(a), (Escape from Federal institution), and sentenced to three years to run concurrently with sentence of May 12, 1967; a total of thirty-two years to serve. He was paroled July 12, 1971, and discharged from parole June 15, 1977. Subject was granted removal of political disabilities on September 30, 1977.

NASH, SIDNEY HARRIS. Convicted December 7, 1967, in the Corporation Court of Martinsville of three counts of grand larceny and sentenced to six years suspended and placed on probation for three years. Probation and suspension terminated April 5, 1971. Subject was granted removal of political disabilities on November 16, 1977.

NEAL, POLK MILLER, JR. Convicted April 20, 1971, in the Circuit Court of Richmond of maliciously destroying property and sentenced to three years suspended for five years. Suspension expired April 20, 1976. Subject was granted removal of political disabilities on August 1, 1977.

NEWELL, JOHN GOODWIN. Convicted January 25, 1973, in the Circuit Court of Newport News, of possession of heroin with intent to distribute and sentenced to four years suspended for four years. Suspension expired January 25, 1977. Subject was granted removal of political disabilities on October 11, 1977.

OAKLEY, THERMAN LEWIS. Convicted February 4, 1964, in the Corporation Court of Norfolk of grand larceny from person and sentenced to twelve months in jail and fined \$10, and two counts of robbery and sentenced to eight years on each count to run concurrent, suspended upon release from jail. To be on probation for three years; on March 24, 1964, in the Circuit Court of Virginia Beach of three counts of robbery and sentenced to eight years on each count suspended and placed on probation for ten years; and on August 1, 1968, in the Circuit Court of Virginia Beach and ordered to serve the eight-year sentence imposed on March 24, 1964. He was paroled June, 1971, and discharged December 22, 1972. His probation from Virginia Beach terminated March 24, 1974. Subject was granted removal of political disabilities on January 18, 1977.

ORTIZ, CARLOS ENRIQUE. Convicted March 21, 1972, in the Circuit Court of Amherst County of unlawfully and feloniously manufacturing or producing a controlled drug, marijuana, and sentenced to four years with three and one-half years suspended and placed on probation for five years after release, and fined \$1,000. Subject was granted removal of political disabilities on May 6, 1977.

OWEN, THOMAS EDWARD. Convicted December 3, 1962, in the Circuit Court of Lunenburg County of obstructing a railroad and sentenced to five years with three years suspended, to be on probation for eighteen months upon release from confinement; and housebreaking, six counts, and sentenced to twelve years suspended (two years each count) and placed on probation for eighteen months. Suspended sentence expired December 3, 1975. Subject was granted removal of political disabilities on February 23, 1977.

PAASCH, HANS. Convicted November 30, 1956, in the Circuit Court of Norfolk County of first-degree murder and sentenced to life. Paroled November 3, 1971 and discharged April 11, 1977. Subject was granted removal of political disabilities on January 10, 1977.

Convicted March 16, 1970, in the Hustings Court of Portsmouth of two counts of grand larceny and sentenced to six years each count to run concurrently; on June 18, 1971, in the Circuit Court of Norfolk of grand larceny and sentenced to four years with two years suspended, to be on probation for three years after release; and on October 7, 1971, in the Circuit Court of Suffolk of bigamy and sentenced to four years to run concurrent with six years imposed on March 16, 1970. He was

paroled July 16, 1973, and discharged from parole November 11, 1976. Subject was granted removal of political disabilities on April 21, 1977.

Convicted February 10, 1975, in the United States District Court, Western District of Virginia, Danville, of violation of Title 18, USC, Sections 922(m) and 924(a), (knowingly, as a licensee, making false entry in failing to make, or failing to maintain records required by law and regulations), four counts, Gun Control Act of 1968; violation of Title 18, USC, Section 922(b)(3), (knowingly, as a licensee, selling firearms to non-residents of the state where your place of business is located), six counts, Gun Control Act of 1968. Imposition of sentence suspended and placed on probation for two years and fined \$5,000. Probation terminated February 9, 1977. Subject was granted removal of political disabilities on May 6, 1977.

REUTLINGER, RONELL RUPERT. Convicted September 13, 1971, in the Corporation Court of Norfolk of unauthorized use of motor vehicle. RIDGWELL, JAMES ALONZO, IV. Convicted September 30, 1970, in the Corporation Court of Norfolk, Part II, of statutory burglary and sentenced to four years suspended and placed on probation. Probation terminated September 11, 1973, and his suspension expired September 30, 1974. Subject was granted removal of political disabilities on April 22, 1977.

ROBINSON, WOODROW. Convicted September 13, 1968, in the United States District Court, Western District of Virginia, Abingdon, of violation of Title 18, USC, Section 241 (election laws). Imposition of sentence was suspended and he was placed on probation for two years which terminated in 1970. Subject was granted removal of political disabilities on February 23, 1977.

RULAPAUGH, ROBERT J. Convicted February 20, 1970, in the United States District Court, District of Columbia, Washington, D. C., of violation of Title 22, USC, Section 1401 (forgery), and sentenced to not less than one nor more than four years suspended and placed on probation for five years. Probation terminated April 23, 1973. Subject was granted removal of political disabilities on October 11, 1977.

RUSSELL, EDWARD, JR. Convicted October 24, 1952, in the Circuit Court of Mecklenburg County of voluntary manslaughter and sentenced to four years. He was paroled November 12, 1953, and discharged from parole June 24, 1955. Subject was granted removal of political disabilities on February 17, 1977.

TUCKER, EVERETTE MALON. Convicted October 15, 1965, in the Circuit Court of Alleghany County of Arson. Imposition of sentence was suspended and he was placed on probation for three years. Probation terminated September 6, 1968. Subject was granted removal of political disabilities on January 4, 1978.

TUELL, JESSE GORDON, SR. Convicted April 18, 1975, in the United States District Court, Western District of Virginia, Roanoke, of violation of Title 18, USC, Section 495 and Title 42, USC, Section 2703(a), (factual misrepresentation and malfeasance in office, respectively). Imposition of sentence was suspended and he was placed on probation for four years and fined \$2,000. Probation terminated April 15, 1977. Subject was granted removal of political disabilities on August 19, 1977.

TURNER, JOSEPH V., III. Convicted June 9, 1975, in the Circuit Court of Richmond, Division II, of three counts of grand larceny and sentenced to six years suspended for ten years and placed on probation. Probation terminated January 26, 1977. Subject was granted removal of political disabilities on November 14, 1977.

TURNER, LINDSEY OWEN. Convicted September 11, 1972, in the United States District Court, Western District of Virginia, Danville, of violation of Title 18, USC, Section 922(a)(b) and App. 1202(a)(1) - Federal Gun Control Act, and sentenced to one year suspended and placed on probation for three years. Probation terminated February 25, 1975; on February 25, 1975, in the United States District Court, Western District of Virginia, Danville, of violation of Title 18, USC, Sections 371, 922(a)(6), 924(a), and 1202(a) - Federal Gun Control Act, six counts. Subject was granted removal of political disabilities on September 6, 1977.

WIGGINS, JOHN MILFORD. Convicted January 23, 1964, in the Corporation Court of Norfolk of robbery. Imposition of sentence was suspended and he was placed on probation for five years; and on October 8, 1968, in the Corporation Court of Norfolk of statutory burglary and sentenced to four years, and statutory burglary with imposition of sentence suspended and placed on probation for five years. Paroled November 10, 1969, and discharged May 10, 1971. Probation terminated October 8, 1973. Subject was granted removal of political disabilities on August 24, 1977.

TYREE, RODNEY MARION. Convicted September 9, 1973, in the Circuit Court of Albemarle County of felonious assault and sentenced to five years with one year suspended. Paroled October 23, 1975, and discharged from parole October 19, 1976. Probation terminated August 25, 1976. Subject was granted removal of political disabilities on February 25, 1977.

WALDBAUER, BARBARA TUCKER. Convicted October 29, 1969, in the Hustings Court of Richmond of possessing narcotics, marijuana, and sentenced to three years suspended for five years and fined \$100. Convicted November 24, 1971, in the Circuit Court of Virginia Beach of five counts of breaking and entering and sentenced to two years each count suspended and placed on probation for six years to run concurrently; on April 30, 1974, in the Circuit Court of Virginia Beach of statutory burglary and sentenced to three years; and on May 14, 1974, in the Circuit Court of Virginia Beach for probation violation of conviction of November 24, 1971, to serve two years on each count to run concurrent. Convicted April 24, 1974, in the Circuit Court of Scott County of grand larceny and sentenced to five years, to serve three years with remaining two years suspended for three years and placed on probation. Convicted November 14, 1966, in the United States District Court, Western District of Virginia, Roanoke, of violation of Title 18, USC, Section 2313, two counts, (receive and dispose of stolen automobile), and sentenced to two years suspended and placed on probation for three years and fined \$1,500. Probation terminated November 14, 1969. Subject was granted removal of political disabilities on May 6, 1977.

WARNOCK, GREGORY A., aka W. C. Warnock. Convicted February 12, 1973, in the Circuit Court of Wayne County, Indiana, of possession of narcotics, heroin, and sentenced to not less than two years nor more than ten years. On June 23, 1973, his sentence was suspended and he was placed on probation for four years. Probation terminated June 25, 1974. Subject was granted removal of political disabilities on January 10, 1978.

WATERFIELD, JOHN WILLIAM, III. Convicted August 5, 1974, in the Circuit Court of Accomack County of possession of a controlled drug with intent to distribute and possession of a controlled drug, and sentenced to three years on each count, to run concurrently, suspended and placed on probation for three years. Probation and suspension terminated September 3, 1976. Subject was granted removal of political disabilities on January 4, 1978.

WEISENSALE, FREDERICK E., JR. Convicted February 19, 1973, in the Corporation Court of Danville, of four counts of accommodation sales of marijuana and imposition of sentence was deferred, to serve six-month sentences on each count, to run concurrently, and placed on probation for three years after release. Probation terminated August 31, 1976. Imposition of any further sentences terminated December 7, 1977. Subject was granted removal of political disabilities on December 12, 1977.

WHITE, KENNETH EARL. Convicted July 2, 1971, in the Circuit Court of City of Williamsburg and James City County of possession of LSD and Hashish and sentenced to serve six months with probation for three years upon release. Probation terminated in 1975. Subject was granted removal of political disabilities on December 14, 1977.

WHITEHORNE, WILLIAM DONALD. Convicted August 5, 1968, in the Circuit Court of Norfolk of two counts of burglary with imposition of sentence suspended and placed on probation for five years, and of three counts of statutory burglary and sentenced to twelve months in jail on one count and imposition of sentence suspended and placed on probation for five years on remaining two counts. Probation terminated December 31, 1972. Subject was granted removal of political disabilities on October 13, 1977.

WILLIAMS, GEORGE EDWARD, JR. Convicted December 20, 1968, in the Circuit Court of Goochland of three counts of forgery and sentenced to five years, to serve twelve months in jail with remaining four years suspended and placed on probation for three years. Probation and Suspension terminated February 8, 1971. Subject was granted removal of political disabilities on November 14, 1977.

WILLIAMS, LARRY DONNELL. Convicted March 24, 1971, in the Circuit Court of Nansemond County of statutory burglary and sentenced to five years; on March 31, 1971, in the Circuit Court of Isle of Wight County of burglary and sentenced to seven years to run concurrent with conviction of March 24, 1971; and on July 21, 1971, in the Hustings Court of Newport news of grand larceny of auto and sentenced to three years to run concurrent with

previous convictions. Paroled May 10, 1973, and discharged from parole July 9, 1975. Subject granted removal of political disabilities on March 14, 1977.

WILSON, HOWARD. Convicted November 29, 1956, in the Hustings Court of Portsmouth of robbery and sentenced to eight years; and on January 13, 1957, in the Corporation Court of Norfolk County (now Circuit Court of Chesapeake) of robbery and sentenced to eight years. Paroled November 26, 1962, and discharged November 10, 1966. Subject was granted removal of political disabilities on May 12, 1977.

WILSON, WILLIAM DOUGLAS. Convicted November 26, 1956, in the Circuit Court of Augusta County of cross burning and sentenced to two years suspended and placed on probation for two years. Subject was granted removal of political disabilities on May 5, 1977.

WOOD, WENDELL MASSIE. Convicted May 14, 1973, in the Circuit Court of Campbell County of receiving stolen goods and sentenced to two years suspended, to serve twelve months in jail and probation for two years. Began serving jail sentence April 28, 1975. Jail sentence suspended July 18, 1975, and ordered to remain on probation which terminated April 28, 1977. Subject was granted removal of political disabilities on January 5, 1978.

WOODALL, CLEMENT RAMSEY, JR. Convicted May 9, 1974, in the Circuit Court of Lynchburg of two counts of grand larceny and sentenced to three years on each count to run concurrently, suspended after serving six months in jail and placed on probation for three years after release. Probation terminated January 21, 1976 and suspension expired May 9, 1977. Subject was granted removal of political disabilities on August 24, 1977.
