

## CONDITIONAL PARDON

SMITH, LUMMIE HARREL. Convicted December 6, 1976, in the Circuit Court of Carroll County of voluntary manslaughter and sentenced to six years. In view of the facts surrounding the offense, the fact that further rehabilitation would be of no value to this individual, the strong and continuing evidence of support from the community for her efforts to rehabilitate herself, and the recommendation of the Virginia Parole Board and the sentencing judge, Subject is granted a conditional pardon, effective August 4, 1978, and will be under supervision. This pardon dated August 4, 1978.

## PARDON WITHOUT CONDITIONS

POPE, RICHARD SONNEY. Convicted December 21, 1936, in the Hustings Court of Portsmouth of murder and sentenced to death by electrocution. Sentence commuted to life on April 1, 1937, by Governor Peery. Subject was granted a conditional pardon by Governor Almond January 11, 1962. Because of a conviction in the City of Norfolk on April 12, 1973, pardon was revoked August 2, 1973, by Governor Holton and reaffirmed November 28, 1975, by Governor Godwin. This sentence was satisfied during early 1975. However, Subject has remained in the Penitentiary serving time on the life sentence imposed in 1937, a total of almost forty-two years. In view of the judgment of the Parole Board that the interests of justice have been met, that further incarceration of the Subject would be of no benefit to him, and that he no longer constitutes a threat to society, the sentencing judge being deceased, the prosecuting Commonwealth's Attorney, the Honorable Robert McMurrin, now Judge of the Third Judicial Circuit, and the current Commonwealth's Attorney, the Honorable James Cales not objecting, I am granting this man a pardon without conditions and without supervision. This pardon effective July 10, 1978. This pardon dated June 30, 1978.

STRAUS, LEONA. Convicted January 3, 1973, in the Circuit Court of Arlington County of obtaining money under false pretenses and sentenced to ten years. She was paroled July 20, 1976.

In view of Subject's health, the recommendations of the Parole Board and reputable citizens, the sentencing judge not objecting, I am granting her a pardon without conditions. This pardon dated December 14, 1978.

#### SIMPLE PARDON

ADCOCK, TERREL D. Convicted August 4, 1972, in the County Court of Fairfax County of contributing to the delinquency of a minor and sentenced to one year with ten months suspended. Relying on the recommendations of the Parole Board, the sentencing judge, and reputable citizens, I am granting him a pardon. This pardon dated November 15, 1978.

CREEKMUR, WILLIAM ROGERS. Convicted June 9, 1975, in the Circuit Court of Richmond, Division II, of three counts of grand larceny and sentenced to two years suspended on each count for ten years. His probation supervision terminated January 26, 1977, and restitution in the amount of \$800 has been paid. Relying on the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, the fact that he has made full restitution in the amount of \$800, that an absolute pardon was granted to this man's co-defendant by Governor Godwin, and in the interests of consistency and fundamental justice, there being no objection from the sentencing judge, the Honorable Frank A. S. Wright, I am granting him a pardon. This pardon dated June 30, 1978.

EDWARDS, KENNETH GLENN. Convicted May 24, 1974, in the Circuit Court of Newport News of grand larceny and sentenced to twelve months suspended and placed on probation for two years. His probation terminated September 8, 1975. In view of Subject's excellent adjustment and rehabilitation since his conviction, the recommendation of the Parole Board, the sentencing judge and Commonwealth's Attorney preferring not to make any recommendation but relying on the judgment of the Parole Board, I am granting him a pardon. This pardon dated March 29, 1978.

HUMBLES, CLIFTON C. Convicted February 18, 1971, in the Circuit Court of Accomack County of three counts of grand larceny and fined \$1,000. In view of this man's good reputation in the community and the recommendation of the Parole Board, the sentencing judge, prosecuting Commonwealth's Attorney and the current Commonwealth's Attorney not objecting, I am granting him a pardon. This pardon dated April 19, 1978.

PLOTKIN, ARLENE SUE. Convicted August 14, 1973, in the Circuit Court of Richmond, Division I, of prostitution and committed to the control and supervision of the Director of the State Board of Welfare and Institutions for rehabilitation, for an indeterminate period of not less than three months nor more than three years, and released after serving ten months.

Relying on the recommendations of the Parole Board and reputable citizens who are familiar with this woman's conduct since her conviction, the sentencing judge and prosecuting attorney not objecting, I am granting her a pardon. This pardon dated August 8, 1978.

WEBB, JOHN JOSEPH. Convicted October 4, 1973, in the Circuit Court of Danville of four counts of grand larceny and sentenced to twelve years with six years suspended on Count 1, however, this sentence was declared null and void on February 27, 1974, at which time Subject was resentenced to five years; on Counts two through four, imposition of sentence was suspended and he was placed on probation for three years. His probation was terminated by the Court on November 15, 1977. He was paroled December 8, 1975, and released from parole December 20, 1977. In view of Subject's excellent adjustment while on parole, his demonstration of a high level of motivation and responsibility since his release from incarceration, and the Parole Board and sentencing judge not objecting, I am granting his a pardon. This pardon dated February 24, 1978.

WHEELER, JAMES RONALD. Convicted January 9, 1964, in the Circuit Court of Roanoke County of grand larceny and sentenced to twelve months suspended and placed on probation for three years. Probation terminated January 7, 1966. Relying on the recommendation of the Parole Board, the sentencing judge and present Commonwealth's Attorney not objecting, the prosecuting Commonwealth's Attorney being deceased, I am granting him a pardon. This pardon dated October 18, 1978.

#### REMOVAL OF POLITICAL DISABILITIES

Relying on the recommendations of parole officers and reputable citizens who are familiar with the conduct of these individuals since their conviction or release, I have granted removal of political disabilities to the following:

ATKINS, WILLIAM ALBERT. Convicted October 26, 1955, in the Circuit Court of Rockingham County of rape and sentenced to five years. Subject was granted removal of political disabilities on May 9, 1978.

BALES, ROBERT E. Convicted May 12, 1975, in the United States District Court, Western District of Virginia, Abingdon, of two counts of violation of Title 18, USC, Section 1014 (giving false information to secure a loan), and sentenced to two years suspended and probation for five years, and fined \$2,500, sentences to run concurrent; and of two counts of violation of Title 26, USC, Section 7201 (income tax evasion), and sentenced to three years suspended and probation for five years, and fined \$12,500. His probation was reduced to three years on March 12, 1976, and his probation terminated by Court Order on February 14, 1978. Subject was granted removal of political disabilities on September 21, 1978.

BATES, JOHN HARVEY. Convicted April 26, 1973, in the Circuit Court of Rockingham County of murder in the second degree and sentenced to five years suspended and placed on probation for five years. His probation and suspension expired April 26, 1978. Subject was granted removal of political disabilities on May 24, 1978.

BEAZLEY, ARTHUR WEBB. Convicted January 11, 1960, in the Hustings Court of Richmond, Part I, of grand larceny and sentenced to three years, and of two counts of forgery and imposition of sentence was suspended and he was placed on probation for ten years. His probation and suspension expired January 11, 1970. Subject was granted removal of political disabilities on August 9, 1978.

BENSON, ANTHONY JOSEPH. Convicted January 5, 1968, in the Corporation Court of Norfolk, Part II, of abortion. Imposition of sentence was suspended and he was placed on probation for three years. His probation terminated April 22, 1970. Subject was granted removal of political disabilities on May 23, 1978.

BOUSH, MARION ARNETTA. Convicted June 11, 1976, in the Circuit Court of Norfolk of uttering and sentenced to twelve months in jail suspended and placed on probation for two years. Her probation terminated June 11, 1978. Subject was granted removal of political disabilities on September 21, 1978.

BOWLING, JAMES FREDERICK aka James Fred Bowling. Convicted March 25, 1971, in the Corporation Court of Danville of distribution of hashish and sentenced to five years and fined \$1,000. He was paroled November 13, 1972, and discharged from parole February 21, 1975. Subject was granted removal of political disabilities on August 29, 1978.

BRAMLETT, LESTER RAY. Convicted May 6, 1975, in the Circuit Court of Rockbridge County of breaking and entering and grand larceny and sentenced to three years on each count, to run concurrently, and suspended and placed on probation for three years. His probation supervision terminated August 3, 1976, and his suspension expired May 6, 1978. Subject was granted removal of political disabilities on December 29, 1978.

BRANTLEY, DEBRA J. aka Debra Brantley Savage. Convicted February 25, 1972, in the Circuit Court of Portsmouth of eight counts of forgery and sentenced to three years on Count 1 and two years on Count 2, both suspended and placed on unsupervised probation, and two years suspended on each remaining six counts; of two counts of forgery and uttering and sentenced to four years on each count suspended. Subject was granted removal of political disabilities on January 5, 1979.

BREEDEN, HARRY LEE. Convicted September 5, 1973, in the Circuit Court of Page County of three counts of statutory burglary and sentenced to three years with one year to run concurrent, and three counts of grand larceny and sentenced to three years with two years to run concurrent; a total of three years to serve. His sentence was suspended and he was placed on probation for five years. His probation terminated March 8, 1978, and his suspension expired September 5, 1978. Subject was granted removal of political disabilities on September 21, 1978.

BROOKS, KAY DIANE. Convicted November 8, 1971, in the Hustings Court of Richmond of possession of marijuana, possession of LSD, and possession of amphetamine hydrochloride. Imposition of sentence was suspended and she was placed on probation. Her probation supervision terminated January 11, 1973. Imposition of suspended sentence was terminated by Court Order on January 4, 1978. Subject was granted removal of political disabilities on February 21, 1978.

BROWN, ROBERT LEE. Convicted July 26, 1971, in the Circuit Court of Staunton of forgery and uttering and sentenced to two years suspended and placed on probation for three years. His probation terminated December 1, 1977. Subject was granted removal of political disabilities on November 20, 1978.

BUCCINI, ANTHONY JOHN. Convicted September 27, 1973, in the Circuit Court of Charlottesville of two counts of breaking and entering and sentenced to four years. He was paroled July 25, 1974, and discharged from parole March 5, 1976. Subject was granted removal of political disabilities on April 19, 1978.

CASON, PRESTON. Convicted November 27, 1963, in the Corporation Court of Norfolk of voluntary manslaughter and sentenced to four years suspended and placed on probation for four years. His probation and suspension expired November 27, 1964. Subject was granted removal of political disabilities on July 12, 1978.

CHANEY, STEVEN WARREN aka Stephen Warren Chaney. Convicted March 22, 1973, in the Corporation Court of Bristol of possession of controlled drug with intent to distribute, marijuana, and sentenced to five years with two years suspended, to be on probation for two years upon release. He was paroled January 28, 1974, and discharged from parole March 14, 1975. Subject was granted removal of political disabilities on August 29, 1978.

CLARK, LeROY, JR. Convicted November 14, 1956, in the Hustings Court of Roanoke of statutory burglary and larceny and sentenced to one year suspended and placed on probation. Subject was granted removal of political disabilities on February 22, 1978.

CLOER, RAY ARNOLD. Convicted January 14, 1965, in the Hustings Court of Richmond of murder in the first degree and sentenced to life. He was granted a conditional pardon on October 19, 1973, to be under parole supervision for a period of three years. He was discharged from parole supervision on October 19, 1976. Subject was granted removal of political disabilities on January 5, 1979.

COGGINS, DONALD RAY. Convicted June 26, 1974, in the Circuit Court of Portsmouth of burglary and sentenced to five years. He was paroled June 10, 1976, and discharged from parole on July 21, 1977. Subject was granted removal of political disabilities on February 17, 1978.

COMPTON, DEWEY BASCOME. Convicted April 21, 1934, in the Circuit Court of Buchanan County of felonious assault and sentenced to three years. He was released after serving eighteen months. Subject was granted removal of political disabilities on August 9, 1978.

CREEKMUR, WILLIAM ROGERS. Convicted June 9, 1975, in the Circuit Court of Richmond, Division II, of three counts of grand larceny and sentenced to two years suspended on each count for ten years. Probation supervision terminated January 26, 1977, and restitution in the amount of \$800 has been paid in full. Subject was granted removal of political disabilities on June 30, 1978.

CUNNINGHAM, JAMES B., Jr. Convicted October 5, 1964, in the Corporation Court of Lynchburg of maliciously throwing missile into a motor vehicle and sentenced to two years. He was to serve six months with the remaining sentence suspended and placed on probation for two years. His probation and suspension terminated November 6, 1967. Subject was granted removal of political disabilities on July 12, 1978.

DANIEL, RICHARD MACK, JR. Convicted December 17, 1962, in the Hustings Court of Roanoke of grand larceny and sentenced to twelve months in jail. Subject was granted removal of political disabilities on August 10, 1978.

DAVIDSON, MYLES ANTHONY. Convicted October 30, 1972, in the Circuit Court of Chesapeake of statutory rape and sentenced to one year suspended for three years. His suspension expired October 30, 1975. Subject was granted removal of political disabilities on June 13, 1978.

DAVIS, GERALD GORDON. Convicted December 5, 1974, in the Circuit Court of Buchanan County of felonious assault and sentenced to three years suspended. His suspension expired December 5, 1977. Subject was granted removal of political disabilities on January 3, 1979.



DEAN, BENNY DALE. Convicted March 6, 1973, in the Circuit Court of Bedford County of distribution of a controlled drug, LSD, and sentenced to ten years. He was to serve three years with the remaining seven years suspended and placed on probation for ten years. He was paroled on February 21, 1974, and discharged on March 6, 1975. His probation supervision terminated March 1, 1976, and his suspension was terminated by Court Order on August 28, 1978. Subject was granted removal of political disabilities on September 5, 1978.

DERBY, JACQUELIN BROWN. Convicted May 2, 1967, in the Circuit Court of Chesapeake of voluntary manslaughter and sentenced to five years. She was paroled April 29, 1969, and discharged from parole on May 25, 1971. Subject was granted removal of political disabilities on February 21, 1978.

DEW, TOMMY LEE. Convicted September 28, 1970, in the Corporation Court of Norfolk, Part II, of unauthorized use of motor vehicle. Imposition of sentence was suspended and he was placed on probation for three years. His probation terminated September 28, 1973, and his suspended sentence expired September 28, 1975. Subject was granted removal of political disabilities on February 21, 1978.

DICKENS, JAMES MELVIN. Convicted April 26, 1971, in the Corporation Court of Norfolk of grand larceny. Imposition of sentence was suspended and he was placed on probation for three years. His probation terminated January 17, 1973. Subject was granted removal of political disabilities on May 24, 1978.

DODD, RICHARD L. Convicted July 26, 1962, in the United States District Court, Eastern District of Virginia, Alexandria, of violation of Title 18, USC, Section 371 (conspiracy), and fined \$500. Subject was granted removal of political disabilities on April 19, 1978.

DONOVAN, WAYNE LEE. Convicted April 23, 1969, in the Circuit Court of Louisa County of breaking and entering with intent to commit larceny and sentenced to three years with two and one-half years suspended and placed on probation for five years. His probation terminated June 10, 1972, and his suspension expired October 25, 1971. Subject was granted removal of political disabilities on December 29, 1978.

DOYLE, JURDY ELIZABETH aka Jurdy Simpson aka Mrs. Charles Earl Doyle, Sr. aka Jurdy Elizabeth Lewis. Convicted August 22, 1966, in the Corporation Court of Norfolk of four counts of forgery and sentenced to two years on each count with four years to run concurrent. She was paroled May 6, 1967, and discharged from parole December 10, 1968. Subject was granted removal of political disabilities on January 3, 1979.

DRAPER, LONNIE EUGENE. Convicted September 11, 1944, in the United States District Court, Western District of Virginia, Danville, of violation of Title 26, USCA, Sections 2810, 2831, 2833 and 2834 (liquor laws), and imposition of sentence was suspended within three years and placed on probation for three years; and on February 12, 1958, in the United States District Court, Western District of Virginia, Danville, of violation of Title 26, USCA, Section 5632 (liquor laws), and imposition of sentence was suspended within three years and he was placed on probation for three years. Subject was granted removal of political disabilities on January 5, 1979.

DREW, FRANK C. Convicted October 4, 1974, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USCA, Section 1006 (fraud), two counts, and sentenced to four years on each count to run concurrent, and fined \$7,500. He was paroled March 15, 1976, and discharged from parole October 13, 1978. Subject was granted removal of political disabilities on November 21, 1978.

DUNN, ROBIN LEE. Convicted October 21, 1969, in the Hustings Court of Richmond of possessing a narcotic drug, heroin, and sentenced to three years suspended and placed on probation for five years and fined \$100. Her probation terminated October 13, 1970, and her suspension expired October 20, 1974. Subject was granted removal of political disabilities on May 24, 1978.

EDWARDS, KENNETH GLENN. Convicted May 24, 1974, in the Circuit Court of Newport News of grand larceny and sentenced to twelve months suspended and placed on probation for two years. His probation terminated September 8, 1975. Subject was granted removal of political disabilities on March 29, 1978.

ELLINGSWORTH, DOROTHY ELIZABETH PROPST. Convicted November 13, 1969, in the Circuit Court of Rockingham County of grand larceny and sentenced to two years suspended and placed on probation for five years. Her probation was terminated on February 20, 1973. Subject was granted removal of political disabilities on October 25, 1978.

ESTEP, CHARLES SAMUEL. Convicted November 18, 1971, in the Circuit Court of Rockingham County of grand larceny and sentenced to two years. He was paroled May 3, 1972, and discharged from parole on November 9, 1973. Subject was granted removal of political disabilities on April 19, 1978.

FITZGERALD, ARTHUR F. Convicted June 7, 1977, in the United States District Court, Western District of Virginia, Abingdon, of violation of Title 18, USC, Sections 922(a)(5), 923 and 924(a), (Gun Control Act). Imposition of sentence was suspended and he was placed on unsupervised probation for one

year and fined \$500. His probation expired June 7, 1978. Subject was granted removal of political disabilities on August 10, 1978.

FULLER, RICHARD TERRY. Convicted March 13, 1975, in the Circuit Court of Richmond, Division I, of statutory rape. Imposition of sentence was suspended and he was placed on probation for an indefinite period of time. His probation terminated September 17, 1976, and his suspended sentence was terminated by Court Order on June 12, 1978. Subject was granted removal of political disabilities on June 30, 1978.

GOLDING, WILLIAM IRVIN, aka William Irvin Golding, Sr. Convicted February 11, 1955, in the Hustings Court of Richmond, Part I, of grand larceny and imposition of sentence was suspended and he was placed on probation, which expired May 29, 1958; on May 20, 1955, in the Circuit Court of Chesterfield County of breaking and entering and larceny and sentenced to eighteen months with one year suspended for five years; on June 20, 1955, in the Hustings Court of Richmond, Part II, of larceny and sentenced to twelve months with six months suspended and fined \$10; and on July 5, 1955, in the Circuit Court of Henrico County of unauthorized use of auto, two counts, and imposition of sentence was suspended for ten years and he was placed on probation for five years on each count, and of statutory burglary, three counts, and imposition of sentence was suspended for ten years and he was placed on probation for five years on each count. Subject was granted removal of political disabilities on October 27, 1978.

GOODLOE, EDWIN KYLE. Convicted October 5, 1973, in the Circuit Court of Albemarle County of two counts of abduction and sentenced to five years with three years suspended on each count; on October 9, 1973, in the Circuit Court of Charlottesville of abduction with intent to extort money and sentenced to five years with three years suspended. He was paroled on October 21, 1974, and discharged from parole on May 18, 1976. His suspension expired October 21, 1977. Subject was granted removal of political disabilities on January 4, 1979.

GORDON, DANIEL BOWMAN. Convicted November 6, 1974, in the Circuit Court of Wythe County of attempted breaking and entering and sentenced to one year and breaking and entering and sentenced to three years; a total of four years to serve. He was paroled August 25, 1975, and discharged from parole on November 17, 1976. Subject was granted removal of political disabilities on September 21, 1978.

GREEN, CARROLL EDWARD aka Mujahid F. Saafir. Convicted November 12, 1959, in the Hustings Court of Richmond of malicious bodily injury and imposition of sentence was suspended

for fifteen years and he was placed on probation. His probation terminated March 1, 1961, and his suspended sentence expired November 12, 1974; on March 2, 1964, in the Circuit Court of Powhatan of illegal manufacture of alcoholic beverage and sentenced to eighteen months with twelve months suspended for three years; and on November 23, 1966, in the Criminal Court of Record, Palm Beach County, Florida, of aggravated assault and sentenced to four years three months and twenty-five days. Subject was granted removal of political disabilities on August 9, 1978.

GUILLIAMS, CHARLIE JACOB. Convicted May 23, 1936, in the United States District Court, Western District of Virginia, Roanoke, of violation of Title 18, USC, Section 242, and sentenced to three months. Subject was granted removal of political disabilities on March 22, 1978.

HACKNEY, WILLIE OSCAR. Convicted October 22, 1958, in the Circuit Court of Buchanan County of voluntary manslaughter and sentenced to five years. Subject was granted removal of political disabilities on January 5, 1979.

HALL, ROBERT EARL. Convicted February 3, 1975, in the Circuit Court of Grayson County of grand larceny and sentenced to three years. He was paroled July 19, 1976, and discharged from parole on October 11, 1977. Subject was granted removal of political disabilities on February 21, 1978.

HALTERMAN, JAMES FRANKLIN. Convicted October 13, 1972, in the Circuit Court of Augusta County of breaking and entering and sentenced to two years suspended and placed on probation. His probation and suspension expired October 13, 1974. Subject was granted removal of political disabilities on May 23, 1978.

HANKINS, THOMAS HATCHER. Convicted May 12, 1950, in the Circuit Court of Danville of storebreaking in night time and sentenced to twelve months in jail and fined \$100. Subject was granted removal of political disabilities on October 25, 1978.

HARRELL, GEORGE. Convicted March 24, 1972, in the Circuit Court of Giles County of breaking and entering and sentenced to two years, breaking and entering and sentenced to two years suspended, grand larceny and sentenced to two years, and grand larceny and sentenced to twelve months in jail suspended; total time to serve four years. He was paroled on January 20, 1973, and discharged from parole on September 21, 1974. Subject was granted removal of political disabilities on July 12, 1978.

HAYNIE, JOSEPH GORDON, JR. Convicted September 4, 1973, in the United States District Court, Eastern District of Virginia, Richmond of violation of Title 18, USC, Section 656 (embezzling bank funds), and imposition of sentence was suspended and he was placed on probation for five years. His probation terminated September 26, 1975. Subject was granted removal of political disabilities on January 5, 1979.

HAYS, ROBERT T., JR. Convicted October 12, 1972, in the Circuit Court of Arlington of possession with intent to distribute a controlled drug, marijuana, and sentenced to four years suspended and placed on probation for four years. His probation supervision terminated July 8, 1974, and his suspension expired July 19, 1976. Subject was granted removal of political disabilities on March 22, 1978.

HAZER, HOWARD WENDELL. Convicted September 19, 1972, in the Circuit Court of Chesapeake of grand larceny and sentenced to three years. He was paroled July 12, 1973, and discharged from parole on June 28, 1974. Subject was granted removal of political disabilities on July 12, 1978.

HEATH, JOHN ELDRIDGE. Convicted December 31, 1971, in the Hustings Court of Petersburg of involuntary manslaughter and sentenced to four years. He was paroled November 29, 1972, and discharged from parole on June 26, 1974. Subject was granted removal of political disabilities on April 19, 1978.

HENDRICKS, CHARLES W. Convicted March 10, 1975, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 201(b), (bribery of public official), and sentenced to three years. Convicted October 3, 1974, in the Circuit Court of Norfolk of unlawful wounding and sentenced to four years with two years suspended and placed on probation for three years upon release. He was paroled April 28, 1975, and discharged from parole April 23, 1976. His probation terminated April 11, 1977, and his suspension expired April 28, 1978. Subject was granted removal of political disabilities on August 29, 1978.

HODGE, JON ROBERT. Convicted February 1, 1974, in the Circuit Court of Fairfax County of statutory burglary and sentenced to two years suspended and placed on probation for two years. His probation and suspension expired February 1, 1976. Subject was granted removal of political disabilities on March 9, 1978.

HODGES, JAMES MARSHALL. Convicted January 4, 1949, in the United States District Court, Western District of Virginia, Roanoke, of violation of Title 26, USC, Sections 2810, 2831, 2833, and 2834 (possession of a distilling apparatus for the production of spirituous liquors without having same registered), and sentenced to six months in jail and fined \$100. He was released in May of 1949; and on April 2, 1951, in the Circuit Court of Henry County of manufacture of whiskey and sentenced to twelve months in jail. Subject was granted removal of political disabilities on May 24, 1978.

HODGES, ROBERT WILSON. HUBBARD, BENJAMIN LANIER. Convicted May 9, 1958, in the Circuit Court of Alleghany County of statutory rape and sentenced to five years suspended and placed on probation for three years. His probation terminated January 11, 1960, and his suspension expired May 9, 1963. Subject was granted removal of political disabilities on November 21, 1978.

HUBBARD, RUFUS ARTHUR. Convicted April 6, 1943, in the Circuit Court of Campbell County of malicious wounding and sentenced to ten years. He was paroled in 1945 and released from parole on January 27, 1950. Subject was granted removal of political disabilities on March 22, 1978.

HUMPHREY, JERRY LYNN. Convicted April 11, 1977, in the United States District Court, Western District of Virginia, Roanoke, of violation of Title 18, USC, Section 1701 (obstruction of mail), and imposition of sentence was suspended and he was placed on probation for one year. His probation terminated April 11, 1978. Subject was granted removal of political disabilities on July 11, 1978.

JACKSON, DONALD LEE. Convicted February 9, 1971, in the Corporation Court of Alexandria of two counts of statutory burglary and sentenced to five years on each count to run concurrent, suspended, and placed on probation for five years. His probation and suspension terminated August 10, 1976. Subject was granted removal of political disabilities on November 21, 1978.

JAMES, DAVID MARION. Convicted June 11, 1974, in the Circuit Court of Norfolk of involuntary manslaughter and imposition of sentence was suspended and he was placed on probation for three years. His probation expired October 4, 1977. Subject was granted removal of political disabilities on October 25, 1978.

JOHNSON, JAMES EDWARD. Convicted July 18, 1955, in the Circuit Court of Montgomery County of grand larceny and sentenced to three years; on September 1, 1955, in the Circuit Court of Roanoke County of two counts of statutory burglary and sentenced to three years on each count to run concurrently with Montgomery County conviction; on September 14, 1955, in the Circuit Court of Rockbridge County of grand larceny and sentenced to thirty months to run concurrent with Roanoke County conviction; on November 7, 1955, in the Circuit Court of Franklin County of two counts of breaking and entering and sentenced to two and one-half years on each count to run concurrently with Montgomery County conviction; on November 17, 1955, in the Hustings Court of Roanoke of two counts of grand larceny of motor vehicle and sentenced to one year on each count to run concurrently; and on June 13, 1956, in the Circuit Court of Botetourt County of two counts of housebreaking and grand larceny and sentenced to two years on each count to run concurrently; a total of six years to serve. He was discharged July 18, 1959. He was convicted on February 14, 1963, in the Circuit Court of Roanoke County of possession of burglary tools and sentenced to three years. He was discharged January 18, 1965. Subject was granted removal of political disabilities on May 23, 1978.

JOHNSON, STEVEN FRANKLIN. Convicted April 6, 1971, in the Circuit Court of Buena Vista of possession of hashish with intent to distribute and feloniously distributing hashish and sentenced to ten years and twelve months, respectively, suspended and placed on probation for ten years. His probation and suspension terminated by Court Order on February 7, 1978. Subject was granted removal of political disabilities on March 9, 1978.

JONES, GLENES FRENCES. Convicted February 18, 1975, in the Circuit Court of Virginia Beach of attempt grand larceny and sentenced to three years suspended and placed on unsupervised probation. His suspension expired February 18, 1975. Subject was granted removal of political disabilities on April 6, 1978.

JOY, RICHARD SHERMAN. Convicted October 29, 1974, in the Circuit Court of Norfolk of grand larceny and sentenced to four years suspended and placed on probation for three years. His probation and suspension expired October 29, 1977. Subject was granted removal of political disabilities on February 21, 1978.

KAYAN, LINCOLN. Convicted March 19, 1973, in the Circuit Court of Page County of unauthorized use of auto and sentenced to one year. He was discharged from the Penitentiary on September 9, 1973. Subject was granted removal of political disabilities on June 30, 1978.

KELSO, WILLIAM HAYWARD, JR. Convicted September 10, 1970, in the Hustings Court of Roanoke of felony hit and run and sentenced to six months in jail and fined \$250; and on October 6, 1970, in the Hustings Court of Roanoke of statutory burglary and larceny and sentenced to two years suspended and placed on probation for three years after serving ninety days in jail. Subject was granted removal of political disabilities on April 19, 1978.

KENNEDY, LEON ROGER. Convicted January 9, 1970, in the Circuit Court of Fairfax County of maiming and sentenced to seven years with five years suspended and placed on probation for five years. He was paroled in September of 1970, and discharged from parole on November 16, 1972. His suspended sentence expired in September of 1975. Subject was granted removal of political disabilities on February 17, 1978.

KING, CHARLES FRANKLIN, JR. Convicted June 22, 1971, in the Circuit Court of Radford of distribute a controlled drug, methamphetamine hydrochloride and/or amobarbital and sentenced to ten years; and on September 22, 1971, in the Circuit Court of Radford of distribute a controlled drug, methamphetamine hydrochloride and/or amobarbital and sentenced to ten years to run concurrent, and distribute a controlled drug, LSD, and sentenced to fifteen years with five years suspended to run concurrent; a total of ten years to serve. He was paroled December 20, 1973, and discharged from parole on September 2, 1977. Subject was granted removal of political disabilities on July 12, 1978.

KLOTZ, ROBERT RUSSELL. Convicted April 27, 1959, in the Circuit Court of Westmoreland County of statutory burglary and sentenced to twelve months suspended and placed on probation for three years; and on May 29, 1959, in the Circuit Court of



Arlington County of grand larceny of auto and sentenced to one year suspended and placed on probation for three years to run concurrent with April 27, 1959, conviction. Subject was granted removal of political disabilities on November 21, 1978.

LANE, WILLIAM DAVID. Convicted March 19, 1969, in the Circuit Court of Arlington County of grand larceny and sentenced to two years. He was paroled February 24, 1970, and discharged from parole on August 24, 1971. Subject was granted removal of political disabilities on January 3, 1979.

LASSITER, RUFUS LEON. Convicted January 31, 1972, in the Circuit Court of Nansemond County of manufacture a controlled drug, marijuana, and sentenced to two years; and on October 12, 1972, in the Circuit Court of Suffolk of three counts of distribute a controlled drug, marijuana, and sentenced to three years on each count to run concurrent with January 31, 1972, conviction, and distribute a controlled drug, heroin, two counts, and sentenced to seven years on each count to run concurrent. He was paroled on June 4, 1974, and discharged from parole on June 9, 1977. Subject was granted removal of political disabilities on April 7, 1978.

LONG, LUTHER E. aka Norman Edward Long aka Edward Luther Long. Convicted July 11, 1957, in the Circuit Court of Danville of two counts of forgery and sentenced to three years on the first count and two years to run concurrent with Count 1 on Count 2; and on April 23, 1969, in the Hustings Court of Richmond of attempt uttering and forgery and sentenced to twelve months on each count and fined \$10 on each count. He was discharged on May 15, 1970. Subject was granted removal of political disabilities on December 29, 1978.

MCDONALD, ALICE L. Convicted August 18, 1972, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 26, USC, Section 7206(2) (filing false tax returns), and sentenced to three years suspended and placed on probation for three years and fined \$500. Her probation terminated July 9, 1975. Subject was granted removal of political disabilities on May 23, 1978.

MCKAY, RICHARD RATCLIFFE. Convicted December 3, 1974, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 287 (false claims vs. Government) and imposition of sentence was suspended

and he was placed on probation for three years. His probation terminated July 21, 1977. Subject was granted removal of political disabilities on September 21, 1978.

MACKLIN, JAMES A. Convicted August 23, 1974, in the Circuit Court of Norfolk of possession of hashish oil and possession of hashish and sentenced to five years on each count to run concurrent, suspended and placed on probation for three years. His probation and suspension terminated August 23, 1977. Subject was granted removal of political disabilities on June 9, 1978.

MARSHALL, HENRY GLENN. Convicted June 12, 1972, in the Circuit Court of Amherst County of distributing a Schedule I controlled drug, marijuana, and sentenced to five years with four years ten months suspended and placed on probation for five years after release; to serve two months. Subject was granted removal of political disabilities on February 3, 1978.

MATNEY, ANDERSON. Convicted February 15, 1965, in the Circuit Court of Buchanan County of rape and sentenced to ten years suspended and placed on probation for ten years. His probation terminated April 13, 1970, and his suspension expired February 15, 1975. Subject was granted removal of political disabilities on October 25, 1978.

MILLER, WILLIAM GILL, III. Convicted June 28, 1972, in the Circuit Court of Loudoun County of breaking and entering and sentenced to four years. He was paroled December 11, 1973, and discharged from parole January 13, 1975. Subject was granted removal of political disabilities on February 17, 1978.

MOORE, CAROL DIANE. Convicted April 7, 1972, in the Corporation Court of Norfolk of possession with intent to distribute and distribute a controlled drug, heroin, two counts, and imposition of sentence was suspended and she was placed on probation for three years; and on July 18, 1974, in the Circuit Court of Norfolk of forgery and sentenced to two years. She was paroled May 20, 1975, and discharged from parole May 20, 1976. Subject was granted removal of political disabilities on March 22, 1978.

MOORE, CHARLES EDWARD. Convicted October 31, 1967, in the Circuit Court of Waynesboro of breaking and entering and sentenced to four years with two years suspended, to be on probation for five years upon release; on March 11, 1968, in the Circuit Court of Waynesboro of breaking and entering and grand larceny and sentenced to three years. He was paroled January 5, 1970, and discharged from parole July 8, 1970; on April 6, 1967, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 495 (forge and utter a Government check), and sentenced to ten years. His sentence was modified to two years suspended and placed on probation supervision for two years on May 5, 1970. His probation supervision expired May 4, 1973. Subject was granted removal of political disabilities on November 20, 1978.

MULLINS, RAYMOND. Convicted May 14, 1975, in the Circuit Court of Henry County of breaking and entering and sentenced to five years suspended and placed on probation for three years. His suspension and probation expired May 14, 1978. Subject was granted removal of political disabilities on August 10, 1978.

NORRIS, JAMES T. Convicted September 4, 1959, in the Circuit Court of Newport News, Part II, of second-degree murder and sentenced to fifteen years. Subject was granted removal of political disabilities on May 24, 1978.

NORTON, GENE THOMAS. Convicted November 5, 1964, in the Circuit Court of Martinsville of forgery and sentenced to one year suspended and placed on probation for two years. His probation terminated January 25, 1967; and on May 11, 1965, in the United States District Court, Western District of Virginia, Abingdon, of violation of Title 26, USC, Section 5604(a)(1) (Internal Revenue Liquor Laws), and imposition of sentence was suspended and he was placed on probation for three years, and fined \$1,000. His probation terminated May 11, 1978. Subject was granted removal of political disabilities on October 25, 1978.

O'NEILL, MICHAEL ALLAN. Convicted March 24, 1974, in the Circuit Court of Baltimore County, Maryland, of distribution of controlled dangerous substance and sentenced to three years suspended and placed on probation for three years; and on December 24, 1974, in the Circuit Court of Baltimore County, Maryland, of two counts of forgery and uttering and sentenced to three years suspended and placed on probation for three years, to run concurrent with March 24, 1974, conviction. His probation terminated September 16, 1977. Subject was granted removal of political disabilities on January 3, 1979.

PERDUE, STEPHEN EDWARD aka Stephen Vernard Perdue. Convicted December 5, 1973, in the Circuit Court of Rockbridge County of breaking and entering and sentenced to five years suspended and placed on probation for five years. His probation supervision terminated October 20, 1977, and his suspension expired December 5, 1978. Subject was granted removal of political disabilities on January 5, 1979.

PHILLIPS, BILLY J., JR. Convicted September 14, 1971, in the Circuit Court of Rockingham County of two counts of sale of controlled drug, marijuana, and sentenced to two years on each count, four counts of sale of controlled drug, LSD, and sentenced to two years on each count with six years to run concurrent; a total of six years to serve. He was paroled February 15, 1973, and discharged from parole July 19, 1975. Subject was granted removal of political disabilities on November 21, 1978.

PIOTROWSKI, JOHN ANTHONY. Convicted October 10, 1974, in the Circuit Court of Virginia Beach of taking indecent liberties with a minor, two counts, and sentenced to twelve months on each count to run consecutively, suspended and placed on probation for three years. His probation terminated April 21, 1976, and his suspension expired October 10, 1977. Subject was granted removal of political disabilities on July 12, 1978.

POTTS, JAMES MONROE, JR. Convicted December 13, 1972, in the Circuit Court of Portsmouth of grand larceny and sentenced to five years suspended and placed on probation for five years. His probation and suspension terminated December 13, 1977. Subject was granted removal of political disabilities on March 22, 1978.

POTTS, MILDRED V. Convicted July 28, 1947, in the Hustings Court of Portsmouth of maiming and sentenced to nine months in jail and fined \$50; on September 23, 1948, in the Hustings Court of Portsmouth with threat to kill and sentenced to ninety days in jail; and on September 22, 1953, in the Hustings Court of Portsmouth of maiming and sentenced to twelve months in jail and fined \$150. Subject was granted removal of political disabilities on November 21, 1978.

PROCTOR, WILLIAM EDWARD. Convicted April 2, 1971, in the Circuit Court of Hampton of sale of marijuana and sentenced to three years suspended and placed on probation for five years. His probation and suspension expired April 2, 1976. Subject was granted removal of political disabilities on February 21, 1978.

PROSSER, JOHN WILLIE. Convicted June 14, 1963, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 641, App. (theft of government property), and imposition of sentence was suspended

for three years and he was placed on probation and fined \$200. His probation terminated June 13, 1966. Subject was granted removal of political disabilities on December 29, 1978.

QUINLAN, MICHAEL ALAN. Convicted April 28, 1971, in the Circuit Court of Virginia Beach of three counts of violation of drug control act, distribution of LSD, and sentenced to four years on each count to run concurrently. His probation terminated October 14, 1974. Subject was granted removal of political disabilities on February 17, 1978.

SMITH, BOOKER T., JR., aka Abdullah Ali Muhammod. Convicted November 23, 1973, in the Circuit Court of Norfolk of grand larceny of auto and sentenced to two years. He was paroled May 16, 1974, and discharged from parole May 15, 1975. Subject was granted removal of political disabilities on June 13, 1978.

SMITH, JACK C., JR. Convicted September 23, 1974, in the United States District Court, Western District of Virginia, Roanoke, of violation of Title 21, USC, Section 846, (conspiring to plant, cultivate and harvest marijuana), and of violation of Title 21, USC, Section 841(a) and Title 18, Section 2, (aiding and abetting in the manufacture of two fields of marijuana), and sentenced to five years probation, which terminated February 18, 1976. Subject was granted removal of political disabilities on January 5, 1979.

SMITH, JOSEPH, JR. Convicted April 27, 1959, in the Corporation Court of Norfolk of robbery and sentenced to twelve years. He was paroled February 7, 1962, and discharged from parole February 6, 1967. Subject was granted removal of political disabilities on October 25, 1978.

SMITHER, JOHN L. Convicted September 9, 1957, in the United States District Court, Western District of Virginia, Danville, of violation of Title 18, USCA, Section 1010, (violation of Federal Housing Administration regulations), five counts, and fined \$300 each count, a total of \$1500. Subject was granted removal of political disabilities on January 3, 1979.

SNAPP, LAWRENCE O. Convicted October 4, 1976, in the United States District Court, Western District of Virginia, Abingdon, of violation of Title 18, USC, Sections 922(b)(5), 922(d), 922(m), 923 and 924(a). He was fined \$1,200, with imposition of sentence suspended and he was placed on probation for two years. His probation terminated April 14, 1978. Subject was granted removal of political disabilities on September 21, 1978.

SPENCE, HENRY LOFTON. Convicted March 12, 1975, in the Circuit Court of Loudoun County of unlawful wounding and sentenced to five years suspended and placed on probation for three years. His probation and suspension terminated March 12, 1978. Subject was granted removal of political disabilities on June 13, 1978.

STANTON, JOSEPH, JR. Convicted September 13, 1966, in the Circuit Court of Buckingham County of unlawful shooting and sentenced to three years suspended and placed on probation for five years. His probation terminated November 11, 1969, and his suspension expired September 12, 1971. Subject was granted removal of political disabilities on August 29, 1978.

STEVENS, DONALD GORDON. Convicted December 8, 1970, in the Circuit Court of Albemarle County of possession of marijuana and sentenced to three years suspended and placed on probation for three years. His probation and suspension terminated August 3, 1972. Subject was granted removal of political disabilities on April 7, 1978.

SWANN, JESSE LEROY, SR. Convicted September 11, 1961, in the United States District Court, Western District of Virginia, Danville, of violation of Title 26, USC, Section 5601(a)(12), (removing and concealing or aiding and abetting in the removal or concealing of distilled spirits on which the tax had not been paid to a place other than a bonded warehouse), and sentenced to two years probation; and on January 29, 1973, in the Circuit Court of Danville of grand larceny and sentenced to five years suspended and placed on probation. His sentence was revoked January 29, 1973, and he was ordered to serve five years. He was paroled April 27, 1976, and discharged from parole April 27, 1977. His probation terminated July 31, 1975. Subject was granted removal of political disabilities on February 22, 1978.

UMBERGER, CONLEY AUSTIN. Convicted December 26, 1976, in the Circuit Court of Pulaski County of grand larceny and sentenced to two years suspended for two years. His suspension terminated by Court Order on June 20, 1978. Subject was granted removal of political disabilities on June 30, 1978.

VAUGHAN, MICHAEL. Convicted August 9, 1973, in the Circuit Court of Virginia Beach of possession of hashish and sentenced to four years suspended and placed on unsupervised probation for four years. His suspension and probation expired August 9, 1977. Subject was granted removal of political disabilities on April 19, 1978.

WADE, JERRY C. aka Jerry Wade. Convicted February 16, 1973, in the Circuit Court of Fairfax County of statutory burglary and sentenced to three years with two years suspended and placed on probation for two years upon release. He was released from confinement June 5, 1973. His probation and suspension expired June 5, 1975. Subject was granted removal of political disabilities on November 20, 1978.

WAFF, MICHAEL MAURICE. Convicted November 11, 1966, in the Corporation Court of Norfolk of three counts of robbery and sentenced to six years on each of counts one and two, to run consecutively, on count three imposition of sentence was suspended and he was placed on probation for five years, and of grand larceny with imposition of sentence suspended and placed on probation for five years. He was paroled November 27, 1972, and discharged from parole October 25, 1974. His probation terminated November 27, 1977. Subject was granted removal of political disabilities on February 17, 1978.

WALKER, ELMER A. Convicted November 12, 1973, in the United States District Court, Eastern District of Virginia, Norfolk, of violation of Title 18, USC, Section 201(g), (gratuity), two counts, and imposition of sentence was suspended for three years and he was placed on probation for three years and fined \$500, both counts to run concurrently. His probation terminated December 10, 1975. Subject was granted removal of political disabilities on April 19, 1978.

WALL, PHILLIP WAYNE. Convicted July 19, 1973, in the Circuit Court of Henry County of distribute controlled drug and sentenced to five years with four years suspended and placed on probation for four years, and fined \$100. His probation and suspension expired April 12, 1978. Subject was granted removal of political disabilities on August 10, 1978.



WASHINGTON, RALPH GEORGE. Convicted July 11, 1974, in the Circuit Court of Fluvanna County of voluntary manslaughter and sentenced to five years. He was paroled October 23, 1975, and discharged from parole October 20, 1977. Subject was granted removal of political disabilities on June 13, 1978.

WEAKLEY, ROGER LEE. Convicted September 8, 1970, in the Circuit Court of Madison County of grand larceny and sentenced to six months suspended and placed on probation for three years. His probation and suspension terminated by Court Order on May 1, 1972. Subject was granted removal of political disabilities on March 9, 1978.

WEBB, JOHN JOSEPH. Convicted October 4, 1973, in the Circuit Court of Danville of four counts of grand larceny and sentenced to twelve years with six years suspended on count one, however, this sentence was declared null and void on February 27, 1974, at which time Subject was resentenced to five years; and imposition of sentence was suspended on counts two through four and he was placed on probation for three years. His probation terminated by Court Order on November 15, 1977. He was paroled December 8, 1975, and released from parole December 20, 1977. Subject was granted removal of political disabilities on February 24, 1978.

WHITE, CORNELIUS BENNIE. Convicted September 25, 1975, in the Circuit Court of Westmoreland County of grand larceny and sentenced to four years with two and one-half years suspended and placed on probation for three years. He was paroled March 18, 1976, and discharged March 15, 1977. His probation terminated September 25, 1978. Subject was granted removal of political disabilities on January 3, 1979.

WILSON, SHIRLEY. Convicted May 18, 1972, in the Corporation Court of Lynchburg of voluntary manslaughter and sentenced to five years suspended and placed on probation for five years. Her probation and suspension expired May 17, 1977. Subject was granted removal of political disabilities on January 5, 1979.

WITCHER, ROBERT. Convicted September 3, 1964, in the Corporation Court of Charlottesville of felonious assault and sentenced to five years; and on December 4, 1964, in the Corporation Court of Charlottesville of forgery and sentenced to four years with two years suspended; a total of seven years to serve. He was discharged from the Penitentiary in 1969. Subject was granted removal of political disabilities on May 9, 1978.

WOODRUFF, HAZEL COOK. Convicted July 17, 1963, in the Circuit Court of Campbell County of arson and sentenced to six years. She was paroled March 29, 1965, and discharged from parole July 6, 1967. Subject was granted removal of political disabilities on April 19, 1978.

WOODWARD, DAVID. Convicted April 18, 1963, in the Circuit Court of Madison County of three counts of breaking and entering and sentenced to two years on each count, suspended and placed on probation for five years. His probation and suspension expired April 18, 1968. Subject was granted removal of political disabilities on August 10, 1978.
