ABSOLUTE PARDON

COSBY, EDWARD LEWIS. Sentenced November 1, 1977, in the Circuit Court of Richmond, Division I, to six years on a conviction of possession of preluin; and in the Circuit Court of Richmond, Division I, on October 11, 1978, to three years on a conviction of being a recidivist for the third time. Based upon after-discovered evidence throwing serious doubt upon the credibility of the arresting officers, whose testimony constituted the sole evidence for the prosecution, the Parole Board recommending, the Honorable J. Randolph Tucker, Jr., and the Honorable Aubrey M. Davis, Jr., not objecting, the Honorable James B. Wilkinson remaining neutral, Subject is granted an Absolute Pardon. It is ordered that he be released forthwith from all penalties and terms of confinement imposed upon him as a result of these convictions addressed herein, and that the aforesaid offenses be removed from any and all records upon which they may appear. This pardon dated August 9, 1979.

JOHNSON, WILLIAM ANTHONY, aka William Anthony Johnson, Jr. Sentenced June 29, 1977, in the Richmond General District Court to thirty days on a conviction of possession of drug paraphernalia; on August 25, 1977, in the Circuit Court of Richmond, Division I, to five years on a conviction of possession of preluin; and on September 13, 1978, in the Circuit Court of Richmond, Division I, to one year on a conviction of being a recidivist. Based upon after-discovered evidence throwing serious doubt upon the credibility of the arresting officers, whose testimony constituted the sole evidence for the prosecution, the Parole Board, the sentencing Judges and the prosecuting Assistant Commonwealth's Attorney recommending favorably, Subject is granted an Absolute Pardon. It is ordered that he be released forthwith from all penalties and terms of confinement imposed upon him as a result of the three convictions addressed herein, and that the aforesaid offenses be removed from any and all records upon which they may appear. It is further ordered that Subject be taken forthwith before the Honorable E. Ballard Baker, Judge of the Circuit Court of the County of Henrico, for further proceedings in connection with a prior suspended sentence, the suspension of which was revoked as a result of the three convictions addressed herein. This pardon dated April 13, 1979.

CONDITIONAL PARDON

DAVIDSON, PAUL MACK. Sentenced January 4, 1979, in the Circuit Court of Danville to four years on a conviction of uttering a forged prescription, and to four years with three years suspended on a conviction of attempt to utter a forged prescription. In view of this man's serious medical condition, the costs of providing continual medical care which his condition necessitates, the recommendation of the Parole Board, the sentencing Judge and Commonwealth's Attorney not objecting, Subject is granted a Conditional Pardon, to remain under the terms, conditions and supervision of the Virginia Parole Board until May 9, 1982, with the special condition that he be transferred from the Department of Corrections to the Veterans Administration for treatment. This pardon dated September 6, 1979.

MOORE, ROBERT EVANS. Sentenced August 17, 1977, in the Circuit Court of Pittsylvania County to twenty years and fined \$15,000, on a conviction of sale of marijuana. Chapter 435 of the 1979 Acts of Assembly reduces the penalty for certain criminal offenses involving the possession, manufacture, cultivation, distribution or sale of marijuana, and there are certain inmates presently confined within the Virginia Department of Corrections who are serving sentences which exceed the maximum sentences which could be imposed pursuant to Chapter 435. It appears to me that Robert Evans Moore, No. 112346, is such an inmate; and in the absence of Executive Clemency such inmates would receive no benefit from Chapter 435. Therefore, I am granting him a Conditional Pardon for the conviction herein named and do order that he be relieved of any unserved sentence and unpaid fine which exceeds one year and one thousand dollars. However, this pardon shall have no effect upon any other sentence which the said Robert Evans Moore is serving or which he may have to serve in the future. He is to be placed under the supervision of the Virginia Parole Board upon his release from a twelve-month jail sentence on December 4, 1980, or upon his release from confinement and is to remain under supervision for a period of ten years ending December 4, 1990. This pardon dated December 4, 1979.

AMENDED CONDITIONAL PARDON (Executive Order Number Twenty-five)

THOMASSON, JOHN EDWARD. On April 16, 1975, the Honorable Mills E. Godwin, Jr., then Governor of the Commonwealth of Virginia, granted a conditional pardon to John Edward Thomasson for his cooperation in the case of Commonwealth vs. DeWease. One of the conditions of the pardon was that Thomasson remain under supervision of the Parole Board for a period of five

years, or until April 8, 1980, and that should he, at any time prior to March 9, 1991, be found guilty of the violation of any of the penal laws of the Commonwealth, or should he violate any of the conditions of parole, this pardon would become null and void and he would be required to serve the unserved portion of his sentence. It has been brought to my attention by the Chairman of the Parole Board, Mr. Pleasant C. Shields, that Mr. Thomasson has encountered serious health problems, which have been diagnosed as kidney failure. It is my understanding that he received a kidney transplant which his body has rejected. He has subsequently been placed on a dialysis machine which he continues to use three times a week in order to stay alive, and which he must continue to use for the rest of his life, unless he can have a successful kidney transplant. I further understand that, since being released on pardon, Mr. Thomasson has reported on a regular basis to his supervising officer, has had no new arrests whatsoever, and has been an extremely cooperative subject of supervision. In view of the foregoing facts, I am amending the Conditional Pardon issued to John Edward Thomasson on April 16, 1975, terminating the period of parole supervision as of this date. However, the remaining pardon conditions are to remain in full force and effect until their expiration on March 9, 1991. This Executive Order Number Twenty-five dated June 27, 1979.

PARDON WITHOUT CONDITIONS

TUCKER, HENRY. Originally sentenced to Life on May 26, 1964. Retried May 22, 1970, in the Circuit Court of Halifax County and sentenced to forty years on a conviction of breaking and entering and attempted rape. In view of his medical condition and upon the recommendation of the Parole Board, the sentencing judge not objecting, and the recommendations of the prosecuting and current Commonwealth's Attorneys, Subject is granted a Pardon Without Conditions. This pardon dated June 27, 1979.

SIMPLE PARDON

CASTRO, RAFAEL FRANCISCO. Sentenced August 29, 1973, in the Circuit Court of Albemarle County to four years which was reduced to two years on October 12, 1973, on a conviction of abduction; and on October 3, 1973, in the Corporation Court of Charlottesville to five years which was reduced to two years on October 12, 1973, to run consecutively with the conviction in Albemarle County, on a conviction of abduction. He was paroled October 30, 1974 and discharged from parole on May 28, 1976. All of his court costs have been paid. In view of Subject's outstanding achievements since his release, and because of the Parole Board's recommendation, the sentencing

Judge of Albemarle County voicing no opinion, the prosecuting Commonwealth's Attorney of Albemarle County remaining neutral, the current Commonwealth's Attorney of Albemarle County not being familiar with the case, the prosecuting Commonwealth's Attorney of Charlottesville voicing no objection and the current Commonwealth's Attorney of Charlottesville not objecting, Subject is granted a Simple Pardon. This pardon dated June 20, 1979.

LAND, HOWARD D. Sentenced May 31, 1943, in the Corporation Court of Newport News to five years suspended on a conviction of grand larceny. In view of the fact that this man has done everything he can to pay his debt to society and the fact that he has served his country in an excellent manner, the Parole Board, the current Judge and Commonwealth's Attorney recommending, Subject is granted a Simple Pardon. This pardon dated July 11, 1979.

MERCHANT, DELORES M., aka Delores Marie Merchant. Sentenced May 8, 1975, in the Circuit Court of Fairfax to thirty days suspended for one year and fined \$100 upon a conviction of concealing merchandise. Her fine and court costs have been paid. In view of the fact that this conviction is hindering Subject in employment, and upon the recommendation of the Parole Board, the sentencing Judge and Commonwealth's Attorney not objecting, Subject is granted a Simple Pardon. This pardon dated July 2, 1979.

SPENCER, BARRY SNEAD, aka Barry Sneed Spencer. Sentenced July 28, 1960, in the Hustings Court of Richmond, Part I, with imposition of sentence suspended for five years and placed on probation for five years on a conviction of grand larceny and statutory burglary. His probation terminated by Court Order on May 25, 1961, and his suspension expired July 28, 1965. In view of this man's outstanding rehabilitation achievements since his conviction, and based upon the high esteem of fellow citizens, the recommendation of the Parole Board and there being no objection from the current Commonwealth's Attorney of the City of Richmond, the sentencing Judge and prosecuting Commonwealth's Attorney being deceased, Subject is granted a Simple Pardon. This pardon dated January 19, 1979.

STEEDLEY, DUNCAN M. Sentenced January 28, 1969, in the Circuit Court of Virginia Beach to two and one-half years on a conviction of involuntary manslaughter. He was paroled September 22, 1969, and discharged from parole March 23, 1971. In view of the fact that he has led an exemplary life since his release, the recommendations of the Parole Board, the prosecuting Commonwealth's Attorney and reputable citizens,

the sentencing Judge not objecting, and the current Commonwealth's Attorney remaining neutral, Subject is granted a Simple Pardon. This pardon dated June 27, 1979.

WALKER, HERBERT RHONE. Sentenced June 9, 1956, in the Corporation Court of Newport News to twelve months in jail on each of four counts of attempted armed robbery, and to eight years suspended for five years and probation on each of three counts of armed robbery; and on July 20, 1956, in the Circuit Court of Warwick County to eight years suspended and probation for six years on a conviction of armed robbery. In view of this man's exemplary life since his release and upon the recommendations of the Parole Board, reputable citizens in his community, the prosecuting Commonwealth's Attorney of Warwick County, who is now a Circuit Court Judge for the City of Newport News, the prosecuting Commonwealth's Attorney of Newport News, the current Commonwealth's Attorney of Newport News not objecting, and the sentencing Judges being deceased, Subject is granted a Simple Pardon. This pardon dated September 27, 1979.

REVOCATION OF CONDITIONAL PARDON

GARRETT, ROOSEVELT. Convicted of murder in the first degree in the Circuit Court of Accomack County on October 10, 1952, and sentenced to life in the penitentiary; and on October 10, 1973, in the Circuit Court of Chesterfield County, he was convicted of escape and sentenced to six months in jail. On March 3, 1976, then Governor Mills E. Godwin, Jr., granted him a conditional pardon. This pardon stated that "...should [he] violate any of such conditions prior to March 3, 1979, or if ever again he be found guilty of violation of the penal laws of any city, county, State, or of the United States, this pardon may be revoked." The Subject has now been returned to confinement as a result of his conviction on June 21, 1978, in the Greensville County Circuit Court of robbery by force, for which he received a ten-year sentence. In addition to this violation, the Parole Board has found Subject guilty of having violated Conditions 4 and 10 of the parole conditions which were incorporated into and made a part of the conditional pardon granted to him on March 3, 1976. A copy of the Parole Board's recommendation and a copy of the hearing transcript were sent to Mr. Garrett, advising him of his right to submit any comments or rebuttals within twenty days from the date of the Parole Board's letter. The twenty-day period elapsed without any communication being received from Mr. Garrett. In addition, an appeal was filed with the Supreme Court of Virginia. I have been advised that this appeal was denied on July 25, 1979. I have reviewed the

transcript of the hearing; and in view of these developments and upon the recommendation of the Parole Board, I do hereby revoke the conditional pardon granted Roosevelt Garrett on March 3, 1976. This revocation dated August 13, 1979.

REMOVAL OF POLITICAL DISABILITIES

Relying on the recommendations of parole officers and reputable citizens who are familiar with the conduct of these individuals since their conviction or release, I have granted removal of political disabilities to the following:

ABRAMS, BOBBY. Sentenced October 18, 1960, in the Circuit Court of Hampton to twelve months and fined \$50 on a conviction of grand larceny. He was paroled April 5, 1961, and discharged October 5, 1962. His court costs have been paid. Subject was granted removal of political disabilities on December 28, 1979.

ALTICE, HENRY LEE. Sentenced June 13, 1973, in the Circuit Court of Franklin County to twenty years with twelve years suspended for ten years upon release on a conviction of distribute LSD; and to twenty years with twelve years suspended for ten years upon his release, to run concurrent with the Distribution conviction, on a conviction of aiding and abetting in the unlawful distribution of Marijuana; and on July 24, 1973, in the Circuit Court of Roanoke to five years, to serve eighteen months with remaining three and one-half years suspended, on a conviction of distribution of Hashish, and to two years with one year to run concurrent with distribution of Hashish and consecutively with distribute LSD on a conviction of possession of Heroin. He was paroled February 2, 1976, and discharged January 18, 1979. His suspension was terminated by Court Order October 10, 1979. Subject was granted removal of political disabilities on December 3, 1979.

ANDREASEN, ROBERT OSCAR. Sentenced December 18, 1974, in the Circuit Court of Botetourt County to three years suspended and placed on probation for three years on each of three counts of breaking and entering with intent to commit larceny. His probation and suspension terminated by Court Order on July 2, 1976, and restitution and court costs have been paid. Subject was granted removal of political disabilities on April 19, 1979.

ARTIS, GILBERT LEE. Sentenced February 26, 1969, in the Circuit Court of Isle of Wight to five years suspended and placed on probation for five years on a conviction of unlawful shooting. His probation and suspension terminated February 26, 1974, and his court costs have been paid. On June 16, 1976, in the United States District Court for the Eastern District of Virginia, Newport News, he was convicted of violation of Title 18, USCA, Section 1202(a)(1), Gun Control Act, and

sentenced to two years suspended and placed on probation for two years. His probation and suspension expired June 16, 1978. No costs were imposed. Subject was granted removal of political disabilities on March 14, 1979.

AYERS, ELMER CONRAD. Sentenced May 6, 1976, in the Circuit Court of Bedford County to five years on each of two counts of maiming, suspended after serving five months in jail and placed on probation for five years. His probation and suspension terminated by Court Order November 7, 1979. His court costs have been paid. Subject was granted removal of political disabilities January 9, 1980.

BENDER, JOHN LOWELL. Sentenced May 2, 1975, in the Circuit Court of Norfolk to four years suspended and placed on probation for three years and fined \$100 on a conviction of possession of LSD. His probation expired May 2, 1978, and his suspension expired May 2, 1979. His fine and court costs have been paid. Subject was granted removal of political disabilities September 6, 1979.

BENTHALL, RALEIGH, aka Riley Benthall. Sentenced March 24, 1964, in the Circuit Court of Chesapeake to three years suspended and placed on probation for five years on a conviction of shooting at or into a dwelling house. His suspension expired March 24, 1967, and his probation terminated March 24, 1969. There were no fines or court costs imposed. Subject was granted removal of political disabilities on February 14, 1979.

BOOKER, CLINTON FRANKLIN. Sentenced September 8, 1959, in the Circuit Court of Gloucester County to one year on each of two counts of statutory burglary. He was discharged from the Penitentiary December 1, 1960; on November 10, 1961, in the Hustings Court of Richmond, Part I, to five years with two years suspended on a conviction of malicious wounding. He was paroled January 17, 1963, and discharged from parole July 16, 1964. Subject was granted removal of political disabilities on January 12, 1979.

BOWLES, BELVIE LEE. Sentenced November 12, 1959, in the United States District Court, Western District of Virginia, Roanoke, on a conviction of violation of Title 26, USCA, Sections 2810, 2831, 2833 and 2834, manufacturing illegal whiskey. Imposition of sentence was suspended for two years. No court costs were imposed. Subject was granted removal of political disabilities on January 9, 1980.

BRACALE, PHILIP J., JR. Sentenced December 3, 1975, in the Circuit Court of Virginia Beach to two years suspended and placed on probation for two years plus costs and restitution in the amount of \$103.34 on a conviction of statutory burglary. His suspension expired December 3, 1977,

and his probation terminated January 25, 1977. Subject was granted removal of political disabilities March 14, 1979.

BRANDS, ROBERT FERRELL. Sentenced November 9, 1973, in the Circuit Court of Arlington to six years with five years suspended and placed on probation for five years on a conviction of possession with intent to distribute Marijuana. His probation terminated January 31, 1975, and his suspension expired June 29, 1979; and on November 12, 1973, in the Circuit Court of Fairfax to five years with four years suspended and placed on probation on a conviction of possession of controlled substance, Hashish. His suspension expired June 28, 1977. His court costs have been paid. Subject was granted removal of political disabilities on August 23, 1979.

BRANHAM, JOHN ALLEN. Sentenced August 30, 1966, in the Circuit Court of Goochland County to one year on a conviction of manufacture alcoholic beverages without being licensed to do so. He was paroled January 5, 1967, and discharged from parole July 16, 1968. Subject was granted removal of political disabilities on July 2, 1979.

BREWER, THOMAS EDWARD. Sentenced August 30, 1963, in the Hustings Court of Richmond on a conviction of statutory burglary. Imposition of sentence was suspended for five years and expired August 30, 1968; on August 11, 1971, in the Circuit Court of Richmond to six years with two years suspended on a conviction of possessing and distributing a controlled drug, Marijuana. He was paroled September 28, 1972, and discharged from parole April 10, 1974. His suspension terminated by Court Order on April 18, 1979. His court costs have been paid. Subject was granted removal of political disabilities on July 2, 1979.

BROOKS, DAVID LEE. Sentenced May 30, 1972, in the United States District Court, Eastern District of California, Fresno, to imprisonment for seven years and mandatory parole for three years on a conviction of violation of Title 21, USC, Section 846, Conspiracy to violate Title 21, USC, Section 841(a) (1), possess with intent to distribute a controlled substance. He was paroled September 10, 1975, and discharged from parole September 6, 1977. The remaining three years' parole expired September 10, 1979. No court costs were imposed. Subject was granted removal of political disabilities on December 27, 1979.

BROWN, NELLIE COOPER. Sentenced July 6, 1972, in the Circuit Court of Norfolk to five years suspended and placed on probation for five years on a conviction of murder. Her probation terminated by Court Order September 14, 1976, and her suspension expired July 6, 1977. Her court costs have been paid. Subject was granted removal of political disabilities on September 18, 1979.

BROWN, RONALD DUANE, aka Ronald D. Brown. Sentenced May 26, 1961, in the Hustings Court of Richmond to five years with three years suspended on a conviction of grand larceny, and discharged from the Penitentiary on June 28, 1962; on May 22, 1963, in the Corporation Court of Danville to one year on a conviction of breaking and entering, and discharged from the Penitentiary in 1964; on March 4, 1970, in the Hustings Court of Richmond to five years on a conviction of statutory burglary, and on March 20, 1970, in the Hustings Court of Richmond to eight years on a conviction of statutory burglary. He was paroled July 14, 1976, and discharged from parole August 15, 1978. No court costs were imposed. Subject was granted removal of political disabilities on October 4, 1979.

BUCHANAN, ALICE HARPER. Sentenced November 11, 1976, in the Circuit Court of Rockbridge County to pay a fine of \$500 on a conviction of embezzlement. Her fine has been paid. Subject was granted removal of political disabilities on December 26, 1979.

BURNETT, MICHAEL VINCENT. Sentenced June 29, 1972, in the Circuit Court of Waynesboro to two years suspended and probation for five years on a conviction of distribute a controlled drug, LSD. His suspension expired June 29, 1974, and his probation terminated May 5, 1977. His court costs have been paid. Subject was granted removal of political disabilities on May 16, 1979.

BYRD, RALPH WAYNE, SR., aka Ralph Wayne Sansome. Sentenced November 15, 1966, in the Fourth Judicial District Court of Stutsman County, North Dakota, to not less than two nor more than eight years on a conviction of robbery in the first degree; and on October 8, 1971, in the Superior Court of Tulare County, Visalia, California, on a conviction of receiving stolen property. Imposition of any sentence was suspended for two years and he was placed on probation which terminated October 8, 1973. There were no court costs imposed. Subject was granted removal of political disabilities on January 9, 1980.

CARICO, WILLIE SUE. Sentenced October 26, 1976, in the Circuit Court of Scott County to three years suspended and placed on probation for two years upon release on a conviction of malicious wounding. Her suspension expired June 24, 1979, and her probation terminated July 2, 1979. Her court costs have been paid. Subject was granted removal of political disabilities on September 26, 1979.

CARR, ROBERT ALLAN. Sentenced July 12, 1974, in the Circuit Court of Arlington to three years suspended and placed on probation for three years on a conviction of obtaining money by means of false pretense. His suspension and probation terminated June 21, 1974. His court costs have been paid. Subject was granted removal of political disabilities on July 31, 1979.

CARTER, BETTY HOOD. Sentenced September 25, 1974, in the United States District Court, Western District of Virginia, Roanoke, on a conviction of violation of Title 21, USC, Section 841(a) and Title 18, USC, Section 2, aiding and abetting in growing marijuana. Imposition of sentence was suspended and she was placed on probation for three years. Her probation terminated September 24, 1977. No fines or court costs were imposed. Subject was granted removal of political disabilities on March 14, 1979.

CARTER, SANFORD LAWRENCE. Sentenced February 17, 1975, in the Circuit Court of Henry County to four years on each of four counts of grand larceny and breaking and entering, which were suspended and he was placed on probation for four years. His probation terminated April 14, 1978, and his suspension expired February 17, 1979. Subject was granted removal of political disabilities on March 14, 1979.

CASTRO, RAFAEL FRANCISCO. Sentenced August 29, 1973, in the Circuit Court of Albemarle County to four years which was reduced to two years on October 12, 1973, on a conviction of abduction; and on October 3, 1973, in the Corporation Court of Charlottesville to five years which was reduced to two years on October 12, 1973, to run consecutively with the conviction in Albemarle County, on a conviction of abduction. He was paroled October 30, 1974, and discharged from parole May 28, 1976. All court costs have been paid. Subject was granted removal of political disabilities on June 20, 1979.

CHAMBERS, HENRY CLAY. Sentenced July 26, 1954, in the Circuit Court of Williamsburg and James City County to two years on each of four counts of breaking and entering; on September 7, 1954, in the Circuit Court of Gloucester County to five years on each of two counts of burglary, with four years to run concurrent with the July 26, 1954, conviction on each count; on March 14, 1972, in the Circuit Court of Arlington to eight years with five years suspended and probation for five years upon release on a conviction of statutory burglary; and on April 27, 1972, in the Circuit Court of Arlington to eight years with five years suspended and probation for five years upon his release, with time to be served to run concurrent with the March 14, 1972 conviction, on each of two counts of statutory burglary. He was paroled

November 8, 1973, and discharged from parole November 8, 1974. He was discharged from probation supervision February 3, 1977, and his suspension expired November 8, 1978. Subject was granted removal of political disabilities on February 14, 1979.

COATES, ROBERT WAYNE. Sentenced December 12, 1974, in the Circuit Court of Westmoreland County to five years with four years suspended and placed on probation for three years on a conviction of possession of a Schedule II controlled drug, cocaine. His probation terminated December 12, 1977, and his suspension expired July 25, 1979; and to twelve months in jail to run concurrent on a conviction of possession of a Schedule IV controlled drug, phenzadratiopene. His court costs have been paid. Subject was granted removal of political disabilities on August 6, 1979.

COBB, JAMES ALLEN. Sentenced May 5, 1948, in the Corporation Court of Norfolk to five years on a conviction of burglary. He was discharged August 31, 1951. No court costs were imposed. Subject was granted removal of political disabilities on December 28, 1979.

COFFMAN, JOHN LOGAN, JR. Sentenced March 2, 1976, in the Circuit Court of Augusta County on a conviction of unlawful wounding. Imposition of sentence was withheld and he was placed on probation for five years. His probation terminated May 17, 1978, and his court costs have been paid. Subject was granted removal of political disabilities on March 30, 1979.

COLEMAN, JESSIE BERNARD. Sentenced January 16, 1976, in the Circuit Court of Louisa County to three years with thirty-three months suspended and placed on probation for five years on a conviction of unlawful assault. His suspension has expired and his probation was terminated by Court Order on October 26, 1978. His court costs and restitution have been paid. Subject was granted removal of political disabilities on July 31, 1979.

COLLINS, NANCY LOCKLEAR, aka Nancy Reaves Collins Saferight. Sentenced April 17, 1972, in the Circuit Court of Patrick County to four years on a conviction of grand larceny. She was paroled September 26, 1973, and her parole was revoked on November 8, 1974. She was discharged from the Penitentiary October 26, 1976. Subject was granted removal of political disabilities on May 16, 1979.

COMBS, THOMAS GEORGE. Sentenced December 4, 1970, in the Circuit Court of Powhatan to three years on a conviction of voluntary manslaughter. He was paroled October 21, 1971, and

discharged April 26, 1973. There were no court costs imposed. Subject was granted removal of political disabilities on November 20, 1979.

CONNOR, CLYDE MARVIN. Sentenced December 23, 1974, in the Circuit Court of Floyd County to two years suspended and placed on probation for two years on a conviction of statutory burglary. His probation and suspension terminated December 23, 1976, and his court costs have been paid. Subject was granted removal of political disabilities on March 14, 1979.

COOPER, WARREN HARDING. Sentenced April 25, 1977, in the Circuit Court of Franklin County and fined \$1,000, on a conviction of shooting into an occupied dwelling. His fine and court costs have been paid. Subject was granted removal of political disabilities on July 31, 1979.

CORDER, ORBIN WALKER. Sentenced June 28, 1950, in the Circuit Court of Dickenson County to fifteen years on a conviction of murder in the second degree. He was paroled October 18, 1954, and discharged January 15, 1961. Subject was granted removal of political disabilities on September 17, 1979.

CRAIG, STEWART PATRICK. Sentenced September 8, 1975, in the Circuit Court of Frederick County to ninety days in jail on each of three counts of involuntary manslaughter and fined \$100. His fine and costs have been paid. Subject was granted removal of political disabilities on May 16, 1979.

CROWDER, PATSY BROWN. Sentenced October 21, 1965, in the Hustings Court of Roanoke to two years suspended on a conviction of embezzlement. Subject was granted removal of political disabilities on October 4, 1979.

DANIEL, BILLY LEE. Sentenced May 17, 1978, in the Circuit Court of Danville to one year on a conviction of operating a motor vehicle after having been declared an Habitual Offender. He was paroled October 12, 1978, and discharged October 12, 1979. His court costs have been paid. Subject was granted removal of political disabilities on December 27, 1979.

DAVIS, ADOLPHUS RICHARD. Sentenced March 18, 1966, in the Circuit Court of Tazewell County to three years suspended and placed on probation on a conviction of burning a car with intent to injure insurer. His probation terminated August 19, 1966, and his suspension expired March 18, 1969. His court costs have been paid. Subject was granted removal of political disabilities on July 2, 1979.

DAVIS, GREGORY ALAN, aka Gregory Allen Davis. Sentenced March 8, 1974, in the Circuit Court of Fairfax County to four years suspended and placed on probation for four years on a conviction of burglary. His probation terminated by Court Order May 27, 1977, and his suspension expired March 8, 1978. His court costs have been paid. Subject was granted removal of political disabilities on December 26, 1979.

DAVIS, McCOY ELLIOTT. Sentenced March 22, 1972, in the Circuit Court of Richmond, Division I, on a conviction of possession of heroin. Imposition of sentence was suspended and he was placed on strict probation. His suspension was terminated by Court Order on August 6, 1979, and his court costs have been paid. Subject was granted removal of political disabilities on September 6, 1979.

DAVIS, MAJOR MARYLAND. Sentenced November 12, 1958, in the Hustings Court of Portsmouth to forty years on a conviction of rape; ten years on each of two counts of robbery; five years for unlawful wounding; and five years for maiming to run concurrent with the rape conviction; a total of sixty-five years. He was paroled August 25, 1971, and discharged from parole November 5, 1976. Subject was granted removal of political disabilities on September 6, 1979.

His suspension expired December 7, 1962, and his probation expired December 7, 1964. His court costs have been paid. Subject was granted removal of political disabilities on January 9, 1980.

DOBSON, THOMAS JOSEPH. Sentenced March 9, 1971, in the Circuit Court of Chesapeake to four years suspended and placed on probation for four years on a conviction of two counts of grand larceny. His probation and suspension expired March 9, 1975, and restitution and court costs have been paid. Subject was granted removal of political disabilities on January 9, 1980.

DOOLITTLE, CARL BENJAMIN. Sentenced September 5, 1969, in the Circuit Court of Orange County to five years suspended and placed on probation for five years on a conviction of breaking and entering. His probation terminated by Court Order November 6, 1972, and his suspension expired September 6, 1974. His court costs have been paid. Subject was granted removal of political disabilities on November 20, 1979.

DOTSON, JOSEPH WILLIAM, JR. Sentenced February 21, 1974, in the Circuit Court of Franklin County to five years suspended after serving four months and placed on probation for five years on a conviction of distribution of LSD. His probation terminated November 18, 1977, and his suspension expired May 3, 1979. His court costs have been paid. Subject was granted removal of political disabilities on September 6, 1979.

DOVEL, ROBERT LESTER. Sentenced March 15, 1955, in the Circuit Court of Rockingham County to five years on a conviction of grand larceny. He was paroled April 2, 1956, and discharged May 20, 1958. His court costs expired under statute of limitation. Subject was granted removal of political disabilities on November 20, 1979.

DURHAM, JULIA ELLEDGE. Sentenced December 19, 1977, in the United States District Court, Eastern District of Virginia, Richmond on a conviction of violation of Title 18, USC, Section 1341, mail fraud. Imposition of sentence was suspended and she was placed on probation for five years. Her probation terminated by Court Order on April 4, 1978. Restitution has been made. Subject was granted removal of political disabilities on February 14, 1979.

DURHAM, SANDRA SUE, aka Sandy Durham. Sentenced November 26, 1973, in the Circuit Court of Fairfax County to five years suspended and placed on probation for five years on a conviction of distributing a controlled drug. Her probation terminated July 8, 1976, and her suspension expired November 26, 1978. Court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

EVANS, JESSE TERRY. Sentenced February 11, 1975, in the United States District Court, Western District of Virginia, Danville, on a conviction of violation of Title 18, USC, Sections 924(a) and 2, Gun Control Act. Imposition of sentence was suspended and he was placed on probation for one year, which terminated February 10, 1976. There were no court costs imposed. Subject was granted removal of political disabilities on August 23, 1979.

FARMER, CECIL. Sentenced August 9, 1976, in the United States District Court, Western District of Virginia, Abingdon, on a conviction of violation of Title 18, USC, Sections 922(b)(5); 922(m); and 924(a), Gun Control Laws. Imposition of sentence was suspended and he was placed on probation for two years and fined \$1,000. His probation and suspension expired August 9, 1978, and his fine has been paid. Subject was granted removal of political disabilities on December 26, 1979.

FORSYTHE, CLARENCE ARRINGTON, JR. Sentenced December 20, 1966, in the Circuit Court of Augusta County to one year suspended and placed on probation for two years on a conviction of burglary. His suspension expired December 20, 1967, and his probation expired December 20, 1968. His court costs and restitution have been paid. Subject was granted removal of political disabilities on July 2, 1979.

FORTUNE, JAMES WELLINGTON. Sentenced August 26, 1971, in the Circuit Court of Fredericksburg to five years with three years suspended for five years on a conviction of arson. He was paroled July of 1972, and discharged from parole November 6, 1972. His suspension expired in July of 1977. His court costs have been paid. Subject was granted removal of political disabilities on November 21, 1979.

FOSTER, DALLAS FORD. Sentenced October 20, 1965, in the Circuit Court of Page County to twelve months in jail on each of two counts of grand larceny. Subject was granted removal of political disabilities on November 20, 1979.

FRALIN, ROY LEE. Sentenced September 6, 1973, in the Circuit Court of Salem to five years on a conviction of sell a controlled drug, Marijuana. He was to serve twelve months with the remaining four years suspended and placed on probation for five years. His probation terminated by Court Order on September 20, 1976, and his suspension expired March 19, 1978. His court costs have been paid. On that same day in the Circuit Court of Roanoke County he was ordered to serve five years on each of two counts of distribution of a controlled drug, which were suspended and he was placed on probation for five years. His probation terminated September 7, 1976, and his suspension expired September 6, 1978. Court costs in this case have also been paid. Sentenced August 22, 1975, in the Circuit Court of Norfolk to four years on each count of possession of Cocaine, possession of Hashish and possession of LSD, which were suspended and he was placed on probation for three years and fined \$1,000. His probation terminated August 22, 1978, and his suspension expired August 22, 1979. His court

costs have been paid. Subject was granted removal of political disabilities on September 11, 1979.

FREEMAN, RANDOLPH STUART. Sentenced March 7, 1977, in the Circuit Court of Lynchburg to two years suspended and placed on probation for two years on a conviction of grand larceny by check. His probation terminated June 6, 1978, and his suspension expired March 7, 1979. His court costs have been paid. Subject was granted removal of political disabilities on July 2, 1979.

FULTON, WILLIAM HAROLD, JR. Sentenced July 10, 1963, in the United States District Court, Eastern District of Virginia, Newport News, to three years on a conviction of violation of Title 18, USCA, Section 656, twelve counts of bank embezzlement. He was ordered to serve three months with the remaining sentence suspended and placed on probation for three years, with each count to run concurrent. His probation expired October 22, 1966. Subject was granted removal of political disabilities on March 14, 1979.

GAMBILL, STEVEN LEE. Sentenced May 14, 1975, in the General Court of Justice, Superior Court Division, Pender County, North Carolina, to one year in jail suspended and fined \$150 plus costs on a conviction of felonious possession of marijuana. His fine and costs have been paid. Subject was granted removal of political disabilities on December 26, 1979.

GARCES, EDWARD ORDMORE. Sentenced March 5, 1956, in the Hustings Court of Portsmouth to three years and fined \$100 on a conviction of possession, etc., of narcotic drug, Heroin Hydrochloride. He was discharged from the Penitentiary on January 12, 1958, and his fine and court costs have been paid. Subject was granted removal of political disabilities on December 3, 1979.

GILES, AUSTIN BLANE. Sentenced February 4, 1976, in the Circuit Court of Prince William County to three years suspended and placed on probation for two years on a conviction of sodomy. His probation terminated June 9, 1977, and his suspension expired February 4, 1979. His court costs have been paid. Subject was granted removal of political disabilities on September 26, 1979.

GOLLUB, WILLIAM F., JR. Sentenced February 6, 1961, in the Superior Court, Lumpoc Judicial Circuit, Santa Barbara, California, to six to fifteen months on each of four counts of second-degree burglary, with each count to run concurrent. He was paroled May 7, 1962, and discharged August 7, 1963. Subject was granted removal of political disabilities on July 31, 1979.

GOURLEY, MARGARET COX. Sentenced November 3, 1960, in the Circuit Court of Hampton to thirteen months on a conviction of embezzlement. She was paroled April 5, 1961, and discharged from parole on October 15, 1962. Her court costs have been paid. Subject was granted removal of political disabilities on December 27, 1979.

GREEN, WILLIAM CALVIN. Sentenced November 17, 1965, in the Hustings Court of Roanoke to eighteen months on a conviction of possession of stolen property. He was paroled May 16, 1966, and discharged from parole November 16, 1967. His court costs have been paid. Subject was granted removal of political disabilities on November 20, 1979.

HARRIS, SHEPARD. Sentenced August 23, 1971, in the Corporation Court of Winchester to two years suspended and placed on probation for two years on a conviction of personal injury and leaving the scene of an accident. His suspension expired August 23, 1973, and his probation was terminated August 23, 1974. Restitution was settled out of court and all court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

HEMMINGS, SHELBY LEON. Sentenced July 29, 1974, in the Circuit Court of Chesapeake on a conviction of three counts of attempt to maim. On Counts 1 and 2 he received five years each which were suspended and he was placed on indefinite probation. On Count 3 he received twelve months in jail. His probation terminated August 9, 1976, and his suspension expired July 29, 1979. Subject was granted removal of political disabilities on September 17, 1979.

HENDERSON, JAMES GARLAND. Sentenced November 23, 1977, in the Circuit Court of King William County to twelve months in jail suspended for two years and placed on probation for two years on a conviction of grand larceny. His probation was terminated by Court Order on September 29, 1978, and his suspension expired November 23, 1979. Restitution and court costs have been paid. Subject was granted removal of political disabilities on December 27, 1979.

HESS, NHYLE LLOYD. Sentenced October 28, 1954, in General Court Martial Order No. 935, Headquarters Company, APO 500, to confinement at hard labor for one year and dishonorable discharge on a conviction of grand larceny. Subject was granted removal of political disabilities on September 27, 1979.

HESSLER, RICHARD ALLEN, JR. Sentenced January 10, 1974, in the Circuit Court of Prince William County to two years suspended and placed on probation for two years on a conviction of forgery. His probation terminated by Court Order on

November 22, 1974, and his suspension expired January 10, 1976. His court costs have been paid. Subject was granted removal of political disabilities on July 2, 1979.

HICKS, CARL LEE. Sentenced February 22, 1974, in the Circuit Court of Petersburg to five years suspended with the exception of sixty days, and placed on probation for two years upon his release on a conviction of possessing with intent to sell, give and distribute a controlled substance, Heroin. His probation terminated December 8, 1975, and his suspension expired February 22, 1979. His court costs have been paid. Subject was granted removal of political disabilities on July 2, 1979.

HILDENBRAND, RONALD DALE. Sentenced December 20, 1974, in the Circuit Court of Augusta County to six years on each of eight counts of grand larceny, with seven counts to run concurrent. He was paroled March 29, 1976, and discharged from parole October 2, 1978. His court costs have been paid. Subject was granted removal of political disabilities on March 30, 1979.

HINES, DANIEL WARNER. Sentenced January 13, 1975, in the Circuit Court of Waynesboro on a conviction of selling or distributing LSD, a Schedule I controlled substance, only as an accommodation. Imposition of sentence was suspended and he was placed on probation for an indefinite period of time. His probation terminated September 9, 1976, and his suspension terminated April 5, 1979. His court costs have been paid. Subject was granted removal of political disabilities on July 2, 1979.

HOLDREN, MICHAEL W. Sentenced January 13, 1976, in the Circuit Court of Roanoke City to two years suspended on a conviction of embezzlement. His suspension terminated January 13, 1976, and restitution and court costs have been paid. Subject was granted removal of political disabilities on March 30, 1979.

HOLLAND, PAUL. Sentenced June 6, 1977, in the Circuit Court of Lynchburg to six months in jail on each of two counts of forgery, and to sixty days in jail on each of two counts of uttering, with sixty days suspended and placed on probation for two years. His probation terminated August 20, 1979, and restitution and court costs have been paid. Subject was granted removal of political disabilities on December 28, 1979.

HORVATH, JULIUS THEODORE, SR. Sentenced June 6, 1977, in the Circuit Court of Botetourt County to twelve months in jail suspended and placed on probation for two years, to commence

upon his release from confinement, on a conviction of voluntary sodomy. His probation terminated July 27, 1978, and his suspension expired June 28, 1979. His court costs have been paid. Subject was granted removal of political disabilities on August 6, 1979.

HOUNSHELL, LARRY LYNN. Sentenced September 8, 1970, in the Circuit Court of Madison County to six months suspended and placed on probation for three years on a conviction of breaking and entering. His probation terminated May 1, 1972, and his court costs have been paid. Subject was granted removal of political disabilities on December 28, 1979.

HUNDLEY, WALTER LEWIS. Sentenced December 17, 1971, in the Circuit Court of Westmoreland County to twelve months in jail with six months suspended and placed on probation for two years on a conviction of unlawful wounding. His probation terminated April 17, 1974, and his court costs have been paid. Subject was granted removal of political disabilities on March 14, 1979.

HUTCHINSON, ROBERT FELDER. Sentenced May 3, 1974, in the Circuit Court of Newport News to five years with three years suspended and fined \$500 on a conviction of violation of Drug Control Act (possession with intent to distribute Marijuana and LSD). He was paroled November 25, 1974, and discharged from parole November 25, 1975. His suspension expired November 25, 1978, and his fine and court costs have been paid. Subject was granted removal of political disabilities on July 30, 1979.

JAGODA, PATRICIA WILSON. Sentenced January 9, 1973, in the Corporation Court of Alexandria on a conviction of possession of controlled drug with intent to distribute, Amphetamines. His probation terminated by Court Order on September 11, 1978, and his suspension expired September 15, 1979. His court costs have been paid. Subject was granted removal of political disabilities on September 27, 1979.

JOHNSON, EARL JUNIUS. Sentenced December 9, 1942, in the Hustings Court of Richmond on a conviction of housebreaking, with imposition of sentence suspended and placed on probation for three years. His suspension was revoked on May 12, 1943, and he was ordered to serve four years. On November 19, 1947,

in the Hustings Court of Richmond to one year on a conviction of unlawful wounding. There were no fines, court costs or restitution imposed. Subject was granted removal of political disabilities on March 30, 1979.

JOHNSON, WILLIAM THOMAS, JR. Sentenced December 12, 1961, in the Corporation Court of Norfolk, Part II, on a conviction of grand larceny. Imposition of sentence was suspended and he was placed on probation for three years. His court costs have been paid. Subject was granted removal of political disabilities on June 8, 1979.

JONES, EDWARD AVERETTE. Sentenced November 5, 1975, in the Circuit Court of Charlotte County to twelve months on each of four counts of grand larceny, with twenty-four months suspended and placed on probation for three years. His probation and suspension terminated by Court Order on September 6, 1977. Subject was granted removal of political disabilities on September 26, 1979.

JONES, HOYT DEMPSEY. Sentenced November 5, 1975, in the Circuit Court of Charlotte County to twelve months on each of two counts of grand larceny, with twelve months suspended for three years. His probation and suspension terminated by Court Order on September 6, 1977, and his court costs have been paid. Subject was granted removal of political disabilities on September 26, 1979.

JOYCE, EDDIE MILTON. Sentenced August 29, 1975, in the Circuit Court of Roanoke County to thirty days in jail and a fine of \$1,000 on a conviction of grand larceny. His fine has been paid. Subject was granted removal of political disabilities on March 30, 1979.

KELLEY, ELMER LEE. Sentenced March 4, 1965, in the Fulton County Superior Court, Fulton County, Georgia, to sixteen years on two counts of robbery, to serve four years with the balance suspended and placed on probation for twelve years upon release. His case was closed by Court Order on December 14, 1967. On November 14, 1967, in the Corporation Court of Danville, he was sentenced to ten years on a conviction of robbery. He was paroled April 18, 1973, and discharged from parole June 5, 1974. His court costs have been paid. Subject was granted removal of political disabilities on July 2, 1979.

three years on a conviction of violation of Title 18, USC, Sections 922(a)(1) and 922(a) and 2, dealing in firearms without a license. His probation terminated by Court Order on March 23, 1979, and no court costs were imposed. Subject was granted removal of political disabilities on July 31, 1979.

KRAUSS, FREDERIC JOHN. Sentenced July 10, 1962, in the Hustings Court of Richmond on a conviction of three counts of burglary. On Counts 1 and 2, imposition of sentence was suspended during his good behavior, and on Count 3, he was sentenced to eight years. Subject was granted removal of political disabilities on September 28, 1979.

LAMBERSON, DANIEL LEE. Sentenced May 16, 1975, in the Circuit Court of Petersburg to twelve months in jail on a conviction of accommodation sale of LSD. He was to serve sixty days with the remaining ten months suspended. His court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

LAMPE, MARK BYERS, SR. Sentenced June 15, 1976, in the United States District Court, Western District of Virginia, Harrisonburg, to two years suspended and placed on probation for three years and fined \$3,750, on a conviction of violation of Title 18, USC, Sections 922(a)(1)(5). Imposition of sentence was suspended and he was fined \$1,250, on a conviction of violation of Title 26, USC, Sections 5861(d) and 5871, Gun Control Laws. His probation expired June 26, 1979. Subject was granted removal of political disabilities on September 11, 1979.

LASCOLETTE, WARREN BRUCE. Sentenced January 25, 1974, in the United States District Court, District of Maryland, Baltimore, to nine months suspended and placed on probation for three years on a conviction of violation of Title 18, USC, Sections 371, 2312, 2313 and 2. His probation expired January 25, 1977, and no court costs were imposed. Subject was granted removal of political disabilities on September 6, 1979.

LAVERTY, JOHN JOSEPH. Sentenced November 25, 1974, in the Circuit Court of Lynchburg to three years on a conviction of statutory burglary. He was ordered to serve one year in jail with the remaining two years suspended and placed on probation for three years. His probation terminated by Court Order on October 28, 1975, and his suspension expired July 21, 1977. His court costs have been paid. Subject was granted removal of political disabilities on July 27, 1979.

LAWHORN, GORDON WAYNE. Sentenced July 5, 1972, in the Circuit Court of Richmond, Division I, on a conviction of distributing Hashish. Imposition of sentence was suspended and he was placed on probation for an indefinite period of

time. His probation terminated by Court Order on October 25, 1973, and his suspension was terminated by Court Order on November 5, 1979. His court costs have been paid. Subject was granted removal of political disabilities on November 21, 1979.

LAWSON, GALE CHARLES, JR. Sentenced November 28, 1972, in the Circuit Court of Wythe County to twelve months suspended for two years and probation for two years on a conviction of aiding in concealing stolen property. His probation terminated April 15, 1974, and his suspension expired November 28, 1974. His court costs have been paid. Subject was granted removal of political disabilities on July 27, 1979.

LEWIS, GRAYLING LAPEL. Sentenced October 14, 1976, in the Circuit Court of Charlottesville to four years suspended with the exception of thirty days, and placed on probation for two years on a conviction of statutory burglary. His probation and suspension terminated October 14, 1978, and his court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

LOCKETT, ANNIE MAE, aka Annie Mae Turner. Sentenced April 18, 1967, in the Hustings Court of Portsmouth to ten years on a conviction of murder. She was paroled March 1, 1972, and discharged from parole June 18, 1974. No court costs were imposed. Subject was granted removal of political disabilities on October 4, 1979.

LONG, MARK SHANNON. Sentenced April 29, 1938, in the Circuit Court of Rockingham County to one year and one day on a conviction of housebreaking. Subject was granted removal of political disabilities on August 23, 1979.

LOSER, CALVIN GRANT. Sentenced June 25, 1951, in the Hustings Court of Richmond to two years on a conviction of storebreaking. He was discharged from the Penitentiary on September 13, 1952. Subject was granted removal of political disabilities on December 28, 1979.

McALLISTER, PATRICIA AILEEN. Sentenced July 22, 1975, in the Circuit Court of Chesapeake on a conviction of possession of Amphetamines. Imposition of sentence was suspended for five years and she was placed on indefinite probation. Her suspension and probation terminated November 4, 1977, and her court costs have been paid. Subject was granted removal of political disabilities on May 15, 1979.

MABE, CAROLYN, aka Carolyn Mabe Thompson. Sentenced May 12, 1969, in the Circuit Court of Smyth County and

fined \$10 on a conviction of perjury. Her fine and court costs have been paid. Subject was granted removal of political disabilities on December 26, 1979.

MACK, JOHN ROBERT. Sentenced May 14, 1953, in the New York County Court not to exceed five years on a conviction of attempt robbery. He was paroled December 2, 1954, and his parole was revoked February 10, 1955. He was discharged from Elmira Reformatory by maximum expiration of sentence on March 24, 1958. Subject was granted removal of political disabilities on March 30, 1979.

MAIGE, MAURICE ANTHONY, JR. Sentenced August 4, 1978, in the Circuit Court of Fairfax to twelve months with eleven months suspended and placed on probation for twelve months and fined \$1,000 on a conviction of distributing a controlled drug as an accommodation. His probation terminated August 4, 1979, and his fine and court costs have been paid. Subject was granted removal of political disabilities on January 9, 1980.

MANN, WILLIAM K. Sentenced August 24, 1978, in the Circuit Court of Montgomery County to twelve months suspended and placed on probation for one year on a conviction of unlawful wounding. His suspension expired August 29, 1979, and his probation was terminated October 2, 1979. His court costs have been paid. Subject was granted removal of political disabilities on November 21, 1979.

MARSHALL, DON RICHARD. Sentenced January 15, 1974, in the Circuit Court of Henrico to five years with three years suspended and placed on probation for three years upon his release on a conviction of possessing with intent to distribute a Schedule I controlled substance, Marijuana. He was paroled March 21, 1975, and discharged from parole March 25, 1976. His suspension and probation expired March 21, 1978. Subject was granted removal of political disabilities on December 28, 1979.

MAURY, WILLIAM LEWIS. Sentenced June 4, 1974, in the Circuit Court of Roanoke City to eighteen months suspended and placed on unsupervised probation on a conviction of embezzlement. His suspension expired December 4, 1975, and his court costs have been paid. Subject was granted removal of political disabilities on September 26, 1979.

MAWYER, EDDIE CARSON. Sentenced April 11, 1977, in the Circuit Court of Albemarle County to two years suspended and placed on probation for one year on a conviction of breaking and entering. His probation terminated April 11, 1978, and his suspension expired April 11, 1979. His court costs have

been paid. Subject was granted removal of political disabilities on December 26, 1979.

MESSICK, JOSEPH PATTERSON, JR. Sentenced March 25, 1974, in the Circuit Court of Prince William County to five years with three years suspended and placed on probation for three years after release on a conviction of possession of Heroin. He was paroled October 15, 1974, and discharged from parole October 10, 1975. His probation and suspension expired October 15, 1977, and his court costs have been paid. Subject was granted removal of political disabilities on July 9, 1979.

MICKEY, WILLIAM, JR. Sentenced February 11, 1964, in the Circuit Court of Alexandria to five years on each of two counts of robbery, to run concurrent. He was paroled April 21, 1966, and discharged from parole October 23, 1967. His court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

MILES, ALPHONSO. Sentenced April 17, 1972, in the Circuit Court of Charles City County to two years suspended and placed on probation for two years on a conviction of unlawful wounding. His probation and suspension expired April 17, 1974. His court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

MILLER, HORTON WAYNE. Sentenced May 31, 1975, in the Circuit Court of Roanoke City to five years on a conviction of unlawful wounding. He was paroled June 30, 1977, and discharged from parole March 7, 1979. Subject was granted removal of political disabilities on July 2, 1979.

MINTON, WILLIAM A. JOHNNY. Sentenced December 13, 1955, in the Circuit Court of Lee County to twelve months in jail suspended upon good behavior on a conviction of involuntary manslaughter. His court costs have been paid. On June 22, 1975, in the United States District Court for the Western District of Virginia, Abingdon, he was suspended to one year suspended and probation for three years on a conviction of violation of Title 18, USC, App. 1202(a), possession of a firearm after having been convicted of a felony. His probation terminated August 13, 1973, and his suspension expired December 8, 1974. Restitution and court costs have been paid. Subject was granted removal of political disabilities on March 30, 1979.

MOSELEY, OSCAR ALPHONSO. Sentenced January 17, 1973, in the Hustings Court of Richmond, Part II, to four years with three years suspended on a conviction of attempt statutory burglary. His probation and suspension expired May 28, 1976, and his court costs have been paid. Subject was granted removal of political disabilities on September 6, 1979.

Sentenced December 13, 1971, in the Circuit Court of Rockingham County to one year on each of three counts of distributing a controlled substance (one count of LSD and two counts of Marijuana). He was paroled on November 22, 1972, and discharged from parole on June 11, 1974. His court costs have been paid. Subject was granted removal of political disabilities on September 14, 1979.

MURPHY, FOSTER ODELL. Sentenced June 27, 1975, in the Circuit Court of Grayson County to three years suspended and placed on probation for five years on a conviction of felonious assault. His probation terminated by Court Order on October 2, 1978, and his suspension expired June 27, 1978. Subject was granted removal of political disabilities on January 16, 1979.

He was paroled June 24, 1970, and discharged from parole December 22, 1971. His court costs have been paid. Subject was granted removal of political disabilities on March 14, 1979.

NORMAN, RONALD, aka Ronald Lowe Norman. Sentenced July 11, 1973, in the Circuit Court of Virginia Beach to three years suspended and placed on unsupervised probation for five years on a conviction of violation of Drug Control Act. Sentenced June 20, 1967, in the Circuit Court of Dickenson County to twelve months in jail with six months suspended on a conviction of forgery and uttering; on October 15, 1968, to six months in jail on a conviction of forgery and uttering; and on November 1, 1976 to five years probation on a conviction of robbery. His probation was terminated by Court Order on October 2, 1978. All court costs and restitution have been made. Subject was granted removal of political disabilities on November 20, 1979.

His suspension and probation terminated by Court Order on November 28, 1978, and his court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

PAYNE, DAVID LIGON. Sentenced March 27, 1974, in the Circuit Court of Norfolk to five years on a conviction of voluntary manslaughter. He was paroled November 15, 1976, and discharged from parole November 1, 1978. His court costs have been paid. Subject was granted removal of political disabilities on November 20, 1979.

Sentenced June 23, 1977, in the United States District Court, Western District of Virginia, Roanoke, and fined \$1,500 with imposition of sentence as to imprisonment only suspended and placed on probation for two years on convictions of violation of Title 18, USC, 922(a)(1), 923, and 924(a) and violation of Title 18, USC, 922(a)(5), 923, and 924(a), unlicensed firearm dealer. His probation terminated August 1, 1978, and his fine has been paid. Subject was granted removal of political disabilities on February 14, 1979.

Sentenced September 14, 1966, in the Circuit Court of Campbell County to ten years suspended and placed on probation for five years on a conviction of aiding and abetting in armed robbery. His probation expired September 14, 1971, and his suspension expired September 14, 1976. His court costs have been paid. Subject was granted removal of political disabilities on July 5, 1979.

PLEASANTS, SALLIE ANNE. Sentenced March 3, 1976, in the United States District Court, Eastern District of Virginia, Richmond, to two years suspended and probation for three years on a conviction of violation of Title 18, USC, Section 656, embezzlement. Her suspension expired March 3, 1978, and her probation terminated December 21, 1978. No court costs were imposed. Subject was granted removal of political disabilities on July 27, 1979.

POFF, RALPH. Sentenced September 22, 1971, in the Circuit Court of Salem to one year on a conviction of habitual offender. He was discharged May 30, 1972. Subject was granted removal of political disabilities on December 19, 1979.

POSS, BRADLEY LAWRENCE. Sentenced January 26, 1973, in the Circuit Court of Fairfax County on a conviction of two counts of distributing a controlled drug, Marijuana. On Count 1 he received two years suspended and probation for two years, and on Count two he was sentenced to three years suspended and probation for three years, with sentences to run consecutively. Subject was granted removal of political disabilities on November 20, 1979.

Sentenced February 18, 1977, in the Circuit Court of Martinsville to twelve months in jail with eight months suspended and placed on unsupervised probation for two years and fined \$300 on a conviction of perjury. His probation expired September 15, 1979, and his fine and court costs have been paid. Subject was granted removal of political disabilities on September 27, 1979.

PRILLAMAN, PAUL LEWIS. Sentenced April 12, 1973, in the United States District Court, Western District of Virginia, Harrisonburg, and fined \$750 on convictions of violation of Title 18, USC, Sections 842(j) and 844(b), and of violation of Title 26, USC, Sections 5861(d), and 5871; on June 13, 1973, in the Circuit Court of Warren County to one year suspended and probation for two years on a conviction of grand larceny, with probation expiring April 11, 1975; and on January 23, 1976, in the United States District Court, Western District of Virginia, Harrisonburg, on a conviction of violation of Title 18, USC, Sections 922(g) and 924(a), App. 1202(a), interstate guns, fraudulent statements, official documents. Subject was granted removal of political disabilities on June 8, 1979.

Imposition of sentence was deferred and he was placed on probation for three years. Probation and suspension expired July 19, 1968. His court costs have been paid. Subject was granted removal of political disabilities on November 23, 1979.

ROBINSON, WALTER GREENLEE, JR. Sentenced March 17, 1971, in the Circuit Court of Campbell County to twelve months in jail suspended and probation for three years on a conviction of receiving stolen property. His probation expired April 21, 1974, and his court costs have been paid. Subject was granted removal of political disabilities on May 15, 1979.

SEALOCK, JAMES EDWARD, JR. Sentenced August 5, 1970, in the Circuit Court of Warren County to five years on a conviction of voluntary manslaughter. He was paroled March 9, 1972, and

discharged from parole on November 9, 1973. His court costs have been paid. Subject was granted removal of political disabilities on July 2, 1979.

SHARPE, JERRY THOMAS. Sentenced December 18, 1953, in the Circuit Court of Carroll County to one year on a conviction of unlawful assault. He was paroled May 20, 1954, and discharged from parole December 28, 1955. His court costs have been paid. Subject was granted removal of political disabilities on November 20, 1979.

SMITH, COURTNEY CLIFFORD. Sentenced May 5, 1977, in the United States District Court, Eastern District of Virginia, Richmond, on a conviction of violation of Title 18, USC, Sections 922(a)(1), 923 and 924(a), engaging in the business of dealing in firearms without a license. Imposition of sentence was suspended and placed on unsupervised probation for one year. His probation terminated May 18, 1978. Subject was granted removal of political disabilities on November 21, 1979.

SMITH, JAMES ROBERT. Sentenced February 17, 1969, in the Circuit Court of Dinwiddie County on a conviction of malicious shooting. Imposition of sentence was suspended for five years and he was placed on probation for five years. His probation terminated May 23, 1972, and his suspension expired February 17, 1974. His court costs have been paid. Subject was granted removal of political disabilities on December 26, 1979.

SPENCER, BARRY SNEAD, aka Barry Sneed Spencer. Sentenced July 28, 1960, in the Hustings Court of Richmond, Part I, on a conviction of grand larceny and statutory burglary. Imposition of sentence was suspended and placed on probation for five years. Probation terminated by Court Order on May 25, 1961, and suspension expired July 28, 1965. Subject was granted removal of political disabilities on January 19, 1979.

SPIELBERGER, JAMES H., JR. Sentenced April 24, 1973, in the Circuit Court of Hampton to three years suspended and probation for three years on a conviction of possession of LSD. His probation terminated April of 1975, and his suspension expired April 24, 1976. His court costs have been paid. Subject was granted removal of political disabilities on December 27, 1979.

STARKE, ROBERT NELSON. Sentenced June 12, 1969, in the Circuit Court of Brunswick County on three counts of receiving stolen property. Imposition of sentence was withheld for ten years and he was placed on probation for ten years. His probation terminated May 24, 1971, and his suspension expired

June 12, 1979. His court costs have been paid. Subject was granted removal of political disabilities on July 27, 1979.

STELL, CARLTON LEE. Sentenced November 30, 1970, in the Circuit Court of Colonial Heights to six months in jail with five months suspended and fined \$300 on a conviction of hit and run, personal injury. His fine and court costs have been paid. Subject was granted removal of political disabilities on August 23, 1979.

STOCKTON, FRANCIS RICHARD. Sentenced March 13, 1973, in the Circuit Court of Alexandria to five years suspended and probation for five years on a conviction of possession of Marijuana with intent to distribute. His probation terminated by Court Order on March 15, 1977, and his suspension expired March 18, 1978. His court costs have been paid. Subject was granted removal of political disabilities on August 23, 1979.

STROOP, LINDEN WAYNE, SR. Sentenced October 5, 1977, in the Circuit Court of Shenandoah County to twelve months on a conviction of involuntary manslaughter. He was ordered to serve three months with the remaining nine months suspended and probation for one year. His suspension expired July 5, 1977, and his probation expired October 21, 1978. His court costs have been paid. Subject was granted removal of political disabilities on July 2, 1979.

SWANNER, HENRY L. Sentenced February 19, 1975, in the United States District Court, Eastern District of Virginia, Norfolk, on a conviction of violation of Title 18, USC, Section 201(f). Imposition of sentence was suspended and he was placed on probation for three years and fined \$5,000. His probation expired February 19, 1978, and his fine has been paid. Subject was granted removal of political disabilities on March 16, 1979.

TATE, ALLEN CHARLES, JR. Sentenced March 15, 1973, in the Circuit Court of Westmoreland County to five years with three years suspended for five years and probation for five years on a conviction of distribution of controlled drugs. His probation terminated by Court Order on November 29, 1976, and his suspension expired March 15, 1978. His court costs have been paid. Subject was granted removal of political disabilities on August 23, 1979.

TAYLOR, CLARENCE FREDERICK, aka Clarence Johnson. Sentenced May 1, 1944, in the Corporation Court of Norfolk, under the alias of Clarence Johnson, to eight years on a conviction of robbery. He was paroled December 22, 1947, and discharged August 24, 1949. On December 2, 1970, in the Circuit Court of

Norfolk, under the name of Clarence Frederick Taylor, he was sentenced to two years on a conviction of malicious wounding. He was paroled August 17, 1971, and discharged from parole on February 21, 1973. His court costs have been paid. Subject was granted removal of political disabilities on May 16, 1979.

THOMPSON, THOMAS FLOYD, JR. Sentenced May 12, 1969, in the Circuit Court of Smyth County and fined \$150 and ninety days in jail on a conviction of perjury; and on June 2, 1969, to three years suspended and probation for four years on a conviction of grand larceny. His probation expired July 12, 1973. His fine and court costs have been paid. Subject was granted removal of political disabilities on December 26, 1979.

THORNES, DONALD RAY. Sentenced July 20, 1966, in the United States District Court, Eastern District of Virginia, Norfolk, on a conviction of violation of Title 18, USCA, Section 2312, interstate transportation of stolen motor vehicle. Imposition of sentence was suspended for four years and placed on probation, which terminated August 14, 1968. Subject was granted removal of political disabilities on February 14, 1979.

TRUMP, EARL BOYD. Sentenced October 14, 1954, in the Circuit Court of Montgomery County to five years on each of two counts of statutory burglary, with one count to run concurrent. He was discharged from the Penitentiary on February 11, 1968; on October 9, 1956, in the Circuit Court of Fairfax County to two years on a conviction of statutory burglary. He was discharged from the Penitentiary on August 22, 1960; and on October 21, 1959, in the Circuit Court of Montgomery County to four years on each of three counts of statutory burglary, with each count to run concurrent. He was to serve one year with the remaining three years suspended and probation for five years. His probation terminated April 1, 1963, and his suspension expired April 1, 1966. TUCKER, REGINA GALE. Sentenced July 10, 1974, in the Circuit Court of Lynchburg to three years suspended and probation for three years on a conviction of embezzlement. Her probation terminated June 9, 1977, and her suspension expired July 10, 1977. Restitution and court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

TUREK, CAROLYN MARIE. Sentenced July 12, 1976, in the Circuit Court of Colonial Heights on a conviction of conspiracy to distribute marijuana. Imposition of sentence was suspended for ten years and placed on probation for indefinite period of time. Her probation terminated July 18, 1977, and her

suspension terminated by Court Order on July 25, 1979. Her court costs have been paid. Subject was granted removal of political disabilities on August 10, 1979.

TYDINGCO, CARLOS LEYAN. Sentenced August 27, 1969, in the Corporation Court of Norfolk to six months in jail suspended and probation for one year and fined \$300, on a conviction of felony hit and run. His fine and court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

TYREE, BENJAMIN FRANKLIN. Sentenced January 19, 1961, in the Hustings Court of Roanoke to eighteen months on a conviction of statutory burglary. Subject was granted removal of political disabilities on August 6, 1979.

VANHORN, VANCE M., SR. Sentenced September 12, 1963, in the United States District Court, Northern District of Florida, Tallahassee, to three years on a conviction of interstate transportation of forged securities. He was paroled on December 8, 1964, and discharged September 10, 1966. Subject was granted removal of political disabilities on November 20, 1979.

Sentenced November 21, 1974, in the United States District Court, Eastern District of Virginia, Richmond, to two years on a conviction of violation of Title 18, USC, Section 4, concealing and failing to make known as soon as possible the commission of a felony. He was ordered to serve six months with the remainder of the sentence suspended and

probation for two years. His probation terminated November 25, 1976; and on January 20, 1977, in the Circuit Court of Norfolk to two years on a conviction of forgery, to serve thirty days with the remaining sentence suspended and unsupervised probation for two years. His suspension and probation expired January 20, 1979. His restitution and court costs have been paid. Subject was granted removal of political disabilities on March 16, 1979.

WASHINGTON, EDWARD JEROME. Sentenced April 26, 1967, in the Circuit Court for the City of Williamsburg and County of James City to twenty years with ten years suspended and probation for five years upon release on a conviction of second-degree murder. He was paroled October 15, 1969, and discharged from parole July 19, 1973. His probation expired October 15, 1974, and his suspension expired October 15, 1979. His court costs have been paid. Subject was granted removal of political disabilities on December 27, 1979.

WASHINGTON, JOHN LLOYD. Sentenced May 20, 1957, in the Hustings Court of Roanoke to sixty days in jail and fined \$10 on a conviction of statutory burglary with intent to commit larceny. His fine has been paid. Subject was granted removal of political disabilities on March 30, 1979.

WHEELER, MICHAEL LEE. Sentenced January 20, 1971, in the Corporation Court of Danville to twelve months in jail and fined \$250 on a conviction of unlawful wounding. On May 21, 1971, the balance of his sentence was suspended, and he was placed on probation for two years. His suspension expired January 20, 1971, and his probation expired May 21, 1973. His fine and court costs have been paid. Subject was granted removal of political disabilities on August 23, 1979.

WHITE, DONALD GLEN. Sentenced December 15, 1975, in the United States District Court, Western District of Virginia, Abingdon, to three years suspended and probation for three years on a conviction of violation of Title 18, USC, Sections 922(a)(6), 924(a) and Title 18, App USC 1202(a), violation of Gun Control Law. His probation and suspension expired December 15, 1978. Subject was granted removal of political disabilities on October 4, 1979.

WHITE, FRANCIS, W., III. Sentenced June 7, 1974, in the Circuit Court of Fairfax County to five years suspended and probation for three years on a conviction of distributing a controlled drug, Marijuana. His probation terminated September 8, 1976, and his suspension expired June 7, 1979. His court costs have been paid. Subject was granted removal of political disabilities on September 27, 1979.

WHITE, ROBERT HENRY. Sentenced September 11, 1973, in the Circuit Court of Virginia Beach to five years suspended and probation for five years on a conviction of violation of Drug Control Act. His probation and suspension expired September 11, 1978. His court costs have been paid. Subject was granted removal of political disabilities on February 14, 1979.

WHITTIES, EUGENE SAMUEL. Sentenced March 21, 1973, in the Circuit Court of Arlington to five years on a conviction of distribution of a controlled substance, Heroin, as an accommodation. His sentence expired March 21, 1978, and his court costs have been paid. Subject was granted removal of political disabilities on April 24, 1979.

WILLIAMS, DAVID MARK. Sentenced May 2, 1977, in the United States District Court, Eastern District of Virginia, Richmond, on a conviction of violation of Title 18, USC, Section 371, conspiracy to unlawfully deal in firearms without a license. Imposition of sentence was suspended and he was placed on probation for five years and fined \$1,000. His probation and suspension terminated November 20, 1979. His fine has been paid. Subject was granted removal of political disabilities on December 28, 1979.

WILLIAMS, MARY ELLEN. Sentenced September 24, 1975, in the Circuit Court of Prince William County to two years suspended and probation for two years on a conviction of forgery of credit card. Her probation terminated April 27, 1979, and her court costs have been paid. Subject was granted removal of political disabilities on December 26, 1979.

WILSON, AULTON LOPAL. Sentenced August 8, 1972, in the Corporation Court of Norfolk, Part II, to four years suspended and probation for three years on a conviction of possession of controlled drugs; heroin, methadone and codeine. His probation expired August 8, 1975, and his suspension expired August 8, 1976. His court costs have been paid. Subject was granted removal of political disabilities on March 16, 1979.

WILSON, BERNARD GARY, aka Gary Wilson. Sentenced January 20, 1971, in the Circuit Court of Virginia Beach to three years on Counts 1 through 4 of violation of Uniform Narcotic Act, to run concurrent with Count 5, for which he received five years. He was paroled January 20, 1973, and discharged from parole on May 22, 1973. No court costs were imposed. Subject was granted removal of political disabilities on May 16, 1979.

WILSON, CHARLES GERALD. Sentenced May 21, 1963, in the Circuit Court of Pittsylvania County to twelve months suspended and probation for two years on a conviction of grand larceny

and unauthorized use of auto, and fined \$10. On January 21, 1964, in the Corporation Court of Danville, he was sentenced to twelve months on a conviction of grand larceny of auto. Subject was granted removal of political disabilities on May 16, 1979.
