ABSOLUTE PARDON

CHRISTIAN, MILTON. Sentenced March 24, 1977, in the Circuit Court of Richmond, Division 1, upon a conviction of Possession of Heroin with intent to distribute and sentenced to twenty years, and of Possession of Preludin and sentenced to one year. Based upon after-discovered evidence throwing serious doubt upon the credibility of the arresting officers, whose testimony constituted the sole evidence for the prosecution, the Parole Board recommending, the Honorable Aubrey M. Davis, Jr., and the Honorable J. Randolph Tucker, Jr., not objecting, I am granting Milton Christian an Absolute Pardon, and order that the aforesaid offenses be removed from any and all records upon which they may appear. This Pardon, however, is not to affect any other sentence which Milton Christian is now serving or may have to serve in the future. This pardon dated May 27, 1980.

CONDITIONAL PARDON

FARIS, WAYNE DEWEY, JR. Sentenced December 21, 1976, in the Circuit Court of Pittsylvania County upon a conviction of Possession of Marijuana with intent to distribute and sentenced to twenty-years. Chapter 435 of the 1979 Acts of Assembly reduces the penalty for certain criminal offenses involving the possession, manufacture, cultivation, distribution or sale of marijuana, and there are certain inmates presently confined within the Virginia Department of Corrections who are serving sentences which exceed the maximum sentences which could be imposed pursuant to Chapter 435. It appears to me that Wayne Dewey Faris, Jr., No. 110348, is such an inmate; and in the absence of Executive Clemency such inmates would receive no benefit from Chapter Therefore, I am granting him a Conditional Pardon for the conviction herein named and do order that he be relieved of any unserved sentence which exceeds ten years, upon the condition that he be placed under the supervision of the Virginia Parole Board for a period of five years, to commence upon his release from incarceration. The Pardon granted hereby shall have no effect upon any other sentence which the said Wayne Dewey Faris, Jr., No. 110348, is serving or which he may have to serve in the future. This pardon dated July 24, 1980.

JACOBSEN, WILLIAM GEORGE. Sentenced September 7, 1961, in the Circuit Court of Princess Anne County upon a conviction of two counts of Attempted rape and sentenced to Death on each count and of two counts of Malicious wounding and sentenced to twenty years on each count. On the two counts of Attempted rape, Mr. Jacobsen was originally sentenced to death by electrocution. These sentences were commuted to life imprisonment by Governor J. Lindsey Almond, Jr., on December 6. 1961. Under present law, these offenses would constitute Class 4 felonies, carrying maximum penalties of ten years for each conviction. Mr. Jacobsen has served nineteen years while stablizing a remarkable correctional record. It is apparent to me that further incarceration would be of no benefit to him or to the safety of the Commonwealth. However, under § 53-251 of the Code of Virginia, Mr. Jacobsen will never become eligible for parole. Considering the foregoing facts, and upon the favorable recommendation of the Parole Board, the present Commonwealth's Attorney and the Circuit Court of Virginia Beach (formerly Princess Anne County) voicing no objection, I am hereby granting William George Jacobsen a Conditional Pardon. I order that he be released forthwith from the custody of the Virginia Department of Corrections and placed under the supervision of the Virginia Parole Board until December 18, 1985, under such conditions as it may impose, and with the special condition that he participate in such alcoholic rehabilitation programs as his Parole Officer may direct. I further order that should he be found guilty of violation of the penal laws of any city, county, State, or of the United States prior to December 18, 1990, this Pardon shall remain subject to revocation. This pardon dated December 18, 1980.

REVOCATION OF CONDITIONAL PARDON

DAVIDSON, PAUL MACK. Sentenced on January 4, 1979, in the Circuit Court of Danville upon a conviction of uttering a forged prescription and sentenced to four years, and of attempt to utter a forged prescription and sentenced to four years with three years suspended. On September 6, 1979, I granted Mr. Davidson a Conditional Pardon and ordered that he be placed under the supervision of the Virginia Parole Board. The Pardon further stipulated that should he violate any of the conditions prior to May 9, 1982, or be found guilty of violation of the penal laws of any city, county, State or of the United States, this pardon may be revoked. The Subject has now been returned to confinement as a result of violation of Condition 1 of the Parole Conditions, a conviction in the General District Court of Henry County on March 19, 1980, on the charge of Speeding, for which he was fined \$60 and required to pay costs of court, and for violation of Condition 4, operating a motor vehicle after having been instructed by his parole officer not to do so. I have reviewed the Parole Board's recommendation and a copy of the hearing transcript, and have discussed this matter with both Mr. Davidson and his attorney, John Swezey. In view of the developments in this case, I do hereby revoke the Conditional Pardon granted Paul Mack Davidson on September 6, 1979. This revocation dated July 31, 1980.

PARDON WITHOUT CONDITIONS

JACOBSON, DAVID JUNIOR. Sentenced October 20, 1978, in the Circuit Court of Prince William County upon a conviction of Second-degree Murder and sentenced to twenty years with five years suspended. In view of the fact that this man has terminal cancer with a life expectancy of four to six months, and upon the unanimous recommendation of the Parole Board, the prosecuting Commonwealth's Attorney and the sentencing Judge, I am granting David Junior Jacobson a Pardon Without Conditions, and order that he be released forthwith from the Department of Corrections. This pardon dated December 18, 1980.

SIMPLE PARDON

BLEDSOE, CHARLES DELAND. Sentenced February 7, 1970, in the Hustings Court of Richmond upon a conviction of Possession of narcotic drug and sentenced to twenty years. In view of the excellent rehabilitative progress made by this individual since his release from incarceration

and the assistance he has rendered to the criminal justice process here in the Commonwealth and upon the recommendation of the Parole Board, I am granting him a Pardon. This pardon dated July 8, 1980.

BROWN, HENRY, JR. Sentenced February 24, 1953, in the Hustings Court of Portsmouth upon a conviction of Unauthorized use of auto and sentenced to twelve months in jail and fined \$100; and on April 3, 1968, in the Corporation Court of Norfolk upon a conviction of two counts of grand larceny and sentenced to five years on each count to run concurrent. He was paroled January 21, 1970, and discharged July 22, 1971, and his fine has been paid. In view of this man's excellent rehabilitation since his release from incarceration and the fact that he has become a well-respected and contributing member of his community, the Parole Board recommending, the Commonwealth's Attorney of Portsmouth not objecting, the sentencing Judge not having any comments, the present Commonwealth's Attorney of Norfolk not objecting, the former Commonwealth's Attorney of Norfolk leaving the matter to my discretion, and the sentencing Judge having no objection, I am granting Henry Brown, Jr., a Pardon. This pardon dated May 29, 1980.

CHAPMAN, GREGORY PORTER. Sentenced January 11, 1967, in the Municipal Court of Portsmouth upon a conviction of committing nuisance and fined \$10 and costs, assault on a Police Officer and fined \$25 and costs, resist arrest and fined \$25 and costs, and disorderly conduct and fined \$25 and costs. In view of this man's desire to enter the field of law enforcement, the recommendation of the Parole Board, the Chief Judge of the General District Court and the present Commonwealth's Attorney not objecting, I am granting him a Pardon. This pardon dated April 4, 1980.

DECKER, KENNETH THAD. Sentenced December 20, 1974, in the Juvenile and Domestic Relations District Court of Norfolk upon a conviction of contributing to the delinquency of a minor and sentenced to six months in jail suspended and fined \$100. In view of this man's contributions to his community and his desire to return to the field of law enforcement, the Parole Board and sentencing Judge recommending, the Commonwealth's Attorney not responding to our inquiry, I am granting him a Pardon. This pardon dated April 10, 1980.

HERRELL, ROBERT WILLIAM. Sentenced October 27, 1972, in the Circuit Court of Frederick County upon a conviction of grand larceny and sentenced to twelve months in jail with ten months suspended for three years upon release. In view of this man's excellent rehabilitation and his participation in community affairs, the recommendations of the Parole Board, the Commonwealth's Attorney, the sentencing and current Judges, I am granting him a Pardon. This pardon dated April 9, 1980.

LONG, MARK SHANNON. Sentenced April 29, 1938, in the Circuit Court of Rockingham County upon a conviction of Housebreaking and sentenced to one year and one day. In view of this man's outstanding contributions to his Country and to the Commonwealth, the recommendation of the Parole Board, the current Judge and Commonwealth's Attorney not objecting, I am granting him a Pardon. This pardon dated April 1, 1980.

THOMPSON, POWELL STANLEY, JR. Sentenced November 7, 1947, in the Circuit Court of Henrico County upon a conviction of Highway robbery and sentenced to three years; on December 14, 1948, in the Hustings Court of Richmond upon a conviction of Escape and sentenced to one year; and on November 14, 1949, in the Circuit Court of Wise County upon a conviction of Escape and sentenced to one year, respectively. In view of this man's excellent rehabilitation since his release from confinement, the Parole Board's recommendation, and there being no objection on the part of the present Commonwealth's Attorney of Henrico County, I am granting him a Pardon. This pardon dated August 7, 1980.

THURSTON, SHEILA KURTZ, aka Sheila Kaye Thurston McCreary. Sentenced April 23, 1973, in the Hustings Court of Newport News upon a conviction of three counts of violation of Drug Control Act and sentenced to five years on each count, suspended, placed on probation for five years each count, and fined \$5.00 on each count. In view of this woman's excellent rehabilitation since her conviction, the recommendation of the Parole Board, the Commonwealth's Attorney not objecting, and the current Judge of the Circuit Court of Newport News, the Honorable Henry D. Garnett, neither recommending nor opposing the petition, I am granting her a Pardon. This pardon dated July 2, 1980.

TOWNE, ARNOLD JAMES. Sentenced July 9, 1945, in the Hustings Court of Richmond upon a conviction of bigamy and sentenced to three years. In view of this man's contributions to his community, the recommendations of the Parole Board and members of the judicial system of the State in which this individual now resides, the present Commonwealth's Attorney of Richmond not objecting, I am granting him a Pardon. This pardon dated July 8, 1980.

VOSS, DAVID GARVIN. Sentenced August 30, 1976, in the Circuit Court of Roanoke County upon a conviction of grand larceny and sentenced to two years suspended after serving eighteen months in jail and placed on probation for five years upon release. Relying on the recommendation of the Parole Board, the Commonwealth's Attorney not objecting and the Judge taking no position, and in view of this individual's success at rehabilitation, I am granting him a Pardon. This pardon dated December 16, 1980.

WORNSTAFF, MARILYNN D., aka Marilynn D. Meyer. Sentenced October 30, 1978, in the General District Court of Norfolk upon a conviction of worthless check and fined \$25 suspended for twelve months plus costs of court. In order for this individual to be accepted as a law enforcement officer with the City of Norfolk, and in view of the unanimous recommendation by the members of the Parole Board and the sentencing Judge and the Commonwealth's Attorney having no objection, I am granting her a Pardon. This pardon dated January 9, 1981.

REMOVAL OF POLITICAL DISABILITIES

Relying on the recommendations of parole officers and reputable citizens who are familiar with the conduct of these individuals since their conviction or release, I have granted removal of political disabilities to the following:

ABERNATHY, CHARLES MAC. Sentenced September 30, 1960, in the Hustings Court of Richmond City upon a conviction of Robbery and sentenced to eight years with three years suspended; and on November 23, 1960, upon a conviction of first-degree Murder and sentenced to twenty years. He was paroled March 19, 1974, and discharged January 5, 1977. His court costs have been paid. He was granted removal of political disabilities on January 5, 1981.

ADAMS, JAMES CURTIS. Sentenced August 3, 1978, and May 3, 1974, respectively, in the Circuit Court of Wise County upon a conviction of Involuntary Manslaughter, and Felonious assault with a loaded weapon and Felonious assault on a police officer, respectively, and sentenced to two years suspended and placed on probation for two years, and twelve months with eleven months suspended, respectively. His court costs have been paid. He was granted removal of political disabilities on November 6, 1980.

ADAMS, MAURICE, JR. Sentenced August 12, 1975, in the Circuit Court of Alexandria upon a conviction of Unlawful wounding and sentenced to eight years with four years suspended and placed on probation for four years upon release. He was paroled July 2, 1976, and discharged February 24, 1978. His probation terminated August 23, 1979, and his suspension expired July 2, 1980. His court costs have been paid. He was granted removal of political disabilities on August 19, 1980.

ADAMS, PRESLEY WILLIAM. Sentenced July 18, 1938, in the Circuit Court of Halifax County upon a conviction of Breaking into a hen house and stealing \$12 worth of chickens and sentenced to two years suspended and no court costs imposed. He was granted removal of political disabilities on June 19, 1980.

ADKINS, JERRY EDWARD aka Jerry Edward Atkins. Sentenced December 27, 1972, in the Circuit Court of Franklin County upon a conviction of Distribute Marijuana and sentenced to five years, to serve eighteen months with balance suspended upon release and placed on probation for four years. He was paroled July 31, 1973, and discharged August 14, 1974. His suspension and probation were terminated August 21, 1975, and his court costs have been paid. He was granted removal of political disabilities on September 10, 1980.

ALIEN, JAMES LLOYD, III. Sentenced April 27, 1978, in the Circuit Court of Norfolk upon a conviction of Statutory Burglary and sentenced to four years with two years suspended and placed on probation for two years. His court costs have been paid. He was granted removal of political disabilities on October 16, 1980.

AMBROSE, NORMAN RAY. Sentenced March 21, 1971, in the Circuit Court of Isle of Wight County upon a conviction of Robbery and Maiming and sentenced to five years, and four years to run concurrent, respectively. He was paroled August 29, 1972, and discharged July 29, 1974. He was granted removal of political disabilities on April 1, 1980.

AMBURN, EDWARD RYAN. Sentenced January 19, 1972, in the Circuit Court of Virginia Beach upon a conviction of two counts of statutory

burglary and sentenced to four years each count to run concurrent, suspended and placed on probation. His probation was terminated December 21, 1973, and his suspension expired on January 19, 1976. His court costs have been paid. He was granted removal of political disabilities on July 22, 1980.

AMES, ALLEN EDWARD. Sentenced July 18, 1975, in the Circuit Court of Norfolk upon a conviction of five counts of uttering with imposition of sentence suspended and he was placed on probation forthree years. His suspension and probation expired July 18, 1978, and his court costs have been paid. He was granted removal of political disabilities on February 20, 1980.

ANDERSON, BUDDY ROOSEVELT. Sentenced May 13, 1958, in the United States District Court for the Eastern District of North Carolina, Raleigh, upon a conviction of Violation of Title 26, USC, Section 7206(4) and sentenced to one year and one day suspended and placed on probation for two years and fined \$500; and on October 16, 1958, in the United States District Court, Western District of Virginia, Danville, upon a conviction of violation of Title 18, USC, Section 371, with imposition of sentence suspended for two years and placed on probation for two years. His fine has been paid. He was granted removal of political disabilities on September 10, 1980.

ANDERSON, FRED DAVID. Sentenced January 31, 1948; November 16, 1953; and September 19, 1957, respectively, in the Circuit Court of Suffolk upon a conviction of Felonious assault and sentenced to four years; of Unlawful assault and sentenced to nine months in jail; and of Malicious maiming and sentenced to three years, respectively. His court costs expired under Statute of Limitations. He was granted removal of political disabilities on September 12, 1980.

ARMEL, CHARLES ROBERT, JR. Sentenced September 29, 1978, in the Circuit Court of Warren County upon a conviction of Solicitation of a felony and Felonious Assault and sentenced to twelve months in jail suspended and placed on probation for twelve months beginning September 13, 1979. His probation was terminated September 13, 1980, and his court costs have been paid. He was granted removal of political disabilities on October 9, 1980.

ASHBURN, DENNIS RAY. Sentenced November 30, 1977, in the Circuit Court of Martinsville upon a conviction of Possession of sawed-off shotgun and sentenced to two years with one year eight months suspended and placed on probation for two years. His probation expired February 27, 1980, and his court costs have been paid. He was granted removal of political disabilities on September 10, 1980.

ATWELL, FRED LEE, JR. Sentenced February 2, 1971, in the Superior Court of Concord, North Carolina, upon a conviction of Statutory burglary and Larceny and sentenced to two to six years, discharged from parole September 7, 1972; and on March 1, 1974, in the Circuit Court of Hampton upon a conviction of Grand larceny and sentenced to four years suspended and placed on probation for four years, which terminated February 1, 1977, and suspension expired March 1, 1978.

His court costs have been paid. He was granted removal of political disabilities on December 5, 1980.

BAKER, RONALD OWEN. Sentenced May 22, 1975, in the Circuit Court of Roanoke City upon a conviction of Grand Larceny and sentenced to two years suspended after serving six months and placed on probation for five years, which was terminated February 16, 1979; and on June 19, 1975, in the Circuit Court of Botetourt County upon a conviction of Breaking and entering with intent to commit larceny and sentenced to two years suspended after serving six months and placed on probation for three years, to run concurrent with the Grand Larceny conviction. His probation was terminated June 5, 1978, and his court costs have been paid. He was granted removal of political disabilities on December 31, 1980.

BARNES, SUMNER HORATIO, JR. Sentenced April 21, 1967, in the Circuit Court of Charlottesville upon a conviction of Malicious Wounding and sentenced to five years suspended and revoked on June 24, 1970. He was paroled on November 3, 1971, and discharged October 12, 1973. His court costs have been paid. He was granted removal of political disabilities on November 14, 1980.

BASHAM, WILLIAM EDWARD, aka William Edward Basham, Jr. Sentenced May 29, 1975, in the Circuit Court of Roanoke City upon a conviction of Malicious wounding and sentenced to five years suspended after serving three months in jail and placed on unsupervised probation for five years; and on September 7, 1977, in the Circuit Court of Roanoke City upon a conviction of being an Habitual Offender and sentenced to three years suspended and placed on probation for three years. His probation on both convictions was terminated April 2, 1979, and his suspension expired September 7, 1980. His court costs have been paid. He was granted removal of political disabilities on September 12, 1980.

BAUMGARDNER, MICHAEL ELLISON. Sentenced May 19, 1969, in the Circuit Court of Frederick County, Maryland, upon a conviction of Possession and control of Narcotic Drug and Amphetamine, and Selling Narcotic Drug and Amphetamine and sentenced to three years with one year suspended and one year to run concurrent. His court costs have been paid. He was granted removal of political disabilities on March 31, 1980.

BEACH, DOUGLAS ALBRIGHT. Sentenced January 3, 1977, in the Circuit Court of Bedford County upon a conviction of Distribution of LSD for Accommodation and sentenced to six years suspended after serving nine months in jail, and placed on probation for five years. His suspension and probation were terminated January 9, 1980, and his court costs have been paid. He was granted removal of political disabilities on September 10, 1980.

BELLANCA, STEPHEN VINCENT. Sentenced March 1, 1974, in the Circuit Court of Henrico County upon a conviction of Statutory Burglary and sentenced to ten years with four years suspended on good behavior. He was paroled April 9, 1976, and discharged October 17, 1977. His

suspension expired April 9, 1980, and his court costs have been paid. He was granted removal of political disabilities on January 5, 1981.

BIRD, KENNETH WESLEY. Sentenced July 18, 1975, in the Circuit Court of Alleghany County upon a conviction of Grand Larceny and sentenced to three years suspended and placed on probation for three years. His probation expired February 1, 1977, and his suspension expired July 18, 1978. His court costs have been paid. He was granted removal of political disabilities on December 31, 1980.

BISHOP, CHARLES WAYNE. Sentenced September 25, 1958, in the Hustings Court of Roanoke City upon a conviction of Statutory burglary and sentenced to one year. He was discharged May 25, 1959, and his court costs have been paid. He was granted removal of political disabilities on May 27, 1980.

BITTLE, SARAH JANE. Sentenced May 4, 1979, in the Circuit Court of Portsmouth upon a conviction of Unlawful wounding with intent and sentenced to twelve months in jail suspended and placed on probation for twelve months. Her probation and suspension expired May 4, 1980, and her court costs have been paid. She was granted removal of political disabilities on July 10, 1980.

BLACK, LACY COURTNEY, SR. Sentenced April 28, 1977, in the Circuit Court of Augusta County upon a conviction of Welfare Fraud with imposition of sentence being withheld and he was placed on probation for three years. His suspension and probation were terminated June 18, 1980, and restitution and court costs have been paid. He was granted removal of political disabilities on July 22, 1980.

BLACK, ROBERT EARL. Sentenced August 9, 1956, in the Corporation Court of Norfolk upon a conviction of Grand larceny with imposition of sentence suspended and placed on probation for three years. His court costs have been paid. He was granted removal of political disabilities on September 10, 1980.

BLACKISTON, LESTER NEWTON. Sentenced January 21, 1965, in the Hustings Court of Richmond upon a conviction of Unlawful wounding with intent and sentenced to twelve months in jail and fined \$5.00. He was granted removal of political disabilities on July 10, 1980.

BLANKENSHIP, WANDA ELAINE. Sentenced June 16, 1977, in the Circuit Court of Martinsville upon a conviction of Sale of Marijuana and sentenced to five years suspended and placed on probation for three years and fined \$100. Her suspension and probation were terminated June 16, 1980. Her fine has been paid. She was granted removal of political disabilities on September 10, 1980.

BLEDSOE, CHARLES DELAND. Sentenced February 7, 1970, in the Hustings Court of Richmond upon a conviction of Possession of Narcotic Drug and sentenced to twenty years. He was paroled August 27, 1974, and discharged October 11, 1979. His court costs have been paid. He was granted removal of political disabilities on July 8, 1980.

BOON, ROGER WILSON, JR. Sentenced September 18, 1968, in the Circuit Court of Roanoke County upon a conviction of Statutory burglary and sentenced to twelve months in jail suspended and placed on probation for three years and fined \$10; and on November 29, 1968, in the Circuit Court of Montgomery County upon a conviction of Two counts of Statutory burglary and sentenced to twelve months in jail and three years suspended upon completion of his jail sentence. His probation expired October 1, 1971, and his court costs and fine have been paid. He was granted removal of political disabilities on September 10, 1980.

BOWER, LEWIS EDMOND. Sentenced November 14, 1972, in the Circuit Court of Floyd County upon a conviction of Forgery and sentenced to ten months in jail. His court costs have been paid. He was granted removal of political disabilities on July 22, 1980.

BOYDEN, FRANK HARWOOD. Sentenced April 23, 1958, in the Circuit Court of Shenandoah County upon a conviction of three counts of Statutory Burglary and sentenced to two years on each count to run concurrent. His court costs have been paid. He was granted removal of political disabilities on December 5, 1980.

BRAMLETT, FRANK LEE. Sentenced April 21, 1970, in the United States District Court, Western District of Virginia, Danville, upon a conviction of violation of Title 18 USC Sec. 1341, 1302, Mail and Lottery Fraud, with imposition of sentence suspended and placed on probation for one year, and three years suspended with three years probation on Count 1; and on April 12, 1972, in the United States District Court, Western District of Virginia, Roanoke, of violation of Title 18, USC, Section 1341 and 2342, eighteen counts, with imposition of sentence suspended and fined \$1,750 on Count 2; Three years suspended to run concurrently with sentences in Counts 1 and 2, and probation for three years on Counts 3 - 18. He was granted removal of political disabilities on November 14, 1980.

BRANDON, STUART DODSON. Sentenced October 3, 1966, in the Circuit Court of Lynchburg upon a conviction of Forgery and Uttering and sentenced to two years which expired November 10, 1967; and on September 6, 1966, upon a conviction of Third Offense Petit Larceny and sentenced to one year in jail suspended and placed on probation for one year. His probation and suspension expired November 9, 1968, and his court costs have been paid. He was granted removal of political disabilities on September 12, 1980.

BRANTLEY, HAROLD LEE. Sentenced October 11, 1978, in the United States District Court, Eastern District of Virginia, Norfolk, upon a conviction of Filing False Claim Against the Government with imposition of sentence suspended and placed on probation for three years. His suspension and probation terminated October 3, 1980. No court costs were imposed. He was granted removal of political disabilities on January 5, 1981.

Sentenced May 29, 1968, in the Hustings Court of Richmond, Part 11, upon a conviction of Grand larceny and Forgery with imposition of sentence suspended for five years and placed on probation; on June 26, 1968, in Police Court of Richmond, Part 11, of Petit Larceny and sentenced to six months in jail; on July 30, 1968, in the Hustings Court of Richmond, Part 11, the suspension of May 29, 1968, was revoked and he was ordered to serve twelve months to run concurrent with June 26, 1968, conviction, from which he was discharged February 27, 1969; and on February 5, 1970, in the Circuit Court of Giles County of four counts each of Forgery and uttering and sentenced to twelve months jail suspended on two convictions in Count 1, three years suspended with three years to run concurrent in Count

2, three years on each conviction in Counts 3 and 4, to run concurrent with Count 2. He was granted removal of political disabilities on May 27, 1980.

WIRMAN, DAVID WILLIAM, SR. Sentenced January 21, 1959, in the United States District Court, Eastern District of Virginia, Alexandria, upon a conviction of Three counts of Violation of Title 26, USC, Sections 7302, 5216 & 5008(b), with imposition of sentence suspended for two years, placed on probation and fined \$200. His fine has been paid. He was granted removal of political disabilities on September 10, 1980.

WOOD, CLIFTON MARSHALL. Sentenced July 19, 1958, in the Circuit Court of Prince William County upon a conviction of Embezzlement and sentenced to two years. He was paroled August 23, 1960, and discharged February 26, 1962. His court costs have been paid. He was granted removal of political disabilities on July 10, 1980.

WOOD, KELLY BOWMAN. Sentenced October 10, 1974, in the Circuit Court of Lynchburg upon a conviction of Statutory burglary and sentenced to five years suspended and placed on probation for five years. His probation was terminated by Court Order on February 8, 1978, and his suspension expired October 10, 1979. His court costs have been paid. He was granted removal of political disabilities on March 17, 1980.

WOOD, NEIL GALEN. Sentenced June 16, 1975, in the Circuit Court of Waynesboro upon a conviction of Three counts of Selling or distributing Marijuana, a Schedule 1 Controlled Substance and sentenced to five years each count with four years each count suspended and placed on probation for four years upon release. He was paroled March 16, 1976, and discharged May 25, 1977. His suspension and probation expired March 16, 1980, and his court costs have been paid. He was granted removal of political disabilities on January 5, 1981.

WOODS, PAUL ANDREW, JR. Sentenced December 17, 1976, in the Circuit Court of Carroll County upon a conviction of Three counts of Possession and sale of Marijuana and sentenced to eight years each count, to serve twelve months in jail with remaining seven years suspended for five years and placed on probation for five years on each count, to run concurrent. His probation and suspension were terminated September 17, 1979, and his court costs have been paid. He was granted removal of political disabilities on June 19, 1980.

WRIGHT, SAMMY GLENN. Sentenced June 20, 1974, in the Circuit Court of Martinsville upon a conviction of Possession of Marijuana with intent to sell and sentenced to six years with five years suspended, placed on probation for three years, and fined \$300. His probation was terminated January 31, 1977, and his suspension expired June 20, 1980. His fine and court costs have been paid. He was granted removal of political disabilities on September 26, 1980.

YOPP, DWIGHT ALDON, JR. Sentenced June 21, 1976, in the Circuit Court of Roanoke City upon a conviction of Statutory burglary and Grand larceny and sentenced to three years suspended after serving thirty days and placed on probation for five years. His probation was terminated November 6, 1978, and his suspension expired May 21, 1978. His court costs have been paid. He was granted removal of political disabilities on July 22, 1980.
