As required by Article V, Section 12, of the Constitution of Virginia, I submit herewith a statement setting forth the "particulars of every case of fine or penalty remitted, of reprieve or pardon granted, and of punishment commuted" with my reasons for remitting, granting, or commuting the same, from January 15, 1982 to January 17, 1983.

CONDITIONAL PARDON

DAVIS, ROGER TRENTON. Sentenced March 8, 1974, in the Circuit Court of Wythe County upon a conviction of Distribution of Marijuana and Possession of Marijuana with Intent to Distribute, and sentenced to 40 years. of the 1979 Acts of Assembly reduces the penalty for certain criminal offenses involving the possession, manufacture, cultivation, distribution or sale of marijuana, and there are certain persons presently confined or subject to confinement within the Virginia Department of Corrections who are serving sentences with exceed the maximum sentences which could be imposed pursuant to Chapter 435. It appears to me that Roger Trenton Davis, No. 102941, is such a person and in the absence of Executive Clemency, such person would receive no Therefore, I, by virtue of the authority vested in benefit from Chapter 435. me by the Constitution of Virginia am reducing the sentence of Roger Trenton Davis, No. 102941, for the convictions herein named, and do order that he be relieved of any unserved portion of the aforementioned sentences which exceed a total of twenty years and of any unpaid fine. If ever again he be found guilty of violation of the penal laws of any city, county, state or the United States, this action may be revoked. The action taken herein shall have no effect upon any other sentence which the said Roger Trenton Davis is serving or which he may have to serve in the future. This pardon dated May 24, 1982.

McBRIDE, DAVID THOMAS. Sentenced March 30, 1971, in the Circuit Court of the County of Bedford upon a conviction of Distribution of a Controlled Drug, two counts and sentenced to 25 years on each count, to run concurrently. In view of subject's exemplary lifestyle and no record of criminal activity while absent from Virginia, and the favorable recommendations of the sentencing judge, prosecuting Commonwealth's Attorney, and defense counsel, I, by virture of the authority vested in me by the Constitution of Virginia, am reducing the sentences of David Thomas McBride, No. 100219, for the convictions herein named to ten years for each of the two counts, the terms to run concurrently. If upon some further grant of parole, David Thomas McBride should violate the conditions of such parole, or if ever again he be found guilty of violation of the penal laws of any city, county, state, or the United States, this action may be revoked. If this action be revoked, the time during which David Thomas McBride is at liberty under the terms of this action shall not be counted as service of any part of the term of imprisonment for which he was sentenced upon his conviction. The action taken herein shall have no effect upon any other sentence which David Thomas McBride is serving or which he may have to serve in the future. This pardon dated November 5, 1982.

SIMPLE PARDON

COCHRAN, STEPHEN LAURIE. Sentenced September 18, 1978 in the Circuit Court of Greene County upon a conviction of Possession of Marijuana with Intent to Manufacture Tetrahydrocannobinol and sentenced to five years, \$1,000 fine, suspended for unsupervised probation for two years. In view of the facts as presented to me and the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated July 14, 1982.

KAIN, WILLIAM WOODEN. Sentenced September 15, 1964 in the Circuit Court of the City of Chesapeake upon a conviction of Grand Larceny and sentenced to

three years, suspended and placed on probation for three years. In view of the facts as presented to me and the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated July 23, 1982.

KERNS, MARIS VERNON, III. Sentenced April 2, 1976 in the Circuit Court of Gloucester County upon a conviction of Concealing Stolen Property and sentenced to 12 months, 11 months and 22 days suspended upon condition he be of good behavior for 5 years, plus costs and restitution. His costs and restitution have been paid and his suspended sentence ended April 2, 1981. In view of the facts as presented to me and the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated July 26, 1982.

WILKINS, STEVEN WARREN. Sentenced May 18, 1971 in the General District Court of the City of Richmond, Manchester Division upon a conviction of Petty Larceny and given a \$10.00 fine, plus costs. Court costs and fine have been paid. In view of the facts as presented to me and the recommendations of reputable citizens who are familiar with this man's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated July 30, 1982.

REMOVAL OF POLITICAL DISABILITIES

ADSIT, SAMUEL DENISON, JR. Sentended June 5, 1979 in the Circuit Court of the City of Norfolk upon a conviction of Conspiracy and Embezzlement and sentenced to three years on each charge, \$5,000 fine, plus costs. Sentences suspended and placed on unsupervised probation for three years, conditioned upon good behavior and payment of fine and costs. Fines and costs have been paid. His sentences and probation expired June 5, 1982. Granted removal of political disabilities December 21, 1982.

ALPHIN, THOMAS VERNON. Sentenced September 15, 1980 in the Circuit Court of Rockbridge County upon a conviction of Aiding and Abetting in the Commission of a Crime, 5 counts, and sentenced to 2 years on each count, to run concurrently, suspended and placed on probation for 2 years, plus costs and restitution. All costs have been paid. His probation and suspended sentence expired September 15, 1982. Granted removal of political disabilities December 10, 1982.

ARMSTRONG, JAMES WILLIAM, JR. Sentenced December 20, 1967 in the Corporation Court of the City of Norfolk upon convictions of Forgery and Utter a Worthless Check. Imposition of sentence on each suspended and placed on supervised probation for 5 years, plus costs. August 29, 1968: Violation of Probation - Sentenced to 3 years on Utter a Worthless Check charge, plus costs. Also on same day in same court convicted of Draw, Utter and Pass a Worthless Check, 3 counts, sentenced to 60 days in jail, \$10 fine, plus costs on each count. Jail sentence and fines suspended for 12 months. August 29, 1968: Violation of Probation - \$10 fine and 60 days in jail on each count, plus costs. In the Circuit Court of the City of Virginia Beach on January 13, 1972, upon a conviction of Robbery, sentenced to 15 years. All costs and fines have been paid. Paroled August 11, 1976 and discharged September 28, 1981. Granted removal of political disabilities September 20, 1982.

ATKINS, LYNN (LIN) STEWART. Sentenced January 26, 1973 in the Hustings Court of the City of Roanoke upon a conviction of Distribution of Meperidine and sentenced to 5 years, suspended upon condition she be of good behavior for 10 years, plus costs. Suspended sentence terminated April 28, 1982. All costs paid. Granted removal of political disabilities June 14, 1982.

AYRES, PAUL WOODROW, JR. Sentenced July 16, 1975 in the Circuit Court of the City of Fredericksburg upon a conviction of Distribution of Controlled Drugs (7 counts) and sentenced to 25 years. Paroled October 24, 1977 and discharged December 3, 1981. Costs have been paid. Granted removal of political disabilities April 23, 1982.

BAGE, OLLIE EDWARD. Sentenced November 17, 1958 in the Corporation Court of the City of Newport News upon a conviction of Operating a Lottery and sentenced to 60 days, suspended, \$150 fine and costs and placed on parole. Fines and costs have been paid. Sentenced January 18, 1962 in the Circuit Court of the City of Newport News upon a conviction of Operating a Lottery and sentenced to 90 days, suspended and \$150 fine and costs, placed on 2 years probation. Costs and fines have been paid. Sentenced December 17, 1973 in the Circuit Court of Williamsburg-James City County upon a conviction of Operating a Lottery and sentenced to 12 months in jail, \$750 fine and costs. Sentence suspended after serving 14 days in jail, placed on 3 years probation. All costs and fine have been paid. Granted removal of political disabilities July 8, 1982.

BARBER, RAY LANGSTON. Sentenced May 25, 1979 in the United States District Court for the Middle District of North Carolina, Greensboro Division upon a conviction of unlawfully, wilfully and knowingly causing a person to travel in interstate commerce with the intent to promote, manage, establish, carry on and facilitate the promotion, management, establishment and carrying on of an unlawful activity being a business enterprise involving prostitution offenses in violation of N.C.G.S. 14-204(1) through (7) and thereafter performing and attempting to perform acts to promote, manage, carry on and facilitate promotion, management and carrying on of said unlawful activity in violation of 18 U.S.C. 1952(a)(3) and sentenced to 18 months, amended by court order dated June 15, 1979 to 15 months. Granted removal of political disabilities May 28, 1982.

BARLEY, STEVEN REX, aka KING REX. Sentenced September 13, 1973 in the Circuit Court of the City of Richmond, Division I upon a conviction of Statutory Burglary. Imposition of sentence suspended during good behavior and placed on probation at the discretion of his probation officer. Imposition of sentence terminated March 1, 1982. Removal of political disabilities granted June 14, 1982.

BARNES, BEULAH MAE. Sentenced June 5, 1974 in the Circuit Court of the City of Portsmouth upon a conviction of Voluntary Manslaughter and sentenced to 5 years. Paroled September 8, 1975 and discharged August 24, 1977. Granted removal of political disabilities September 14, 1982.

BAYSDEN, WALTER SUTTON. Sentenced November 8, 1972 in the Circuit Court of the City of Virginia Beach upon a conviction of Possession of Sawed-Off Shotgun and sentenced to 10 years, suspended and placed on 3 years probation, plus costs. Sentenced April 16, 1977 in the Circuit Court of the City of

Norfolk upon a conviction of Sale of Marijuana and sentenced to 5 years, suspended and placed on 3 years probation, plus costs. All costs have been paid. Probation expired April 26, 1980 and suspension expired November 8, 1982. Granted removal of political disabilities November 12, 1982.

BEAHM, ROBERT WILLIAM. Sentenced September 25, 1939 in the Circuit Court of Page County upon a conviction of Housebreaking and sentenced to 8 months, plus costs and fine. Fine and costs paid. Granted removal of political disabilities April 21, 1982.

BEAVERS, RUSSELL DOWNING. Sentenced April 9, 1979 in the United States District Court for the Western District of Virginia upon a conviction of violation of Internal Revenue Tax Laws, 18 U.S.C. 1341; 18 U.S.C. 287 and sentenced to \$5,000 fine, payable within 90 days; imposition of sentence as to imposition only, suspended, placed on probation for 3 years, plus make restitution within 90 days. Probation terminated April 8, 1982. Fine and restitution paid. Granted removal of political disabilities August 18, 1982.

BELTON, WESLEY DAVIS. Sentenced November 29, 1965 in the Circuit Court of the City of Danville upon a conviction of Grand Larceny and sentenced to 12 months, plus costs, suspended for 2 years, plus costs. Placed on probation for 2 years. Costs have been paid. Probation expired November 29, 1967. Granted removal of political disabilities November 15, 1982.

BENTON, JOHN MURRAY. Sentenced October 9, 1975 in the Circuit Court of the City of Suffolk upon a conviction of Statutory Burglary and Grand Larceny and sentenced to 3 years, suspended for 3 years probation, plus costs. Granted removal of political disabilities April 8, 1982.

BLAKESLEE, JAMES MARTIN. Sentenced September 23, 1974 and amended October 1, 1974 in the Court of Common Pleas of Centre County, Pennsylvania, upon convictions of Possession and Delivery of Marijuana (2 counts) and Possession and Delivery of Hashish (2 counts). Sentence suspended for 2 years supervised probation, plus costs. Costs have been paid. Discharged from probation July 19, 1976. Granted removal of political disabilities April 21, 1982.

BOLER, WILMA RENE. Sentenced February 10, 1981 in the Circuit Court of the City of Portsmouth upon a conviction of Delivering Marijuana to a Prisoner and sentenced to 12 months in jail and \$250 fine, plus costs, suspended for 12 months, plus \$25 fine and costs. All costs and fine have been paid. Suspension expired February 10, 1982. Granted removal of political disabilities September 14, 1982.

BOLLING, LLOYD, aka BOLDEN. Sentenced May 10, 1960 in the Circuit Court of Sussex County upon a conviction of Unlawful Wounding with Intent to Maim, Disfigure, Disable and Kill and sentenced to 2 years, plus costs. Granted removal of political disabilities August 23, 1982.

BOWLES, EUGENE GRAY, JR. Sentenced September 29, 1981 in the United States District Court for the Eastern District of Virginia, Richmond Division upon a conviction of conspiracy in restraint of interstate trade and commerce in violation of Title 15, U.S.C., Section 1. Sentenced to 60 days, plus \$15,000 fine due and payable 120 days from date of conviction. Fine has been paid. Granted removal of political disabilities September 21, 1982.

BRANNOCK, FLETCHER GUY. Sentenced November 13, 1980 in the Circuit Court of Grayson County upon a conviction of Obtaining Personal Property by False Pretenses and sentenced to 12 months, suspended and placed on probation for 1 year. Costs have been paid. Granted removal of political disabilities April 8, 1982.

BRANT, WILLIAM ALBERT. Sentenced July 7, 1981 in the Circuit Court of the County of Wythe upon a conviction of Unlawful Wounding and sentence to 12 months in jail and \$1,000 fine, plus costs. Unserved portion of sentence suspended by court order dated March 2, 1982. All costs and fine have been paid. Granted removal of political disabilities September 22, 1982.

BRISSOM, RICHARD GERARD. Sentenced January 28, 1974 in the Circuit Court of the City of Portsmouth upon a conviction of Distribution of Narcotics for Accommodation (4 counts, Marijuana, LSD, Marijuana and Amphetamine) and sentenced to 4 years, suspended and placed on 4 years supervised probation, plus costs on each count to run concurrently. Costs and fine paid. Probation terminated March 23, 1976 and suspension expired August 14, 1977. Granted removal of political disabilities October 19, 1982.

BROWN, SAMUEL EDWARD, JR. Sentenced April 21, 1975 in the Circuit Court of the City of Richmond, Division I, upon convictions of Forgery and Uttering and sentenced to 12 months on forgery charge and 5 years, suspended, placed on supervised probation, plus costs on uttering charge. Probation supervision terminated by court order dated October 15, 1979. Sentence expired April 21, 1981. Costs have been paid. Granted removal of political disabilities September 29, 1982.

BROWN, WILLIAM ARTHUR. Sentenced March 22, 1960 in the Corporation Court of the City of Norfolk, Part Two, upon convictions of Storebreaking and Grand Larceny and sentence to 5 years on each charge, to run consecutively, plus pay attorney fees. Costs have been paid. Removal of political disabilities granted August 23, 1982.

BRUGH, EVELYN HARMON. Sentenced October 15, 1974 in the United States District Court for the Western District of Virginia, Roanoke Division upon a conviction of Violation of Title 26, U.S.C. 7206(1) and given a \$3,000 fine imposed under Federal Youth Correction Act; Violation of Title 21, U.S.C. Section 846, conspiring to distribute marihuana, a Schedule I controlled substance; Violation of Title 21, U.S.C. Section 841(a)(1), distributing marihuana, a Schedule I controlled substance (7 counts). (Sentences consolidated for sentencing). Committed to custody of Attorney General or his authorized representative for treatment and supervision pursuant to 18 USCA 5010(b) until discharged by the Federal Youth Correction Division of the Board of Parole as provided in 18 USCA 5017(c). January 14, 1975 ordered released from custody of Attorney General and placed on probation with supervision for 3 years. January 26, 1978 unconditionally discharged from probation. All costs and fine have been paid. Granted removal of political disabilities December 9, 1982.

CAMP, FRANK WADE. Sentenced November 27, 1974 in the Circuit Court of Franklin County upon convictions of (1) selling and distributing for profit thereby a quantity of a controlled substance, Marijuana, a Schedule I drug and sentenced to 5 years, to serve 3, execution of balance suspended for 3 years,

plus fine and costs. Sentence amended by court order dated December 5, 1974 to serve 12 months, execution of balance suspended on condition he be of good behavior for 3 years plus fine and costs. (2) Selling and distributing for profit thereby a quantity of a controlled substance, Marijauna, a Schedule I drug and sentenced to 5 years, to serve 3, balance suspended upon good behavior for 3 years, plus fine and costs. Sentence amended by court order dated December 5, 1974 to serve 12 months, execution of balance suspended upon condition he be of good behavior for 3 years, plus pay fine and costs, to run concurrently. (3) Selling and distributing for profit thereby a quantity of a controlled substance, Marijauna, a Schedule I drug and sentenced to 5 years, to serve 3 years, execution of balance suspended upon condition he be of good behavior for 3 years, plus fine and costs. Sentence amended by court order dated December 5, 1974, to serve 12 months, execution of balance suspended on condition he be of good behavior for 3 years and pay fine and costs, to run concurrently. (4) Distributing as an accommodation a quantity of a controlled substance, Marijuana, a Schedule I Drug and sentenced to 3 months in jail, plus fine and costs. Sentence amended by court order dated Decembe 5, 1974 to 12 months plus fine and costs, to run concurrently. All fines and costs have been paid. Probation terminated by court order September 27, 1982. Granted removal of political disabilities September 28, 1982.

CAMPBELL, JOSEPH BYRON. Sentenced May 17, 1978 in the Circuit Court of Henry County upon conviction of Distribution of a Schedule I Controlled Substance and sentenced to 5 years, to serve 12 months, balance suspended and placed on supervised probation for 3 years, plus costs and fine. February 26, 1979 convicted of (3 counts) Distribution of a Schedule I Controlled Substance and sentenced to 5 years, suspended and placed on supervised probation for 3 years, plus costs and fine. All fines and costs have been paid. Granted removal of political disabilities July 29, 1982.

CARDEN, DAVID STERN. Sentenced June 29, 1976 in the Circuit Court of Montgomery County upon a conviction of Accommodation Sale of a Controlled Drug and sentenced to 12 months in jail and \$100 fine and costs. He was also convicted on the same day of Distributing a Controlled Drug and sentenced to 5 years in the penitentiary, \$500 fine and costs. Execution of sentence suspended and placed on supervised probation for 3 years after serving jail sentence upon condition he pay costs and fines. All costs and fines have been paid. Probation terminated July 29, 1979. Granted removal of political disabilities September 20, 1982.

CARTWRIGHT, VIDA RENEE. Sentenced May 26, 1976 in the Circuit Court of the City of Norfolk upon a conviction of Forgery (3 counts), imposition of sentence suspended, placed on supervised probation for 3 years, plus costs. Probation expired May 26, 1979. Costs have been paid. Granted removal of political disabilities September 27, 1982.

CARUSO, FRANK B. Sentenced March 12, 1979 in the Circuit Court of the City of Danville upon the conviction of Selling Marijuana (3 counts) and sentenced as to Count 1: 5 years, \$100 fine, suspended, 6 months confinement and placed on probation for 3 years, plus fine and costs. As to Count 2: Imposition of sentence suspended upon good behavior for 20 years, plus fine and costs. Released from probation supervision December 7, 1981. Released from balance of period of good behavior March 9, 1982 by court order. All fines and costs have been paid. Granted removal of political disabilities September 14, 1982.

CASEY, ANNA NORA. Sentenced September 23, 1977 in the Circuit Court of the City of Norfolk upon a conviction of Forgery (3 counts) and sentenced to 2 years on each count, plus costs, to run concurrently, suspended and placed on unsupervised probation for 3 years, plus restitution and costs. All costs and restitution have been paid. Probation ended September, 1980. Granted removal of political disabilities September 23, 1982.

CASEY, MARY VIRGINIA. Sentenced October 29, 1974 in the Circuit Court of Louisa County upon a conviction of Involuntary Manslaughter and sentenced to 2 years, plus costs, suspended for 3 years, plus costs. All costs have been paid. Granted removal of political disabilities September 20, 1982.

CHARITY, RONALD KARL. Sentenced May 20, 1980 in the Circuit Court of the City of Norfolk upon a conviction of Grand Larceny by Worthless Check and sentenced to 12 months, \$500 fine, plus costs, placed on unsupervised probation for 2 years, conditioned upon good behavior and payment of costs. All costs and fine have been paid. Probation expired May 20, 1982. Granted removal of political disabilities September 16, 1982.

CHITWOOD, JESSE DAVID, JR. Sentenced January 4, 1979 in the Circuit Court of the City of Danville upon a conviction of Sale of Marijuana (2 counts) and sentenced to 5 years, suspended for 9 months incarceration and 3 years supervised probation. Suspended sentence terminated March 9, 1982. Fine and costs paid. Granted removal of political disabilities May 3, 1982.

CISCO, REUBEN. Sentenced March 23, 1977 in the Circuit Court of Southampton County upon a conviction of Delivering a Firearm to an Inmate and sentenced to 5 years, to remain in custody until July 1, 1977 at which time remainder of unserved protion suspended and placed on supervised probation upon condition he be of good behavior for 5 years, plus costs. Costs have been paid. Probation supervision ended December 12, 1978; suspended sentence expired March 23, 1982. Granted removal of political disabilities November 18, 1982.

CLARK, GARNETT STEPHEN. Sentenced January 13, 1972 in the Circuit Court of Mecklenburg County upon a conviction of Distribution of Controlled Drugs (4 counts) and sentenced to 10 years, suspended for supervised probation until age 21. Released from probation April 30, 1974. Granted removal of political disabilities April 21, 1982.

COCHRAN, STEPHEN LAURIE. Sentenced September 18, 1978 in the Circuit Court of Greene County upon a conviction of Possession of Marijuana with Intent to Manufacture Tetrahydrocannobinol and sentenced to 5 years, \$1,000 fine, suspended for unsupervised probation for 2 years. Granted removal of political disabilities July 14, 1982.

COLEMAN, NATHANIEL. Sentenced November 3, 1947 in the Circuit Court of the City of Danville upon a conviction of Forgery (3 counts) and sentenced to 3 years on each count, to run concurrently. Granted removal of political disabilities September 22, 1982.

COLLIER, LARRY SERANNA. Sentenced May 28, 1980 in the Circuit Court of the City of Portsmouth of Forgery and Uttering (2 counts each) and sentenced to 2 years on each charge. All sentences to run concurrently with the first 2

year sentence for Forgery, for a total of 2 years, suspended and placed on 2 years supervised probation, plus costs. Probation changed to unsupervised status on November 20, 1981 and ended in May, 1982. All costs have been paid. Granted removal of political disabilities July 16, 1982.

CONRAD, MARK STEPHEN, aka MARK STEVEN CONRAD. Sentenced January 24, 1973 in the Circuit Court of Frederick County upon a conviction of Distribution of a Schedule I Controlled Drug and sentenced to 2 years, plus costs. Parole completed October 11, 1974. Granted removal of political disabilities July 16, 1982.

COSTIGAN, JOHNIE EVANS. Sentenced April 15, 1947 in the Circuit Court of Montgomery County upon a conviction of Unlawfully Leaving the Scene of an Accident and sentenced to 18 months, in lieu of being committed to penitentiary, placed on 3 years probation. Granted removal of political disabilities November 16, 1982.

COWAN, CARTER HOPKINS, JR. Sentenced December 18, 1972 in the Hustings Court of the City of Richmond upon convictions of Selling Hashish and Selling Marijuana (2 charges) and sentenced to 5 years and \$10 fine on Selling Hashish and one count of Selling Marijuana with 3 years each suspended and remaining 2 years each to run consecutively. On second Selling Marijauna charge imposition suspended during good behavior. Total to be served, four years, \$20 fine. All costs and fine have been paid. Discharged from parole May 25, 1976. Suspended sentences terminated August 26, 1982. Granted removal of political disabilities September 3, 1982.

CROCKER, GERTIE MAE. Sentenced February 27, 1978 in the Circuit Court of the City of Portsmouth upon a conviction of Welfare Fraud and sentenced to 6 months in jail, suspended and placed on 1 year unsupervised probation, plus costs and restitution. All costs and restution paid. Granted removal of political disabilities September 14, 1982.

CROOK, ARTHUR LEE. Sentenced February 5, 1969 in the Hustings Court of the City of Richmond upon a conviction of Statutory Burglary and sentenced to 3 years. Paroled October 1, 1970 and discharged March 29, 1972. Granted removal of political disabilities May 3, 1982.

CROWDER, EARL LEE, JR. Sentenced June 4, 1980 in the Circuit Court of Roanoke County upon a conviction of Involuntary Manslaughter and sentenced to 12 months in jail, \$1,000 fine, to serve 6 months with balance suspended, plus fine and costs.
