ABSOLUTE PARDON

NONE GRANTED

CONDITIONAL PARDON

WHALEY, DALE LEONARD. Sentenced October 1, 1981, in the Circuit Court of Campbell County upon a conviction of Statutory Burglary and sentenced to five years. In view of diagnosis of lymphoma, venous thrombosis and hydronephrosis and his physician's judgment of his life expectancy being a few months, together with favorable recommendations for executive clemency having been received from the Virginia Parole Board and the current judge of the 24th Judicial Circuit and the current Commonwealth's Attorney for the County of Campbell having no objection, I, by virtue of authority vested in me by the Constitution of Virginia, hereby reduce the sentence of Dale Leonard Whaley to four years. If, upon some further grant of parole, or if ever again he be found guilty of violations of the penal laws of any city, county, state or the United States, this action may be revoked. If this action be revoked, the time during which Dale Leonard Whaley is at liberty under the terms of this action shall not be counted as service of any part of the term of imprisonment for which he was sentenced upon his conviction. The action taken herein shall have no effect upon any other sentence which Dale Leonard Whaley is serving or which he may have to serve in the future. This pardon granted June 21, 1983.

SIMPLE PARDON

ABBOTT, TIMOTHY CLAY. Sentenced September 3, 1976 in the Circuit Court of Roanoke County upon a conviction of Distribution of Controlled I Substance and sentenced to ten years, suspended after serving three years, to be served currently with any other sentence imposed by any other court. Sentenced January 27, 1977, in the Circuit Court of the County of Bedford upon a conviction of Distribution of a Controlled Substance, two counts, and sentenced to five years on each count, suspended, to serve six months on each count and placed on unsupervised probation for four years. Sentenced February 2, 1977, in the Circuit Court of the City of Roanoke upon a conviction of Distribution of Marijuana and sentenced to five years, suspended, to run concurrent, and fined \$396.00. All costs and fines have been paid. His civil rights were restored September 1, 1981. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this man's conduct since his convictions and in view of the fact that the convictions might deter future career development as a physician, I am granting Timothy Clay Abbott a Simple Pardon. The pardon will not operate to erase the fact or record of the convictions of the above-described offenses. This pardon dated June 7, 1983.

ALBERT, JACK HUFFORD, JR. Sentenced April 25, 1978, in the Circuit Court of Warren County upon a conviction of Grand Larceny by Embezzlement and sentenced to three years, to serve 60 days with the remainder suspended and placed on probation for three years. His probation expired May 23, 1981 and all costs have been paid. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his conviction and in view of the fact that the conviction might deter future career development, I am granting Jack Hufford Albert, Jr. a Simple Pardon. This pardon will not operate to erase the fact or record of the conviction of the above-described offense. This pardon dated August 12, 1983.

GREEN, THOMAS LEE. Sentenced July 8, 1970 in the General District Court of the City of Norfolk upon a conviction of Assault and sentenced to 60 days, suspended for 12 months and fined \$150; Disorderly Conduct and sentenced to 30 days, suspended for 12 months and \$20 fine; Assault and sentenced to 30 days, suspended for 12 months; Disorderly Conduct and fined \$20. Sentenced April 10, 1970, in the General District Court of the City of Hampton upon a conviction of Resisting Arrest and fined \$58.75. Sentenced October 19, 1970, in the General District Court of the City of Hampton upon a conviction of Drunk in Public and fined \$35, plus costs. Sentenced June 8, 1971, in the General District Court of the City of Hampton upon a conviction of Trespassing and fined \$50, plus costs, and sentenced to 30 days, suspended for 12 months. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his convictions and in view of the fact that these convictions might deter future career development, I am granting Thomas Lee Green a Simple Pardon. This pardon will not operate to erase the fact or record of the convictions of the above-described offenses. This pardon dated December 10, 1983.

HAMILTON, MELVINA PAULETTA. Sentenced August 4, 1969, in the Circuit Court of the City of Richmond, Division I, upon a conviction of Possession of Marijuana. The imposition of her sentence was suspended conditioned upon payment of costs and placed on supervised probation. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since her conviction and in view of the fact that the conviction might deter future professional growth, I am granting Melvina Pauletta Hamilton a Simple Pardon. This pardon will not operate to erase the fact or record of the conviction of the above-described offense. This pardon dated June 7, 1983.

KEY, PHILLIP WINFREY, JR. Sentenced January 4, 1979; in the Circuit Court of the City of Danville upon a conviction of Selling Marijuana and sentenced to five years, \$100 fine and costs, suspended after serving six months in the Danville City Prison Farm, be of good behavior for three years from date of release from probation and not use or associate with persons using or dealing in drugs during said period; pay fine and costs; and placed on probation for one year from date of release from confinement. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this man's conduct since his conviction and in view of the fact that his conviction might deter future career development, I am granting Phillip Winfrey Key, Jr., a Simple Pardon. This pardon will not operate to erase the fact or record of the conviction of the above-described offense. This pardon dated November 5, 1983.

REMOVAL OF POLITICAL DISABILITIES

Relying upon the recommendations of parole officers and/or reputable citizens who are familiar with the conduct of these individuals since their conviction or release, I have granted Removal of Political Disabilities to the following:

ADAIR, WILLIAM ALLEN, JR. Sentenced August 27, 1974, in the Circuit Court of Henrico County upon a conviction of Distribution of Marijuana. The imposition of his sentence was suspended during good behavior and placed on probation, plus costs. Released from probation August 22, 1975 and suspension terminated January 21, 1983. Costs have been paid. Granted removal of political disabilities May 31, 1983.

ADAMS, BEVERLY TUCKER, JR. Sentenced July 9, 1970, in the Circuit Court of the City of Richmond, Division I, upon a conviction of Possession of Heroin. Imposition of sentence suspended during good behavior and placed on probation, plus costs. Discharged from probation February 19, 1971. All costs have been paid. Granted removal of political disabilities June 22, 1983.

AKERS, DANNY RICHARD. Sentenced May 22, 1968, in the Circuit Court of the County of Carroll upon a conviction of Breaking and Entering, 3 counts. Sentenced on Court 1 to 3 years, suspended and placed on probation for 3 years, plus costs and restitution, to run consecutively; Count 2, 3 years to serve 12 months and placed on probation for 3 years, 2 years suspended, plus costs and restitution, to run consecutively; Count 3, 3 years, suspended and placed on probation for 3 years, plus costs and restitution, to run consecutively. All costs and restitution have been paid. Discharged from probation March 8, 1971. Granted removal of political disabilities April 25, 1983.

ALLEN, PEYTON. Sentenced July 14, 1949, in the Hustings Court of the City of Richmond upon a conviction of Second Degree Murder and sentenced to 7 years. Paroled January 17, 1952 and discharged February 19, 1954. Granted removal of political disabilities November 21, 1983.

ALMOND, DALE LEE. Sentenced April 30, 1979, in the Circuit Court of the City of Lynchburg upon a conviction of Unauthorized Use of Automobile, 2 counts, and sentenced to 1 year on each count, plus costs, suspended upon the condition of his good behavior for 2 years and placed on probation for 2 years, plus costs and restitution. Costs and restitution have been paid. Probation and suspension expired April 29, 1981. Granted removal of political disabilities February 21, 1983.

AMBROSE, MICHAEL CHARLES. Sentenced January 2, 1959, in the Circuit Court of Fairfax County upon a conviction of Statutory Burglary, 4 counts, and sentenced to 2 years, plus costs, suspended during good behavior and placed on probation for 2 years, to run concurrently, on each count. Suspension and probation revoked October 9, 1959. Granted removal of political disabilities June 21, 1983.

AREHART, KYM ALEXANDER. Sentenced November 23, 1977, in the Circuit Court of the City of Portsmouth upon a conviction of Robbery and sentenced to 5 years, plus costs, suspended and placed on probation for 5 years of which the first 2 years and 6 months are supervised and the second 2 years and 6 months unsupervised upon the condition he not violate any laws of this State or any other State or of the United States for 5 years, to serve 2 weeks in jail and pay restitution. Restitution and costs have been paid. Probation terminated June 29, 1982. Suspension expired November 23, 1982. Granted removal of political disabilities September 6, 1983.

ARNOLD, HENRY CLAY, JR. Sentenced February 13, 1947, in the Circuit Court of Scott County upon a conviction of Malicious Wounding and sentenced to 4 years, plus costs. Costs have been paid. Granted removal of political disabilities September 6, 1983.

AUSTIN, MARK SHAW. Sentenced June 9, 1976, in the U.S. District Court for the Middle District of North Carolina, Greensboro Division, upon a conviction of Possession of Unregistered Firearm in violation of 26 USC 5861 (d) and 5871 and sentenced to 3 years, suspended and placed on probation for 5 years to receive psychological therapy and treatment as probation officials direct. Probation expired June 9, 1981. Granted removal of political disabilities August 17, 1983.

AVILA, HERACLIO, JR. Sentenced February 17, 1981, in the Circuit Court of the City of Norfolk upon a conviction of Unlawful Wounding and sentenced to 2 years, plus costs, suspended upon condition of confinement in jail for 6 months and probation for 2 years. Costs have been paid. Probation and suspension expired February 17, 1983. Granted removal of political disabilities October 19, 1983.

BAGGERLEY, CARVELLE HAMPTON, III. Sentenced April 9, 1976, in the Circuit Court of Warren County upon a conviction of Statutory Burglary and sentenced to 12 months, plus costs, suspended and placed on probation for 2 years, pay restitution and costs. Costs and restitution have been paid. Probation completed April 9, 1978. Granted removal of political disabilities March 18, 1983.

BAILEY, ORMAN LITTLE. Sentenced December 5, 1954 in the Circuit Court of the County of Campbell upon a conviction of Statutory Rape and sentenced to 20 years, plus costs. Costs have been paid. Pardoned by Governor Almond May 28, 1958 whereby effective June 11, 1958 he would be placed under the supervision of the Virginia Parole Board. Parole supervision terminated March 19, 1968. Granted removal of political disabilities February 18, 1983.

BAILEY, THOMAS JORDAN, JR. Sentenced March 12, 1980 in the Circuit Court of Albemarle County upon a conviction of Uttering a Worthless Check with Intent to Defraud and sentenced to 12 months, suspended 6 months on condition he pay restitution and costs and attorney fees within 3 months. Costs, restitution and fees have been paid. Suspension expired March 12, 1981. Granted removal of political disabilities June 29, 1983.

BALDWIN, DANIEL DOYLE. Sentenced December 7, 1970, in the U.S. District Court for the Eastern District of Virginia, Richmond Division, upon a conviction of violation of Title 26, Section 7203, USC, Failure to File Federal Income Tax Return, 2 counts. Imposition of sentence suspended for 5 years, placed on probation for 5 years on each count. Probation and suspension expired December 6, 1975. Granted removal of political disabilities March 21, 1983.

BANKS, JOSEPH HENRY, JR. Sentenced June 20, 1962, in the Circuit Court of Charles City County upon a conviction of Unlawful Wounding and sentenced to 1 year, suspended and placed on probation for 2 years, plus costs, conditioned upon good behavior. Sentenced March 1, 1963, in the Circuit Court of James City County upon a conviction of Malicious Wounding and sentenced to 6 years, suspended, to serve 3 years and placed on probation for 3 years after release. Costs have been paid. Granted removal of political disabilities October 27, 1983.

BARNES, JOHN GARFIELD. Sentenced August 17, 1979, in the Circuit Court of the City of Norfolk upon a conviction of Exposure and sentenced to 12 months in jail, \$100 fine and costs, jail sentence suspended and placed on supervised probation for 3 years upon condition of good behavior and payment of fine and costs. Costs and fine have been paid. Discharged from probation September 17, 1982. Granted removal of political disabilities March 15, 1983.

BARTEE, MARY LEE. Sentenced April 14, 1976 in the Circuit Court of Buckingham County upon a conviction of Unlawful Wounding and sentenced to 2 years, suspended upon condition of good behavior for 5 years, plus costs. Costs have been paid. Suspension and good behavior expired April 14, 1981. Granted removal of political disabilities September 7, 1983.

BARTLETT, SAMUEL BENSON, III. Sentenced May 21, 1982, in the U.S. District Court for the Eastern District of Virginia, Alexandria Division, upon a conviction of Conspiracy in Restraint of Trade in violation of Title 15, USC 1 and sentenced to 1 year, to serve 60 days in halfway house with balance of sentence suspended and placed on supervised probation for 1 year and perform 300 hours of community service. Probation and suspension expired January 27, 1983. Granted removal of political disabilities March 28, 1983.

BELL, WILL THOMAS. Sentenced May 28, 1962, in the Circuit Court of Nelson County upon a conviction of Involuntary Manslaughter and sentenced to 2 years, plus costs. Sentenced January 29, 1964, in the Circuit Court of Nelson County upon a conviction of Malicious Wounding, 2 counts, and sentenced to 2 years, plus costs, on each count, to run concurrently. Costs have been paid. Granted removal of political disabilities April 7, 1983.

BENNETT, JOAN TWIGG. Sentenced November 24, 1969, in the Circuit Court of the County of Chesterfield upon a conviction of Attempt Abortion. Imposition of sentence suspended for 10 years upon condition of payment of costs and keep the peace and be of good behavior. Probation terminated October 19, 1970. Costs have been paid. Granted removal of political disabilities September 27, 1983.

BIRCH, HERMAN ROLAND. Sentenced August 17, 1966, in the Circuit Court of Accomack County upon a conviction of Use of Forged License Plate and sentenced to \$500 fine and costs, fine suspended upon condition of payment of costs. Costs have been paid. Granted removal of political disabilities September 29, 83.

BLAIR, JAMES EDWARD. Sentenced September 8, 1977, in the Circuit Court of the City of Roanoke upon a conviction of Statutory Burglary and sentenced to 2 years, suspended after serving 6 months in jail, suspended for 5 years; and convicted of Grand Larceny and sentenced to 2 years, suspended after serving 6 months in jail upon the condition of his good behavior and payment of costs, to run concurrent and placed on probation for 5 years. Sentenced January 8, 1979, in the Circuit Court of the City of Waynesboro upon a conviction of Statutory Burglary and sentenced to 3 years; convicted of Unauthorized Use of Auto and sentenced to 2 years, plus costs. Costs have been paid. Paroled November 19, 1980 and discharged March 4, 1982. Granted removal of political disabilities August 18, 1983.

BLANKENSHIP, ROGER DALE. Sentenced February 9, 1966, in the Circuit Court of Buchanan County upon a conviction of Statutory Burglary and sentenced to 2 years, plus costs. Paroled September 12, 1966 and discharged March 12, 1968. Costs have been paid. Granted removal of political disabilities October 14, 1983.

BLAYLOCK, RONNIE LEE. Sentenced September 25, 1978, in the Circuit Court of the City of Bristol upon a conviction of Grand Larceny and sentenced to 3 years, 2 years suspended after serving 12 months and placed on probation for 3 years, plus costs and restitution. Costs and restitution have been paid. Probation terminated September 29, 1980 and suspension expired September 25, 1981. Granted removal of political disabilities August 31, 1983.

BLEVINS, BRUCE V. Sentenced December 16, 1980, in the Circuit Court of Smyth County upon a conviction of Felonious Possession of Firearms Where Alcoholic Beverages Unlawfully Sold and sentenced to 6 months in jail, suspended for 1 year, plus costs. Costs have been paid. Sentence expired December 16, 1981. Granted removal of political disabilities May 10, 1983.

BLOWE, JEAN MILDRED. Sentenced September 4, 1981, in the Circuit Court of Frederick County upon a conviction of Grand Larceny and sentenced to 7 months in jail, plus costs, 5 months suspended and placed on probation for 2 years, plus costs and restitution. Costs and restitution have been paid. Probation completed October 22, 1982. Granted removal of political disabilities December 6, 1983.

BLUM, ROBERT KELLY. Sentenced September 7, 1978, in the Circuit Court of the County of Bedford upon a conviction of Distribution of Controlled Substance, 2 counts, and Possession of Controlled Substance with Intent to Distribute, 1 count. Sentenced to 5 years on each count, suspended upon the condition he serve 12 months in jail on each conviction and placed on probation for 5 years, concurrent, plus costs. Costs have been paid. Probation expired June 17, 1983. Suspension expired September 7, 1983. Granted removal of political disabilities November 4, 1983.

BLUMENTHAL, HAROLD SOLOMON. Sentenced April 2, 1976, in the Circuit Court of the City of Norfolk upon a conviction of Forgery and Uttering. Imposition of sentence suspended and placed on probation for 3 years during good behavior and payment of costs. Costs have been paid. Probation expired April 2, 1979. Granted removal of political disabilities December 9, 1983.

BOOKER, HORACE LEE, JR. Sentenced June 10, 1969, in the Circuit Court of the County of Powhatan upon a conviction of Armed Robbery and sentenced to 20 years. Sentenced December 5, 1969, in the Circuit Court of Chesterfield County upon a conviction of Armed Robbery and sentenced to 5 years, concurrent with Powhatan conviction. Paroled November 28, 1973 and discharged January 12, 1979. Granted removal of political disabilities April 8, 1983.

BOTELLO, MICHAEL WARREN. Sentenced January 11, 1974, in the Circuit Court of Fairfax County upon a conviction of Distribution of a Controlled Drug as an Accommodation and sentenced to 1 year, suspended upon the condition of good behavior and placed on probation for 2 years and enter Cross-Roads Drug Program and pay costs. Costs have been paid. Probation terminated January 11, 1976. Granted removal of political disabilities October 27, 1983.

BOWERS, JACK WESLEY. Sentenced February 20, 1973, in the Hustings Court of the City of Roanoke upon convictions of Distribution of Amphetamines, Distribution of LSD, and Distribution of Marijuana. Sentenced to 3 years on each count, to run consecutively, suspended after serving 8 months upon condition he be admitted to RADAAC Therapeutic Community and complete program, pay costs, placed on supervised probation and be of good behavior for 9 years. Probation terminated March 6, 1978. Suspension expired February 20, 1982. Granted removal of political disabilities March 3, 1983.

BOWMAN, SAM HENRY. Sentenced October 28, 1968, in the Circuit Court of Henry County upon a conviction of Aiding & Abetting Abortion and sentenced to 4 years. Sentenced January 19, 1979 in the Circuit Court of the County of Henry upon a conviction of Violation of the Habitual Offender Act and sentenced to 1½ years, plus costs. Costs have been paid. Paroled July 1, 1979 and discharged January 1, 1980. Granted removal of political disabilities December 6, 1983.

BRADY, BARRY DAVID. Sentenced October 1, 1976, in the Circuit Court of Arlington County upon a conviction of Conspiracy to Distribute Controlled Substance, Heroin, and sentenced to 5 years, plus costs, suspended and placed on probation for 3 years. Costs have been paid. Probation terminated March 30, 1979 and suspension expired October 1, 1981. Granted removal of political disabilities October 20, 1983.

BRANCH, GEORGE LEE. Sentenced September 1, 1977, in the Circuit Court of Southampton County upon a conviction of Unlawful Wounding and sentenced to 3 years, suspended upon condition of good behavior for 3 years, plus costs. Costs have been paid. Suspension and good behavior expired September 1, 1980. Granted removal of political disabilities August 31, 1983.

BRASWELL, ROBERT ERNEST. Sentenced August 15, 1969, in the Circuit Court of the City of Virginia Beach upon a conviction of Hit and Run and fined \$500 plus costs. Fine and costs have been paid. Granted removal of political disabilities August 17, 1983.

BREAKFIELD, RALPH HARRY. Sentenced May 29, 1981, in the U.S. District Court for the Eastern District of Virginia, Norfolk Division, upon a conviction of Conspiracy in Restraint of Interstate Trade & Commerce, 15 USC 1, and sentenced to 1 year with confinement in jail-type institution for 120 days with remainder suspended for 3 years and placed on probation for 3 years, \$15,000 fine to be paid within 60 days of release from confinement. Fine has been paid. Probation and sentence terminated October 17, 1983. Granted removal of political disabilities November 22, 1983.

BREEDEN, LARRY JAMES. Sentenced October 5, 1977, in the Circuit Court of Montgomery County upon a conviction of Malicious Wounding and sentenced to 2 years, plus costs, suspended and placed on probation for 2 years during good behavior and payment of costs. Costs have been paid. Released from probation October 2, 1979 and suspension expired October 5, 1979. Granted removal of political disabilities September 23, 1983.

BRIDGFORTH, JOSEPH SEWARD. Sentenced February 2, 1976, in the Circuit Court of Lunenburg County upon a conviction of Grand Larceny and sentenced to 5 years, plus costs, suspended during good behavior upon condition he pay costs. Costs have been paid. Suspension expired February 2, 1981. Granted removal of political disabilities March 1, 1983.

BRISO, DORIS SENORA ELLEN. Sentenced January 17, 1979, in the Circuit Court of the City of Portsmouth upon a conviction of Grand Larceny-Welfare Fraud, and sentenced to 12 months in jail, suspended and placed on unsupervised probation for 12 months, plus costs and restitution. Costs and restitution have been paid. Probation and suspension expired January 17, 1980. Granted removal of political disabilities July 5, 1983.

BRITT, EDWARD LEE, JR. AKA RUFUS REEVES. Sentenced October 20, 1978, in the Circuit Court of the City of Portsmouth upon a conviction of Grand Larceny and sentenced to 12 months, suspended during good behavior for 12 months and probation for 12 months, plus costs. Costs have been paid. Suspension expired October 20, 1979 and probation supervision terminated June 28, 1979. Granted removal of political disabilities August 1, 1983.

BROCK, WILLIS. Sentenced February 4, 1972, in the Circuit Court of the City of Chesapeake upon a conviction of Attempted Statutory Burglary. Imposition of sentence suspended and placed on probation for 10 years, plus costs. Probation completed April 30, 1975. Costs have been paid. Granted removal of political disabilities November 21, 1983.

BROOKS, BERKLEY ADAMS. Sentenced February 1, 1977, in the Circuit Court of Spotsylvania County upon a conviction of Grand Larceny and sentenced to \$1,000 fine and 12 months in jail, suspended all but 50 days upon the condition of good behavior and payment of costs. Costs and fine have been paid. Suspension expired February 1, 1978. Granted removal of political disabilities September 30, 1983.

BROOKS, LORA GENEVA. Sentenced February 1, 1977, in the Circuit Court of Spotsylvania County upon a conviction of Grand Larceny and sentenced to \$1,000 fine, 12 months in jail, jail sentence suspended upon condition of good behavior for 1 year and payment of costs. Costs and fine have been paid. Sentence expired February 1, 1978. Granted removal of political disabilities October 14, 1983.

BROOKS, RUTH JONES. Sentenced April 5, 1978, in the Circuit Court of the City of Richmond, Division II, upon a conviction of Unlawful Wounding. Imposition of sentence suspended for 5 years on condition of good behavior and placed on supervised probation, plus costs. Costs have been paid. Discharged from probation June 7, 1979. Suspension expired April 5, 1983. Granted removal of political disabilities June 15, 1983.

BROTHERS, EVERTON LEE. Sentenced March 7, 1975, in the Circuit Court of the County of Fairfax upon a conviction of Uttering and Delivering a Forged Check and Forgery and sentenced to 3 years, suspended and placed on probation for 3 years on each count, to run concurrently. Costs have been paid. Probation supervision terminated May 2, 1977 and suspensions expired March 7, 1978. Sentenced October 11, 1974, in the Circuit Court of Arlington County of convictions of Uttering, 2 counts and Forgery, 2 counts, and imposition of sentence suspended and case continued for 1 year.
