REMOVAL OF POLITICAL DISABILITIES

Relying upon the recommendations of parole officers and/or reputable citizens who are familiar with the conduct of these individuals since their conviction or release, I have granted Removal of Political Disabilities to the following:

ACKERSON, LAURA L., AKA LAURA LOGSDON Sentenced March 4, 1975, in the Sparta Municipal Court, Sussex County, New Jersey, upon a conviction of Possession of Less Than 25 Grams of Marijuana and given a conditional discharge and 6 months probation. Case dismissed October 15, 1976. Granted removal of political disabilities September 6, 1984.

ADAMS, CHARLIE LEE Sentenced October 2, 1974, in the Circuit Court of the City of Danville upon a conviction of Hit and Run Personal Injury. Imposition of sentence deferred upon condition of good behavior for 3 years from date of release from Danville City Prison Farm and probation for 3 years, plus costs. Sentenced September 5, 1978, of Involuntary Manslaughter and sentenced to 12 months in Danville City Prison Farm, fined \$100, plus costs, with 9 months suspended upon condition of good behavior for 1 year from date of release from probation, plus pay fine and costs. Placed on probation for 1 year from date of release from Prison Farm. Costs and fine have been paid. Probation completed November 2, 1979. Granted removal of political disabilities November 19, 1984.

ADAMS, JORDAN ALLEN Sentenced March 27, 1957, in the Circuit Court of Grayson County upon a conviction of Rape and sentenced to 48 years, plus costs. Costs have been paid. Paroled September 17, 1970. Discharged January 29, 1975. Granted removal of political disabilities March 12, 1984.

ADAMS, SHARON SUE, AKA SHARON SUE McKINNEY Sentenced February 12, 1975, in the Circuit Court of the City of Hampton upon a conviction of Possession of Marijuana with Intent to Distribute and sentenced to 12 months, suspended upon condition of good behavior for 2 years, plus costs; Possession of LSD and sentenced to 5 years, suspended 4 years and 9 months upon condition of good behavior, plus costs. Costs have been paid. Suspensions expired February 12, 1980. Granted removal of political disabilities August 16, 1984.

ADAMS, TIMOTHY RAY Sentenced October 27, 1982, in the Circuit Court of Campbell County upon convictions of Involuntary Manslaughter and Hit & Run and sentenced to 12 months, concurrent, and license suspended for 6 months and participate in work release program, plus costs on each conviction. All costs have been paid. Released from incarceration by court order of February 3, 1983. Granted removal of political disabilities April 24 1984.

ADKINS, JR., ALVIN EUGENE Sentenced August 25, 1978, in the Circuit Court of the City of Martinsville upon a conviction of Obtaining Money Under False Pretenses. Imposition of sentence suspended during good behavior for 2 years and placed on probation for 2 years, plus costs and restitution. Costs and restitution has been paid. Released from supervised probation July 2, 1980. Good behavior expired August 25, 1980. Granted removal of political disabilities August 28, 1984.

AKER, RALPH CAMPBELL Sentenced June 27, 1961, in the Hustings Court of the City of Roanoke upon a conviction of Second Degree Murder and sentenced to 20 years. Paroled April 9, 1968. Discharged February 28, 1973. Granted removal of political disabilities February 17, 1984.

ALFORD, JIMMY VAUGHN Sentenced May 12, 1970, in the Corporation Court of the City of Bristol upon a conviction of Statutory Burglary and sentenced to 3 years, plus costs. After serving 2 years, 1 year suspended and placed on probation for 1 year upon condition of good behavior. Costs have been paid. Released from Penitentiary March 2, 1971. Released from probation September 3, 1972. Suspension expired May 12, 1973. Granted removal of political disabilities March 20, 1984.

ALGER, ALDINE REUBEN Sentenced July 24, 1945, in the Circuit Court of Page County upon a conviction of Malicious Assault and sentenced to 2 years, plus costs. Costs have expired under Statute of Limitations. Paroled April 15, 1946. Discharged October 15, 1947. Granted removal of political disabilities August 10, 1984.



ALLAHUDIN-CONWAY, ISHMAIL ABDUL, AKA ROGER OTHELLO CONWAY, JR. Sentenced July 24, 1972, in the Common Pleas Court of Philadelphia, Pennsylvania, upon a conviction of Conspiracy and sentenced to not less than 9 nor more than 18 months in prison from November 20, 1970. Granted removal of political disabilities October 2, 1984.

ALLEN, SCOTT PHILIP Sentenced June 13, 1979, in the Circuit Court of Patrick County upon a conviction of Breaking and Entering and sentenced to 5 years, plus costs, suspended upon condition of good behavior for 3 years, plus costs. Costs have been paid. Suspension, good behavior and probation terminated October 6, 1981. Granted removal of political disabilities August 13, 1984.

ALSTON, MILTON Sentenced September 18, 1979, in the Circuit Court of the City of Norfolk upon a conviction of Malicious Wounding and sentenced to 3 years, plus costs, suspended and placed on probation for 3 years, plus costs. Costs have been paid. Probation and suspension expired September 18, 1982. Granted removal of political disabilities August 24, 1984.

ANDERSON, ARLIE GWYN Sentenced March 16, 1977, in the Circuit Court of Smyth County upon convictions of Hit and Run and sentenced to 4 years; and Involuntary Manslaughter and sentenced to 3 years. Costs have been paid. Paroled April 2, 1979. Discharged December 30, 1981. Granted removal of political disabilities February 28, 1984.

AREHART, WILLIAM EDWARD Sentenced February 23, 1977, in the Circuit Court of Rockingham County upon a conviction of Statutory Burglary and sentenced to 3 years, suspended and placed on probation for 3 years conditioned upon payment of costs. Sentenced October 17, 1977, in the Circuit Court of Rockingham County upon a conviction of Statutory Burglary and sentenced to 3 years, suspended and placed on probation for 3 years conditioned upon payment of costs. Costs have been paid. Probation and suspensions expired October 17, 1980. Granted removal of political disabilities April 16, 1984.

ARNOLD, RONALD WALLACE Sentenced March 2, 1970, in the Corporation Court of the City of Bristol upon a conviction of Forgery and Uttering a Forged Check and sentenced to 12 months in jail, plus costs on each count to run concurrently, suspended and placed on probation for 2 years. Costs have been paid. Probation expired March 2, 1972. Granted removal of political disabilities September 27, 1984.

ARRINGTON, DANNY HERMAN Sentenced June 7, 1966, in the Circuit Court of the City of Martinsville upon convictions of Forgery and sentenced to 2 years; and Uttering a Forged Instrument and sentenced to 2 years, plus costs. Sentences suspended upon condition of good behavior for 3 years and payment of costs and restitution. Costs and restitution have been paid. Good behavior expired June 7, 1969. Granted removal of political disabilities December 3, 1984.

ARTISE, PINRECKO LLOYD Sentenced June 5, 1980, in the U.S. District Court for the Eastern District of Virginia, Norfolk Division, upon a conviction of violation of the Food Stamp Act and sentenced to 18 months, suspended for 3 years and placed on probation for 3 years, plus pay fine. Fine has been paid. Probation expired June 4, 1983. Granted removal of political disabilities January 16, 1984.

ARTRIP, HOWARD WALTER Sentenced February 12, 1959, in the Hustings Court of the City of Roanoke upon a conviction of Grand Larceny and sentenced to 12 months, plus \$50 fine and costs. Fine and costs have been paid. Granted removal of political disabilities August 30, 1984.

ATKINS, ALLEN RAY Sentenced April 2, 1969, in the Circuit Court of the City of Salem, upon a conviction of Grand Larceny and sentenced to 12 months in jail, \$10 fine, plus costs. In lieu of confinement placed on probation for 3 years upon condition of good behavior. Costs have been paid. Released from probation February 18, 1972. Granted removal of political disabilities June 1, 1984.

AYERS, ARTHUR WAYNE Sentenced September 27, 1977, in the Circuit Court of King and Queen County upon a conviction of Distribution of Marijuana and sentenced to 5 years, \$1.00 fine, plus costs. Convicted of Sale of Marijuana and sentenced to 5 years and fined \$500. Costs and fines have been paid. Paroled September 30, 1980. Discharged November 25, 1980. Granted removal of political disabilities February 20, 1984.

AYERS, JR., MAXIE GLENWOOD Sentenced June 1, 1976, in the U.S. District Court for the Western District of Virginia, Roanoke Division, upon a conviction of violation of Title 18, USC Sections 641, 1708, 371 & 2, Conspiracy to Commit Robbery, Robbery and Mail Theft. Sentence amended September 2, 1976. Imposition of sentence suspended and placed on probation for 3 years. Probation and sentence terminated September 9, 1979. Granted removal of political disabilities June 25, 1984.

BAILEY, DENNIS PAUL Sentenced April 5, 1976, in the Circuit Court of Isle of Wight County upon a conviction of Grand Larceny and sentenced to 3 years, suspended and placed on probation for 3 years, plus costs. Costs have been paid. Released from probation April 21, 1978. Suspension expired April 5, 1979. Granted removal of political disabilities June 1, 1984.

BAILEY, JAMES ROGERS Sentenced December 10, 1929 in the Corporation Court of the City of Norfolk, Part II, upon a conviction of Grand Larceny and sentenced to 3 years. Costs have been paid. Granted removal of political disabilities July 30, 1984.

BANKS, RODNEY WAYNE Sentenced January 28, 1974, in the Circuit Court of the City of Salem upon a conviction of Robbery and sentenced to 5 years, plus costs. In lieu of confinement placed on probation for 5 years, plus costs and restitution. Costs and restitution have been paid. Released from probation December 23, 1978. Suspension expired January 28, 1979. Granted removal of political disabilities March 5, 1984.

BARBOUR, LONNIE LOWELL Sentenced April 17, 1970, in the U.S. District Court for the Southern District of Illinois, Springfield Division, upon a conviction of violation of T18, USC, Section 641, Theft of Public Property, 2 counts, and T18, USC, Section 2312, Interstate Transportation of a Stolen Motor Vehicle. Imposition of sentence suspended and placed on probation for 5 years, plus pay restitution. April 5, 1975, probation revoked for failure to pay restitution and ordered to pay \$1,600 fine. Fine has been paid. Discharged from probation April 5, 1975. Granted removal of political disabilities October 16, 1984.

BARDEN, HARVEY LEE Sentenced April 27, 1976, in the U.S. District Court for the Eastern District of Virginia, Richmond Division, upon a conviction of Filing a False and Fraudulent Income Tax Return with the Internal Revenue Service for Calendar Year 1970 in violation of Title 26, USC, Section 7201. Sentenced to 4 years, suspended and placed on probation for 5 years, plus costs. Costs have been paid. Probation and suspension terminated October 16, 1978. Granted removal of political disabilities June 15, 1984.

BARNES, HOSEA Sentenced September 23, 1977, in the Circuit Court of the City of Portsmouth upon a conviction of Unlawful Wounding with Intent to Maim and sentenced to 5 years, suspended and placed on probation for 5 years upon condition of good behavior for 5 years, plus costs. Costs have been paid. Released from probation February 4, 1980. Suspension expired September 23, 1982. Granted removal of political disabilities December 3, 1984.

BARNES, LARRY THOMAS Sentenced September 1, 1965, in the Hustings Court of the City of Petersburg upon a conviction of Statutory Burglary and sentenced to 12 months in jail, plus costs, 6 months suspended upon condition of good behavior for 5 years and payment of costs. Unserved portion of 12 months jail sentence not previously suspended was suspended upon condition of good behavior and placed on probation for 2 years. Costs have been paid. Probation expired September 1, 1967. Good behavior expired September 1, 1970. Granted removal of political disabilities September 4, 1984.

BARNETTE, JOYCE LYNN Sentenced May 11, 1977, in the Circuit Court of the City of Virginia Beach upon convictions of Credit Card Theft and Credit Card Fraud and sentenced to 5 years, suspended and placed on probation during good behavior for 5 years, plus costs to be paid within 90 days and make restitution within 12 months, to run concurrently. Costs and restitution have been paid. Suspensions expired May 11, 1982. Granted removal of political disabilities August 31, 1984.

BARRETT, RICHARD HUGH Sentenced June 5, 1981, in the Circuit Court of Fairfax County upon a conviction of Distribution of More Than One-Half Ounce of Marijuana and sentenced to 2 years and fined \$500, suspended upon condition of good behavior and placed on probation for 2 years. Costs and restitution have been paid. Probation and suspension expired June 5, 1983. Granted removal of political disabilities July 25, 1984.

BARTON, FREEMAN ARNOLD Sentenced October 10, 1975, in the Circuit Court of the County of Russell upon a conviction of Malicious Wounding and sentenced to 4 years, plus costs, to serve 3 months in jail with remainder suspended and placed on probation for 4 years, plus costs and restitution. Costs and restitution have been paid. Discharged from probation September 10, 1979. Granted removal of political disabilities February 1, 1984.

BARTON, GEORGE EARNEST Sentenced May 12, 1983, in the Circuit Court of Russell County upon a conviction of violation of the Habitual Offender Act and sentenced to 1 year, plus costs. Costs have been paid. Probation and suspension expired May 9, 1984. Granted removal of political disabilities August 13, 1984.

BECK, JAMES CURTIS Sentenced May 21, 1959, in the Circuit Court of Dinwiddie County upon a conviction of Manufacturing Alcoholic Beverages Without a License and sentenced to 18 months in the Penitentiary, suspended upon condition of good behavior for 5 years. Sentenced October 25, 1960, in the U.S. District Court for the Eastern District of Virginia, Richmond Division, upon a conviction of Grand Larceny. Imposition of sentence was suspended for 5 years and placed on probation for five years to run equal time with State probation. Costs have been paid. Good behavior expired May 21, 1964. Granted removal of political disabilities July 25, 1984.

BENSON, JR., THOMAS LEE Sentenced December 5, 1966, in the Circuit Court of the County of Albemarle upon a conviction of Breaking and Entering and sentenced to 3 years, plus costs. Costs have been paid. Paroled September 20, 1967. Discharged March 20, 1969. Granted removal of political disabilities March 1, 1984.

BENTHAM, WILLIAM NEFF Sentenced June 9, 1978, in the Circuit Court of the City of Norfolk upon a conviction of Possession of Cocaine. Imposition of sentence suspended during good behavior for 3 years and placed on probation for 3 years upon condition of good behavior and payment of costs. Costs have been paid. Discharged from probation and good behavior expired June 9, 1981. Granted removal of political disabilities August 22, 1984.

BETHEA, ALEXANDER Sentenced December 19, 1977, in the Circuit Court of the City of Norfolk upon a conviction of Grand Larceny and sentenced to 2 years, plus costs. Costs have been paid. Paroled June 22, 1979. Discharged December 20, 1979. Granted removal of political disabilities July 23 1984.

BEVERLY, LONNIE LEE Sentenced August 20, 1980, in the Circuit Court of Rockbridge County upon a conviction of Receiving Stolen Goods and sentenced to 2 years. Imposition of sentence suspended and placed on probation for 2 years upon condition of good behavior, plus costs and restitution. September 1, 1982, probation extended until costs and restitution paid. Released from probation June 11, 1984. Sentenced August 24, 1981, in the U.S. District Court for the Western District of Virginia, Roanoke Division, upon a conviction of Conspiracy in violation of T18, USC, Section 271. Imposition of sentence suspended and placed on probation for 3 years. Discharged from probation August 23, 1984. Costs and restitution have been paid. Granted removal of political disabilities October 23, 1984.

BEVERLY, MARY LOUISE, AKA MARY LOUISE EWING Sentenced July 25, 1972, in the U.S. District Court for the Eastern District of Virginia, Newport News Division, upon a conviction of Assault with a Dangerous Weapon with Intent to do Bodily Harm in violation of T18, USC, Section 113(c). Imposition of sentence suspended and placed on probation for 3 years and submit to psychiatric treatment. Probation expired July 25, 1975. Granted removal of political disabilities September 12, 1984.

BILLUPS, EDWARD BENJAMIN Sentenced November 1, 1962, in the Corporation Court of the City of Norfolk upon a conviction of Forgery, 2 counts. Imposition of sentence suspended and placed on probation for 3 years upon condition of good behavior and payment of costs. Costs have been paid. Discharged from probation November 1, 1965. Granted removal of political disabilities February 21, 1984.

BISHOP, RAYMOND EDWARD Sentenced August 10, 1981, in the Circuit Court of the City of Norfolk upon a conviction of Grand Larceny and sentenced to 12 months in jail, plus costs, suspended and placed on probation for 3 years upon condition of good behavior and payment of costs. Costs have been paid. Supervised probation expired July 9, 1982. Unsupervised probation expired August 10, 1984. Granted removal of political disabilities November 14, 1984.

BLACK, THOMAS JEFFERSON Sentenced July 21, 1948, in the Circuit Court of Pittsylvania County upon a conviction of First Degree Murder, 2 counts, and sentenced to 25 years, plus costs on each count to run concurrently. Costs have expired under Statute of Limitations. Paroled December 22, 1954. Discharged November 28, 1960. Granted removal of political disabilities July 25, 1984.

BLANKENBAKER, THOMAS JEFFERSON Sentenced April 20, 1967, in the Circuit Court of Culpeper County upon a conviction of Statutory Burglary and sentenced to 12 months in jail with 9 months suspended for 3 years, plus costs and restitution and probation for 3 years. Costs and restitution have been paid. Released from probation March 11, 1969. Granted removal of political disabilities September 25, 1984.

BLUHM, FREDDIE LEON Sentenced November 19, 1965, in the Circuit Court of Patrick County upon a conviction of Breaking & Entering. Imposition of sentence delayed and placed on probation for 3 years, plus costs. Convicted of Petit Larceny and sentenced to 9 months. Costs have been paid. Probation terminated November 27, 1967. Granted removal of political disabilities August 10, 1984.

BOND, ROBERT GLENN Sentenced July 2, 1964, in the Circuit Court of Carroll County upon convictions of Breaking and Entering and Grand Larceny and sentenced to 6 years, plus costs and restitution, suspended and placed on probation during good behavior for 4 years. Sentences not to run concurrently. Released from probation March 27, 1967. Suspensions expired July 2, 1976. Granted removal of political disabilities November 19, 1984.

BOOTHE, PAUL DOUGLAS Sentenced March 16, 1962, in the Circuit Court of the City of Roanoke upon a conviction of Statutory Burglary and sentenced to 3 years, suspended after serving 4 months upon condition of good behavior and probation for 3 years. Sentenced November 21, 1963 in the Circuit Court of the City of Roanoke upon a conviction of Disposal of Pledged Property and sentenced to 12 months in jail, plus costs, suspended upon condition of good behavior. Statute of Limitations as to costs has expired. Probation completed September 3, 1965. Granted removal of political disabilities September 6, 1984.

BOUTWELL, BILLY JEROME Sentenced December 12, 1963, in the Circuit Court of the City of Portsmouth upon a conviction of Grand Larceny and sentenced to 6 months in jail, \$100 fine, suspended upon payment of costs; Carrying a Concealed Weapon and fined \$25, plus costs. Costs and fines have been paid. Granted removal of political disabilities August 16, 1984.

BOWERS, RAYMOND RICHARD Sentenced January 24, 1964, in the Circuit Court of the City of Portsmouth upon a conviction of Second Degree Murder and sentenced to 5 years, suspended and probation for 8 years conditioned upon good behavior for 8 years, plus costs. Sentenced June 5, 1964, in the Circuit Court of the City of Portsmouth upon a conviction of Abortion. Imposition of sentence delayed and placed on probation for 10 years upon condition of good behavior for 10 years, plus costs, to run concurrently. All costs have been paid. Suspensions terminated February 14, 1969. Granted removal of political disabilities April 10, 1984.

BOWMAN, HOWARD EUGENE Sentenced January 28, 1982, in the U.S. District Court for the Western District of Virginia, Abingdon Division, upon a conviction of Embezzlement, 4 counts, and fined \$5,000 with all but \$1,500 suspended. Imposition of sentence as to imprisonment suspended and placed on probation for 3 years, pay fine and perform 100 hours of community service. Fine was set aside May 5, 1982. Probation and suspension terminated June 4, 1984. Granted removal of political disabilities August 2, 1984.

BOYERS, ROBERT CHARLES Sentenced December 12, 1979, in the Circuit Court of Rockingham County upon a conviction of Malicious Wounding and sentenced to 6 years, 3 years suspended with probation for 10 years, plus costs and restitution. May 27, 1982, violated probation and 3 years of suspension revoked. Costs and restitution have been paid. Paroled April 28, 1983. Discharged February 6, 1984. Granted removal of political disabilities March 9, 1984.

BRACEY, ANDERSON MCBIER Sentenced February 23, 1948, in the Circuit Court of Mecklenburg County upon a conviction of Murder and sentenced to Life. Paroled March 25, 1963. Discharged May 4 1970. Granted removal of political disabilities April 30, 1984.

BREWER, LUTHER CLAYTON Sentenced November 30, 1971, in the Circuit Court of the City of Chesapeake upon a conviction of Unlawful Wounding. Imposition of sentence suspended and placed on probation during good behavior for 3 years, plus costs. Costs have been paid. Probation expired November 30, 1974. Granted removal of political disabilities December 7, 1984.

BROWN, CHARLES WILLIAM Sentenced June 26, 1948, in the Circuit Court of the City of Staunton upon a conviction of Larceny from the Person and sentenced to 1 year. Sentenced July 19, 1950, upon a conviction of Malicious Maiming and sentenced to 3 years. Granted removal of political disabilities June 1, 1984.

BROWN, GAYNELL MARTIN Sentenced July 31, 1979, in the Circuit Court of the City of Martinsville upon a conviction of Sale and Distribution of Phenmetrazine Hydrochloride and sentenced to 5 years and fined \$300, with 4 years 3 months suspended and placed on probation upon release and good behavior for 4 years, plus costs. Costs have been paid. Probation terminated January 19, 1983. Suspension expired July 31, 1984. Granted removal of political disabilities August 1, 1984.

BROWN, JAMES CORNELIUS Sentenced January 23, 1978, in the Circuit Court of Buckingham County upon a conviction of Falsification of Auto Title and sentenced to 12 months in jail, suspended all but two weekends in jail upon condition of payment of restitution and costs and be of good behavior for 3 years. Costs and restitution have been paid. Good behavior expired January 23, 1981. Granted removal of political disabilities October 3, 1984.

BROWN, ROBERT MILLER Sentenced February 9, 1966 in the Circuit Court of Nelson County upon a conviction of Statutory Burglary (breaking & entering and grand larceny), 2 counts, and sentenced to 2 years on each count, plus costs, suspended and placed on probation by order of November 27, 1972 during good behavior for 5 years upon condition of payment of costs and refrain from use of alcohol. Convicted of Statutory Burglary (breaking & entering and grand larceny) and sentenced to 2 years on each count, plus costs, suspended and placed on probation November 27, 1972 during good behavior for 5 years upon condition of payment of costs and refrain from use of alcohol. All costs and fines have been paid. Probation terminated September 5, 1975. Granted removal of political disabilities February 22, 1984.

BRYAN, MARCUS Sentenced August 10, 1976, in the Circuit Court of Carroll County upon a conviction of Grand Larceny and sentenced to 8 years, to serve 12 months in jail in lieu of Penitentiary sentence and placed on probation for 7 years during good behavior after release, plus costs and restitution, not to run concurrently. Unserved portion of sentence suspended January 11, 1977 and placed on probation. Sentenced August 18, 1976, in the Circuit Court of Grayson County upon convictions of Breaking and Entering and Grand Larceny and sentenced to 8 years to run concurrently with sentence imposed in Carroll County, suspended for 7 years after release from confinement on previous sentence upon condition of good behavior for 7 years and placed on probation, plus costs.
