BLUMENTHAL, HAROLD SOLOMON Sentenced April 2, 1976 in the Circuit Court of the City of Norfolk upon a conviction of Forgery and Uttering and the imposition of sentence was suspended and placed on probation for three years during good behavior, plus costs. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since her conviction, I am granting her a Simple Pardon. This pardon dated December 20, 1985.

HARRIS, RICHARD TATE Sentenced November 30, 1978 in the Circuit Court of Amherst County of a conviction of Manufacturing Marijuana and sentenced to five years and fined \$1000, plus costs. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his release, I am granting him a Simple Pardon. This pardon dated January 10, 1986.

IRELAND, SCOTT BROWN Sentenced January 2, 1979 in the Circuit Court of the City of Danville upon convictions of Selling Cocaine, Selling a Schedule II Controlled Substance and Selling Marijuana and sentenced to five years, plus \$100 fine and costs on count one and the imposition of sentence was suspended on the remaining two counts. The court suspended the five year sentence as to confinement conditioned upon twelve months jail and placed on probation for one years upon released and three years good behavior upon released from probation, plus fine and court costs. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his release, I am granting him a Simple Pardon. This pardon dated January 10, 1986.

McLOUGHLIN, DANIEL L. Sentenced June 8, 1978 in the General District Court of Fairfax County upon a conviction of Brandishing a Firearm and sentenced to thirty days in jail, suspended and fined \$50, plus court costs. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated December 20, 1985.

MANNING, GLENN SHERWOOD Sentenced January 23, 1959 in the Circuit Court of the City of Chesapeake upon a conviction of Statutory Rape and sentenced to five years, suspended and placed on probation for five years. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated August 20, 1985.

MILLER, BENJAMEN ANTONIO Sentenced January 11, 1967 in the Circuit Court of the City of Lynchburg upon a conviction of Attempted Grand Larceny and fined \$500, plus court costs. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated January 10, 1986.

SWEENEY, ROBERT H. Sentenced November 15, 1977 in the General District Court of the City of Salem upon a conviction of Petit Larceny and fined \$50. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated December 20, 1985.

TAVSS, SIDNEY TOBIN Sentenced November 30, 1977 in the Circuit Court of the City of Danville upon a conviction of Selling Marijuana, 2 Counts, and sentenced to five years and \$100 fine, suspended upon condition of confinement in the City Prison Farm for six months and to be of good behavior for three years and placed on probation for one year, plus fine and court costs as to count one; count two suspended imposition of sentence conditioned upon good behavior for five years, plus court costs. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his release, I am granting him a Simple Pardon. This pardon dated January 10, 1986.

THOMAS, PAUL DERRING Sentenced March 3, 1971 in the Circuit Court of Fairfax County upon a conviction of Possession of a Controlled Drug, LSD, and sentenced to one year in the penitentiary, suspended upon the condition of his good behavior and placed on probation for two years. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated January 10, 1986.

WHELAN, ROBERT E. Sentenced June 18, 1974 in the Circuit Court of the City of Richmond, Division II, upon a conviction of Accessory After the Fact of Larceny and sentenced to twelve months in jail, suspended and placed on probation for five years, plus pay fine, court costs, and restitution. In view of the facts presented to me and the recommendations of reputable citizens familiar with this person's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated January 10, 1986.

WHITE, SAMUEL PEARCE Sentenced August 23, 1978 in the Circuit Court of Henrico County upon a conviction of Indecent Exposure and was fined \$24, plus court costs. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated January 10, 1986.

WOODINGTON, JOSIAH HARVEY, III Sentenced January 19, 1977 in the Circuit Court of the City of Virginia Beach upon a conviction of Possession of Cocaine and sentenced to two years and \$1000 restitution, sentence as to confinement suspended and placed on probation during good behavior for two years, plus costs. In view of the facts presented to me and the recommendations of reputable citizens who are familiar with this person's conduct since his conviction, I am granting him a Simple Pardon. This pardon dated January 10, 1986.

ALEXANDER, DAVID CHARLES Sentenced December 16, 1982 in the Circuit Court of the City of Bristol upon a conviction of Possession of Marijuana with Intent to Sell and sentenced to 2 years, plus costs, and after serving 30 days in jail remaining unserved portion suspended and placed on probation for 2 years from date of release and ordered to donate 100 hours to community service work. Costs have been paid. Probation expired December 16, 1984. Probation terminated by court order January 2, 1985. Granted removal of political disabilities May 9, 1985.

ALEXANDER, JAMES ERNEST, JR. Sentenced December 14, 1973 in the Circuit Court of Roanoke County upon a conviction of Habitual Offender and sentenced to 1 year in the Penitentiary, plus costs. Having been placed on work release by order of June 27, 1973 and having served sufficient period of time in jail to comply with sentence he was released from further custody. Costs have been paid. Granted removal of political disabilities May 10, 1985.

APPLEGATE, DOTTIE JEAN BROWN

Court of Amelia County upon a conviction of Making a False Application of Assistance, to wit: Medical Assistance in violation of Virginia Code Section 63.1-107.1, 2 counts and Obtain by Means of a Willfully False Statement or Representation, Assistance, to wit: Food Stamps in violation of Virginia Code Section 63.1-124, 3 Counts and sentenced to 2 years with all but 30 days suspended and placed on probation for two years after release plus costs and restitution on each count to run consecutively. Suspended sentence revoked November 4, 1982. Sentenced November 4, 1982 of Making False Application of Assistance, to wit: Medical Assistance in violation of Virginia Code Section 63.1-107.1 and sentenced to 2 years. Costs and restitution have been paid. Suspended sentence terminated July 21, 1984. Granted removal of political disabilities April 17, 1985.

APPLEWHITE, EDWARD WAYNE Sentenced May 30, 1973 in the Circuit Court of Chesterfield County upon convictions of: Accessory After the Fact and sentenced to 6 months in jail, suspended for 5 years upon condition of good behavior and payment of costs; and Possession and Distribution of Sodium Pentobarbital and sentenced to 3 years suspended for five years upon condition of good behavior and payment of costs and placed under supervision of probation and parole officer. Costs have been paid. Released from probation supervision May 20, 1974. Suspensions expired May 30, 1978. Granted removal of political disabilities February 8, 1985.

ARNOLD, LUTHER AUBREY

Sentenced December 10, 1953 in the Corporation Court of the City of Lynchburg upon convictions of Burglary, Possession of Burglary Tools; 5 charges of Statutory Burglary and sentenced to forty-seven years; 10 years on Burglary charge; 8 years on Possession Burglary Tools; 6 years each on 4 Statutory Burglary charges and 5 years on one Statutory Burglary charge. Granted Conditional Pardon on March 10, 1961 effective March 16, 1961 and placed under supervision.

Convicted March 8, 1954, in the Circuit Court of Campbell County upon a conviction of Statutory Burglary, 2 counts. Imposition of sentence suspended and placed on probation for 5 years conditioned upon good behavior for 5 years, plus costs. Costs have expired under Statute of Limitations. Released from parole supervision March 16, 1966. Granted removal of political disabilities February 26, 1985.

ARTHUR, DONALD CLAUDE Sentenced May 26, 1976 in the Circuit Court of Broward County, Florida upon a conviction of Robbery and sentenced to 5 years, plus \$2.00 assessment. Sentenced April 11, 1977 in the Circuit Court of Jackson County, Florida, upon a conviction of Escape and sentenced to 2 years after release from Broward County conviction. Discharged by expiration October 8, 1982. Convicted January 26, 1981 in the Circuit Court of the City of Colonial Heights upon a conviction of Possession with Intent to Distribute Marijuana and sentenced to 12 months, \$500 fine, plus costs. Fine and costs have been paid. Sentence expired January 26, 1982. Granted removal of political disabilities February 25, 1985.

BAILEY, BARRY ALLEN Sentenced June 28, 1982 in the Circuit Court of Washington County upon a conviction of Selling Marijuana and sentenced to 2 years suspended and placed on probation for 3 years, plus costs. Costs have been paid. Discharged from probation October 9, 1984. Granted removal of political disabilities February 12, 1985.

BAILEY, GEORGE ROBERTSON Sentenced September 13, 1975 in the Circuit Court of Isle of Wight County upon a conviction of Receiving Stolen Goods and sentenced to 3 years suspended and placed on probation for 5 years conditioned upon good behavior, plus costs. Costs have been paid. Released from probation August 13, 1980. Granted removal of political disabilities August 2, 1985.

BAILEY, JERRY BAYNARD Sentenced December 2, 1975 in the Circuit Court of Greensville County upon a conviction of Extortion and sentenced to 5 years with 2 years suspended during good behavior for 5 years plus costs. March 25, 1976, unserved portion of sentence suspended upon condition of good behavior for 5 years from March 25, 1976, and placed on probation. Released from probation March 1, 1978. Good behavior expired March 25, 1981. Costs have been paid. Granted removal of political disabilities May 9, 1985.

BALDWIN, JOHN WESLEY Sentenced December 19, 1980 in the Circuit Court of Highland County upon a conviction of Unlawfully Discharging a Firearm into an Occupied Dwelling and sentenced to 12 months in jail and fined \$750, plus costs. Costs and fine have been paid. Sentence expired December 19, 1981. Granted removal of political disabilities February 8, 1985.

BARBATO, ROBERT ALLEN, JR. Sentenced April 4, 1984 in the Circuit Court of the City of Lynchburg upon a conviction of Grand Larceny and sentenced to 1 year, plus costs. Execution of sentence suspended with 1 year probation and good behavior, plus pay costs. Costs have been paid. Discharged from probation April 3, 1985. Suspension expired April 4, 1985. Granted removal of political disabilities June 6, 1985.

BARTON, TIMMY LEANZA Sentenced July 24, 1984 in the Circuit Court of Buchanan County upon a conviction of Operating a Motor Vehicle After Having Been Adjudicated an Habitual Offender and sentenced to 1 year, plus pay costs. Costs have been paid. Paroled October 23, 1984. Discharged April 23, 1985. Granted removal of political disabilities June 7, 1985.

BEARD, CHARLES THOMAS Sentenced June 20, 1975 in the Circuit Court of Henry County upon a conviction of Forgery. Imposition of sentence suspended upon condition of good behavior and placed on probation for 3 years, plus costs. Costs have been paid. Released from probation July 6, 1976. Granted removal of political disabilities February 7, 1985.

BENNETT, KAREN REBECCA Sentenced February 22, 1983 in the Circuit Court of Rockingham County upon a conviction of Perjury, 2 counts. Sentenced to 1 year on each count to run consecutively, plus costs. Execution of sentence suspended for two years and placed on probation and perform 100 hours of community service work, plus costs. Costs have been paid. Probation expired February 22, 1985. Granted removal of political disabilities March 26, 1985.

BLEVINS, RANDOLPH LEGARDE Sentenced December 18, 1975 in the Circuit Court of Washington County upon a conviction of Statutory Burglary and sentenced to 3 years. Sentenced September 12, 1980 in the Circuit Court of Smyth County upon convictions of Common Law Burglary, 3 counts, and sentenced to 5 years on each count to run concurrently, and convicted of one count of Grand Larceny and sentenced to 1 year to run concurrently. Paroled June 20, 1983. Discharged October 30, 1984. Granted removal of political disabilities February 20, 1985.

BOYD, FRED MONROE Sentenced February 2, 1981 in the Circuit Court of the County of Buchanan upon a conviction of Involuntary Manslaughter and sentenced to 5 years suspended and placed on probation for 5 years upon the condition of good behavior during the 5 year probation period and to remain under counseling and rehabilitation for the 5 year probation period and privilege to operate a motor vehicle suspended for 1 year. Discharged from probation April 8, 1985. Suspended sentence expired April 8, 1985. Costs have been paid. Granted removal of political disabilities September 23, 1985.

BRAY, VICTORIA JOAN Sentenced February 1, 1978 in the Circuit Court of the City of Hampton upon a conviction of Possession of Marijuana with Intent to Distribute and sentenced to 5 years, plus costs, suspended upon condition of good behavior and placed on probation for 18 months. Costs have been paid. Probation expired August 1, 1979. Suspension expired February 1, 1983. Granted removal of political disabilities July 11, 1985.

BRITTON, RAYMOND LENON, JR. Sentenced April 23, 1980 in the Circuit Court of Accomack County upon convictions of Statutory Burglary and Grand Larceny and sentenced to 5 years on each to run concurrently, suspended and placed on probation for 5 years, plus costs. Costs have been paid. Released from probation April 8, 1982. Suspension expired April 23, 1985. Granted removal of political disabilities June 17, 1985.

BROOM, RICHARD ALAN Sentenced September 27, 1972 in the Circuit Court of Hanover County upon a conviction of Distributing a Controlled Drug, to wit: Marijuana and sentenced to 4 years with 2 years suspended for 10 years upon the condition of good behavior, suspended execution of sentence to allow defendant to perfect appeal. October 4, 1972 motion withdrawn and sentenced to 4 years with 2 years suspended and credit for time spent in jail. Paroled August 7, 1973. Discharged August 14, 1974. Released from probation September 20, 1974. Good behavior expired September 27, 1982. Granted removal of political disabilities May 21, 1985.

BROWN, JAMES ORSON Sentenced January 3, 1973 in the U.S. District Court for the Western District of Texas, San Antonio Division, upon a conviction of Conspiracy (18 USC 371) involving 18 USC 2113(a). Imposition of sentence suspended under provision of Title 18, USC 3651, and placed on probation for 5 years. May 23, 1974 probation revoked and sentenced to custody of Attorney General or his authorized representative for 3 years under 18 USC 4208(a)(2). Paroled December 2, 1975. Discharged December 15, 1976. Granted removal of political disabilities July 9, 1985.

BROWN, RAYMOND MATHIAS Sentenced August 11, 1976 in the Circuit Court of the County of Frederick, Maryland upon convictions of Robbery, Assault and Conspiracy, 2 counts, and sentenced to 8 years on each to run concurrently, suspended and placed on probation for 5 years and enter Second Genisis Program and complete successfully. Probation expired August 11, 1981. Suspension expired August 11, 1984. Granted removal of political disabilities June 4, 1985.

BURKHOLDER, DAVID WAYNE Sentenced December 11, 1973 in the Circuit Court of Powhatan County upon a conviction of Breaking and Entering and sentenced to 18 months with 9 months suspended and good behavior for 3 years after release. Good behavior expired April 8, 1977. Granted removal of political disabilities February 25, 1985.

CAHILL, MARK HENRY Sentenced May 5, 1982, in the Circuit Court of the City of Martinsville, upon a conviction of Sale of Marijuana and sentenced to 12 months in jail with 10½ months suspended upon the condition of good behavior and placed on probation for 2 years, plus costs. Costs have been paid. Released from probation February 10, 1984. Suspension expired May 5, 1984. Granted removal of political disabilities May 16, 1985.

CALHOUN, WILLIAM EDMOND Sentenced April 25, 1947 in the Circuit Court of Elizabeth City County, now City of Hampton, upon a conviction of Attempted Rape, 3 counts and sentenced to 3 life sentences. Paroled February 18, 1969. Discharged July 7, 1977. Granted removal of political disabilities May 21, 1985.

CARPER, JAMES DOUGLAS

Sentenced January 7, 1971 in the Corporation

Court of the City of Newport News upon convictions of Forgery and

Uttering, 3 counts, and sentenced to 2 years on each, plus costs,
suspended upon condition of good behavior for 5 years and payment of
costs and parole for 5 years with probation on each count. Sentenced

January 7, 1971, in the Corporation Court of the City of Newport News
upon a conviction of Violation of Uniform Narcotic Drug Act and
sentenced to 5 years, plus costs, suspended, upon condition of good
behavior for 5 years upon condition of payment of costs and parole for 5
years with probation. Payment of costs suspended by order of December
12, 1984. Probation and suspensions expired January 7, 1976. Granted
removal of political disabilities February 20, 1985.

CARR, LOYD DAVID Sentenced March 14, 1958 in the Circuit Court of Campbell County upon a conviction of Voluntary Manslaughter and sentenced to 3 years, plus costs. Costs have been paid. Paroled December 15, 1958. Discharged June 15, 1960. Granted removal of political disabilities July 5, 1985.

CARTER, BETTY HOOD Sentenced September 25, 1974, in the U.S. District Court for the Western District of Virginia, Roanoke Division, upon convictions of violation of Title 21, USC, Section 841(a) and Title 18, USC, Section 2. Imposition of sentence was suspended and placed on probation for 3 years. Probation expired September 24, 1977. Sentenced March 11, 1982, in the Circuit Court of the City of Roanoke upon a conviction of Attempting to Deliver a Drug to a Prisoner and sentenced to 12 months in jail, \$1,000 fine, plus costs. On April 8, 1983 ordered to serve 500 hours of community service work in lieu of \$1000 fine and placed on probation until December 6, 1983. Fine and costs have been paid. Probation terminated October 19, 1983. Granted removal of political disabilities September 21, 1985.

CHAPMAN, DAVID LEE Sentenced February 17, 1978 in the Circuit Court of Smyth County upon a conviction of Sale of a Schedule I Controlled Substance and sentenced to 5 years, \$100 fine, suspended after serving 12 months upon condition of probation for 5 years. Sentenced December 20, 1977 in the Circuit Court of the City of Bristol upon a conviction of Sale or Distribution of a Controlled Substance, 5 counts. Sentenced on Counts 1 and 2, to 5 years with 4 years suspended and serve 12 months in jail, to run consecutively. Sentenced on Counts 3, 4, and 5, to 5 years, 4 years suspended and serve 12 months in jail to run concurrently and ordered to pay costs. Upon release placed on probation for 3 years. Paroled November 6, 1978. Discharged November 6, 1979. Probation expired November 6, 1983. Costs and fine have been paid. Granted removal of political disabilities March 18, 1985.

COLEMAN, BARBARA SMITH Sentenced February 5, 1981 in the Circuit Court of Roanoke County upon a conviction of Grand Larceny by Embezzlement and sentenced to 3 years suspended, plus costs, and placed on probation for 3 years. Probation terminated April 2, 1982. Suspension expired February 5, 1984. Granted removal of political disabilities April 2, 1985.

COLEMAN, ROY LEE Sentenced February 15, 1982 in the Circuit Court of Buchanan County upon convictions of Statutory Burglary and Grand Larceny and sentenced to 4 years on each count to run consecutively. Execution of sentence suspended and ordered to serve 12 months jail and placed on probation for 3 years and good behavior upon release, plus costs. Costs have been paid. Discharged from probation and suspensions terminated April 8, 1985. Granted removal of political disabilities September 26, 1985.

COLINGER, CHARLES ERNEST Sentenced November 26, 1967 in the Circuit Court of Bedford County upon a conviction of Malicious Wounding with Intent to Maim, Disfigure, Disable, or Kill and sentenced to 6 years, plus costs. Sentenced May 12, 1967 in the Corporation Court of the City of Lynchburg upon a conviction of Grand Larceny and sentenced to 2 years execution suspended upon the condition of good behavior for 2 years and placed on 2 years probation, plus costs and restitution. Costs have been paid. Released from probation May 11, 1971. Granted removal of political disabilities September 25, 1985.

CORBETT, WILLIAM PENNINGTON Sentenced February 24, 1982 in the U.S. District Court for the Western District of Virginia, Abingdon Division, of two counts of False Representation of Certified Coal Mine Noise Survey, Title 18 USC 1001, and sentenced to 3 years and fined \$5,000, sentence suspended only and placed on probation for 3 years and pay fine within 6 months. Fine has been paid. Discharged from probation and sentence terminated February 23, 1985. Granted removal of political disabilities May 21, 1985.

COUSINS, DENNIS LLOYD Sentenced April 23, 1975 in the Circuit Court of the City of Richmond, Division I, upon a conviction of Conspire, Confederate or Combine with an Inmate to Procure, Sell, Secrete or Have in his Possession a Controlled Drug, and sentenced to 2 years, suspended during good behavior for 10 years, plus costs. Costs have been paid. Good behavior expired April 23, 1985. Granted removal of political disabilities September 21, 1985.

COX, FRANK LEE Sentenced January 24, 1975 in the Circuit Court of the City of Staunton upon a conviction of Breaking and Entering in the Nighttime and sentenced to 2 years, plus costs with all but 90 days suspended and placed on probation for 4 years upon release during good behavior on each count. Probation revoked October 7, 1976 and was ordered to serve 1 year and placed on probation for 2 years upon release, plus costs; in lieu of 1 year sentence ordered to serve 12 months on Count 1 and placed on probation for 2 years, plus costs on Count 2 upon release from 12 month sentence imposed on Count 1. Costs have been paid. Probation expired January 24, 1981. Granted removal of political disabilities August 2, 1985.

COX, WILLIAM KENNETH Sentenced November 21, 1957 in the Circuit Court of Caroline County upon a conviction of Breaking and Entering and imposition of sentence delayed until June 2, 1960. February 23, 1959, ordered to pay court costs and delayed imposition of sentence for 10 years. September 16, 1959, violated probation and sentenced to 12 months in jail and fined \$10.
