ABSOLUTE PARDON

CLARK, PAMELA HALEY ADKINS Sentenced August 14, 1980 in the Circuit Court of the County of Pittsylvania upon a conviction of Petit Larceny and was ordered to serve twelve months, with the execution of the sentence suspended upon the condition that she keep the peace and be of good behavior. She was placed on probation for two years, and was required to pay court costs. The innocence of this individual has been subsequently proven, based upon the confession of the complaining party in this case that she had perpetrated this offense and also upon the said complaining party's conviction for Giving False Information to a Police Officer. In view of the facts presented to me and the recommendations of the Virginia Parole Board, the Honorable Glenn L. Berger, Commonwealth's Attorney, County of Pittsylvania, and the Honorable Samuel M. Hairston, Judge of the Circuit Court of the County of Pittsylvania, I am granting her an Absolute Pardon, and order that the aforesaid offense be removed from any and all records upon which they may appear. This pardon dated October 22, 1986.

CONDITIONAL PARDON

MOORE, THOMAS Convicted June, 1957 in the Circuit Court of the City of Norfolk upon convictions of Grand Larceny, (8 Counts) and Recidivism and was thereupon sentenced to be imprisoned for a term of one year to run concurrently on seven counts of Grand Larceny, five years on one count of Grand Larceny and fifteen years on Recidivism; and subsequently escaped from the Virginia correction system in 1957 and remained at large until he was recaptured this year. It appears to the Executive that he is a fit subject for clemency, in view of his clean record and commendable adjustment since his escape and the unanimous recommendation of the Virginia Parole Board. I therefore pardon Thomas Moore and do order that his sentence be appropriately reduced so as to cause him to be immediately eligible for parole and that he be forthwith discharged from imprisonment effective October 31, 1986 but under such terms, conditions, and requirements for supervision as the Virginia Parole Board shall establish. If he should violate any of such conditions prior to March 1, 1994, or if ever again he be found guilty of violation of the penal laws of any city, county, State or the United States, this pardon may be revoked. This pardon effective October 31, 1986.

REMOVAL OF POLITICAL DISABILITIES

AMOS, RUDY Sentenced June 11, 1974 in the Circuit Court of the County of Buckingham upon a conviction of Unlawful Wounding and was sentenced to 2 years with execution suspended and placed on probation for 3 years, conditioned upon his good behavior, payment of medical expenses, confiscation of his gun, and payment of court costs. Released from probation June 11, 1977. Court costs have been paid. Granted removal of political disabilities November 21, 1986.

ARMENTROUT, DAVID WILBUR Sentenced July 12, 1982 in the Circuit Court of the County of Alleghany upon a conviction of Breaking and Entering and the imposition of sentence was suspended and he was placed on probation for 3 years during his good behavior, plus court costs and restitution. Sentenced July 12, 1982 in the Circuit Court for the County of Alleghany upon a conviction of Grand Larceny and the imposition of sentence was suspended and he was placed on probation for 3 years during his good behavior, plus court costs and restitution. He was released from probation on December 8, 1983. Court costs and restitution have been paid. Granted removal of political disabilities September 11, 1986.

ARRINGTON, JAMES EDGAR, JR. Sentenced April 16, 1984 in the U. S. District Court, Western District, Roanoke Division upon a conviction of Receipt and Sale of Stolen Goods Shipped in Interstate Commerce and the imposition of sentence was suspended and he was placed on probation for 2 years, plus a fine of \$10,000 with execution of payment of \$5,000 suspended and was required to perform 200 hours of community service work. Probation was terminated August 19, 1985. Fine has been paid and community service work has been performed. Granted removal of political disabilities October 23, 1986.

BAILEY, KEITH Sentenced February 5, 1980 in the Circuit Court of the County of Fairfax upon a conviction of Abduction and sentenced to 5 years with execution suspended and placed on probation for 5 years, plus payment of court costs. His probation expired February 5, 1985. All court costs have been paid. Granted removal of political disabilities October 30, 1986.

BECKER, KENNETH GEORGE, JR. Sentenced June 24, 1980 in the Circuit Court of the County of Fairfax upon a conviction of Statutory Burglary and sentenced to 3 years with execution suspended conditioned upon his good behavior and placed on probation for 2 years, plus payment of court costs and restitution. Probation was terminated June 24, 1982. Costs and restitution have been paid. Granted removal of political disabilities September 10, 1986.

BEVERLY, DONALD RUSSELL Sentenced June 23, 1982 in the U. S. District Court, Eastern District of Virginia, Richmond Division upon a conviction of Violation of Title 26, U.S.C. Section 7206(1), Income Tax Evasion and was sentenced to 15 months imprisonment with all but 45 days suspended, and he was placed on probation for 3 years upon his release and ordered to pay a fine of \$5,000 and restitution in the amount of \$2,459. His probation was terminated September 14, 1984. Fine and restitution have been paid. Granted removal of political disabilities October 1, 1986.

BOOKER, FORD EVERETT Sentenced November 30, 1959 in the Circuit Court of the County of Amelia upon a conviction of Unlawfully and Feloniously Manufacturing Alcoholic Beverages Without Being Licensed to Do So by Law and was sentenced to 18 months with 9 months suspended conditioned upon his good behavior for 5 years, plus payment of court costs. His good behavior expired November 30, 1964. All costs have been paid. Granted removal of political disabilities September 8, 1986.

BOWMAN, FERDIE ROBERT Sentenced August 2, 1972 in the Circuit Court of the County of Buchanan upon a conviction of Unlawful Wounding and was sentenced to 4 years with the execution suspended and placed on probation for 4 years upon the condition that he be of good behavior and not violate any laws, plus payment of court costs. His probation was terminated on April 12, 1976. All court costs have been paid. Sentenced April 24, 1984 in the Circuit Court of the County of Buchanan upon a conviction of Manufacturing Alcoholic Beverages Without a License and was sentenced to 12 months with execution suspended and placed on probation for 1 year upon the condition that he be of good behavior and not violate any law for 1 year, plus payment of court costs. He was discharged from probation on August 1, 1985. All court costs have been paid. Granted removal of political disabilities January 6, 1986.

BOYD, RICKY NELSON Sentenced September 21, 1983 in the Circuit Court of the County of Russell upon a conviction of Breaking and Entering with Intent to Commit Larceny and was sentenced to 12 months with execution suspended upon the condition that he be placed on probation for 12 months and perform 30 hours of community service work. He was also ordered to pay court costs in the amount of \$307.45 and restitution on the amount of \$71.13. His probation terminated October 18, 1984. Community service work has been performed. Court costs and restitution have been paid. Granted removal of political disabilities November 21, 1986.

BROWN, GARY LEE Sentenced March 11, 1981 in the Circuit Court of the City of Roanoke upon a conviction of Delivering a Controlled Substance to an Inmate and was sentenced to 2 years with execution suspended after serving 30 days in jail upon the condition that he keep the peace and be of good behavior. He was placed on probation for 2 years upon his release and required to complete 90 hours of community service work, fined \$100 and ordered to pay court costs. His probation terminated April 6, 1982. Community service work has been completed and all court costs and fine have been paid. Granted removal of political disabilities October 6, 1986.

BRYANT, BEULAH VIRGINIA Sentenced February 24, 1983 in the U. S. District Court, Western District, Roanoke Division upon a conviction of Destroying Mail Matter in Violation of Title 18 U.S.C. Section 1703(a). The imposition of sentence was suspended and she was placed on probation for 2 years conditioned upon 100 hours of community service. Release from probation February 23, 1985. Excused from community service performance. Granted removal of political disabilities September 4, 1986.

CAMPBELL, KENNETH LEE Sentenced June 11, 1980 in the Circuit Court of the County of Augusta upon a conviction of Malicious Wounding and was sentenced to 5 years with execution suspended and placed on probation for 5 years, plus costs and restitution. Probation ended April 15, 1982. Costs and restitution have been paid. Granted removal of political disabilities September 8, 1986.

CARTWRIGHT, GLEN LOYD Sentenced March 9, 1981 in the Circuit Court of the County of Southampton upon a conviction of Possession of a Controlled Substance with Intent to Distribute (Cocaine) and Possession of a Controlled Substance with Intent to Distribute (Marijuana) and was sentenced to 5 years with execution suspended upon the condition that he serve 12 months and upon release be placed on probation for 7 years, plus court costs, to run concurrently. All costs have been paid. Probation ended January 27, 1983. Granted removal of political disabilities September 8, 1986.

COX, MARVIN ELLIS Sentenced November 17, 1981 in the Circuit Court of the County of Russell upon a conviction of Possession of a Schedule II Controlled Substance, Dilaudid, with Intent to Sell or Distribute and was sentenced to 5 years with all but 6 months suspended, to be served on consecutive weekends and placed on probation during his good behavior for 4 1/2 years, after his release, plus \$5000 fine and payment of court costs. Probation was terminated November 12, 1984. Fine and court costs have been paid. Granted removal of political disabilities November 21, 1986.

CREASY, DENISE RENE Sentenced November 29, 1977 in the Circuit Court of the City of Virginia Beach upon a conviction of Manufacturing Marijuana with Intent and was sentenced to 5 years suspended with good behavior and 5 years probation, plus payment of court costs. Probation expired November 29, 1977. Costs have been paid. Granted removal of political disabilities July 25, 1986.

DAVIS, LARRY DELORO Sentenced June 5, 1979 in the Circuit Court of the County of Greenville upon a conviction of Grand Larceny (3 Counts) and the imposition of sentence was suspended conditioned upon his good behavior for 4 years, and placed on probation for 2 years on each count, plus costs and restitution. His probation ended March 23, 1981. Costs and restitution have been paid. Granted removal of political disabilities November 21, 1986.

DEMURU, MARCO Sentenced September 12, 1979 in the Circuit Court of the County of Augusta upon a conviction of Receiving Stolen Goods and sentenced to 2 years with the execution of sentence suspended and placed on probation for 3 years conditioned upon his good behavior, plus payment of court costs. Probation ended June 12, 1981. Costs have been paid. Granted removal of political disabilities September 8, 1986.

FALLS, JOSEPH CLARK Sentenced January 27, 1958 in the Circuit Court of the County of Giles upon a conviction of Involuntary Manslaughter and sentenced to 12 months, plus payment of court costs. Court costs have been paid. Released from imprisonment without further supervision. Granted removal of political disabilities October 14, 1986.

GLAVE', CLARK MILLARD Sentenced March 31, 1982 in the Circuit Court of the City of Richmond, Division 1 upon a conviction of Grand Larceny and the imposition of sentence was suspended on the condition that he serve 12 months in jail, make restitution in the amount of \$10,000 to the victim, pay court costs of \$108 and placed on probation for an indefinite period of time. On July 12, 1982, the balance of his jail sentence was suspended. Costs and restitution have been paid. Granted removal of political disabilities November 11, 1986.

GIVEN, WILLIAM JAMES Sentenced December 10, 1979 in the Circuit Court of the City of Virginia Beach upon a conviction of Attempted Murder and sentenced to 5 years with the execution of 2 years suspended conditioned upon his good behavior, plus payment of court costs. On June 30, 1980 in the Circuit Court of the City of Virginia Beach a Modification and Suspension of Attempted Murder Sentence of December 10, 1979 was modified as follows: 5 years with the execution suspended conditioned upon 12 months in jail on work release, that he be of good behavior for 5 years, and that he continue drug treatment. All costs have been paid. Released from imprisonment without further supervision. Granted removal of political disabilities September 4, 1986.

GRANINGER, WADE ALLEN Sentenced April 2, 1979 in the Circuit Court of the County of Stafford upon a conviction of Distribution of Marijuana and was sentenced to 5 years with all but 6 months suspended upon the condition that he keep the peace and be of good behavior for 10 years, and that he pay a fine of \$1,000, plus payment of court costs to be paid within one year from his release and placed on active probation. Released from probation June 17, 1980. Fine and court costs have been paid. He was released from his suspended sentence September 9, 1985. Granted removal of political disabilities September 19, 1986.

GREEN, JOSEPH EDWARD Sentenced June 19, 1980 in the Circuit Court of the City of Norfolk upon a conviction of Malicious Wounding and was sentenced to 5 years with the execution suspended and placed on probation for 5 years with 4 years unsupervised conditioned upon his good behavior and that he pay court costs. His probation expired June 19, 1985. All court costs have been paid. Granted removal of political disabilities October 6, 1986.

GUENTHER, JOSEPHINE Sentenced October 9, 1981 in the U. S. District Court, Eastern District, Norfolk Division upon a conviction of Violation of Title 18 U.S.C. Section 201(c) (2), Bribery and was sentenced to 4 years. Discharged from parole October 19, 1985. Granted removal of political disabilities September 11, 1986.

HAIRSTON, JAMES HOWARD Sentenced July 23, 1980 in the Circuit Court of the County of Henry upon a conviction of Malicious Wounding and was sentenced to 6 years with the execution suspended and placed on probation for 5 years conditioned upon his good behavior, plus payment of court costs. His probation expired July 23, 1985. Court costs have been paid. Granted removal of political disabilities September 15, 1986.

HARPER, JACQUELINE DAVIS A/K/A JACQUELINE SUE DAVIS Sentenced April 25, 1983 in the Circuit Court of the County of Henrico upon a conviction of Distribution for Accommodation of LSD. The imposition of sentence was suspended and she was placed on probation during her good behavior, plus payment of court costs. Sentenced November 8, 1973 in the Circuit Court of the County of Henrico upon a conviction of Accommodation Sale of LSD, a Controlled Drug, 3 Counts and the imposition of sentence suspended and she was placed on probation during her good behavior, plus payment of court costs, on 2 counts and 12 months on the remaining count. She was released from probation March 24, 1975. All court costs have been paid. Granted removal of political disabilities August 18, 1986.

HARPER, STEVEN WAYNE Sentenced March 10, 1983 in the Circuit Court of the City of Roanoke upon a conviction of Involuntary Manslaughter and was sentenced to 3 years suspended after serving 1 year, upon the condition that he keep the peace and be of good behavior, placed on probation for 2 years upon his release, operators license suspended for 12 months, plus payment of court costs. Probation was terminated August 13, 1984. Costs have been paid. Granted removal of political disabilities September 8, 1986.

HEAD, MURDOCK Sentenced July 17, 1981 in the U.S. District Court for the Eastern District of Virginia, Alexandria Division upon a conviction of Violation of Title 18 U.S.C. 371 - Conspiracy to Violate Title 18 U.S.C. 201(b) & (f) and Title 26 U.S.C. 7201 & 7206 and was sentenced to 3 years; and Violation of Title 18 U.S.C. 201(f) - Attempting to Influence Public Official- and sentenced to 18 months to run consecutively with previous conviction. On September 3, 1983 the sentence as to the Conspiracy charge was reduced and he was ordered to serve 6 months consecutively with the other conviction with the balance suspended conditioned upon 4 years probation and to perform 20 hours of community service work. Released from custody January 19, 1984. Discharged from probation January 14, 1986. Granted removal of political disabilities September 5, 1986.

HOLLAND, RAYMOND ALBERT, JR. Sentenced November 3, 1976 in the Circuit Court of the City of Portsmouth upon a conviction of Possession with Intent to Sell Marijuana and Hashish and was sentenced to 5 years with the sentence suspended conditioned upon his good behavior for 5 years, and was placed on probation for 5 years, plus \$300 fine and payment of court costs. He was released from probation October 20, 1978. Fine and court costs have been paid. Granted removal of political disabilities September 11, 1986.

HOSTETTER, PAMELA WALLACE Sentenced September 30, 1981 in the Circuit Court of the City of Buena Vista upon a conviction of Possession of Marijuana with Intent to Distribute and was sentenced to 5 years with the execution suspended conditioned upon her good behavior and placed on probation for 5 years, plus fine and payment of court costs. Probation expired April 13, 1984. Fine and court costs have been paid. Granted removal of political disabilities November 21, 1986.

HUBBARD, WALTER LANE Sentenced June 13, 1978 in the Circuit Court of the City of Norfolk upon a conviction of Unauthorized Use of a Motor Vehicle and was sentenced to 3 years with the execution suspended for 3 years and placed on probation for 2 years conditioned upon his good behavior and that he pay court costs and a fine in the amount of \$100. Sentenced June 20, 1978 in the Circuit Court of the City of Virginia Beach upon a conviction of Grand Larceny and was sentenced to 2 years imprisonment with the execution of sentence suspended and placed on probation for 2 years upon the condition that he serve 9 days in jail on weekends, and that he be of good behavior, plus payment of court costs. He was discharged from probation on June 13, 1980. Fine and court costs have been paid. Granted removal of political disabilities December 4, 1986.

HUDGINS, GEORGE MORRIS, III Sentenced June 3, 1975 in the Circuit Court of the City of Richmond upon a conviction of Distribution of Marijuana and the imposition of sentence was suspended conditioned upon his good behavior and was placed on probation, plus payment of court costs. Sentenced July 15, 1975 in the Circuit Court of the County of Henrico upon a conviction of Possession of a Schedule I Controlled Substance; to wit: Hashish and the imposition of sentence was suspended conditioned upon 5 years good behavior, and was placed on probation, plus payment of court costs. All costs have been paid. Released from probation October 31, 1977. Granted removal of political disabilities August 19, 1986.

IRONS, THOMAS ALBERT Sentenced March 30, 1959 in the Circuit Court of the City of Norfolk upon a conviction of Grand Larceny and was sentenced to 9 months, plus payment of fine and costs. Fine and costs have been paid. Granted removal of political disabilities August 18, 1986.

KAUFMAN, LAWRENCE HARRY, JR. Sentenced April 20, 1976 in the U. S. District Court of the Eastern District of Virginia, Newport News Division upon a conviction of Violation of Title 18 U.S.C., Section 641, Theft of Government Property and the imposition of sentence was suspended and he was placed on probation for 3 years. Probation expired April 20, 1979. Granted removal of political disabilities September 6, 1986.

LYONS, JOHN WALTER Sentenced February 25, 1972 in the Circuit Court of the County of Arlington upon a conviction of Distribution of a Controlled Drug, to wit: Marijuana and was sentenced to 3 years with the execution suspended and he was placed on probation for 3 years, plus fine of \$500 and payment of court costs. His probation was terminated on February 25, 1975. Court costs and fine have been paid. Granted removal of political disabilities November 21, 1986.

MADDOX, GARY LUDWELL, JR. Sentenced February 8, 1952 in the Circuit Court of the City of Chesapeake upon a conviction of Grand Larceny and was sentenced to 4 years with execution of sentence suspended and placed on probation for 4 years upon the condition that he be of good behavior, keep the peace and not violate any laws for 4 years, plus payment of court costs and restitution within 3 months. He was released from probation on February 7, 1956. Court costs and restitution have been paid. Granted removal of political disabilities October 15, 1986.

MARTIN, LOUISE DAVIS A/K/A LOUISE D. STACKHOUSE Sentenced October 22, 1982 in the Circuit Court of the City of Portsmouth upon a conviction of Malicious Wounding and Use of a Firearm and was sentenced to 5 years for the Malicious Wounding charge and 1 year on the Firearm charge, for a total of 6 years in the penitentiary, plus payment of court costs. She was paroled on September 20, 1983 and discharged on March 18, 1986. Court costs have been paid. Granted removal of political disabilities October 28, 1986.

MCCOMBER, ROBERT WAYDE Sentenced April 11, 1978 in the Circuit Court of the City of Hopewell upon a conviction of Burglary and was sentenced to 5 years suspended for 5 years conditioned upon good behavior and placed on probation, plus payment of court costs and restitution; also convicted of Grand Larceny and was sentenced to 2 years suspended for 5 years conditioned upon good behavior and placed on probation, plus payment of court costs and restitution. Released from probation April 11, 1984. Suspensions expired April 11, 1983. Costs and restitution have been paid. Granted removal of political disabilities August 19, 1986.

MOATZ, WALLACE WILLIAM, JR. Sentenced November 17, 1982 in the Circuit Court of the City of Roanoke upon a conviction of Sodomy and was sentenced to 12 months suspended for 5 years, fined \$1000 and placed on probation for 5 years, plus payment of court costs. Granted removal of political disabilities August 19, 1986.

MORELAND, DEBRA ANN Sentenced May 4, 1982 in the Circuit Court of the City of Winchester upon a conviction of Obtaining Welfare Benefits to Which She was Not Entitled, 3 counts and was sentenced to 12 months with 11 months suspended, on each count, to run concurrently, and placed on probation for 3 years upon release, plus costs and restitution. Probation expired January 15, 1985. Costs and restitution have been paid. Granted removal of political disabilities September 9, 1986.

MOSLEY, BETTIE GOLD Sentenced June 19, 1984 in the Circuit Court of the City of Virginia Beach upon a conviction of Embezzlement and was sentenced to 12 months with the execution suspended conditioned upon good behavior for 1 year, plus payment of court costs and restitution. Requirement for good behavior expired June 19, 1985. All court costs have been paid. Granted removal of political disabilities December 1, 1986.

MOUTON, AGENS MARIA Sentenced September 2, 1983 in the Circuit Court of the County of Fairfax upon a conviction of Concealing Merchandise and was sentenced to 12 months suspended upon the condition that she be of good behavior and placed on probation for 12 months, plus payment of court costs. Probation was terminated May 9, 1984. Court costs have been paid. Granted removal of political disabilities September 8, 1986.

NELSON, WILLIAM WAYNE Sentenced November 4, 1974 in the Circuit Court of the County of Appomattox upon a conviction of Breaking and Entering and was sentenced to 5 years with the imposition suspended and placed on probation for 3 years during his good behavior, plus payment of court costs and restitution. Discharged from probation December, 1977. Costs and restitution have been paid. Granted removal of political disabilities December 1, 1986.

OWENS, DANIEL LEE Sentenced February 3, 1984 in the Circuit Court of the County of Fairfax upon a conviction of Distributing a Controlled Drug as an Accomodation and was sentenced 2 years with the execution suspended conditioned upon his good behavior and placed on probation 2 years, plus payment of court costs and restitution. Released from probation on February 5, 1985. Court costs and restitution have been paid. Granted removal of political disabilities November 21, 1986.

OWEN, JAMES GENTRY Sentenced February 8, 1979 in the Circuit Court of the City of Danville upon a conviction of Accessory Before the Fact to Burglary and was sentenced to 10 years, plus payment of court costs. Paroled March 26, 1981 and discharged August 13, 1985. Court costs have been paid. Granted removal of political disabilities September 9, 1986.

PASEUR, VANDY LYNN Sentenced April 21, 1983 in the Circuit Court of the County of Fairfax upon a conviction of Grand Larceny and was sentenced to 2 years with all but 1 month suspended conditioned upon her good behavior, and placed on probation for 2 years, must enter a drug treatment program, plus payment of court costs. Sentenced August 8, 1983 in the Circuit Court of the County of Fairfax upon a conviction of Violation of Probation and the remainder of the suspended sentence was ordered into execution; however, she was allowed to serve her sentence in the work release program. Paroled May 11, 1984 and discharged November 11, 1984. All court costs have been paid. Granted removal of political disabilities September 15, 1986.

POPE, RALPH ALTON Sentenced March 17, 1977 in the Circuit Court of the County of Southampton upon a conviction of Malicious Wounding and was sentenced to 7 years with the execution suspended conditioned upon his good behavior and that he keep the peace for 7 years, placed on probation for 7 years, plus payment of costs. All conditions of the court expired March 17, 1984. All costs have been paid. Granted removal of political disabilities September 4, 1986.

RICE, ROGER LEE Sentenced October 4, 1974 in the Circuit Court of the County of Madison, State of Georgia upon a conviction of Burglary and was sentenced to 3 years. Paroled December 3, 1975 and discharged February 8, 1986. Granted removal of political disabilities August 18, 1986.

RICHARDS, CHARLES LESLIE Sentenced September 29, 1986 in the Circuit Court of the County of Page upon a conviction of Illegal Manufacture of Alcoholic Beverages and was sentenced to 2 years with the execution of sentence suspended for 5 years conditioned upon his good behavior, plus payment of court costs. Court costs have been paid. Granted removal of political disabilities September 29, 1986.

RIDDLE, LEWIS WAYNE Sentenced August 2, 1983 in the Circuit Court of the County of Henry upon a conviction of Operating an Illegal Gambling Operation and was sentenced to 15 months suspended upon his good behavior for 2 years, plus \$1000 fine and payment of court costs. Fine and costs have been paid. Granted removal of political disabilities September 9, 1986.

ROSE, TERRY RAY, SR. Sentenced May 2, 1980 in the Circuit Court of the County of Prince William upon a conviction of Sodomy and was sentenced to 5 years with all but 90 days suspended conditioned upon his good behavior and placed on probation for 5 years and must seek psychiatric counseling, plus payment of court costs. Probation was terminated June 30, 1985. Costs have been paid. Granted removal of political disabilities September 8, 1986.

ROUSE, GEORGE STEPHEN Sentenced June 8, 1982 in the Circuit Court of the County of Smyth upon a conviction of Forgery, 6 Counts, Grand Larceny by False Pretenses, 3 Counts, and Attempted Grand Larceny by False Pretenses and was sentenced to 6 months on each count of Forgery, 12 months on each count of Grand Larceny by False Pretenses and 12 months on Attempted Grand Larceny by False Pretenses to run consecutively suspended and ordered to serve weekends in jail for the months of August and September, donate one days work per week for six months to public service, and placed on probation for six years, plus fine and costs. Probation was terminated June 3, 1985. Costs and fine have been paid. Granted removal of political disabilities August 5, 1986.

RUTHERFORD, JOHN FITZGERALD Sentenced July 18, 1983 in the Circuit Court of the County of Wise upon a conviction of Conspiracy to Commit a Felony and was sentenced to 1 year with the execution of sentence suspended and placed on probation for 2 years; must perform 40 hours of community service work, plus payment of court costs. Discharged from probation July 30, 1985. Court costs have been paid. Granted removal of political disabilities September 11, 1986.

SAUNDERS, MICHAEL CLARK Sentenced January 2, 1975 in the Circuit Court of the City of Charlottesville upon a conviction of Breaking and Entering and was sentenced to 3 years with execution of sentence suspended on April 23, 1975, and placed on probation for 2 years, plus payment of court costs. TATE, DEBORAH LEE Sentenced March 16, 1970 in the Circuit Court of the County of Hanover upon a conviction of Statutory Burglary, 2 Counts and was sentenced to 2 years suspended for 10 years conditioned upon good behavior, plus costs on each count. All costs have been paid. Granted removal of political disabilities July 9, 1986.

TYLER, JOYCE ANN A/K/A JOYCE ANN GULLEN Sentenced May 18, 1981 in the U. S. District Court, District of Kansas upon a conviction of Conspiracy to Distribute Cocaine in Violation of Title 21, U.S.C. Section 846 and was sentence to 3 years. Parole expired October 9, 1984. Granted removal of political disabilities September 11, 1986.

WALL, MARVIN PAUL, JR. Sentenced August 9, 1982 in the Circuit Court of the County of Carroll upon a conviction of Unlawfully and Feloniously Operating Illegal Gambling Operations and was sentenced to 2 years and ordered to forfeit to the Commonwealth \$3,174, plus payment of court costs.
