#### ABSOLUTE PARDON

VASQUEZ, David

Crime:

Sentence Date: Pardon Granted: Burglary and Second Degree Murder Circuit Court, County of Arlington

February 4, 1985 January 4, 1989

On February 4, 1985, David Vasquez was sentenced to serve a total of 35 years in prison, after having plead guilty and been convicted of Burglary and Second Degree Murder. Thereafter, in October of 1988, the Commonwealth's Attorney for the County of Arlington, as well as defense counsel for David Vasquez, made formal requests that he be pardoned for these crimes. These requests were made after an extensive reinvestigation of the evidence against David Vasquez by local prosecutors, the Arlington County Police Department and the FBI National Center for the Analysis of Violent Crime. This reinvestigation led the police and local prosecutors to conclude that another person was responsible for the murder and burglary for which David Vasquez was convicted. The request for executive clemency from the Arlington County Commonwealth's Attorney was made with the concurrence of the Arlington Police Department and the former Commonwealth's Attorney for Arlington County who prosecuted the Vasquez case. Based upon these developments, a favorable recommendation from the Virginia Parole Board and a lengthy and comprehensive review of this matter by the Governor and his executive staff, the Governor granted David Vasquez an Absolute Pardon.

### CONDITIONAL PARDONS

David Wayne Hall resides in Spokane, Washington, where he is employed, has obtained a GED, and has enrolled in Spokane Falls Community College. In view of his law-abiding behavior and commendable adjustment since his escape from the Virginia correctional system in February, 1980, the Governor granted him a conditional pardon and ordered that his sentence be appropriately reduced so as to cause him to be immediately eligible for parole and ordered that he be placed on parole for four years and ten months, upon such terms, conditions, and requirements for supervision as the Virginia Parole Board shall establish. Such terms included an obligation for 500 hours of community service work. The pardon was also conditioned upon his waiver of all claims against the Commonwealth or any of its officials, officers, or employees. If prior to August 1, 1993, this individual should violate these conditions, or be found guilty of violation of the penal laws of any city, county, State, or of the United States, this pardon may be revoked. The Governor granted the conditional pardon after the Commonwealth's Attorney for the City of Richmond had decided that, given David Hall's commendable record, the ends of justice would be better served by not going forward on an escape charge.

James Manuel has resided in the State of Texas for the past 35 years. In so doing, the Governor ordered that his sentence be appropriately reduced so as to be deemed satisfied upon his acceptance of the pardon, conditioned upon his good behavior and upon his waiver of all claims against the Commonwealth or any of its officials, officers, or employees. If, prior to June 16, 1989, this individual should violate these conditions, or be found guilty of violation of the penal laws of any city, county, State, or of the United States, this pardon may be revoked. The Governor's action was taken after a favorable recommendation from the Commonwealth's Attorney for the City of Richmond.

# COMMUTATION OF SENTENCE

REES, Melvin Davis, Jr.

Rees was sentenced to death in January, 1962, for the murder of Carroll V. Jackson. Rees is presently in federal prison, serving concurrent federal life sentences for the interstate transportation of kidnapped members of the Jackson family.

The commutation was granted because the death penalty statute under which Rees was sentenced was rendered constitutionally unenforceable in 1972 when the United States Supreme Court decided Furman v. Georgia. Similar action was taken by former Governor Mills E. Godwin, Jr. in 1976 when he commuted the death sentences of five Virginia death row inmates whose sentences had also been rendered constitutionally invalid.

No action to commute the death sentence of Rees was taken prior to this because, since June of 1968, Rees has been in federal custody. This commutation ensures that should Rees be paroled by federal authorities he will be retained in the custody of the Virginia corrections system for life, without parole. The commutation had been recommended by the Commonwealth's Attorney for Spotsylvania County because of the difficulty, if not impossibility, of successfully prosecuting this case again.

With the recommendation of the Office of the Attorney General, the Governor granted commutation from death to imprisonment for a term of life.
