House Joint Resolution 441, agreed to by the 1989 General Assembly, directed the State Library Board to study the local minimum expenditure requirements last revised in 1984 and other criteria libraries must meet in order to receive grants-in-aid to determine whether local financial effort is meeting the intent of the law. In fulfilling this directive, a study was conducted by the State Library Board. I have the honor of submitting herewith the study report and recommendations pursuant to the intent of the resolution.

PURPOSE OF THE STUDY

This study is the Virginia State Library and Archives Board's response to the House Joint Resolution No. 441 of the 1989 session of the Virginia General Assembly. The resolution charged the Board to study:

- o the local minimum expenditure requirements libraries must meet in order to receive grants in aid to determine whether local financial effort is meeting the intent of the law:
- o other criteria libraries must meet in order to receive grants in aid.

The intent of the 1970 revision of Section 42 of the <u>Code of</u> Virginia is:

- o ...to be the policy of the Commonwealth, as part of its provision for public education, to promote the establishment and development of public library service throughout its various political subdivisions. [42.1-46]
- o ...to encourage the maintenance and development of proper standards...and the combination of libraries or library systems into larger and more economical units of service, grants of state aid...shall be made by the Board to any free public library... [42.1-48]

EXECUTIVE SUPPARY

The State Library Board finds the program of state grants to: establish and develop public library service, encourage the maintenance and development of proper standards, and encourage the combination of libraries or library systems into larger and more economical units, to be a judicious investment in the future of the Commonwealth. Although the statutory formula for the grant program has not changed since 1970, the State Library Board's minimum local expenditure requirement (\$2.00 per capita) has been the same since 1977, and State Aid has been "fully funded" only in Fiscal Years 1985 through 1990, the program has contributed to the following improvements in public information services:

- o Statewide participation in the library development program by 88 of Virginia's 94 public libraries, serving 99% of the state's population.
- o An increase in the per capita local and state combined expenditure for public library services from \$5.59 in 1977 to \$14.63 in 1988.
- o While Virginia's population increased 27%, 1977 to 1988, public library collections grew 57.1%, circulation of materials increased 58.3%, and the number of certified librarians to assist public library users increased 30%.
- o The geographical area of Virginia not served by public libraries has been reduced from over 50% of the state in 1970 to an area of three counties by 1989.

The \$2.00 per capita local expenditure requirement to participate in the state aid program has been surpassed by inflationary pressures on public library budgets, the public's demand for information services, and the local efforts of library directors, trustees, staffs, and communities.

In addition to improving their fiscal efforts toward meeting the information needs of Virginia's citizens, the public libraries made significant progress in improving the management, delivery, efficiency, and quality of public information services by meeting the State Library Board's qualitative requirements to receive grants-in-aid.

The State Library Board changes the requirement for local expenditures in support of public library services that stimulates local fiscal effort, allows for inflation, and continues the consistent growth necessary to meet the information needs of the citizens of Virginia.

BACKGROUND: STATE AID TO PUBLIC LIBRARIES

Although state aid to public libraries has existed since the 1940s, the "modern era" of this program of support for public education dates from the 1970 revision of the <u>Code</u>. In section 42.1-48, the General Assembly established a formula for state aid with the following criteria:

- 1. Thirty-five cents of state aid for every dollar expended (exclusive of state and federal aid) by each political subdivision. This amount is not to exceed \$150,000.
- 2. Thirty-five cents per capita for the first 600,000 persons served by a city or county library, and an additional ten cents per capita for the first 600,000 persons for each additional city or county served (libraries or systems serving a population in excess of 600,000 shall receive ten cents per capita for the excess).
- 3. A grant of ten dollars per square mile of area served by every library or system and an additional grant of twenty dollars per square mile of area served to every library system serving more than one city or county.
- 4. Every qualifying municipal library serving an area containing less than 5,000 population shall receive its proper share, using the formula above, but not less than \$400.

If state appropriations provided for the library grants are not sufficient to meet the formula detailed above, the State Library Board shall prorate the available funds in such manner that each application shall receive a proportionate share.

This formula has remained unchanged since 1970. The General Assembly appropriated \$600,000 for this program for FY 1970-71. The appropriation grew to the upper limit of the statutory formula in FY 1984-85. "Full funding" has continued through the current year. \$11,602,117 was appropriated by the General Assembly for FY 1989-90.

REQUIREMENTS FOR RECEIVING GRANTS-IN-AID

The State Library Board is charged with the responsibility of establishing standards under which libraries shall be eligible for state aid (42.1-52) On October 31, 1977, the State Library Board adopted, in essence, the current Requirements Which Must Be Met in Order to Receive Grants-in-Aid. The Requirements which were adopted in 1970 as part of the agency's first program budget and were revised in 1973, '74, '77, and '84 have remained unchanged since the revision of January 30, 1984.

Eighty-eight of ninety-four Virginia public libraries have qualified for state aid. Three of the ninety-four public libraries, Edinburg, New Market, and Strasburg, are town libraries and are ineligible to receive state aid because of the requirement that "not more than one library in a county or regional library system or a municipal governmental unit may receive a grant."

LOCAL MINIMUM EXPENDITURE REQUIREMENTS

The current <u>Requirements</u> mandate a local operating <u>expenditure</u> of \$1.75 per capita by July 1, 1980 and \$2.00 per capita by July 1, 1981, two-thirds of which must be from taxation or endowment funds. Libraries obtaining aid for the first time must meet the lower requirement within two years after approval of first grant and the higher figure within three years.

State aid, with the local minimum expenditure requirement has become a significant factor in developing Virginia's public library services and in matching the growth of local library support. However, many libraries' services still remain partially developed.

Between 1977 and 1988, state aid increased from \$0.33 to \$1.79 per capita (442.4%) while local expenditures increased from \$5.26 to \$12.84 per capita (144.1%). The State's overall share of spending for public libraries has increased during this same period from 0.86% to 12.2% per capita.

While the local and state financial efforts, 1977 through 1988, are significant, such efforts were required to match the state's growth (population increase of 27%), inflation in library related costs, and the increased demands for public library service.

In 1970, 37 counties and 1 city were without public library service. In 1989, three counties, Giles, King and Queen, and Richmond, lack formal public library service which qualifies them to receive State aid.

The program has also helped Virginia's public libraries weather a difficult financial period. Between 1980 and 1987 the consumer price index for all items increased 72%, the cost of hardback books rose 47.2%, prices of periodicals increased 106.7%, 16mm films costs rose 67%, and microfilm prices increased 93.1%. State aid funds have been used by Virginia's public libraries mainly to support the development of collections for the citizens of the Commonwealth. For example, it is estimated that 79% of state aid expenditures in the current fiscal year will be for books and materials based on certified state aid budgets submitted by public libraries.

There are indications that state aid to public libraries in Virginia has contributed toward meeting increased demands for local library services, 1977 through 1988. While Virginia's population increased 27%, the state's public libraries' circulation of public library materials to users increased from 5.23 to 6.23 books per capita, a rise of 58.3%, from 23 to 36.5 million items. The total number of books available to the public increased 57.1%, from 7.9 to 12.5 million volumes. However, 46 libraries have less than two books per capita.

The number of professional staff (certified librarians) to serve users rose 30%, from 450 to 587. However, 11 libraries do not have a certified librarian and 12 libraries serve their users with less than two paid staff.

OTHER CRITERIA

The State Library Board's <u>Requirements Which Must Be Met In Order To Receive Grants-In-Aid</u> also contain quite a number of qualitative requirements for Virginia's public libraries serving more than 5,000 persons.

Section I of the <u>Requirements</u> mandates libraries to "Be organized under the appropriate section of the Code of Virginia. Not more than one library in a county or regional library system or a municipal governmental unit may receive a grant." The justification for prohibiting more than one library in a county or regional system or a municipal governmental unit to receive a grant is to encourage countywide and regional service. Although small municipal libraries serving fewer than 5,000 persons are eligible to receive state aid if they meet the requirements, those libraries may no longer receive state aid funds directly once countywide service is established. Small municipal libraries have the option of becoming part of the county library system and benefiting from state aid or remaining independent.

Under section II of the <u>Requirements</u>, libraries must submit copies of their: legal papers of organization, a list of the names of trustees, a five year plan for the development of information services with annual updates, written service, personnel, and collection maintenance and development policies, statistical and financial reports, and the budget for the expenditure of local funds.

These requirements ensure that the library is organized according to laws governing the establishment of public libraries in Virginia, sections 42.1-33 through 42.1-43 <u>Code of Virginia</u>. They also support sound library management principles. As the agency which administers the grants, the State Library monitors the compliance by receiving and maintaining this fundamental documentation.

Section IV of the State Library Board's <u>Requirements</u> supports Virginia's law (section 54.271-1) requiring certified librarians.

Under section V of the <u>Requirements</u> a beadquarters or centrally located branch library must be opened 40 hours per week for public services. The schedule must include at least four evening hours and appropriate weekend hours. This requirement provides flexibility in scheduling library hours of operation to meet local needs and at the same time ensures that libraries will be open some hours in the evening and on weekends to accommodate those persons who find it inconvenient to come to the library during weekdays. A few libraries, particularly those located in small towns, indicate that they have problems staffing their libraries at night, are concerned about security, and discouraged by low use of library services in the evening.

Section VI of the State Library Board's <u>Requirements Which Must Be</u>
<u>Met In Order To Receive Grants-In-Aid</u> mandates each library to
maintain an up-to-date reference collection, participate in
interlibrary loan services, organize, classify, and maintain
collections, and provide information services to all community
groups, organizations and individuals. These requirements pertain to
basic services which all libraries should provide.

Section VII of the <u>Requirements</u> stipulates that each library serving an area of more than 400 square miles to provide some form of extension service acceptable to the board. This requirement ensures convenient access to library services for persons residing in a large geographical service area or in counties and cities with large populations. Extension services, although not defined in the requirement, include such service points as branch libraries, stations, bookmobiles, and books by mail programs.

Section VIII requires libraries with more than two service units to maintain a delivery system. This requirement promotes accessibility to all the resources of each library system for all patrons.

Finally, section IX of the <u>Pequirements</u> permits the State Library Board to exempt libraries from any single requirement. Occasionally, a library will request a waiver from a requirement. The reason most commonly cited is a decrease in local expenditures due to a one-time special purchase the previous year, for example, the purchase of a bookmobile or computer system. Libraries will also sometimes need additional time to meet the requirement for providing extension services. All requests are reviewed by the State Library Board.

The State Library Board's requirements have contributed toward a more professional management of Virginia's public libraries by insuring that each participating library has bylaws, an up to date list of its trustees, written policies for personnel, administration, and services, the proper financial reports, a budget process, and certified librarians to deliver services to users.

Although five year plans have been part of the state aid process since 1977, much work remains to be done to develop local, regional, and statewide plans for public information services in the 1990s.

State aid grant funds are used primarily to expand and improve library collections. However, they have also supported the hiring of professional librarians according to a recent estimate compiled by the Public Library Development Division of the Virginia State Library and Archives. For example, we estimate that this year, city libraries will devote 87% of their state funds to books and 3.4% to salaries. County libraries plan to spend 82% of state funds on books and 8% on salaries. Regional libraries need more state funds for salaries. They plan to spend 68% of their state aid on books and 16% on salaries.

Virginia's public libraries' compliance with the qualitative <u>Requirements</u> for reference and information services, collection development, and administration has contributed to a steady improvement in the <u>delivery of public library</u> services.

ANALYSIS

The \$2.00 per capita local expenditure requirement has been surpassed by inflationary pressures on public library budgets, service demands on Virginia's public libraries, and the local efforts of library directors, trustees, staffs, and communities. Over the past five years, 18 public libraries have maintained a local expenditure effort below \$4.00 per capita. Ten of these 18 are below \$3.00 per capita.

In reviewing the ten public libraries which are presently spending less than \$3.00 per capita in local funds for library services, many of these agencies have participated in the state aid program for less than five years. They have received only small annual increases in local funds during this period. Seven of these libraries serve populations of less than 25,000.

Another contributing factor to lower local support for public library services may be that libraries which are organized as a company, society, or association, under section 42.1-43 of the Code of Virginia, have more difficulty in obtaining local funds that they would if they were a department of the local government. There are 18 public libraries in Virginia that are organized in this fashion. Seven of the ten public libraries spending less than \$3.00 per capita are organized as company, society, or association libraries. Also, three public libraries that came into the state aid program since July 1, 1988 are organized in this manner.

Prior to the adoption of the 1977 Requirements, the minimum local expenditure requirement was sixty cents per capita, two-thirds of which had to be from taxation or endowment sources. Virginia's public libraries were given five years to increase local expenditures to the new level of \$2.00 per capita. No libraries dropped out of the state aid program because they were unable to reach the \$2.00 minimum.

In addition to analyses of the statistical data relating to state aid, the Public Library Development Division of the Virginia State Library and Archives worked closely with the Virginia Library Association and its Committee to Review State Aid. A number of fiscal variations on: (1) the State Library Board's \$2.00 per capita local expenditure requirement, (2) the statutory match of \$0.35 per dollar of local expenditure, (3) the statutory \$150,000 limitation on grants to cities and counties, and (4) the \$20 per square mile of area served by all library systems serving more than one city or county were studied by staff and the Committee. Models were also produced to reflect these variables with no increase in state funds. In this cooperative analysis of state aid needs, the Committee and staff agreed that the \$2.00 per capita requirement should be increased.

CONCLUSIONS

Based on the history of the minimum expenditure requirement of the State Library Board's Requirements Which Must Be Met In Order To Receive Grants-In-Aid, the analyses of the impact of the 1977 \$2.00 per capita local expenditure, and study of the efforts of Virginia's public libraries participating in the state aid program, the Board resolves to change the local per capita operating expenditure standard for receipt of state aid in section III of the Requirements. The Board hereby increases the per capita expenditure from \$2.00 to:

o Local operating expenditures of at least 50% of the median statewide local operating expenditures per capita. The median shall be recalculated each biennium. Libraries obtaining aid for the first time or those falling below the 50% median must meet the requirement within five years.

When this amendment becomes effective, under the provisions of the Administrative Process Act, the Board believes that this requirement will provide a structure to allow a measured, consistent increase in local support for public libraries. The statewide median, based on 1988 expenditures, was \$6.94. Thus, \$3.47 would be the current per capita expenditure under this proposal. This change in the State Library Board's <u>Requirements</u> would currently impact 13 public libraries.

In taking this action, the Board recognizes that this requirement may have a negative impact. It is possible that local governments may refuse to provide the necessary increases, thereby causing some libraries to lose state aid. It is also possible that this requirement may make the task of extending public library service to the three unserved counties through the state aid program more difficult. However, the Board has to balance these possibilities against the demonstrated statewide need to help public libraries secure the local funds necessary to maintain, develop, and improve information services and fulfill the intent of the state aid law.

In reviewing the impact of the qualitative requirements for the state aid program, the State Library Board sees no need to change the standards of sections I, II, IV, VII, VIII, and IX of the Requirements Which Must Be Met In Order To Receive Grants-In-Aid.

In reviewing Section V of the <u>Requirements</u>, regarding the library hours of service to the public, the Board is sensitive to the concerns of libraries, especially those located in smaller towns, regarding scheduled evening hours. The Board changes the requirement in section V, to:

o This schedule must include three consecutive evening hours. Evening hours are defined as the hours after 5 p.m.

In its review of section VII of the <u>Requirements</u>, the Board Wishes to strengthen the standards for basic library services by adding the following requirements:

- o Each library should have a telephone and the number of the telephone should be listed in the local <u>community</u>'s public directory and in the <u>Directory of Virginia Libraries</u> published by the Virginia State Library and Archives.
- o Each library should provide the basic services listed in this section free of charge to the public, as required by law.

REQUIREMENTS WHICH MOST BE MET IN ORDER TO RECEIVE GRANTS-IN-AID

In order to qualify for grants-in-aid, all libraries serving more than 5,000 persons shall meet the following requirements by July 1, 1980:

- I. Be organized under the appropriate section of the Code of Virginia. Not more than one library in a county or regional library system or a municipal governmental unit may receive a grant.
- II. Submit to the State Library Board:
 - 1. Charter, resolutions, or other legal papers under which they are organized.
 - 2. A copy of the by-laws of the board of trustees, a list of trustees, revised as changes occur.
 - 3. A five-year plan, adopted by the governing body of the library service in the area (areas) served. In order to receive continuing grants, this plan must be updated annually.
 - 4. A written statement of policy covering such items as: service, personnel, and maintenance of book collections and other materials.
 - 5. Statistical and <u>financial</u> reports including audits and statements of progress of the plan as requested.
 - 6. A copy of the budget for the expenditure of local funds, not including anticipated state and federal funds. This must be submitted annually.
- III. Have local operating expenditures of at least \$1.75 per capita by July 1, 1980 and \$2.00 per capita by July 1, 1981, two-thirds of which must be from taxation or endowment. Libraries obtaining aid for the first time must meet the lower requirement within two years after approval of first grant and the higher within three year.

Local operating expenditures from taxation or endowment for any library, or library system, shall not fall below that of the previous year. In cases where the budgets of all the departments of the local government are reduced below those of the previous year, the library's state grant-in-aid would be reduced. The State Library may require that the amount of such reduction in the library's total expenditure be subtracted from the library's eligibility and that the state grant be reduced accordingly. If the library's budget is reduced and other agencies' budgets are not, then the library would receive no state grant-in-aid and would be ineligible for one until local expenditures shall have again reached or exceeded the local effort at the time of the last previous grant.

The library would be ineligible for any federal funds if local funds are reduced below that of the previous year.

Grants-in-aid shall be used as supplements to local funds.

The amount of any undesignated balance in the local operating budget at the end of the fiscal year which exceeds 10 percent will be subtracted from the grant which is based on that year's expenditures.

- IV. Have certified librarians in positions as required by state law.
- V. Keep open a headquarters library or centrally located branch at least 40 hours a week for a full range of library services. This schedule must include at least four evening hours and appropriate weekend hours.
- VI. 1. Maintain an up-to-date reference collection and set up procedures for securing materials from other libraries through interlibrary loan.
 - 2. Organize materials for convenient use through shelf arrangement, classification and cataloging, and provide a catalog of its resources.
 - 3. Stimulate use of materials through publicity, displays, reading lists, story hours, book talks, book and film discussions and other appropriate means.
 - 4. Lend guidance in all outlets to individuals in the use of informational, educational, and recreational materials.
 - 5. Lend assistance to civic, cultural, and educational organizations in locating and using materials for program planning, projects, and the education of members.
 - 6. Maintain a collection of currently useful materials by annual additions and systematic removal of items no longer useful to maintaining the purposes of quality of its resources.
- VII. Every regional, county, and city library serving an area of more than 400 square miles and/or more than 25,000 persons must provide some form of extension service acceptable to the board.
- VIII. If a library system has two or more service units, either branches or stations, it must maintain a scheduled, frequent delivery system.
 - IX. The Library Board may, at its discretion, make exceptions for a specified period of time to any single requirement listed above. The exception will be made only if the library can show that a real effort has been made to meet the requirement and that significant progress has been made toward meeting this requirement.
