DEPARTMENT OF EDUCATION RESPONSE TO SENATE JOINT RESOLUTION 165

The Department of Education began revising the Standards of Learning objectives for health education in August 1989. Representatives from the Fire Marshal's Office, Fire Programs Service, and Department of Forestry served on the revision committee. The objectives related to fire prevention education were increased and strengthened for kindergarten through grade ten. The objectives will be finalized in the summer of 1990. The assessment strategies will be completed in the spring of 1991.

A memo has been sent to all division superintendents to encourage them to continue to work with outside resources in their community to assist in strengthening fire prevention education in the schools. (See attached memorandum).

The Department of Fire Programs has submitted a report which includes the number of schools using fire-related agencies to bring fire prevention education programs into the schools, the number and types of programs presented, and the number and grade level of students participating, and the names of the participating agencies. (See attached report). While this is not a complete report of school programs because many of the community resources did not document or report to the Fire Program office, a more complete report based on a survey to be conducted by the Department of Education will be submitted to the 1991 General Assembly.

SENATE JOINT RESOLUTION NO. 165

Encouraging the Department of Education to promote fire prevention education in the public schools.

Agreed to by the Senate, January 31, 1989 Agreed to by the House of Delegates, February 17, 1989

WHEREAS, fire prevention education is worthwhile because it can reduce the number of human lives lost, injuries caused by fire, property loss and destruction due to fire; and

WHEREAS, the Department of Education has a health education program which includes fire prevention education in the safety and first-aid strands of the Standards of Learning Objectives for kindergarten through the eighth grade; and

WHEREAS, some school administrators feel that they cannot allocate time to fire prevention activities because of the emphasis on test scores in academic subjects; and

WHEREAS, in some instances outside agencies are discouraged from bringing their programs into the schools; and

WHEREAS, students and the community at large would benefit if the amount of fire prevention education in the public schools was increased; now, therefore, be it

RESOLVED by the Senate, the House of Delegates concurring. That the Department of Education is requested to give increased attention to fire prevention education during its next revision of the Standards of Learning Objectives and the accompanying assessment strategies in the health education program for kindergarten through the eighth grade; and, be it

RESOLVED FURTHER. That the General Assembly requests the Department of Education to urge each school division in the Commonwealth to work cooperatively with outside resources in the community, such as local fire department personnel, local fire marshals, the Department of Fire Programs and the Department of Forestry to bring fire prevention education into the public schools; and, be it

RESOLVED FINALLY. That the Department of Education is requested (i) to submit to the 1990 General Assembly a report on all efforts made to have school divisions include fire prevention education in their curriculums; (ii) to submit to the 1990 General Assembly a joint report with the Department of Fire Programs on the number of schools using fire-related agencies to bring fire prevention education programs into the schools, the number and types of programs presented, the number and grade level of students participating, the names of the participating agencies and all efforts made to encourage school divisions to work cooperatively with fire-related agencies to bring fire prevention education programs into the schools; and (iii) to submit to the 1991 General Assembly a report on any revisions to the Standards of Learning Objectives in the health education program regarding fire prevention education for kindergarten through the eighth grade.
