CONDITIONAL PARDONS

FISHER, Samuel E., Jr.

Samuel E. Fisher, Jr. was convicted of six counts of Grand Larceny and one count of Conspiracy in the Circuit Court of the City of Richmond. He was subsequently sentenced to be imprisoned for a term of eighty years in the State Penitentiary, with thirty years suspended. In view of his commendable conduct while incarcerated and his dedication to helping other inmates and their families, the Governor granted him a conditional pardon. In so doing, the Governor ordered that his sentence be appropriately reduced so as to cause him to be immediately eligible for parole and ordered that he be placed on parole for ten years, upon his acceptance of the conditional pardon, and upon such terms, conditions, and requirements for supervision as the Virginia Parole Board shall establish. Such terms included an obligation for 500 hours of community service work. This pardon was also conditioned upon his waiver of all claims against the Commonwealth or any of its officials, officers, or employees. If, prior to August of 1999, this individual should violate these conditions, or be found guilty of violation of the penal laws of any city, county, State, or of the United States, this pardon may be revoked.
