EXECUTIVE SUMMARY

The Governor's Task Force on Promotion of the Arts looked at the results of state funding of the arts through the Virginia Commission for the Arts and the impact of the state spending cuts on the arts. The finding of the Task Force was that there has been expansive growth in the arts in all areas of the state as a result of the programs of the Commission for the Arts. These programs have had a multiplier effect by encouraging additional funding from individuals, businesses, and local governments. The public dollars have made it possible for millions of Virginians in all parts of the state to participate in the arts, regardless of income, race, age, disability, or social barriers.

It is the recommendation of the Task Force that the General Assembly reconfirm its commitment to promoting the arts by rewriting the enabling legislation of the Commission for the Arts to detail state government goals for the arts and to direct the Commission to address specific issues. These goals and issues are on pages 5 and 6 of this report. Furthermore, the Task Force recommends that the General Assembly establish a financial goal of an annual General Fund appropriation for the Commission of \$1 per citizen of the Commonwealth. The Task Force recognizes that with the pressures on the state budget that it will take some time to reach this financial goal.

REPORT OF THE GOVERNOR'S TASK FORCE ON PROMOTION OF THE ARTS

Summary

The Governor's Task Force on Promotion of the Arts met four times in 1990 and 1991 - in Richmond, Roanoke, Alexandria, and Norfolk. The Task Force heard testimony from 78 speakers about the value of state support of the arts and about the impact of the state spending cuts on not-for-profit arts organizations and artists.

-Public funding of the arts helps pay for educational programs, outreach activities for the economically disadvantaged, and touring to all parts of the state. Without public support arts organizations will focus only on those programs that generate the most revenue. The arts will then be available only to a small segment of the population.

-The arts depend upon the efforts of thousands of volunteers, thereby making a small amount of public funding go a long way.

-Funding from the Virginia Commission for the Arts to arts organizations creates a multiplier effect by encouraging additional funding from individuals, businesses, and local governments.

-Artists and arts organizations that tour or exhibit nationally and internationally produce good public relations for Virginia and attract visitors to the Commonwealth.

-Studies have shown increases in reading scores of 12 to 26% in schools with cultural enrichment programs.

-A 1987 study in Richmond showed total attendance of 3.8 million at arts events, a 700% increase from 1981. The organizations involved in the study spent \$12.4 million in goods and services that year and \$9.6 million in wages to local employees.

-In the Hampton Roads area there are 2500 arts employees who pay state income taxes to Virginia. This number is comparable with some of the biggest employers in the area such as Sovran Bank with 2800 employees and Canon and Norfolk Southern with 1100 each. -Businesses and individuals are already generous in their financial support of the arts in Virginia. Arts organizations are not able to make up the loss of state support through increased private fundraising.

-The combined budgets of the arts organizations funded by the Commission total over \$60 million, a match of more than ten to one of state funds.

-Study of the arts develops aesthetic skills, helps students to appreciate the cultures of our nation and the world, and inspires creative thinking. These qualities are desperately needed if Virginia is to compete in a world economy.

One theme that appeared repeatedly in the public hearings was that state support of the arts through the Virginia Commission for the Arts has led to expansive growth in the arts in all areas of the state. The Task Force discussed ways to maintain the high level of arts activity in the Commonwealth in an era of limited financial resources. It was the consensus of the Task Force that the mission statement for the Virginia Commission for the Arts in the Code of Virginia should be rewritten to identify areas of concentration for the Commission. The current mission is simply to "stimulate and encourage throughout the State public interest and participation in the arts."

The Task Force recommends substituting the following language in the Code under "duties of the Commission."

GOALS FOR STATE SUPPORT OF THE ARTS IN VIRGINIA

The General Assembly of Virginia has the following goals for public support of the arts in the Commonwealth.

-All Virginians should have access to high quality art. Through the Virginia Commission for the Arts the Commonwealth supports artistic excellence where it already exists, encourages growth in artistic quality, and works to make this artistic excellence available to all Virginians.

-Virginia should be an economically viable and intellectually stimulating place for artists to live and work.

-All Virginians should be able to experience and appreciate quality art at affordable prices.

-A well-planned, sequential, comprehensive program of arts education, taught by certified specialists, should be part of the curriculum of all elementary and secondary schools in Virginia. While the major responsibility for arts education lies with state and local education agencies, the Virginia Commission for the Arts is directed to encourage the arts within the educational system by providing activities that supplement the curriculum.

-Virginia should have a network of resident professional arts organizations producing a variety of classical and new work.

-Virginia should have a network of well-managed media, literary, performing and visual arts presenters dedicated to bringing to their communities the greatest diversity of artistic experiences possible.

In support of these goals, the General Assembly directs the Virginia Commission for the Arts:

-to provide funding and management assistance to nonprofit arts organizations of recognized artistic quality and to encourage these organizations to make their programs available to as many citizens as possible

-to support and encourage new arts organizations that serve people with limited access to the arts

-to provide incentives for local governments to support the arts with local tax revenues

-to recognize and provide funding to individual artists of exceptional talent

-to support performing arts touring as a way of increasing the availability of high quality arts throughout the state

-to provide funding for arts organizations, artists, and arts activities that celebrate and preserve the many cultures which constitute contemporary life in the Commonwealth

-to encourage and provide funding for the creation of new works of art

-to provide programs that support and supplement the arts education curriculum in elementary and secondary schools

-to develop the arts in rural areas of the state

-to utilize advisory panels of artists, administrators of arts organizations, and other citizens residing in each

region of the state to assist the Commission in making funding decisions

Guiding Principles of State Support of the Arts:

The General Assembly of Virginia views its role in providing financial support to artists and nonprofit arts organizations as that of a catalyst, helping to augment and strengthen private and local support of the arts. Through the Virginia Commission for the Arts the General Assembly provides support for those activities least likely to be funded through other sources. This philosophy recognizes that government resources are limited while demands for services are high, and that the arts are healthier when open to diverse influences and not financially dependent on any single source of support.

The General Assembly has set as a goal for state support of artists and arts organizations through the Virginia Commission for the Arts an annual General Fund appropriation of \$1 per citizen of the Commonwealth. In addition, the General Assembly may from time to time appropriate additional funds for specific new programs to be administered by the Commission to address changing needs in the arts.

<u>Conclusion</u>

The Task Force members recognize that state resources will be limited in the next biennium and that it will take some time to reach the financial goal described above. With such limited resources, however, it is more important now than ever that the General Assembly be specific about the state role in support of the arts. **1990 SESSION**

That the Governor is 42 43 requested to continue the Task Force on the Arts in Virginia to study all aspects of promoting the arts in the Commonwealth, including the identification of problems and the 44 determination of appropriate action to resolve the problems. The Task Force shall continue 45 46 with the same membership and the Virginia Commission on the Arts shall continue to assist the Office of the Governor in staffing the Task Force.
