**ABSOLUTE PARDON**

WORSHAM, Welton Earl

Crime: Petit Larceny  
Court: District Court City of Richmond  
Sentence Date: March 8, 1968  
Pardon Granted: November 11, 1991

On March 8, 1968, Welton Earl Worsham, age eighteen, was convicted of Petit Larceny involving the theft of \$4.00 worth of gasoline, and ordered to pay a fine of \$25.00. Thereafter, an individual who was present at the time Welton Earl Worsham was charged with the offense has issued a signed statement concerning the actual events that took place.

For the past twenty-three years, Welton Earl Worsham has led an exemplary, community oriented and law-abiding life. In May of 1991, he risked his life to save the life of a police officer. He now lives in the state of South Carolina and has been denied admittance into the South Carolina Criminal Justice Academy due to this charge being on his criminal record.

Based on the extraordinary and unusual nature of this case, a unanimous recommendation from the Virginia Parole Board and a lengthy and comprehensive review of this matter by the Governor and his executive staff, the Governor granted Welton Earl Worsham an absolute pardon.

## COMMUTATION OF SENTENCE

GIARRATANO, Joseph M., Jr.

On May 22, 1979, Joseph M. Giarratano, Jr. was found guilty of the rape of Michelle Kline, of capital murder for the death of Michelle Kline and of first degree murder for the death of her mother, Barbara Kline.

On August 17, 1979, Joseph M. Giarratano, Jr. was sentenced to death for the capital murder conviction, life imprisonment for the first degree murder conviction and 30 years for the rape conviction.

In view of the facts and circumstances surrounding his arrest and conviction, his numerous judicial appeals, and the evidence presented by the Attorney General and defense counsel, the Governor commuted the sentence of death for the capital murder conviction to life imprisonment and granted Joseph M. Giarratano, Jr. parole eligibility with the opportunity for parole to be determined by the Virginia Parole Board in the same manner as if, originally, he had been sentenced to life imprisonment under present law; provided that in no instance shall he be eligible for parole until he has served a total of 25 years including present time served. The findings and sentence of the court as to rape and first degree murder are to remain unchanged.
