MEDICAL PARDON

BROWN, Tony

On March 1, 1995, Tony Brown submitted through his mother, Isabell Robinson, a request for Executive Clemency based upon the fact that he had been diagnosed as positive for human Auto Immune Deficiency Syndrome (AIDS) complicated by anemia and that his condition had deteriorated to the point that his prognosis for recovery was questionable. His request was then submitted to an Assessment Committee which is directed to review all requests for clemency based upon allegations of fatal illness.

It was determined that Tony Brown's condition had deteriorated to the point where advising physicians could not assure that he would survive beyond the requisite three month period.

ABSOLUTE PARDON

PRINCE, Christopher E.

Crime: Breaking and Entering a Dwelling House in the Daytime with the Intent to Commit a Felony other than Rape, Robbery or Murder, in violation of Section 18.2-91 of the Code of Virginia.

On September 23, 1994 Mr. Prince pled guilty, which the Court accepted based on a statement of facts proffered by the Commonwealth's Attorney. The Court sentenced Mr. Prince to a term of imprisonment of twelve years, with six years conditionally suspended.

In November 1995, counsel for Mr. Prince contacted the Culpeper County Commonwealth's Attorney, the Honorable Gary Close, and provided information and evidence calling into question the veracity of the eyewitness testimony upon which the prosecution and conviction of Mr. Prince had been based. The principal prosecution witness provided a sworn affidavit stating that she had lied previously in providing the statement, relied upon by the Commonwealth's Attorney and the Circuit Court, that incriminated Mr. Prince.

The principal prosecution witness was submitted to polygraph examination by experienced personnel of the Virginia State Police, and the results of these examinations indicated that the witness's sworn statement recanting the incriminating allegations against Mr. Prince was truthful.

Based upon the foregoing, the Commonwealth's Attorney of Culpeper County communicated to Governor Allen his support of the petition for executive clemency filed on Mr. Prince's behalf on December 15, 1995. Mr. Close advised that the law enforcement officer who originally investigated the case also concluded that the statements incriminating Mr. Prince were perjurious, and that Mr. Prince is innocent of the crime for which he was convicted.

MACINTYRE, Stuart Ellsworth

On December 28, 1995, Lisa Portaluppi submitted through her father, Charles J. Portaluppi, a request for Executive Clemency based upon the fact that she had been diagnosed as positive for human Auto Immune Deficiency Syndrome (AIDS) complicated by intracerebral hemorrhage with severe anemia and low platelets and that her condition had deteriorated to the point that her prognosis for recovery was questionable. Her request was then submitted to an Assessment Committee which is directed to review all requests for clemency which are based upon allegations of fatal illness.

It was determined that Lisa Portaluppi's condition had deteriorated to the point where advising physicians could not assure that she would survive beyond the requisite three month period.

REPRIEVE

BARNES, Herman Charles, a/k/a Herman Budda Barnes

Crime: Capital Murder, Murder (Two Counts), Abduction, Attempt
Robbery, Use of a Firearm (Three Counts)
Court: Circuit Court City of Hampton
Sentence Date: September 26, 1986
Reprieve Granted: October 2, 1995

The principal counsel for Herman Charles Barnes petitioned the Governor for a temporary reprieve of Herman Charles Barnes' execution because of the grave illness and imminent death of the counsel's father, which required the counsel's presence outside Virginia during the period immediately preceding the scheduled execution. Counsel supplied a statement from his father's physician confirming the seriousness of the illness.

On the basis of this circumstance, and upon the determination that the knowledge and involvement of this counsel in the representation of Herman Charles Barnes was of such a character and extent as to make his participation desirable for a full explication of Herman Charles Barnes' petition for executive clemency, I granted a reprieve of 38 days.

Thereafter, following consideration of the merits of the petition of Herman Charles Barnes for executive clemency, I determined not to intervene to halt the execution of the sentence imposed by the Court.

REPRIEVE

CORRELL, Walter Milton, Jr.

Crime: Capital Murder and Robbery by Force
Court: Circuit Court County of Franklin
Sentence Date: May 5, 1986
Reprieve Granted: November 28, 1995

The Attorney General had moved for an execution date of November 30, 1995, but the later date of execution set by the Court fell between two state holidays. Since the assistance of various state agencies and employees has on occasion been required in the disposition of requests for clemency, I determined that it was desirable to grant Walter Milton Correll, Jr., a reprieve of seven (7) days in order to give full consideration to his expected petition for clemency.

Thereafter, following consideration of the merits of the petition of Walter Milton Correll, Jr. for executive clemency, I determined not to intervene to halt the execution of the sentence imposed by the Court.
