

## **ABSOLUTE PARDON**

### **WEBB, Troy Lynn**

Crime: Robbery, Abduction with Intent to Defile, Use of a Firearm  
in the Commission of a Felony, and Rape  
Court: Circuit Court, City of Virginia Beach  
Sentence Date: March 9, 1989  
Pardon Date: October 16, 1996

On February 1, 1989, Mr. Webb, having pled not guilty to all of the charges, nevertheless was found guilty by a jury of his peers of all the crimes charged. On March 9, 1989, the Honorable Edward W. Hanson, presiding judge, imposed the sentence recommended by the jury which totaled 47 years in prison.

Through his counsel, Mr. Webb petitioned Governor Allen on September 24, 1996 for a grant of Executive Clemency. The principal ground presented in Mr. Webb's petition was that recently completed DNA tests eliminated Mr. Webb as the contributor to genetic material found in samples collected from the victim shortly after the crime was committed, and therefore, Mr. Webb could not have committed the crimes for which he was convicted on February 1, 1989 in the Circuit Court of the City of Virginia Beach.

On September 26, 1996, the Honorable Robert J. Humphreys, Commonwealth's Attorney for the City of Virginia Beach whose office prosecuted Mr. Webb, submitted a letter to Governor Allen in which he joined in the petition for clemency for Mr. Webb. Mr. Humphreys based his recommendation upon DNA tests conducted by the Commonwealth's Division of Forensic Science.

The Governor convened a group of law enforcement experts to provide technical assistance in a thorough review of the contentions made in the clemency petition, the evidence adduced at the trial, and the scientific evidence that had become available after the Webb trial as a result of the technological advances in the field of DNA testing.

The results of this review and the DNA testing established that Mr. Webb could not have been the source of the genetic material taken from the victim following these crimes.

## COMMUTATION OF SENTENCE

Joseph Patrick Payne, Sr., was brought to trial in the Circuit Court of the County of Powhatan and on June 19, 1986, he was sentenced to death for the murder of David Dunford.

The Circuit Court of Powhatan County, by order, fixed the date of Payne's execution for the murder of David Dunford for November 7, 1996. The execution was temporarily stayed by the Governor, pending the acceptance of the commutation of sentence.

On November 8, 1996, the Governor commuted the sentence of death for the murder conviction to life imprisonment without the possibility of parole. The commutation is conditioned upon Payne not seeking, and expressly waiving any claims or rights to a new trial for the murder of David Dunford; and the agreement that should Payne ever receive by gift or have the rights or claim to any royalties, monies, funds, fees or any other form of remuneration deriving from the sale of book rights, film or television rights, interview rights, or similar rights, all such gifts, rights or claims, and the funds flowing therefrom, shall not be the property of Payne or his heirs, assigns or donees, but shall become the property of the Commonwealth of Virginia and shall be used by the Commonwealth for programs benefiting the victims of crime or family members of the victims of crime.
