ABSOLUTE PARDON

JOHNSON, Yvonne Crittle

Crime: Use of a Firearm in the Commission of a Felony, Aggravated Sexual Battery, Robbery and Rape
Court: Circuit Court, City of Newport News
Sentence Date: December 20, 1988
Pardon Date: April 30, 1997

On December 20, 1988, Ms. Johnson was sentenced as follows: Use of a Firearm--two years; Aggravated Sexual Battery--five years suspended, fifteen years probation; Robbery--five years suspended, fifteen years probation; Rape--ten years, five years suspended, fifteen years probation. She was released from incarceration in October 1990.

Through her counsel, Ms. Johnson petitioned Governor Allen on January 31, 1997, for a grant of Executive Clemency. The principal ground stated in the petition was that the purported victim in the case against Ms. Johnson, Tammy Wilson, had recanted her trial testimony against Ms. Johnson, and a co-defendant, Steve Lawton, and had admitted that she lied under oath at the trials of both. On January 15, 1997, Governor Allen granted an Absolute Pardon to Steve Lawton for the crimes of which he was accused by Tammy Wilson.

In a letter dated March 26, 1997, The Honorable Howard E. Gwynn, Commonwealth's Attorney for the City of Newport News, whose office prosecuted Ms. Johnson, endorsed her clemency petition. Mr. Gwynn stated that he had visited the purported victim, Tammy Wilson, at a drug rehabilitation center in Richmond and interviewed her regarding the Johnson and Lawton cases. Mr. Gwynn stated that he had given Ms. Wilson a written grant of immunity from prosecution for perjury, which he stated was for the purpose of encouraging honest answers from Ms. Wilson. Mr. Gwynn stated that Ms. Wilson admitted to him that neither Steve Lawton nor Yvonne Crittle Johnson had committed any crimes against her and that she had lied.

As part of the clemency investigation for Steve Lawton, Yvonne Crittle Johnson voluntarily submitted to a polygraph examination. The results of the investigation indicated that Ms. Johnson was telling the truth when denying the allegations made by Ms. Wilson at the trials of Ms. Johnson and Mr. Lawton.

Tammy Wilson also voluntarily submitted to a polygraph examination. The results indicated that Ms. Wilson was telling the truth when admitting that she had consensual sex with Mr. Lawton, rather than having been forced into sex with him, and therefore her testimony against Mr. Lawton and Ms. Johnson at their trials was a lie. Tammy Wilson also signed and swore to a notarized affidavit, dated January 2, 1997, in which she admitted that Steve Lawton did not force her into sex and that Yvonne Crittle Johnson was not present at the time of the alleged crimes.

On October 23, 1990, Mr. Lawton was sentenced as follows: Rape--seventy years; Use of a Firearm--two years; for a total of seventy-two years to serve.

Through his counsel, Mr. Lawton petitioned Governor Allen on August 16, 1996, for a grant of Executive Clemency. The principal ground stated in the petition was that the purported victim in the case against Mr. Lawton, Tammy Wilson, had recanted her trial testimony against Mr. Lawton, and a co-defendant, Yvonne Crittle Johnson, and had admitted that she lied under oath at the trials of both.

In a letter dated July 25, 1996 to Pamela J. Jones, counsel for Lawton, The Honorable Howard E. Gwynn, Commonwealth's Attorney for the City of Newport News, whose office prosecuted Mr. Lawton, endorsed his clemency petition. Mr. Gwynn stated that he had visited the purported victim, Tammy Wilson, at a drug rehabilitation center in Richmond and interviewed her regarding the Lawton case. Mr. Gwynn stated that he had given Ms. Wilson a written grant of immunity from prosecution for perjury, which he stated was for the purpose of encouraging honest answers from Ms. Wilson. Mr. Gwynn stated that Ms. Wilson admitted to him that neither Steve Lawton nor Yvonne Crittle Johnson had committed any crimes against her and that she had lied. Mr. Gwynn restated his endorsement of Mr. Lawton's clemency petition in a letter to Governor Allen dated January 15, 1997.

As part of the clemency investigation for Steve Lawton, Yvonne Crittle Johnson voluntarily submitted to a polygraph examination. The results of the investigation indicated that Ms. Johnson was telling the truth when denying the allegations made by Ms. Wilson at the trials of Mr. Lawton and Ms. Johnson.

Tammy Wilson also voluntarily submitted to a polygraph examination. The results indicated that Ms. Wilson was telling the truth when admitting that she had consensual sex with Mr. Lawton, rather than having been forced into sex with him, and therefore her testimony against Mr. Lawton at his trials was a lie. Tammy Wilson also signed and swore to a notarized affidavit, dated January 2, 1997, in which she admitted that Steve Lawton did not force her into sex and that there was no gun present at the time. She also admitted that she lied under oath at the trial.

On December 17, 1996, Melvin L. Banks submitted through his mother, Daisy L. Banks, a request for Executive Clemency based upon the fact that he had been diagnosed as positive for human Auto Immune Deficiency Syndrome (AIDS) complicated by Hepatitis and that his condition had deteriorated to the point that his prognosis for recovery was questionable. His request was then submitted to the Medical Clemency Assessment Committee which is directed to review all requests for clemency which are based on allegation of fatal illnesses.

It was determined that Melvin L. Banks' condition had deteriorated to the point where advising physicians could not assure that he would survive beyond the requisite three month period.
