COMMUTATION OF SENTENCE

SWANN, Calvin Eugene

Calvin Eugene Swann was convicted in the Circuit Court of Danville of murder and robbery and sentenced to death. After a long series of appeals, the Circuit Court of Danville eventually fixed the execution date for May 12, 1999.

On May 7, 1999, counsel for Calvin Swann requested the Governor to invoke his legal authority of clemency by commuting the sentence of death to a sentence of life without the possibility of parole.

On May 12, 1999, the Governor commuted the sentence of death for the murder conviction to life imprisonment without the possibility of parole. The commutation is based upon a thorough review of the Petition for Clemency, the legal decisions issued in the case, numerous other records, and the circumstances of this matter.

His request was then submitted to the Medical Clemency Assessment Committee, which is directed to review all requests for clemency, which are based on allegation of fatal illnesses.

It was determined that Gilbert Q. Dawson's condition had deteriorated to the point where advising physicians could not assure that he would survive beyond the requisite three month period.
