PREFACE

Senate Joint Resolution 382, approved by the 2001 General Assembly, requested the Commonwealth Competition Council, in cooperation with certain agencies and institutions, to prepare a plan for the development of a statewide database of nonprofit and not-for-profit entities that could be accessed via the Internet. This report presents the plan for consideration by the Governor and the 2002 General Assembly.

Those agencies working with the Commonwealth Competition Council on this plan included the Department of Taxation, Attorney General's Office, Department of Agriculture and Consumer Services, State Corporation Commission, Charitable Gaming Commission, Virginia Information Providers Network, Commissioners of the Revenue, INOVA Health System, Restaurant Association of Virginia, Young Men's Christian Association of the USA, Commission on Local Government, Compensation Board, Division of Legislative Services, Auditor of Public Accounts, Virginia Association of Counties, Virginia Municipal League, and the Weldon Cooper Center for Public Service. The taskforces heard presentations from several sources, providing keen insight into the benefits of an Internet database.

This plan represents the second year of concentrated study by the Commonwealth Competition Council of nonprofit or not-for-profit organizations in Virginia. In 2001 the results of the SJR 219 study of ongoing or permanent commercial activities of not-for-profit organizations and their effect on state revenues were published in House Document No. 50 (2001). All three recommendations of last year's study are reflected in the Internet-based plan proposed in this document.

Great strides have been made in gathering access to data on the 36,571 exempt organizations in Virginia. Since the SJR 219 study, the Internal Revenue Service has publicly released its information on organizations that they have granted "exempt organization" status. It is recommended that this public information from the IRS be utilized in its entirety and downloaded to a web-enabled Internet accessible database. This would provide a sound foundation for the Virginia database which will be kept current monthly.

The Council recommends that a survey be undertaken of all the counties, cities, and towns of Virginia to ascertain the Authorities serving their localities. Over 500 Authorities have been identified this year, an increase from the 433 identified during the SJR 219 study. The survey will establish the basis for a similar Internet accessible Authorities database to be developed. The Council concluded that Authorities represent a potential challenge to private sector competition. The initial findings also reflect a total of \$17 billion in outstanding debt identified in 110 of these Authorities.

The Council believes and recommends that placing information about these organizations on the Internet constitutes good public policy. It would provide information on the various organizations in one place. It could be used by the public, federal, state, and local governments, as well as by businesses and other nonprofit or not-for-profit organizations and Authorities.

This report outlines the proposed plan for both the nonprofit or not-for-profit organization and Authorities Internet databases. Nominal funding has been identified to enable the Commonwealth Competition Council to proceed with carrying out this plan.

On behalf of the Commonwealth Competition Council, I would like to thank those who served on the taskforces established to develop the plan. Virginia is indeed fortunate to be served by such talented and dedicated state employees and citizens.

Dear Senator Hanger:

I am pleased to inform you that the Commonwealth Competition Council Taskforce developing the plan requested by SJR 382 (2001) has completed its work and has proposed a workable plan for an Internet website on nonprofit/not-for-profit organizations and Virginia Authorities. That plan and draft report are attached.

The Taskforce members devoted much of the summer and fall in meetings to examine the issues involved. Given the depth of review and the extensive amounts of information examined, two distinct study groups were established: one for nonprofit issues and one for the Authorities. The nonprofit/not-for-profit study group was further organized into three subgroups. That scheme allowed us to consider the myriad of issues inherent in nonprofit/not-for-profit organizations and the various Authorities.

The Taskforce found that placing information about these institutions on the Internet would constitute good public policy. It would provide in one place information on the various organizations that could be used by the public, state agencies and local governments as well as by businesses and other nonprofit/not-for-profit organizations and Authorities. It is recommended that the public information from the Internal Revenue Service on exempt organizations be utilized in its entirety and downloaded to a web-enabled Internet accessible database. Downloading of the entire IRS database with information on all organizations across the country will provide the most complete data. This is also more accurate and less time consuming than trying to download selected pieces of information. With respect to the Authorities database, it is recommended that a survey be undertaken of all the counties, cities and towns of Virginia to ascertain the Authorities that serve their localities. This will establish the basis for a similar Internet accessible Authorities database to be developed.

It is further recommended that development of this or these website(s) for these institutions proceed immediately and that the relatively minimal funds identified be requested to permit development during the next year. Alternatively, it is conceivable that the project could be self-funded by the use of value added data mining techniques that would produce commercially valuable products. Such an alternative would require either interim borrowing authority from the Treasury or a deferral of the costs requisite to the development of these sites.

EXECUTIVE SUMMARY

One of the recommendations from the SJR 219 (2000) study of ongoing or permanent commercial activities of not-for-profit organizations and their effect on state revenues was the need for a statewide database of these organizations. There are over 36,000 organizations in Virginia that are granted tax exempt status by the Internal Revenue Service (IRS). Nationwide, there are over 1.25 million. Further, there are at least six Virginia government agencies that deal with exempt organizations in varying degrees, but the Commonwealth Competition Council found there was no central repository on these organizations and in only one instance a sharing of data.

Similarly there was little data available on the vast number of independent Authorities that are authorized in Virginia. The General Assembly and local governments, enabled by the *Code of Virginia*, create these entities. Originally the number of such quasi-governmental organizations identified during the SJR 219 study last year totaled 433. Currently, over 500 have been identified, and it appears the number is continuing to rise as other Authorities are identified. In addition, some 98 "Special Districts" have also been identified, but the Competition Council has not collected data on these entities at this time. Initial findings reflect a total of \$17 billion in outstanding debt identified in 110 of these Authorities.

Based on the findings and recommendations of SJR 219 to the Governor and 2001 General Assembly, SJR 382 (2001) was passed by the General Assembly requesting the Commonwealth Competition Council to coordinate the development of a plan to provide for a database of such organizations, including Authorities and cooperatives, to be available on the Internet.

A taskforce was formed from the six agencies, Charitable Gaming Commission, Office of the Attorney General, Department of Taxation, State Corporation Commission, Department of Agriculture and Consumer Services, and the Commonwealth Competition Council, plus the Virginia Information Providers Network (VIPNet), local Commissioners of the Revenue, private businesses, nonprofit or not-for-profit organizations, the Virginia Municipal League, the Virginia Association of Counties, and the Auditor of Public Accounts. The vastness of the potential databases dictated that the study be divided into two specific areas of emphasis:

- 1. Nonprofit or not-for-profit organizations
- 2. Authorities

The decision was made by the Commonwealth Competition Council to exclude cooperatives from this plan due to the magnitude of material.

The taskforce concluded that the information in a public forum, such as the Internet, would provide a valuable public service not only to individuals, nonprofit or not-for-profit organizations, and Authorities, but to businesses and governments (federal, state, and local) alike. The use of technology would greatly enhance the creation of two databases, one on nationwide exempt organizations and one of Virginia Authorities. Both groups recommended a phased-in approach, with a review of the use of the data, and modifications made in future phases depending on further analysis and use of the information.

The IRS has made available a nationwide listing of the exempt organizations. It is proposed to utilize this data and download it into a Virginia website that would be searchable through a variety of means. A survey is recommended to be undertaken to determine the number of Authorities that are serving the localities and state government. This will determine the actual number for placement on the Internet database.

It is recommended by the Commonwealth Competition Council that action be undertaken to establish these two databases, and to seek funding in the amount of \$23,500 the first year and \$15,000 the

second year to provide for the technical capabilities needed to accomplish this service. Funding sources could be provided:

- by direct appropriation
- through Treasury borrowings to be re-paid by data mining opportunities resulting from the dissemination and aggregation of data through VIPNet or
- by deferral of costs by VIPNet, if agreeable, with recovery to be obtained based on the commercial use of data.

It is further recommended that the Commonwealth Competition Council explore any and all revenue sources from the mining of the data in both the nonprofit database and the Authorities database.

I. NONPROFIT OR NOT-FOR-PROFIT ORGANIZATIONS

The Commonwealth Competition Council, in cooperation with various state agencies, commissioners of the revenue, and representatives of nonprofit organizations and the private sector, met throughout 2001 to discuss the issues in SJR 382 (see Appendix A) in developing a plan for an Internet database of nonprofit organizations in Virginia. The plan presented represents the findings of this multiagency taskforce.

The representatives on this taskforce decided that there were three areas of concentration that needed to be addressed:

- 1. Exploration of the policy issues associated with a public database
- 2. Review of the data elements
- 3. Discussion of the standards of nonprofit organizations and how the organizations are functioning under the law

The policy issues discussed and resolved centered around what information in the proposed database would be viewed and considered public information vs. that which is not open for the public. The provisions of the Freedom of Information Act (FOIA) were reviewed in the context of the information in the database. It was the consensus of the group that the FOIA issues were resolved because the public would have access to the entire database on the Internet. The decision was made to download the entire Internal Revenue Service database into a Virginia portal. The privacy issues would have been decided by the IRS before that agency published its data on the Internet. Another issue the policy group discussed was the question of resources and how the database could be financed. It was concluded that the information would be of sufficient interest to explore data mining, and this effort will be explored fully as the database is implemented.

The taskforce reviewed the several hundred data elements in the IRS database. It was the consensus of the group that it was more efficient and accurate to utilize the entire IRS database as opposed to downloading only the Virginia exempt organizations. This decision was based on the premise that if the organization did not have a Virginia address, the data would not be captured. There will be information available on all exempt organizations in the 50 states, the District of Columbia, and Puerto Rico. The IRS further advised that once determination letters are issued to organizations upon the granting of an exemption, they are not routinely re-issued. These letters are considered valid throughout the life of the organization, as long as the organization complies with the provisions of its exemption. The data from the IRS will be updated monthly. Should an organization's exemption be revoked, its name is removed from the publicly accessible venues and would not appear on the subsequent monthly updated information.

The taskforce discussed some options on what standards should be created to evaluate the actions of nonprofit organizations. One issue of primary concern was the competition by nonprofits with for-profit businesses, and their ability to compete and provide services without the burden of taxation. This extended into unrelated business income and its full reporting to the IRS. When discussing the sales tax exemption status of such organizations, the issue arose on the frequency of events when raising funds for charitable purposes. An organization holding an occasional event to raise funds probably should be exempted from sales tax. However, if the organization held an event every Friday evening, it would raise questions on the exemption and how much money actually went to the charity. The Competition Council felt this was an area where it should be studied next year.

With respect to the nonprofit or not-for-profit organizations, the SJR 382 taskforce has proposed a plan with multiple phases, to allow for a review and use of the material:

UNDER PHASE I

The timeline proposed would be beginning early 2002 and extending into 2003.

The taskforce has outlined ten (10) key elements for a successful Internet web site for exempt organizations:

10 POINT PLAN

1. Use entire IRS database (all 50 states) as basis for the Virginia Web page

It was the consensus that the IRS database for the entire United States would be downloaded, not specific data fields and not just the Virginia information. This was based on the recommendation of the Virginia Information Providers Network (VIPNet) as being more efficient and accurate in making available information to the agencies and general public. This also captures those organizations operating in Virginia that do not have a Virginia mailing address.

The IRS updates its information monthly, and this would be downloaded monthly into the Virginia website.

There are 1,262,883 exempt organizations throughout the country based on the taskforce's review of the IRS data during October 2001.

Virginia exempt organizations authorized by the IRS total 36,571.

The IRS also has made the decision of what information is confidential and not a part of the database; therefore, the taskforce made its recommendation based on all public data elements in the IRS databank.

The Federal Employer Identification Number (EIN) is critical as the common denominator in accessing possible links to the state agencies with databases on the Internet. This assures the viewer that he is looking at the same organization across state agencies and across all states. The EIN is already a requirement in the Virginia accounting and procurement systems, and it appears in the Virginia databases of Agriculture and Consumer Services, Taxation, and the Charitable Gaming Commission.

10 POINT PLAN

2. Institutionalize the Federal
Employer Identification
Number (EIN) as a requirement
for all nonprofit or not-forprofit databases as the common
link

The legal staff and agency management of the State Corporation Commission are reviewing their regulations to determine if specific legislation is needed for them to require this number for their databases. If so, this agency would need to propose new legislation.

3. Establish a Virginia portal

10 POINT PLAN

While the entire IRS database would be downloaded, for Virginia specifically there would be a portal, with connectivity to:

State agencies dealing with various aspects of nonprofit organizations, such as:

Charitable Gaming Commission

(organizations conducting bingo games)

Department of Agriculture and Consumer Services

(organizations soliciting donations in Virginia)

Attorney General's Office

(private foundation tax forms)

State Corporation Commission

(incorporation of stock or nonstock entities)

Commonwealth Competition Council

(unrelated business income and competition of nonprofit organizations/state agencies with private sector)

Other state agencies and institutions dealing with exempt organizations

Commissioners of the Revenue

(local government sites)

Guidestar.com (http://www.guidestar.org)

(source of information on public and private philanthropic organizations)

National Center for Charitable Statistics

(http://www.nccs.urban.org)

(National repository of data on the nonprofit sector)

The National Association of State Charity Officials

(http://www.NASCOnet.org)

(meeting place for nonprofit leaders in the United States and state charity officials)

4. Create Frequently Asked Questions (FAQs)

Specifically for Virginia, FAQs would be developed by each agency involved as well as by Commissioners of the Revenue. These would be based on previous inquiries and questions to the various offices.

Specifically for Virginia, outline suggestions for educating nonprofit organizations:

Review reporting and filing requirements (Taxation and IRS), unrelated business income, complying with rules, and understanding the requirements of the law, who monitors the rules, information on intent of law, frequency of permits, exemptions granted to nonprofits from various rules and fees.

10 POINT PLAN

5. Create Helpful Hints for conducting business in Virginia for the exempt organizations

The taskforce recommends that the "owner" of the database be the Commonwealth Competition Council.

As owner, the Council would be responsible for tasks such as:

- •the monthly downloads from the IRS
 •managing the data fields and links to be sure all are
 correct and working
- ·backing up data for trending or in case of computer failure
- ·developing report formats (in Excel, Access, etc.) (See Appendix B as an example of one report format presented to the Taskforce)
- ·developing disclaimer on portal (not sanctioning an organization or the accuracy of the data, relying on the IRS information only)
- ·developing privacy statement on the portal
- ·developing self-help (how to use the data) ·identifying search engines with key words to be identified
- ·developing search functions of database ·archiving prior data and establish trend reports (such as number of new organizations by region, number of organizations who lost their nonprofit status, etc.)

·receiving and analyzing webtrends to determine how the database is being used

Designate "Owner" of database

No name was suggested, but it was important that the Internet database not be buried under several layers of an agency. It was the consensus that the website needed to be independent of any agency with a distinct moniker, although it would be under the control of the owning agency, the Commonwealth Competition Council.

10 POINT PLAN

7. Name of portal (as a standalone, not under another agency)

10 POINT PLAN

8. Feedback to webmaster on site

The Commonwealth Competition Council would receive feedback and then forward it to the appropriate state entity.

The Commonwealth Competition Council would maintain statistics on feedback and provide reports on issues raised, complaints, questions, etc. The site will not contain a public "bulletin board" for open-ended discussions.

How to publicize the website within Virginia

Several strategies were explored and offered as recommendations on making available to the public the existence of the database:

- 1 Press release from Governor

II. AUTHORITIES

The Commonwealth Competition Council, in continuing its review of not-for-profit organizations initiated by SJR 219 (2000), concluded that Authorities should and need to be included in the Internet database plan pursuant to SJR 382 (2001). The objective of the scope of this plan is to identify, describe, catalogue, and report on the role, scope and functions of Authorities in Virginia. The initial investigation demonstrated that legislative and executive oversight of these entities should be enhanced for the purposes of identifying how they function within the context of the mission of the Commonwealth Competition Council with respect to its mandate that the Council shall:

"Review the practices of government agencies and nonprofit organizations that may constitute inappropriate competition with private enterprise." Section 2.2-2662 (10) of the *Code of Virginia*

During the SJR 219 study last year the Council identified 433 Authorities. This included, among others, Authorities for airports, economic development, industrial development, jail, park, parking, and transportation. As a result of our continuing efforts under SJR 382 this year, the Competition Council has identified over 500 Authorities (See Appendix C), and it appears the list is not yet complete.

A sample analysis of slightly over 100 Authorities shows a combined bond debt in excess of \$17 billion. In the apparent absence of transparency, oversight, and reporting requirements, these Authorities are virtually free of sunset and sunshine review. As our data demonstrates for a relatively small sample, there is a significant bonded indebtedness, the implications of which have yet to be fully appreciated.

In fact, as of 2000 there was legislation requiring Authorities to register with the Secretary of the Commonwealth. Beyond that minimum requirement, nothing was done with the data once it was reported. Accordingly, it is not known if all Authorities complied with the reporting requirements. Adding to the problem is the fact that legislation was enacted by the 2001 General Assembly that deleted this reporting requirement.

Further, the Competition Council has identified 98 "Special Districts" which, like Authorities, are created at the discretion of local governments. These special districts include, but are not limited to, mosquito control, regional juvenile detention, regional library, sanitary, sanitation, and soil and water conservation districts. The combined list of Authorities and Special Districts available to local government, identified as of October 2001, exceeds 600 (see Appendix C). The Competition Council has not collected data on these special districts.

The Council concluded that Authorities and Special Districts can represent a potential challenge to private sector competition. In some instances they might inhibit efficient leveraging of private sector assets, both as to the services provided and their ability to compete without the burden of taxation.

A database on Authorities and Special Districts available on the Internet could be used to inform legislative and executive decision makers of the impact of Authorities and Special Districts as quasi-governmental entities that perform governmental or proprietary functions. This information could then be used to assess the scope and nature of any competition with private sector entities. The SJR 382 taskforce has proposed a plan with multiple phases to allow for a review and use of the material:

UNDER PHASE I

The timeline proposed would be beginning early 2002 and extending into 2003.

The taskforce has outlined four (4) key elements for a successful Internet web site for Authorities and Special Districts:

The taskforce recommends that the Commonwealth Competition Council be considered the "owner" of the Authorities database, and as such would be responsible for functions described under nonprofit descriptions.

No name was suggested, but it was important that this database, just as the nonprofit database, not be buried under several layers of an organization. It was the consensus that the website needed to be independent of any agency, although it would be under the control of the owning agency, the Commonwealth Competition Council.

Even though Authorities are nonprofit organizations, it was determined that a separate database from the exempt organizations on the Internet would better serve the public interest.

4. Name of portal (as a standalone, not under another agency)

The remaining steps under Phase I, II, and III would mirror those under the nonprofit organization database. These include feedback to webmaster on site, public awareness and how to publicize database.

VIRGINIA SENATE JOINT RESOLUTION NO. 382

Requesting the Commonwealth Competition Council, in cooperation with certain agencies and organizations, to prepare a plan for the development of a system and review process to implement and maintain a statewide database of nonprofit and not-for-profit entities that could be accessed by all Virginians via the Internet.

Agreed to by the Senate, February 22, 2001 • Agreed to by the House of Delegates, February 21, 2001

WHEREAS, the Commonwealth Competition Council has completed its study of the ongoing or permanent commercial activities of not-for-profit organizations and the effects of such activities on state revenues, as requested by Senate Joint Resolution No. 219 passed at the 2000 Session of the General Assembly; and

WHEREAS, this study found that there are more than 19,000 individual nonprofit or not-for-profit organizations as well as 400 quasi-governmental authorities operating in Virginia; and

WHEREAS, this study found that the work of nonprofit and not-for-profit organizations in the Commonwealth continues to be highly desired and valued both by its governmental entities and the citizens of Virginia; and

WHEREAS, it is recognized that these organizations provide much needed and valued services in all areas of life and that countless numbers of Virginians are the benefactors of these services; and

WHEREAS, it is further recognized that it is in the best interest of the Commonwealth that certain of these organizations continue to be granted certain exemptions from taxation; and

WHEREAS, it is a finding of Senate Joint Resolution No. 219 that several state agencies are maintaining information on various aspects of these tax exempt organizations, each dealing with its own information and each not being able to share information with the other agencies of the Commonwealth; and

WHEREAS, it is a finding of Senate Joint Resolution No. 219 that the current independent databases, manual systems and processes of state government agencies working with nonprofit and not-for-profit organizations may neither be cost effective nor do the systems reflect the current trend in electronically accessible government, or e-government; and

WHEREAS, it is a finding of Senate Joint Resolution No. 219 that the citizens of the Commonwealth would be better served if there were a single e-government depository of information regarding these organizations that would serve any and all who receive and desire to obtain information on any and all nonprofit or not-for-profit organizations; and

WHEREAS, agencies such as the Department of Taxation, the Attorney General's Office, the Department of Agriculture and Consumer Services, the State Corporation Commission, the Charitable Gaming Commission, and the Commonwealth Competition Council, and others all maintain their own databases and data information that serve to meet only their individual agency's needs and is not reflective of the age of e-government in Virginia and that these systems may not be adequate or cost efficient; and

WHEREAS, it is a finding of Senate Joint Resolution No. 219 that certain ongoing or permanent commercial activities of not-for-profit organizations have made an impact on State revenues and at times potentially compete unfairly with for-profit businesses that must pay taxes; now, therefore, be it

RESOLVED by the Senate, the House of Delegates concurring, That the Commonwealth Competition Council be requested, in cooperation with representatives of nonprofit and not-for-profit organizations, the Department of Taxation, the Attorney General's Office, the Department of Agriculture and Consumer Services, the State Corporation Commission, the Charitable Gaming Commission, Commissioners of the Revenue, and the Virginia Information Providers Network, and others, to prepare a plan for the development of a system and review process to implement and maintain a statewide database of nonprofit and not-for-profit entities that could be accessed by all

Virginians via the Internet. All agencies of the Commonwealth shall provide assistance to the Commonwealth Competition Council for this study, upon request.

The Commonwealth Competition Council shall complete its work in time to submit its findings and recommendations by November 30, 2001, to the Governor and the 2002 Session of the General Assembly as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents.
