Preface

The session of the 2002 Virginia General Assembly resulted in amendments to previous statutes governing public charter schools. Section 22.1-212.9 of the *Code of Virginia* requires all local school boards to review and act on applications for public charter schools. (Legislation passed in 2000 allowed local school boards the option to review or not to review charter school applications.) Section 22.1-212.11 requires local school boards to report the number of public charter school applications that were approved and denied to the state Board of Education on an annual basis. Section 22.1-212.15 maintains the requirement that local school boards submit annual evaluations of any public charter schools to the Board of Education and that the board report annually its findings to the Governor and the General Assembly.

Executive Summary

Since the initial state legislation for charter schools was passed in 1998, eight charter schools in eight school divisions have been approved and opened for students. They continue to operate and provide programs designed to increase educational opportunities for at-risk students. Information collected from school division superintendents in August 2003 revealed that no new charter school applications were approved during 2002-2003. Four charter school applications were denied in four school divisions.

The eight charter schools continue to focus on increasing educational opportunities and providing alternative educational programs for students at risk of academic failure. Many of the students, particularly older students enrolled in high school programs, were in danger of dropping out of school. Poor attendance, past academic failure, and other risk factors create many challenges for the schools in raising the academic achievement level of the students. In spite of the challenges, some progress has been reported in improving academic achievement, average daily attendance, parental and community involvement, and decreasing the number of dropouts.

Chapter One

Background Information

The session of the 2002 Virginia General Assembly resulted in amendments to previous statutes governing public charter schools. Section 22.1-212.9 of the *Code of Virginia* requires all local school boards to review and act on applications for public charter schools. (Legislation passed in 2000 allowed local school boards the option to review or not to review charter school applications.) Section 22.1-212.11 requires local school boards to report the number of public charter school applications that were approved and denied to the state Board of Education on an annual basis. Section 22.1-212.15 maintains the requirement that local school boards submit annual evaluations of any public charter schools to the Board of Education and that the board report annually its findings to the Governor and the General Assembly.

The Department of Education collected information on the number of charter school applications approved and denied by local school boards through a Superintendent's Memorandum dated August 8, 2003. Additional information was collected through an annual evaluation report submitted for 2002-2003 by each of the eight public charter schools operating in the state.

Current Status of Charter Schools

Since the initial state legislation for charter schools was passed in 1998, eight charter schools in eight school divisions have been approved. They continue to operate. For the 2002-2003 school year, 685 students were enrolled in charter schools in grades 3 through 12. One school requested and was granted a waiver from state regulations to operate year-round. No other waivers were sought.

Information collected from school division superintendents in August 2003 revealed that no new charter school applications were approved during 2002-2003. Four charter school applications were denied in four school divisions: Alexandria, Norfolk, Prince William, and Richmond City.

Chapter Two

Staff

The number of administrators, teachers, paraprofessionals, and guidance counselors in the eight charter schools is shown in full-time equivalents (FTEs) on the following chart. In addition to these persons, several of the larger schools employ other personnel such as security officers, nurses, tutors, monitors, parent involvement facilitators, and adjunct teachers.

Albemarle County – *Murray High School*

Grades Served: 9-12 Enrollment: 94

Murray High School was established as a nontraditional high school in 1988-1989 and was approved to convert to a charter school in February 2001.

<u>Chesterfield County</u> – *Chesterfield Community High School* Grades Served: 9-12 Enrollment: 250

Chesterfield Community High School was approved to convert to a charter school in October 2001. It opened as a charter school in September 2002. The Standards of Learning data were available for 2002-2003 only.

<u>Franklin County</u> – New Opportunity for Winning

Grades Served: 7 Enrollment: 25

The New Opportunity for Winning charter school was developed as a new school and opened in August 2001. There is no SOL testing in the seventh grade. Other assessment measures included unit tests, locally prepared end-of-grade tests, and grades for the seventh grade curriculum. The school reported that 75 percent of the students passed the seventh grade in 2001-2002, and 84 percent passed in 2002-2003.

Gloucester County – Victory Academy

Grades Served: 8-9 Enrollment: 44

Victory Academy was approved to convert to a charter school in January 2000. It was the first charter school approved in Virginia.
