Executive Summary

The Individual Student Alternative Education Plan (ISAEP) program prepares secondary students to take the Tests of General Educational Development (GED) while developing career and technical education skills. Section 22.1-254 of the Code of Virginia authorizes local school boards to fulfill compulsory attendance requirements for individuals who are at least 16 years of age and enrolled in an ISAEP program that includes career guidance counseling, GED preparation, counseling on the economic impact of not completing high school, and procedures for reenrollment.

During 2002-03 school year:

- The Department of Education distributed \$2,173,058.78 in grants to support ISAEP programs in school divisions. The grants ranged from \$8,114 to \$105,481.
- Board of Education guidelines for ISAEP programs were revised to reflect score requirement changes resulting from the release of the 2002 series of the GED Tests. Technical assistance activities focused on increasing the use of technology to support assessment and instructional activities that prepare students for the 21st century workforce.
- School divisions reported that 4,163 students between the ages of 16 and 18 years of age qualified for an ISAEP and received ISAEP services. The percentage of 17 and 18 year old students with an ISAEP increased slightly, and some ISAEP programs reported serving students older than 18 years of age.
- Fifty of the 131 participating school divisions reported issuing GED Certificates as an ISAEP exit credential. Those 50 school divisions reported that 938 GED Certificates were issued to students with an ISAEP.

The 2003 annual report of the ISAEP program was prepared by staff at the Virginia Department of Education and approved by the Virginia Board of Education on November 19, 2003. Authority for the Report

Section 22.1-254 of the Code of Virginia authorizes local school boards to allow the fulfillment of compulsory attendance requirements by any student who is 16 years of age and for whom an Individual Student Alternative Education Plan (ISAEP) is developed. The Virginia Board of Education is charged with development of the guidelines associated with the ISAEP program. The plan must conform to guidelines prescribed by the Board of Education to include:

- (1) Career guidance counseling;
- (2) Mandatory enrollment and attendance in a General Educational Development (GED) preparatory program or other alternative education program approved by the local school board;
- (3) Counseling on the economic impact of failing to complete high school; and
- (4) Procedures for re-enrollment in school.

Item 145.H.2 of the appropriation act, Chapter 899, 2002 Acts of Assembly, requires the Department of Education to monitor the implementation of this program, now called the Individual Student Alternative Education Plan (ISAEP) program, and to provide annual reports to the General Assembly.

Historical Review of the ISAEP Program

The legislation that created the ISAEP program became law on July 1, 1999. In the months that followed, the Department of Education developed guidelines for the program, established a process for funding local programs, and assisted school divisions in developing program components. The first program year was viewed as successful by school divisions, even though it was only a few months in duration. Year two involved technical assistance visits and regional training primarily to address the planned changeover to a new series of the Tests of General Educational Development (GED) that occurred in January 2002. The third year of the ISAEP program was characterized by continued technical assistance site visits and training, with increased emphasis on the career and technical education component. Career and technical education benchmarks were established, and three options for career preparation were added to the 2002-03 ISAEP application.

State Administrative Activities during the Fourth Year of the Program

During the fourth year of the program, the Board of Education guidelines for ISAEP programs were revised to reflect score requirement changes resulting from the release of the 2002 series of the Tests of General Educational Development (GED). The new career and technical education benchmarks were also included in the revised guidelines. State staff continued monitoring and conducting technical assistance site visits to selected programs. Technical assistance activities focused on increasing the use of technology to support assessment and instructional activities that prepare students for the 21st century workforce. *GED as Project*¹, a new curriculum

¹ *GED as Project* is a Virginia Department of Education funded project developed by James Madison University. It is a curriculum framework that focuses on curriculum and instruction methods that are designed to prepare students to pass the GED Tests and to assist them in developing critical thinking skills essential to success in post-secondary education and training programs and the 21st century workforce.

framework, was introduced to ISAEP teachers and coordinators and training was provided throughout the year.

The following events reflect activities during the fourth year of the ISAEP program (July 1, 2002 - June 30, 2003):

- Eight technical assistance site visits were completed (September 2002 June 2003).
- Eighteen site-monitoring visits were completed (September 2002 June 2003).
- ISAEP student recognition ceremonies and GED graduations were attended (July 2002 June 2003).
- Program information and technical assistance were provided for approximately 250 ISAEP coordinators and teachers at two statewide institutes in Roanoke and Fredericksburg (May, 2003).

Five school divisions chose not to apply for state ISAEP program funds for the 2002-2003 school year. They identified one of the following reasons: (1) they had a locally developed alternative education program functioning; (2) the ISAEP program did not meet their needs; or (3) they wanted to explore the ISAEP program at a later date. Based on conversations with non-participating school divisions, it is expected that this number will decrease to two in the 2003-04 school year.

During the 2002-2003 school year, the Department of Education distributed \$2,173,058.78 in grants to school divisions, ranging from \$8,114 to \$105,481. Local programs used grant monies to purchase materials and technology for instruction and to secure personnel. The statewide average per pupil allocation was \$507.01.

Local Program Data, 2002-03²

In June 2003, the Department of Education distributed to participating school divisions a request for data from the GED Testing Service of the American Council on Education related to the ISAEP program.³ These data were aggregated with other information collected throughout the 2002-03 school year. The data highlight student participation rates, the number of students earning the GED credential, student demographics, program profiles, and per-pupil costs. Responses to the request for information on the 2002-2003 programs were received from 111 programs of the 131 participating school divisions. School division level data are provided in the appendix.

Programs were asked to provide quantitative data pertaining to age, gender, and ethnicity. They were also asked to describe their respective program in qualitative terms, including information about student/teacher ratios, program selection criteria, counseling activities, instructional methodologies, and curriculum.

School divisions reported 4,163 students between the ages of 16 and 18 years qualified for an ISAEP and received services. This represents a slight decrease from the 2001-2002 school year.


³ GED Testing Service requires a completed *GED Option Report* as a condition of approval to allow the GED Tests to be administered to students between the ages of 16 and 18 years. Only nine states in the nation have approved GED Option programs. Virginia was the first state to receive this approval.

Figure 1 provides a breakdown of ISAEP participants by age.⁴ The percentage of 16 year old students participating in the ISAEP program decreased by five percent from last year. In 2002-03, the percentage of 17 and 18 year old students with an ISAEP increased slightly, and some ISAEP programs reported serving students older than 18 years of age.

Figure 1 - Participation by Age

Figure 2 provides a breakdown of participation rates based on ethnicity. The rate of participation by selected ethnic groups in 2002-03 remains largely unchanged from 2001-02. However, it is worth noting that there is a significantly higher rate of participation in ISAEP programs among Caucasian students compared to other ethnic groups in the general student population.






⁴ For entry into the ISAEP program, a student must score at the 7.5 grade equivalent level (or higher) in reading on a standardized test and achieve a minimum score of 410 on each of the subtests of the official GED practice tests. Students who are ineligible for the ISAEP program based on academic weaknesses should be referred for remedial services to another alternative education program or the regular school program.

Only 50 of the 131 participating school divisions reported issuing GED Certificates as an ISAEP exit credential. Those 50 school divisions reported that 938 GED Certificates⁵ were issued to students with an ISAEP. Seventy-five school divisions reported that they issued 803 GED Certificates as part of an alternative education program. Figure 3 provides information on the trend of students earning GED Certificates in one of the two approved *GED Option* programs ⁶.

Major Focus for 2003-2004

In the coming school year, the major focus of the Department of Education's technical assistance will be:

- To help programs improve academic and career preparation of ISAEP students
- To help programs provide students with adequate technology skills related to the workplace
- To provide programs with assistance in developing high quality counseling services for ISAEP students, which includes
 - Ensuring fair and equitable access to the ISAEP program for all students
 - Ensuring students have appropriate transition plans
- To help programs improve reporting for formative and summative evaluation purposes

⁵ These numbers of GED Certificates issued to ISAEP students and to students in other approved alternative education programs appear to be considerably underreported. This contention is based on the fact that nearly 6,000 individuals between the ages of 16 and 18 years took the GED Tests in calendar year 2002 (this number will be exceeded at the end of calendar year 2003), with just over 70% passing. Although not all individuals in this age group are part of an approved GED Option program, it is believed that most are. A problem that may be causing underreporting is the lack of communication between the GED Option program staff and the GED Testing Center staff. GED Option program staff may need to ensure that students and parents are authorizing the release of their GED test results to the GED Option program. If such authorization is not given, GED examiners may not release that information.
