## ABSOLUTE PARDON

### ANDERSON, Marvin Lamont

On October 23, 2001, pursuant to a newly enacted statute, the Circuit Court of the County of Hanover ordered the Virginia Division of Forensic Science to perform appropriate DNA testing upon the biological evidence from the rape kit retained in its files for Mr. Anderson.

Pursuant to that Order, the Division of Forensic Science completed STR DNA testing. The December 6, 2001 Certificate of Analysis issued by the Division of Forensic Science states that Mr. Anderson was excluded as a possible contributor of genetic material found in samples collected from the victim shortly after the crime was committed. The Certificate of Analysis further stated that the DNA profile detected in the genetic material was searched against the Virginia DNA Data Bank and two individuals were identified who could not be eliminated as possible contributors of the genetic material.

Through his counsel, Mr. Anderson petitioned on April 3, 2002 for a grant of Executive Clemency. The principal ground of the petition was that the DNA testing completed by the Division of Forensic Science demonstrated that Mr. Anderson could not have committed the crimes for which he was convicted on December 14, 1982 in the Circuit Court of Hanover County.

On April 23, 2002, The Honorable Kirby H. Porter, Commonwealth's Attorney for the County of Hanover, whose office prosecuted the case submitted a letter joining the petition for clemency for Mr. Anderson. Mr. Porter further stated that based upon DNA analysis, eyewitness testimony, and statements made under oath, John Otis Lincoln has been indicted for the crimes.

After consideration of the evidence in the case, including but not limited to, the DNA analysis conducted by the Division of Forensic Science of the Commonwealth of Virginia, the petition for clemency submitted by Mr. Anderson, and the letter endorsing that petition submitted by the Commonwealth's Attorney of Hanover County, an absolute pardon was granted on August 20, 2002.
