Study Mandate

This status report is submitted pursuant to the Item 362 B of the 2004 Appropriations Act. Item 362 B requires that child care appropriations be administered on a sliding fee scale to income eligible families. Item 362 B further requires that:

"The Department of Social Services shall report on the sliding fee scale and eligibility criteria adopted by the Board of Social Services by December 15, of each year."

Background

The General Assembly requires the State Board of Social Services to establish rules and regulations for the sliding fee scale and eligibility criteria for child care services. These sliding fee scale regulations and eligibility criteria are required to adjust for variations in the local cost of living index by metropolitan statistical areas.

The State Board of Social Services first established rules and regulations governing the sliding fee scale for Fee System Child Care in October 1997. Since 1998, local departments of social services have been assigned to one of three assistance groups based on Standard

Metropolitan Statistical Areas, in order to reflect statewide cost of living indicators. These three groups, with adjustments for family size, guide the maximum gross income limits for Fee System Child Care services.

The maximum family income limits for Fee System Child Care are based on three different percentages of the federal poverty level index: 150 percent of poverty, 160 percent of poverty, and 185 percent of poverty. Use of these three particular percentages of the federal poverty levels to establish income eligibility limits has been in effect since November 1998.

Year 2004 Update

Attached is a listing of the localities in each of the three groupings. The federal poverty levels are adjusted annually; therefore, comparable annual adjustments are made to the sliding fee scale for income eligibility thresholds. The only change in the rules and regulations for the sliding fee scale in 2004 has been to reflect the changes in the federal poverty level threshold amounts for family size, which are outlined in the chart below.
