#### MEDICAL PARDON

### **CARTERET**, Tommie Jean

On October 12, 2002, Tommie Jean Carteret, submitted through her mother, Ms. Beatrice G. DeLeon, a request for Executive Clemency based upon the fact that she had been diagnosed with cirrhosis of the liver. Her request was then submitted to the Medical Clemency Assessment Committee, which is directed to review all requests for clemency that are based on allegations of fatal illnesses.

On April 30, 2003, the Governor's Office was notified of the Committee's determination that Tommie Jean Carteret's condition had deteriorated to the point that she would not survive beyond a three month period.

On December 31, 2002, the Circuit Court of the City of Norfolk ordered the Virginia Division of Forensic Science to perform appropriate DNA testing upon biological evidence retained in its case files for Mr. Ruffin. Pursuant to that Order, the Division of Forensic Science completed DNA testing. The February 11, 2003, Certificate of Analysis issued by the Division of Forensic Science stated that Mr. Ruffin was excluded as a possible contributor of genetic material found in samples collected from the crime scene after the crime was committed. The Certificate of Analysis further stated that the DNA profile detected in some of the genetic material was searched against the Virginia DNA Data Bank and an individual was identified who could not be eliminated as a possible contributor of the genetic material.

On February 12, 2003, Mr. Ruffin was released to parole.

On February 19, 2003, the Honorable John R. Doyle, III, Commonwealth's Attorney for the City of Norfolk, whose office prosecuted the case against Mr. Ruffin for the offenses for which Mr. Ruffin now seeks clemency, requested clemency for Mr. Ruffin.

Through his counsel, Mr. Ruffin petitioned on February 19, 2003 for a grant of Executive Clemency.

A review of the case in detail established that there was no fault with the verdict of the jury based upon the evidence available to it at the time of trial, the actions of the attorneys for the Commonwealth or the Court at trial. It was determined that Mr. Ruffin is innocent of the charges for which he was convicted. It was also determined that had the jury been accorded the benefit of the DNA analysis it would not have found Mr. Ruffin guilty of the offenses for which he sought clemency.
