SUBJECT: Disaster Relief Report

Attached is the report required by the *Code of Virginia*, § 44-146.28 - "Annual report on the Disaster Relief Funds expended for any local jurisdictions that received financial assistance and the amount each jurisdiction received."

The disaster recovery costs documented below represent payments to local governments, state agencies, and other eligible applicants. The total amount of \$6,554,574.75 represents payment from the Commonwealth's sum-sufficient for eligible costs of disaster recovery.

These costs include mitigation grants through the hazard mitigation grant program and the State and Federal Public Assistance Programs.
