The Mental Health, Mental Retardation and Substance Abuse Laws of Virginia, Annotated, 2005 Edition under section 37.2-402 states "The regulations shall require the human research committee to submit to the Governor, the General Assembly and the Commissioner or his designee at least annually a report on the human research projects reviewed and approved by the committee and shall require the committee to report any significant deviations from the proposals as approved."

Since the elimination of the Research and Education Office in the Department of Mental Health, Mental Retardation and Substance Abuse Services several years ago, DMHMRSAS central office has not had a human research committee. Each facility has its own research committee. Research projects that involve human subjects are submitted and reviewed for approval by Independent Review Boards (IRB) selected by each facility. When a research project is approved, a copy of the proposal is forwarded to the DMHMRSAS Office of Health and Quality Care for further review. However, this office does not conduct a formal review and approval, which is done by the facility's research committee, and, if necessary, the IRB chosen by the facility.
