RE:	Annual Report on Commonwealth Agency and Department Reporting of Small, Women- and Minority Business Procurement		

The Virginia Department of Minority Business Enterprise ("DMBE") is established and granted statutory powers pursuant to § 2.2-1400 through 1405 of the *Code of Virginia* ("Va. Code"). Virginia Code § 2.2-1402 grants certain powers and duties to the DMBE, which specifically includes, *inter alia*, the duty to "[i]mplement any remediation or enhancement measure for small, women-, or minority-owned business as may be authorized by the Governor pursuant to subsection C of § 2.2-4310 and develop regulations, consistent with prevailing law, for program implementation."

As part of this duty, the DMBE Director is required to report to the Governor and the General Assembly, on the participation of small, women- and minority-owned (or "SWaM") businesses in state procurement as well as identify state departments and agencies failing to submit annual progress reports on SWaM procurement as required by Virginia Code § 2.2-4310. More specifically, the Virginia Code, § 2.2-1405, in pertinent part states:

The Director shall report on or before November 1 of each year, to the Governor and the General Assembly the identity of the state departments and agencies failing to submit annual progress reports on small, women- and minority-owned business procurement required by § 2.2-4310, and the nature and extend of such lack of compliance. The annual report shall include recommendations on the ways to improve compliance with the provisions of § 2.2-4310 and such other related matters as the Director deems appropriate.

Virginia Code § 2.2-4310(B), of the Virginia Public Procurement Act's anti-discrimination policy in procurement, requires that:

All public bodies shall establish programs consistent with this chapter to facilitate the participation of small business and businesses owned by women and minorities in procurement transactions. The programs established shall be in writing and shall comply with the provisions of any enhancement or remedial measures authorized by the Governor pursuant to subsection C or, where applicable, by the chief executive of a local governing body pursuant to § 15.2-965.1, and shall include specific plans to achieve any goals established therein. State agencies shall submit annual progress reports on small, women- and minority-owned business procurement to the Department of Minority Business Enterprise in a form specified by the Department of Minority Business Enterprise.

As such, the Annual Report of the Virginia Department of Minority Business Enterprise ("DMBE") of the state agencies and departments failing to submit annual progress reports on small, women- and minority-owned business procurement, as required by § 2.2-1405, Code of Virginia, is attached. The reporting requirement applies to any authority, board, department, instrumentality, institution, agency or other unit of state government, as defined in § 2.2-1401, and does not include any county, city, or town in the Commonwealth.

Annual Report of the Virginia Department of Minority Business Enterprise

DMBE is pleased to report the reporting compliance rate of 99.8%. This achievement is attributable in part to the efforts of the General Assembly and our Governor to promote and improve access to Virginia's business opportunities for small, women- and minority-owned businesses in state procurement. With the exceptions of two entities, the Chesapeake Bay Local Assistance Department and the Virginia Resources Authority, all state agencies and departments were in compliance by submitting their annual progress reports on small, women- and minority-owned business procurement for Fiscal Year 2005-2006. See Table 1. It is important to note, however, although the Virginia Resources Authority did not prepare and/or submit its fiscal year 2006 Annual SWaM Plan or progress report, with the leadership of its new Director, Dr. Sheryl Bailey, the fiscal year 2007 Annual SWaM Plan was submitted.

DMBE also notes that procurement data from state agencies, departments, educational institutions, and authorities are also available to DMBE (and are being utilized for reporting purposes) through CARS and self-reporting methods. This information serves as back-up data and is also obtained through quarterly and annual reports submitted to DMBE.
