Dear Messrs. Chairmen:

I am writing to provide documentation of the transactions of the Governor's Opportunity Fund which have occurred during the third quarter of the 2006 fiscal year as required by **Chapter 951, Item 128.H.** 

As of March 31, 2006, a total of \$151,571,010 had been appropriated to the Fund. This amount excludes legislative mandates and monies which were unallotted after the original allocation. As of March 31, 2006, the cash balance was \$27,536,212, and the balance available for future commitments totaled \$12,813,712. Grants awarded since the inception of the fund total 347.

For the third quarter of the 2006 fiscal year, ended March 31, 2006, a total of \$5,315,000 was committed from the Opportunity Fund to assist 11 projects relocating to or expanding in the state. Total job creation of these projects was 1,769, while investment totaled \$491.7 million. Summaries on these projects follow:

- 1. Wythe County: Amcor PET Packaging, a manufacturer of plastic bottles for the beverage industry, will locate a new facility in Wythe County. Amcor will create 144 new jobs and invest \$105 million (amount of grant: \$400,000; use of grant: site improvements). This project has been announced.
- 2. <u>Town of Saltville</u>: **Reline America, Inc.**, a manufacturer of liner for underground pipes, will locate a new facility in the Town of Saltville. With an investment totaling \$4.9 million, this location will create 25 new jobs (amount of grant: \$50,000; use of grant: site and building improvements). This project has been announced.
- 3. Orange County: **Diversified Information Technologies**, a provider of technology-based information management services to Fortune 100 and 500 companies nationwide, will locate a new facility in Orange County. Investment will total \$10.2 million, with 200 new jobs being created (amount of grant: \$250,000; use of grant: site improvements). This project has been announced.
- 4. <u>City of Radford</u>: **Intermet Corporation** will locate a new facility in the City of Radford. Intermet is a manufacturer of cast-metal automotive components and will create 175 jobs. Investment will total \$14.3 million (amount of grant: \$250,000; use of grant: building improvements). This project has been announced.
- 5. <u>City of Richmond</u>: **Philip Morris USA**, a manufacturer of cigarettes, will expand its existing facility in the City of Richmond by establishing a Research and Development division in the Virginia Biotechnology Research Park. Philip Morris will create 500 new jobs and invest \$266 million (amount of grant: \$3,000,000; use of grant: site development and infrastructure improvements). This project has been announced.
- 6. Mecklenburg County: American Industrial Heat Transfer, Inc. will locate a new facility in Mecklenburg County. American Industrial Heat Transfer is a manufacturer of heat exchanger equipment and products. Total investment is \$11 million, with 85 jobs being created (amount of grant: \$250,000; use of grant: site improvements and building construction). This project has been announced.
- 7. <u>Russell County</u>: Northrop Grumman Information Technology, Inc., a provider of information technology solutions and engineering and business services, will locate a new facility in Russell County. This location will create 219 new jobs, and investment will total \$16.7 million (amount of grant: \$500,000; use of grant: site and building development). This project has been announced.
- 8. <u>Shenandoah County</u>: **Merillat Industries, LLC** will expand its facility in Shenandoah County. Merillat is a manufacturer of kitchen cabinets. This company will create 150 new jobs, and investment will total \$16 million (amount of grant: \$150,000; use of grant: extension of natural gas to the site and building construction). This project has been

announced.

- 9. Rockbridge County: Lees Commercial Carpet, a manufacturer of carpet, will expand its existing facility in Rockbridge County. Lees will create 25 new jobs, and investment will total \$26.4 million (amount of grant: \$40,000; use of grant: workforce training not covered by other sources). This project has been announced.
- 10. <u>City of Danville</u>: **Unarco Industries, Inc.**, a manager of shopping carts, will locate a new facility in the City of Danville. Unarco will create 194 jobs and invest \$5.5 million (amount of grant: \$300,000; use of grant: site improvements). This project has been announced.
- 11. <u>Botetourt County</u>: **Dynax America Corporation**, a manufacturer of pressure plates for automatic transmissions, will expand its Botetourt County facility. Dynax will create 52 new jobs and invest \$11.7 million (amount of grant: \$125,000; use of grant: site development and building construction). This project has been announced.

For the projects which have been announced, I am enclosing a profile, an analysis and recommendation by the Virginia Economic Development Partnership, and a scoring sheet.

For the third quarter of the 2006 fiscal year, actual disbursements from the Fund were made to the Town of Pulaski for James Hardie Building Products; Prince George County for Service Center Metals; James City County for Wal-Mart; the City of Manassas for Micron; the City of Radford for Intermet; Russell County for CGI-AMS; the City of Galax for Turman Hardwood Flooring; the City of Richmond for Philip Morris; and Roanoke County for Integrity Windows. Actual disbursements totaled \$6,800,000.
