# **EXECUTIVE SUMMARY**

The purpose of this report is to analyze exercise results, identify strengths to be maintained and built upon, identify potential areas for further improvement, and support the development of corrective actions. The Commonwealth of Virginia, Virginia's Emergency Response Team (VERT) hurricane functional exercise (FE) (VERTEX 2007) was developed to test the VERT's preparations, response, and recovery operations. This exercise was evaluated using the U.S. Department of Homeland Security's (DHS's) Homeland Security Exercise and Evaluation Program (HSEEP) guidelines, specifically and in alphabetical order by the capabilities of Citizen Evacuation and Shelter-In-Place, Communications, Critical Resource Logistics and Distribution, Economic and Community Recovery, Emergency Operations Center Management, Emergency Public Information and Warning, Fatality Management, Firefighting Operations and Support, Food and Agriculture Safety and Defense, Information Gathering and Recognition of Indicators and Warnings, Mass Care (Sheltering, Feeding, and Related Services), Medical Surge, Structural Damage and Mitigation Assessment, Urban Search and Rescue, and Volunteer and Donations Management. Law Enforcement capabilities are covered under Citizen Evacuation and Shelter-In-Place, Emergency Operations Center Management, and Fatality Management, while Intelligence/Information Sharing and Dissemination is covered under Information Gathering and Recognition of Indicators and Warnings.

Among the capabilities not included in this report are Environmental Health, Onsite Incident Management, and Restoration of Lifelines.

The exercise planning team comprised numerous and diverse agencies, including but not limited to the Virginia Department of Emergency Management (VDEM); Virginia Department of Health (VDH); Virginia State Police; Virginia Department of Military Affairs; Department of Transportation; Department of Social Services; Department of Agriculture and Consumer Services; Virginia Information Technologies Agency; Department of Environmental Quality; jurisdictional representatives from the emergency management regions; DHS, DoD, and other Federal entities; and Old Dominion University's Virginia Modeling, Analysis and Simulation Center.

The Virginia Fusion Center's focus was primarily the Noble Resolve Exercise with NORTHCOM and providing pertinent information to and through the Virginia Emergency Operations Center (VEOC) during VERTEX 2007. The simultaneous National Capital Region exercise, Regional Response '07, was coordinated to be a stand-alone exercise, held within the framework of VERTEX 2007 using the same scenario. The VDEM Region 3 Tabletop Exercise was also conducted during VERTEX 2007 as a follow-on to that region's 2006 tabletop exercise concerning inland host sheltering in central Virginia.

# **Section 1: Exercise Design Summary**

VERTEX 2007 was a 3<sup>1</sup>/<sub>2</sub>- day event conducted April 23–26, 2007, in Richmond, VA. Through the exercise, various Commonwealth and local agencies and jurisdictions realized their roles, responsibilities, and emergency response capabilities when responding to the aftermath of a major hurricane. The hurricane made initial landfall in North Carolina, quickly impacting the Hampton Roads area of Virginia, and took a northwestern to northeasterly direction, moving through central Virginia, the National Capital Region (NCR), northern portions of Maryland, and Pennsylvania.

A tabletop exercise was conducted for the local jurisdictions in Emergency Management Region 3 in conjunction with the VERTEX 2007. It involved local decision makers in a discussion of hurricane evacuation and response issues, policies, and procedures, with a focus on inland host sheltering.

The Noble Resolve exercise, a U.S. Northern Command (NORTHCOM) exercise supported by U.S. Joint Forces Command (USJFCOM), was conducted April 9–13, 2007, preceding the VERTEX 2007 Functional Exercise (FE) with objective elements and overlapping scenario.

The Regional Response '07 exercise was conducted by the NCR, and was involved in ancillary exercise play concurrent with the VERTEX 2007 FE on April 26, 2007.

It must be noted that the VERTEX 2007 exercise involved many challenges. However, by incorporating all of the events within the context of the larger exercise, the Virginia Emergency Response Team (VERT) demonstrated an ability to respond to multiple issues simultaneously.

#### **Exercise Purpose and Design**

The purpose was to demonstrate the preparedness system and the effectiveness and efficiency of the Commonwealth of Virginia's Emergency Operating Plan (VEOP) and the Virginia Emergency Operations Center's (VEOC's) Standard Operating Procedures (SOPs). More specifically, the exercise focused on the critical entities responsible for directing, communicating, and coordinating Virginia's response and recovery efforts with regard to emergencies.

## **Exercise Objectives, Capabilities, and Activities**

Capabilities-based planning allows for exercise planning teams to develop exercise objectives and observe exercise outcomes through a framework of specific action items that were derived from the Target Capabilities List (TCL). VERTEX 2007 was well underway in the design phase when the final U.S. Department of Homeland Security TCL was published in February 2007. It was determined that evaluation should be conducted using the most current Exercise Evaluation Guides (EEGs).

However, due to the timing of the release of the TCL and VERTEX 2007 planning process, the selection of capabilities and activities and matching them with specific objectives did not occur.

Consequently, the controllers and evaluators were asked to determine which TCLs were appropriate based on the scenario and the Emergency Support Functions (ESFs) they were evaluating. The capabilities listed below form the foundation for the organization of all objectives and observations in this exercise. (The activities are captured in Chapter 3: Analysis of Capabilities.)

- **Objective 1:** Demonstrate the effectiveness of the VERT in conducting response and recovery operations and sharing critical information with participating jurisdictional emergency operations centers (EOCs) and maintaining situational awareness.
