SIMPLE PARDON

ARRINGTON, Danita Marie

Crime: Shoplifting
Court: City of Hampton General District Court
Sentence Date: August 7, 1996
Sentence: 40 days, suspended; 40 hours community service
and \$209 court costs.
Pardon Granted: October 27, 2006

Ms. Arrington was convicted of shoplifting as a teenager and has had no other charges or convictions.

Ms. Arrington is a single mother and an active member of her church. She has served as a Notary Public and manages a group home.

BAPTISTE, Tamara Nicole

Ms. Baptiste was convicted of possessing obscene material. This “obscene material” was a decal displayed on her vehicle depicting a mischievous-looking little boy wearing a Boston Red Sox cap urinating on the New York Yankees logo.

This particular type of conviction on her record conveys a much more serious impression than the situation warrants and is having a seriously detrimental impact on her employment opportunities.

Mrs. Betts has had no other charges or convictions. She and her husband have raised all five children to adulthood. She has earned a Bachelors of Science degree and is employed with the local office to the Department of Health and she aspires to work with special education students.

Mr. Blackwell is now retired from the military and he and his wife are purchasing their home. HE is active in several community activities and employed with the District of Columbia Department of Corrections where he is a member of the Honor Guard.

Mr. Blackwell' employment will be terminated without a pardon.

Mrs. Jones had settled into a job that she believed would serve as her lifetime career, but that job ended when her employer closed the facility. She took advantage of opportunities for education and training offered through the provision of NAFTA, but she now finds that this single conviction two decades ago has precluded her from being considered for several career opportunities.

Mr. Avelar's convictions were for breaking into a parked car and stealing stereo equipment when he was twenty years old. He has had no other arrests or convictions.

Mr. Avelar has been a sheet rock installer since 1994, and now owns his own contracting business. He is married and he and his wife are raising their four children in the home they own in North Carolina. He is active and well respected in his community and his distinctions include the National Leadership Award that was bestowed in 2005 by the National Republican Committee.

Even though Mr. Avelar is a lawful permanent resident of the United States, his convictions have caused the U. S. Department of Homeland Security to institute removal proceedings to deport him to Mexico, which will destroy his family. This pardon will preclude his deportation.

Jackie Everette Rife was convicted of failure to stop at the scene of an accident, failure to stop for a police officer, driving on a suspended license and three counts of forgery involving checks totaling \$150.00 in the Tazewell County Circuit Court on December 15, 1995. He was sentenced to five (5) years for failure to stop at the scene of an accident, one (1) year for failure to stop for a police officer, one (1) year for driving on a suspended license and five (5) years each for the forgeries, for a total of twenty-two (22) years, and the imposition of the sentence was suspended.

On May 24, 1996, Mr. Rife was found by the Court to be in violation of his terms of probation, specifically for failure to report that he had voluntarily resigned from an employment position. The Court revoked probation and imposed the twenty-two (22) year sentence. Mr. Rife has been incarcerated since May 24, 1996, and his anticipated release date is January 6, 2015.

NOW THEREFORE, I, Timothy M. Kaine, acting in accordance with the powers and authority granted to me as Governor of Virginia under Article V, Section 12 of the Constitution of Virginia, do hereby grant Jackie Everette Rife a conditional pardon. This pardon is conditioned upon Mr. Rife's acceptance of the following terms and conditions:

- I. Mr. Rife shall be under the custody and control of the Virginia Parole Board, subject to the following conditions:
 1. He shall obey all Federal, State, and local laws and ordinances.
 2. He shall report any arrest, including traffic tickets, within three (3) business days to the Parole Officer.
 3. He shall report in person or by telephone to the assigned Probation and Parole office within three (3) business days of his release from incarceration, and as otherwise instructed thereafter.
 4. He shall permit the Parole Officer to visit his home and place of employment.
 5. He shall follow the Parole Officer's instructions and will be truthful, cooperative, and report as instructed.

CONDITIONAL PARDON

6. He shall not unlawfully use, possess or distribute controlled substances or related paraphernalia.
7. He shall not use, own, possess, transport or carry a firearm.
8. He shall report any change in residence within three (3) business days to the Parole Officer.
9. He shall not leave the Commonwealth of Virginia or travel outside of an area designated by the Parole Officer without permission of the Parole Officer.

II. The Parole Board may revoke Mr. Rife's pardon, based on a violation of one or more of the conditions in Section I, or based on a finding by the Board that he is otherwise unfit or unsuitable to remain on supervision. Mr. Rife shall be subject to arrest upon cause shown by the Parole Board or the Parole Officer. The maximum date of release from supervision is January 6, 2011. However, Mr. Rife may be considered for unsupervised probation after three (3) years from the date of release, but must continue on good behavior until January 6, 2015

REPRIEVE

1. Percy Levar Walton was convicted of the murders of Jessie E. Kendrick, Elizabeth W. Kendrick, and Archie D. Moore, Jr. between November 19 and 28, 1996. He killed these three innocent people in their homes—where people should feel most secure from acts of violence. Mr. Walton admitted that he committed these horrific crimes and, after pleading guilty, was sentenced to death.

2. Given the nature of these crimes, I have no reason to question the prosecutor's decision to seek the death penalty or the judge's decision that death was an appropriate sentence. In addition to the death sentence, Walton was sentenced to life sentences for each of three robbery convictions, ten years for burglary, and three years for each of six firearms convictions.

3. State and federal courts have consistently upheld Walton's convictions.

4. By counsel, Walton has petitioned me for a conditional pardon. He seeks relief from his death sentence on the ground that he is not competent to be executed, among other grounds for relief. This competence issue is based on the U.S. Supreme Court's decision in Ford v. Wainwright, 477 U.S.399 (1986), that the U. S. Constitution does not permit the execution of persons who are mentally incompetent. This ruling is focused on whether the condemned has sufficient mental capacity to understand the punishment he is about to suffer and why he is to suffer it.

5. Courts considering Walton's death sentence have struggled with the question of whether his mental capacity imposes a bar to his execution.

6. A few days before Walton's scheduled execution date of May 28, 2003, the U.S. District Court for the Western Division of Virginia granted Walton a stay of execution in order to determine Walton's mental competence. In July 2003, following extensive submission of evidence about Walton's mental state from 1997 through 2003, the district court ruled that he was competent to be executed. A three-judge panel of appellate judges of the United States Court of Appeals for the Fourth Circuit vacated the lower court ruling, directing a broader inquiry into Walton's mental state. Before that inquiry took place, the entire Fourth Circuit Court reconsidered the panel's decision in an *en banc* review. The *en banc* Court found Walton competent to be executed by a narrow 7-6 majority.

7. In issuing its ruling, the Fourth Circuit properly limited its consideration to the evidence before it regarding Walton's mental state as of 2003. However, three years have passed since the evidence was presented. Walton's clemency petition presents significant information suggesting that he has schizophrenia, that such a mental illness can cause serious deterioration of mental competence, and that there is more than a minimal chance that Walton no longer knows why he is to be executed or is even aware of the punishment he is about to receive. Due to the history of judicial concern about his mental status, the claims in Walton's clemency petition are entitled to serious consideration.

8. In order to comply with the law forbidding execution of a mentally incompetent person and to ensure just application of Virginia's capital punishment statute, it is important to have current and independent information about Walton's mental condition. It would be imprudent to either proceed with the execution or grant clemency without further review.

REPRIEVE

9. Accordingly, I am hereby granting a delay of Walton's execution date until December 8, 2006, for the purpose of conducting an independent evaluation of his mental condition and competence, on terms and conditions prescribed by this office, in order to complete my assessment of the petition for clemency. Absent further intervention by this office, the execution will take place on December 8, 2006.

NOW, THEREFORE, in light of the foregoing and in accordance with the powers granted to me as Governor of Virginia under Article V, Section 12 of the Constitution of Virginia and Virginia Code Sections 53.1-229 and 53.1-232(C), I, Timothy M. Kaine, do hereby grant a reprieve of the execution of Percy Levar Walton to December 8, 2006.

Given under my hand and the Lesser Seal of the Commonwealth at Richmond, this 8th day of May in the year Two Thousand and Six and the 230th year of the Commonwealth.

1. Percy Levar Walton was convicted of the murders of Jessie E. Kendrick, Elizabeth W. Kendrick, and Archie D. Moore, Jr. between November 19 and 28, 1996. He killed these three innocent people in their homes—where people should feel most secure from acts of violence. 8. In May 2006, I granted a delay of Walton's execution date until December 8, 2006, for the purpose of conducting an independent evaluation of his mental condition and competence, on terms and conditions prescribed by this office, and completing my assessment, in light of that evaluation, of Walton's petition for clemency. I determined at that time that in order to comply with the law forbidding execution of a mentally incompetent person and to ensure just application of Virginia's capital punishment statute, it was important to have current and independent information about Walton's mental condition and that it would be imprudent either to proceed with the execution or grant clemency without further review.

REPRIEVE

9. Over the past six months, I have been provided with current and independent information from a number of sources pertaining to Walton's mental state. After reviewing this information, I am compelled to conclude that Walton is severely mentally impaired and meets the Supreme Court's test for mental incompetence. Because one cannot reasonably conclude that Walton is fully aware of the punishment he is about to suffer and why he is to suffer it, his execution cannot proceed at this time.

10. At the same time, it is within the realm of possibility—though unlikely—that Walton's mental condition is not permanently impaired. Accordingly, I believe that a commutation of his sentence is not appropriate at this time. Rather, I believe that continued observation of Walton's condition over a more extended period of time is the appropriate course of action.

11. Accordingly, I am hereby delaying Walton's execution date to permit further observation of Walton's mental condition and competence. Absent further intervention by this office, the execution will take place on June 10, 2008.

NOW, THEREFORE, in light of the foregoing and in accordance with the powers granted to me as Governor of Virginia under Article V, Section 12 of the Constitution of Virginia and Virginia Code Sections 53.1-229 and 53.1-232(C), I, Timothy M. Kaine, do hereby grant a reprieve of the execution of Percy Levar Walton to June 10, 2008.
