INDIVIDUAL STUDENT ALTERNATIVE EDUCATION PLAN PROGRAM

PRESENTED TO

THE HONORABLE TIMOTHY KAINE GOVERNOR OF VIRGINIA AND THE VIRGINIA GENERAL ASSEMBLY

Authority for the Report

Section 22.1-254 of the *Code of Virginia* authorizes school boards to allow the fulfillment of compulsory attendance requirements by any student who is at least 16 years of age and for whom an Individual Student Alternative Education Plan (ISAEP) is developed. As required by the *Code*, the Virginia Board of Education has developed guidelines associated with the ISAEP program. The ISAEP must conform to these guidelines, to include:

- (1) career guidance counseling;
- (2) mandatory enrollment and attendance in a General Educational Development (GED_®) preparatory program or other alternative education program approved by the local school board;
- (3) counseling on the economic impact of failing to complete high school; and
- (4) procedures for reenrollment in school.

Item 140 of the Appropriation Act, Chapter 879, 2008 Acts of Assembly, requires the Virginia Department of Education (VDOE) to monitor the implementation of this program, now called the Individual Student Alternative Education Plan program, and to provide annual reports to the General Assembly.

Historical Review of the ISAEP Program

The legislation that created the ISAEP program became law on July 1, 1999. In the months that followed, the Board of Education developed guidelines for the program, and VDOE established a process for funding local programs and assisted school divisions in developing program components. The first program year was viewed as successful by school divisions, even though it was only a few months in duration. Year two (2000-2001) involved technical assistance visits and regional training primarily to prepare for the planned changeover to a new series of the GED® Tests that occurred in January 2002. During 2001-2002, the ISAEP program was characterized by continued technical assistance site visits and training, with increased emphasis on the career and technical education component. Career and technical education benchmarks were established, and three options for career preparation were added to the 2002-2003 ISAEP application. During 2002-2003, the Board of Education guidelines for ISAEP programs were revised to reflect score requirement changes resulting from the release of the 2002 series of the GED® Tests. The new career and technical education benchmarks were also included in the revised guidelines. Activities in the following four fiscal years focused on program improvement and strengthening the career and technical component of the program, as well as increasing awareness among the school divisions in response to greater demand for the program.

State Administrative Activities during the Ninth Year of the Program

During 2007-2008, state staff continued delivering technical assistance and training to programs. Technical assistance and monitoring activities focused on improving program management, assessment, and the use of technology to support assessment and instructional activities that prepare students for the 21st century work force. Professional development focused on strategies for counseling and transition, effective programs that demonstrated results, and strategic instruction for the special needs population.

Funding and participation during the ninth year of the ISAEP program (July 1, 2007-June 30, 2008) is summarized below.

- For the time period of July 1, 2007 to June 30, 2008, the Virginia General Assembly allocated \$2,247,581 in funds to school divisions, with grants ranging from \$7,859 to \$102,162. School divisions spent \$2,231,863 in funding. The difference between the appropriation and the expenditures, which is \$15,718, represents funding for which one school division did not apply because of economic issues and one school division which did not submit an application but served students utilizing their own funds. Local programs used grant monies to purchase materials and technology for instruction and for personnel costs.
- In the 2007-2008 school year, four school divisions began ISAEP programs for the first time.
- School divisions reported that 6,512 students, ages 16 years and older qualified for an ISAEP program.


Local Program Data, 2007-2008

In May 2008, VDOE continued to refine the ISAEP data collection completed by participating school divisions. The data collection effort highlights student participation rates, the number of students earning the GED_® credential, student demographics, program profiles, and state per-pupil costs. Responses were received from all programs that participated in 2007-2008.

During state data collection efforts, programs were asked to provide quantitative data pertaining to age, gender, and ethnicity of participants. Also, they were asked to describe their respective programs in qualitative terms, including information about student/teacher ratios, program selection criteria, career counseling and preparation activities, instructional methodologies, curriculum, enrollment, and completion data.

Participation in ISAEP





Figure 1 illustrates an 81 percent increase in the number of students with an ISAEP since the first full year of implementation of the program and a two percent increase since school year 2006-2007.



Age and Gender of Participants

School divisions reported that 6,512 students for the 2007-2008 school year, ages 16 years and older, qualified for an ISAEP program. The number of 16-year-old students with an ISAEP represents 32 percent of the total ISAEP student enrollment. Seventeen-year-old students represent 53 percent, and 18-year-old students represent the remaining 15 percent of the student population. The age and gender percentages remain the same as school year 2006-2007.





Figure 2 provides a breakdown of ISAEP participants by age. The total number of 16- and 17year-old students who remained in the program has increased over the last four years while the number of 18-year-old students has decreased.

Gender enrollment data for 2007-2008 reflect that 59 percent (3,816) of ISAEP students were male, while 41 percent were female (2,696). See Appendix B for age and gender enrollment by school division.



Ethnicity of Participants





Figure 3 provides a breakdown of participation rates based on ethnicity. The rate of participation by selected ethnic groups changed slightly from 2006-2007 to 2007-2008.

Between 2006-2007 and 2007-2008, participation by Caucasians dropped by one percent from 62 percent in school year 2006-2007 to 61 percent in 2007-2008. African-American participation remained at 30 percent. Hispanic participation increased from six percent in school year 2006-2007 to seven percent in school year 2007-2008. Other ethnicities remained the same at two percent. See Appendix C for ethnicity enrollment by school division.

Figure 4 provides a breakdown of ISAEP participants by reason for enrollment. School divisions reported that 45 percent of the students enrolled due to academic reasons. This represents a nine percent decline from the 2006-2007 school year. Disciplinary reasons for enrollment were reported at 14 percent, a decline of one percent from the 2006-2007 school year. Twenty-eight percent of the students enrolled due to being overage (those students one year or more behind their peers), which is an eight percent increase over the 2006-2007 school year. Thirteen percent enrolled due to other reasons, an increase of one percent from the 2006-2007 school year. See Appendix D for reasons for enrollment in ISAEP by school division.



Major Focus Areas for 2008-2009

In the coming school year, the VDOE's technical assistance priorities will include:

- helping programs improve academic and career preparation of ISAEP students;
- providing assistance in developing high quality, effective programs that demonstrate results;
- helping programs improve reporting for formative and summative evaluation purposes; and
- ensuring fair and equitable access to the ISAEP program for all students.


