

ON THE MOVE!

After 24 years at 3600 West Broad Street in Richmond, DPOR moved in August 2007 to the Perimeter Center at Deep Run in Henrico County.

DPOR is co-located with other state agencies including the Board of Accountancy, the Department of Conservation and Recreation's State Parks Reservation Division, the Department of Health's Office of Licensure and Certification, the Department of Health Professions, and the Department of Rehabilitative Services' Disability Determination Services.

DPOR's move involved relocating more than 170 employees, replacing all agency furniture with modular systems, donating existing furniture to other state agencies and to state surplus, installing a state-of-the-art electronic records management filing system, and converting to VITA's VOIP telephones (Voice Over Internet Protocol). DPOR leases its Perimeter Center space from the Department of General Services in accordance with the Commonwealth's real estate management initiative.

As a non-general fund agency, DPOR is financed by assessments on regulated practitioners, not by any tax revenues.



Complaint Volume by Board



The Complaint Analysis & Resolution Section processes all complaints received by DPOR and, with the Field Investigations Section, determines whether evidence supports a probable violation of board regulations or state law. The Adjudication Section conducts Informal Fact-Finding (IFF) Conferences in accordance with the Administrative Process Act. Cases resolved through the agency's Alternative Dispute Resolution (ADR) Section may avoid formal investigation.

The average number of days disciplinary cases remained open decreased from 229 days in FY 2004 to 142 days in FY 2008. During the biennium, DPOR conducted **630 disciplinary** IFFs and **276 recovery fund** IFFs. Boards entered 1,521 orders, of which 61% were consent orders/agreements. The agency **resolved 217 complaints** through free, voluntary ADR services.

In addition, DPOR worked with local authorities in successfully prosecuting 334 cases of unlicensed activity. DPOR helped consumers receive nearly **\$1.9 million** in court-ordered victim

Public Awareness Initiatives

As part of its ongoing commitment to increase public awareness, DPOR requested legislation to allow the Real Estate Board to use Real Estate Transaction Recovery Fund interest for consumer education initiatives. Prior to the passage of SB 1185 (2007), the Board could use interest earned on deposits to the Fund for research and education on subjects benefiting only real estate licensees (salespersons, brokers and firms).

The agency's public awareness efforts feature a fulltime, bilingual consumer education coordinator who travels throughout the Commonwealth and reaches diverse audiences, as well as membership with the Virginia Association of Consumer Agency Administrators, the VDACS Consumer Affairs Advisory Committee, and the statewide TRIAD/S.A.L.T. Council. During the biennium, DPOR partnered with Housing Opportunities Made Equal (H.O.M.E.), a statewide housing advocacy organization, on a fair housing audit evaluating accessibility compliance. With funding from the U.S. Department of Housing and Urban Development, the fair housing audit assessed new multi-family construction in the greater Richmond and Hampton Roads regions for accessible design features and compliance with legal requirements for reasonable modifications and accommodations.

The Fair Housing Board and Real Estate Board at DPOR administer and enforce fair housing laws, which prohibit discrimination on the basis of race, color, religion, sex, national origin, familial status (children under age 18), disability, or elderliness (persons age 55 or older).

LEGISLATIVE INITIATIVES & BOARD ACTIVITIES



New Regulatory Programs

MARTIAL ARTS

Codifies the previous task force on professional boxing and wrestling, established by regulation, and creates the Martial Arts Advisory Board of five members, appointed by the DPOR Director, to advise on any martial arts competition. [HB 1798 (2007)]

ONSITE SEWAGE SYSTEM PROFESSIONALS

Transfers the regulation of onsite soil evaluators, as well as installers and operators of alternative onsite sewage systems, from the Department of Health to DPOR. The expanded Board for Waterworks and Wastewater Works Operators and Onsite Soil System Professionals (WWWOOSSP) administers the new licensure program. [HB 3134/SB 1270 (2007)]

Increased educational requirements for licensees

The General Assembly increased educational requirements for several professions/occupations during the biennium. As a result, the Board for Contractors established a prelicense education program for contractor firms as a condition of initial licensure, specifically to include basic business coursework. [HB 1054 (2007)]

The Board for Architects, Professional Engineers, Land Surveyors, Certified Interior Designers, and Landscape Architects (APELSCIDLA Board) must require 16 hours of continuing education in order for architects, professional engineers, and land surveyors to renew or reinstate a license. [HB 1118/SB 72 (2007)]

Increased educational requirements for Real Estate Board licensees include: (1) an additional eight hours of continuing education coursework in supervision and management for brokers, and (2) amending the number of mandatory continuing education hours from eight to 10 for brokers and salespersons, with at least three hours in ethics and standards of conduct. [HB 2064 (2007)]

In addition, the Board for Contractors amended its regulations to require continuing education for tradesmen. As a condition for license renewal as of January 1, 2008, journeyman and master plumbers, electricians, HVAC mechanics, and gas-fitters must complete coursework related to the applicable building code in their fields.

Study of Auto Body Repair Industry

At the request of a member of the House of Delegates and the Virginia Auto Body Legislative Committee, in Fiscal Year 2007 the Board for Professional and Occupational Regulation (BPOR) conducted a study on the need to regulate the auto body repair industry. In considering whether to recommend regulation of a profession or occupation, BPOR observes the Commonwealth's philosophy outlined in statute that such regulation is only justified when necessary to protect the public (*Code of Virginia* § 54.1-310).

Based on evidence obtained during the study, the public appeared adequately protected from the risk of harm without a state-mandated regulatory program governing the auto body repair industry. Insurance companies, customer referrals, trade associations, and automobile manufacturers all provide information to the public to assist in finding competent practitioners. In addition, the existing complaint mechanism at the Virginia Department of Agriculture and Consumer Services appeared to satisfy consumer concerns.

As a result, in November 2006, BPOR recommended against a regulatory scheme for the auto body repair industry.
