The primary purpose of the Authority is to enhance the economic base for the seven county and one city coalfield region of Virginia (Lee, Wise, Scott, Buchanan, Russell, Tazewell and Dickenson Counties and the City of Norton).

We are pleased to submit to you and the General Assembly the 2006 Annual Report of the Virginia Coalfield Economic Development Authority. We appreciate your commitment to our region and thank you for visiting and celebrating with us so many times during this eventful year in the coalfield region of the Commonwealth.

In 2006, VCEDA approved seven loans and seven grants for a total of \$10.4 million. New announcements in the region, including the proposed \$1 billion power plant, Holston Medical Group's medical records data center, and Jennmar Corporation's new plant are expected to create nearly 2,000 new jobs. Expansions such as Results-Duffield and KCG Call Centers, and Tempur Production's plans to add a R&D component to its Scott County facility, also contribute to the new job totals.

We appreciate the leadership and support of the Governor's Office and the General Assembly. Your interest in our region throughout the year is welcomed, and we look forward to continuing to work with you and our other allies to further diversify the economy and add jobs to the coalfields.



Executive Director's Report


It is truly an honor for me to have been selected by the Board of Directors to be the new chief administrative officer of the Virginia Coalfield Economic Development Authority. I extend my sincere thanks and appreciation to the board for promoting me first to Acting Executive Director, and then to Executive Director on November 9. My goal is to build and expand upon the excellent foundations already established, to carry out the board's policies and plans, and to help plan and implement new initiatives and strategies to help further enhance and diversify the economy of our region. I'm eagerly looking forward to this exciting challenge.

Thankfully, the condition of the authority has never been better. Regional unemployment rates are at the lowest levels recorded in years. The region has gone from double-digit unemployment in many areas to the low-single digits in several counties with none now above six percent. Although much work remains to be done, these statistics indicate that VCEDA and our many allies are making much progress towards the basic mission of job creation.

One key to this has been VCEDA's over-decade-old strategy to attract information technology jobs to the region. This progressed to the next level within the past 12-18 months with the locations of CGI, a major

software development firm, and Northrop Grumman Information Technology, Inc., to the region. These projects are well under way, with CGI already employing more than 130 well-paid professionals in a temporary facility in Lebanon, and Northrop Grumman planning to begin operations in 2007 after completion of their facility. In addition, health services leader Holston Medical Group announced in October that it will build a medical-related information technology center at Duffield. Projects such as these validate the notion that our regional economy is beginning to transition to more of a knowledge-based economy.

Other successes include Dominion's announcement that a site in Wise County has been chosen for further evaluation for a new coal-fired power station that could result in nearly \$1 billion in investment, 800 construction jobs, 250 mining jobs, and 75 permanent jobs at the plant. The new Garden campus of the University of Appalachia College of Pharmacy opened at Oakwood, and Breaks Interstate Park received approval on a major capital improvements funding package from VCEDA.



Our challenge as we move forward is to build upon the excellent foundations that have been established, to stay true to our mission, and to grow upon this success. With the leadership of the VCEDA board, staff, and our many allies, I believe we have a great team in place to help do just that.

Northrop Grumman announces \$1 million in funding with half of the funding coming from a VCEDA grant.

Turning the Corner with Energy and Technology

After seeing more than 1,500 jobs and \$37 million in investments come to the coalfield region in recent years, "we still have work to do," Charles Yates told the VCEDA Executive Advisory Board during the group's annual meeting on June 5. Theme of the event was "Turning the Corner with Energy and Technology." "We're definitely at the next level of jobs we hoped to be seeking after we launched our technology initiatives in the early nineties," said Yates. "And with the arrival of CGI and Northrop Grumman and the proposed \$1 billion coal-fired power plant, we have turned the corner, but we're not through yet. There is still more work to do."

Yates told the advisory group that the VCEDA board and staff have worked hard to advance and broaden the economic base of the region as then Virginia Delegate Ford Quillen envisioned in 1988 in leading the effort to create the coalfield authority. Since its creation, VCEDA has helped the region attract 67 new companies, assisted with 38 expansions and helped add 13,400 jobs.

Eva Teig Hardy, advisory board chairperson, who is executive vice president external affairs and communications of Dominion Virginia Power Co., called the region's economic development activity "a remarkable story" of how a region has come together, set important goals and focused on a common approach. "We need to share this great success story," she said.

The board chair also briefed the group on the proposed coal-fired power plant to be located in Wise County. "This is a major regional asset that cannot be moved overseas on a whim," said Hardy.

Coal remains a critical asset in the region, and Michael Quillen, president and CEO of Alpha Natural Resources and a member of the VCEDA board of directors, told the group all the easy-to-mine coal is gone. Quillen, who served as VCEDA's first board chairman, said the coal industry's biggest challenges are finding places to economically mine coal and replacing an aging labor force whose average age is 50.

Congressman Rick Boucher told the group that the coal industry remains a significant contributor to economic growth. He said the Energy Information Administration predicts continued growth in the industry and that by 2030, 57 percent of the fuel mix to generate electricity will be coal, compared to 51 percent today.

Both CGI and Northrop Grumman officials presented updates on the two information technology centers being built in Lebanon.

The advisory group also heard from Jeff Anderson, executive director of the Virginia Economic Development Partnership, who outlined the state's economic development strategies. This involves working with regions of the state to establish existing industry programs, to help companies identify expansion opportunities in the state and to attract new companies into Virginia.

Marketing the Region

With the announcements by CGI and Northrop Grumman in late 2005, the region received some national media attention. In January, the Washington Post featured the two IT companies' plans to build technology centers in Southwest Virginia. The article's headline: "Mining Coal Country for Tech Workers." National Public Radio also featured a segment on the two companies' decisions to locate their high-tech centers in the VCEDA region. State news media, including the Richmond Times-Dispatch, and Virginia Business magazine also featured the coalfield region's growing IT emphasis and the plans for CGI's Center of Excellence and Northrop Grumman's Southwest Enterprise Solutions Center.

In addition to interest in bringing information technology jobs to the coalfields, VCEDA contracted with an outside firm to contact hundreds of general manufacturing companies in an effort to generate leads for the region. This campaign will continue into 2007.

VCEDA received numerous inquiries and entertained prospects on a number of visits throughout the year. The VCEDA website reports nearly 30,000 hits a month. Ten announcements of new or existing business expansions took place in 2006.
