## **SIMPLE PARDON**

### **ASINGUO, SAMUEL CHIJOKE**

CRIME: Identity Fraud (Misdemeanor)  
COURT: City of Alexandria General District Court  
SENTENCE DATE: December 7, 2004  
SENTENCE: 360 days (suspended)  
PARDON GRANTED: July 19, 2007

On June 22, 2003, Mr. Asinguo was stopped for a minor traffic violation in the City of Alexandria. His driver's license bears the name of Samuel Chijioke Asinguo, but he signed the warrant with his other legal name, Michael Igwemere. This resulted in his being convicted of identity fraud.

Mr. Asinguo was born in Nigeria during the Nigerian-Biafra civil war. At the age of 7, his parents gave him the name of Michael Igwemere to shield him from the massacre being waged by Ikwere tribesmen. Documentation was presented to show that the High Court of Rivers State of Nigeria granted Mr. Asinguo the right to use both names in 1980.

Mr. Asinguo holds dual citizenship of the United States and Nigeria. He has held United States citizenship for eighteen years. He owns and operates two businesses in Alexandria, Virginia.

Documentation was provided by the Secretary of the Government of Imo State of Nigeria that Mr. Asinguo was to be appointed to a government position that requires no convictions for the preceding ten years, or a pardon for any convictions. The Secretary, on behalf of the government, requested that a pardon be granted to Mr. Asinguo. The authenticity of these documents was verified.

### **BARKER, RICHARD LEE**

CRIME: Selling Two Prescription Pills (Felony)  
COURT: City of Newport News Circuit Court  
SENTENCE DATE: February 17, 1982  
SENTENCE: 55 days (City Prison Farm)  
PARDON GRANTED: September 9, 2007

Mr. Barker was convicted of a felony for selling two prescription drug pills for \$7.00 while he was a teenaged high school student. Since that time he has had no charges of violating the law.

He has been a local government employee since 1989 and has received periodic promotions in his chosen career.

**BRENNER, LINDA L.**

CRIME: Unlawfully Brandishing a Firearm (Misdemeanor)  
COURT: County of York Circuit Court  
SENTENCE DATE: October 28, 1994  
SENTENCE: 12 months (suspended on condition of participation in the  
Community Diversion Incentive Program)  
PARDON GRANTED: June 7, 2007

Ms. Brenner accidentally shot herself in the abdomen during an altercation with her boyfriend. No other injury occurred during this incident. At the time, she had been a school bus driver for eighteen years, but she lost that position as the result of this conviction.

Ms. Brenner has been declared permanently disabled with a blood disease and pulmonary disease and is not able to care for herself. She is unable to become a resident of an assisted living facility unless she is pardoned for this conviction.

**DUNNAVILLE, KIMBERLY M.**

CRIME: Statutory Burglary and Grand Larceny (Felony)  
COURT: City of Roanoke Circuit Court  
SENTENCE DATE: June 28, 1989  
SENTENCE: 2 years (suspended on payment of \$400 restitution,  
graduate from high school or obtain a GED and perform 25  
hours of community service)  
PARDON GRANTED: September 11, 2007

A month after Ms. Dunnville's eighteenth birthday, she and several others broke into a skate center, taking money, skating equipment and clothing. She has had no other charges.

Ms. Dunnville is a single parent of a teenage son and a medical assistant. She has been approved to adopt a child and plans to enroll in educational programs in order to serve the elderly, but without a pardon she cannot receive the necessary clearance to pursue this career.

**FORD, WAYNE KEITH**

CRIME: Assault and Battery (Misdemeanor)  
COURT: County of Albemarle Circuit Court  
SENTENCE DATE: February 21, 1978  
SENTENCE: 6 months (suspended)  
PARDON GRANTED: September 11, 2007

This conviction is for an incident between Mr. Ford and his wife while he was drinking. His wife was not injured, he stopped drinking twenty-five years ago, he and his wife are still married and she joined in his request for a pardon.

The Fords are caregivers for five foster children and they have raised three children of their own (a daughter was murdered in 1997).

Mr. Ford serves on the board of his church, has been active in local charities and assisted in relief efforts for Hurricane Katrina. He owns and operates a septic tank service business, manages two large farms and is a private game warden for a large foundation. Endorsements of his pardon petition were offered by Albemarle Commonwealth's Attorney James L. Camblos, II and Albemarle Sheriff Edgar S. Robb.

**HODAK, KAREN SUE**

CRIME: Possession of Cocaine (Felony)  
COURT: City of Chesapeake Circuit Court  
SENTENCE DATE: August 17, 1991  
SENTENCE: 3 years (2 years, 11 months and 20 days suspended)  
PARDON GRANTED: September 11, 2007

Ms. Hodak was found to be in possession of cocaine after a vehicle in which she was a passenger was stopped. This is her only criminal charge.

Ms. Hodak has been married for eleven years and employed in the same company for fifteen years. She is a volunteer with Bowl-a-thon for Big Brothers and Big Sisters and a leader in Reality Tour, a program to educate parents and children about drug and alcohol abuse. This pardon was requested and endorsed by community leaders to enable her to fill roles in programs for children and youth for which a clearance is required.

**HUTCHIND, PETER**

CRIME: Breaking and Entering and Grand Larceny (Felony)  
COURT: County of Madison Circuit Court  
SENTENCE DATE: June 3, 1964  
SENTENCE: 2 years (suspended and placed on probation)  
PARDON GRANTED: September 11, 2007

Mr. Hutchind broke into a dwelling during the daytime and took two musical instruments, a clock, an item of cut glass, a radio and a lamp. He has had no other charges.

Mr. Hutchind became disabled in 2000 due to a heart condition. He and his wife have custody of a four year old grandson. He requests a pardon so he may be a volunteer in a hospital. His petition is endorsed by Randy Jenkins, Sheriff of Madison County.

**ISIANDINSO, KENECHUKWU WALTER**

CRIME: Petit Larceny (Misdemeanor)  
COURT: County of Henrico General District Court  
SENTENCE DATE: July 13, 1999  
SENTENCE: 12 months (suspended); \$200 fine  
PARDON GRANTED: September 10, 2007

Mr. Isiandinso's petit larceny conviction was for stealing toothpaste and razor blades from a Wal-Mart store. He accepted a plea agreement upon advice of counsel who was not aware that the 12-month sentence would cause the U. S. Citizenship and Immigration Services to consider him to be an "aggravated felon" and thereby barred from consideration for citizenship and eligible for deportation. Had he been sentenced to an active sentence of eleven months and twenty-nine days, he would not be deportable and could become a U. S. citizen.

Mr. Isiandinso came to the United States from Nigeria, fleeing execution due to a death sentence by the Abacha regime in 1997 because of his political activities. He is married and has two children who all live in a home they own. He owns his business with 50 employees. This pardon will enable him to remain in the United States.



## CONDITIONAL PARDON

SENTENCE: 15 years (12 years suspended); pay restitution of \$831.17. Modified on November 12, 1997, to payment of restitution; completion of the Boot Camp Incarceration; suspension of the previously unsuspended portion of the sentence; and indefinite probation.

**CONDITIONAL PARDON GRANTED:                    JULY 6, 2007**

The judge who presided over all of Mr. Willis' hearings and ordered his incarceration has submitted a letter regarding Mr. Willis' petition, saying, "Not only do I not object to his request, but I unreservedly support the request." Four other persons who have served as judges for the Tazewell County Circuit Court support Mr. Willis' petition. The Commonwealth's Attorney who prosecuted Mr. Willis has no objection to his petition.

This pardon is conditioned upon Mr. Willis' acceptance of the following terms and conditions:

Mr. Willis shall be under the custody and control of the Virginia Parole Board, subject to the following conditions:

1. He shall obey all Federal, State, and local laws and ordinances.
2. He shall report any arrest, including traffic tickets, within three (3) business days to the Parole Officer.
3. He shall report in person or by telephone to the assigned Probation and Parole office within three (3) business days of his release from incarceration, and as otherwise instructed thereafter.
4. He shall permit the Parole Officer to visit his home and place of employment.
5. He shall follow the Parole Officer's instructions and will be truthful, cooperative, and report as instructed.
6. He shall not use, possess or distribute any alcoholic beverage.
7. He shall not unlawfully use, possess or distribute controlled substances or related paraphernalia.
8. He shall not use, own, possess, transport or carry a firearm.
9. He shall report any change in residence within three (3) business days to the Parole Officer.
10. He shall not leave the Commonwealth of Virginia or travel outside of an area designated by the Parole Officer without permission of the Parole Officer.

The Parole Board may revoke Mr. Willis' pardon, based on a violation of one or more of the conditions in Section I, or based on a finding by the Board that he is otherwise unfit or unsuitable to remain on supervision. Mr. Willis shall be subject to arrest upon cause shown by the Parole Board or the Parole Officer. The maximum date of release from supervision is August 26, 2013. However, Mr. Willis may be considered for unsupervised probation after three (3) years from the date of release, but must continue on good behavior until August 26, 2013.

**MEDICAL PARDON GRANTED: JUNE 7, 2007**

In May of 2007, Ms. Leona Carter submitted a request for Executive Clemency for her son, Willie Lee Carter, based upon his diagnosis of a brain tumor that renders him terminally ill with a life expectancy of ninety days or less. This was confirmed by the professional experts who comprise the Medical Clemency Assessment Committee.

Mr. Carter was determined to be non-ambulatory and he did not constitute a threat to the public. His mother was willing, able and desirous of assuming custody of and responsibility for his care. The crimes for which he was incarcerated were not considered to be so heinous as to require his continued imprisonment, based on his health.

Mr. Carter died on June 21, 2007.

## **REVISED ABSOLUTE PARDON**

### **WASHINGTON, EARL, JR.**

1. On June 4, 1982, Rebecca Williams was raped and stabbed in her home in Culpeper, Virginia, and died a short time later in a local hospital. At an autopsy, various samples were taken. Additional evidence was collected from the crime scene at the Williams home.
2. Approximately a year later, Earl Washington, Jr., was in custody for other crimes for which he was convicted and sentenced to prison. He was questioned about Mrs. Williams' rape and murder and he eventually confessed to those crimes.
3. Based on the confession and other evidence, Mr. Washington was tried and convicted of the capital murder and rape of Mrs. Williams and sentenced to death.
4. Ten years later, Governor Lawrence Douglas Wilder requested and was presented with DNA tests of samples taken from Mrs. Williams, Mr. Washington, and other physical evidence from the crime scene. The DNA tests did not exonerate Mr. Washington, but cast doubt on whether he had committed the crimes against Mrs. Williams. In light of that new information, Governor Wilder commuted Washington's death sentence to life in prison with the possibility of parole.
5. In 2000, Governor James S. Gilmore, III directed the Virginia Division of Forensic Science to perform further DNA tests on evidence taken from Mrs. Williams' body and her residence. These tests were conducted with more advanced DNA technology that had been developed since the time of Governor Wilder's review.
6. According to the results of these DNA tests, it became evident that the semen taken from Mrs. Williams' body was not that of Mr. Washington and his DNA also could not be located elsewhere in the Williams residence.
7. The DNA results further revealed the semen of another person on a blue blanket taken from the crime scene. The DNA from that semen matched the DNA of a convicted rapist, Kenneth Tinsley. However, at the time, it appeared that the DNA on the blue blanket did not match the DNA of the sole sample of semen taken from Mrs. Williams' body, thus making it possible that there were at least two perpetrators of the crime.

8. Based on this information, Governor Gilmore granted Mr. Washington an absolute pardon on October 2, 2000, on the limited grounds that a reasonable jury would not have convicted him based on the evidence as it was then known.
9. In 2004, Dr. Edward Blake conducted new and more sophisticated DNA tests at Mr. Washington's request and expense. These DNA tests revealed that the DNA sample from Mrs. Williams' body and the DNA that was found on the blue blanket from the crime scene both belonged to Kenneth Tinsley.
10. The reliability of Dr. Blake's DNA testing in this case was confirmed by an external audit of the Division of Forensic Science ordered by Governor Mark R. Warner.
11. In April 2007, Kenneth Tinsley pled guilty to the rape and murder of Rebecca Williams. He was sentenced to two life terms in addition to the two life terms he was already serving for a previous rape and robbery conviction.
12. Based on DNA evidence and analysis now available, and the conviction of Kenneth Tinsley for the murder and rape of Mrs. Williams, it is now evident that Mr. Washington was and is innocent of the crimes against Mrs. Williams. Therefore, upon careful deliberation and review of all of the evidence, as well as the circumstances of this matter, I have decided it is just and appropriate to grant this revised absolute pardon that reflects Mr. Washington's innocence of the rape and capital murder of Mrs. Williams.

NOW, THEREFORE, I, Timothy M. Kaine, Governor of the Commonwealth of Virginia, in accordance with the authority granted to me as Governor of Virginia under Article V, Section 12 of the Constitution of Virginia, do hereby grant unto Earl Washington, Jr., this revised Absolute Pardon from the convictions of rape and capital murder handed down by the Circuit Court of Culpeper County on March 20, 1984.

Given under my hand and under the Lesser Seal of the Commonwealth at Richmond, this 3rd day July in the year of our Lord Two Thousand and Seven and the 232nd year of the Commonwealth of Virginia.

## REMITTANCE OF FINE

### MORRIS, QUINTON LEE

CRIME: Possession with Intent to Distribute Cocaine (Felony)  
COURT: County of Spotsylvania Circuit Court  
SENTENCE DATE: March 29, 1990  
SENTENCE: 25 years (10 years suspended) and \$50,000 fine  
PETITION GRANTED: July 3, 2007

On March 29, 1990, Quinton Lee Morris, at the age of twenty years, was convicted in Spotsylvania Circuit Court of possession with intent to distribute cocaine. He was sentenced to twenty-five years imprisonment and a fine of \$50,000, with ten years of the imprisonment suspended. He was subsequently released from his active prison term on parole. On January 2, 1998, Mr. Morris was released from further supervised probation and formal judgment was entered against him for the outstanding balance of his fine and court costs which then totaled \$51,340.37.

A co-defendant of Mr. Morris' was tried and convicted of the same charge and even though the Commonwealth concedes that the evidence against both men was the same, the co-defendant was sentenced to eight years imprisonment and a fine of \$5,000.00.

On February 11, 2000, The Honorable William H. Ledbetter, Jr., Judge of the Fifteenth Judicial Circuit, which includes Spotsylvania County, issued an Opinion stating that Mr. Morris, "...should be relieved of his obligation to pay the fine imposed on May 14, 1990. Otherwise, he has no chance of ever improving the lifestyle of his family because he will be unable to borrow money or otherwise obtain acceptable credit. Providing such relief to the petitioner would result in no real net loss to the Commonwealth because it is unlikely that he can ever pay the fine in his lifetime; and, if he attempted to do so, it would impose severe hardship upon him and his family." This Opinion satisfies the requirement of Section 19.2-368 of the Code of Virginia.

Mr. Morris has been adhering to a payment plan that is commensurate with his income and financial obligations.

In accordance with Article V, Section 12 of the Constitution of Virginia, that empowers the Governor to remit fines and penalties under such rules and regulations as may be prescribed by law, the Governor remits the fines and penalties imposed upon Quinton Lee Morris to \$5,000.00. The total of all payments Mr. Morris has already made shall be credited to this amount. Interest shall not accrue on the unpaid balance so long as Mr. Morris pays a minimum of \$50.00 per month toward this amount; should Mr. Morris fail to make a monthly \$50 payment, interest shall then accrue and be payable on the entire unpaid balance until the \$5,000.00, plus interest, is paid in full.

## **REPRIEVE**

### **EMMETT, CHRISTOPHER SCOTT**

1. Christopher Scott Emmett was convicted of the murder of John Fenton Langley on October 10, 2001. He killed Langley, his co-worker, in their hotel room and then proceeded to rob him of \$100 to purchase cocaine. Mr. Emmett was sentenced to death.

2. Given the nature of this crime, I have no reason to question the prosecutor's decision to seek the death penalty or the jury's decision that death was an appropriate sentence.

3. State and federal courts have consistently upheld Emmett's convictions.

4. By counsel, Emmett has petitioned me for a conditional pardon.

5. Emmett is scheduled to be executed this evening at 9:00 p.m. He has filed a writ of certiorari with the United States Supreme Court seeking review of his conviction and sentence, as well as a motion to stay his execution. Earlier today, the Court denied his stay motion, with four Justices voting to grant the stay.

6. The Court has yet to consider whether to grant Emmett's writ of certiorari. Under the Rules of the Supreme Court, the writ will be granted if four Justices vote to accept his appeal. The Court does not expect to consider his appeal until late September.

7. Basic fairness demands that condemned inmates be allowed the opportunity to complete legal appeals prior to their execution. Allowing Emmett's execution to go forward before the Supreme Court rules on his appeal would foreclose any additional review of his case. The irreversibility of an execution and the fact that four Justices of the Court believe a stay is needed to consider the appeal warrant my intervention in this case.

8. Accordingly, I am hereby granting a delay of Emmett's execution date until October 17, 2007, for the purpose of allowing the United States Supreme Court to rule on the writ. In light of that ruling, on terms and conditions prescribed by this office, I will complete my assessment of Emmett's petition for clemency.

NOW, THEREFORE, in light of the foregoing and in accordance with the powers granted to me as Governor of Virginia under Article V, Section 12 of the Constitution of Virginia and Va. Code Sections 53.1-229 and 53.1-232(C), I, Timothy M. Kaine, do hereby grant a reprieve of the execution of Christopher Scott Emmett to October 17, 2007.
