### REPORT ON THE ACTUAL EXPENDITURES AND PERFORMANCE RESULTS ACHIEVED BY THE NORTHERN VIRGINIA INTERNET CRIMES AGAINST CHILDREN TASK FORCE DURING THE FIRST YEAR

### **OVERVIEW OF THE TASK FORCE**

The Northern Virginia-District of Columbia Internet Crimes Against Children (ICAC) Taskforce, otherwise known as NOVA-DC ICAC, is charged with the responsibility of investigating crimes perpetrated against children through the use of the Internet. These crimes involve the exploitation of children for the purpose of the production and distribution of child pornography as well as the pursuit of children for the purpose of engaging them in illicit sexual activity.

As such, the Virginia State Police in partnership with thirty-eight local and federal law enforcement agencies formed NOVA-DC ICAC for the purpose of aggressively pursuing those responsible for these crimes. These are the participating agencies:

In an effort to provide the utmost efficient and professional services in performing this task, special training and equipment are necessary on an ongoing basis to remain current in technological and investigative procedures. Further, the ability to perform thorough and efficient forensic analysis of digital evidence in these cases is an absolute must. Details are attached.

## TRAINING

Task force members are required to successfully complete an essential training regimen that includes specified courses encompassing many technical topics of study. Currently these courses range in duration from two days to one week depending on the depth and complexity of subject matter. Minimum standards of training must be achieved as well as compliance with the Internet Crimes Against Children Investigative Guidelines and Operational Standards.

The following is an outline of some courses that are utilized by the NOVA-DC ICAC. These courses are generally delivered by the ICAC National Training and Technical Assistance Program. Expenses for this training include tuition, lodging, and meals. As a result of the funding appropriated, numerous task force members have completed the following courses.

#### EQUIPMENT

Online investigations require specific equipment to investigate Internet Crimes against Children. Through the appropriated funding, the NOVA-DC ICAC was able to purchase an extensive amount necessary equipment packages for member agencies to include the following.

As technology and the investigative environment changes, equipment and techniques evolve. When this evolution occurs and newer devices and techniques become available, older devices and techniques quickly become obsolete. NOVA-DC ICAC strives to ensure that each affiliate that is fully participating has the necessary, state-of-the-art equipment and software to enable them to conduct thorough investigations.

### FORENSIC CAPABILITY

The NOVA-DC ICAC applied a significant amount of the appropriated funding towards developing a centrally located digital forensic laboratory for the exclusive purpose of supporting the digital forensic examination needs of the dedicated task force affiliate agencies.

Existing space at State Police Division VII Headquarters in Fairfax was renovated to accommodate the needs in this area. Forensic examination equipment was purchased and the space was constructed to include a secure laboratory working environment and a secure evidence storage facility.
