RE: Annual Report on Compliance with the State

Publications Depository Act

Per the instructions in §42.1-97 of the <u>Code of Virginia</u>, requiring the Librarian of Virginia to report annually to the Governor and the chairmen of the House and Senate Committees on General Laws and the House Appropriations and Senate Finance Committees of the General Assembly, indicating which, if any, state agencies did not furnish or otherwise make available copies of their publications or other information required under this chapter, I wish to advise you on the results of the through 31 October 2009.

When the General Assembly re-enacted and recodified provisions related to the State Publications Depository Program in 2006, §42.1-92 of the Code of Virginia added:

"... the General Assembly recognizes that an informed citizenry is indispensable to the proper functioning of a democratic society. In order to remain informed, citizens must know about the activities of their government and benefit from information developed at public expense. Through the administration of the State Publications Depository Program, citizens will be ensured continued access to state publications, regardless of geographical location in the Commonwealth."

To that end, the Library of Virginia contacts, at least annually, every state agency, commission and board to inquire about their publications during that year, and to

ensure that the Library of Virginia has received copies of their digital publications for preservation and access at the Library or paper copies for distribution to designated state publications depository libraries around the state. The Library also requests a list of publications currently available to the public for inclusion in *Virginia State Documents*, the annual compilation of all state government publications in print.

Agencies that do not respond are contacted again, and we examine their Web sites for publications we may not have received during the year. Additionally, many agencies contact the Library regularly, sending materials as they are published, or seeking guidance for depositing their publications directly into the Library's digital repository, DigiTool. During FY 2009, the Library corresponded with state agencies more than 900 times, including listsery postings, e-mail, and phone.

During the same time period, the Library of Virginia received 10,905 publications, representing approximately 727 individual titles. These materials were cataloged, distributed, preserved, and made available to the citizens of the Commonwealth. Additionally, 9656 bills and documents were received from the General Assembly. Only House and Senate Documents were distributed to all depository libraries.

With the full implementation of the Library of Virginia's digital repository for electronic state publications, state agencies began submitting their digital publications via a secure, web-based interface, which the public can access via the Library's Web page and www.virginiamemory.com. State agencies have been enthusiastic about contributing digital content, and have praised the Library's work in developing the digital repository. There are now over 1660 items in the repository, which can be browsed by topic or searched full-text. In addition, a copy of each digital publication is stored in a "dark archive" creating a digital back-up copy to help ensure that no document is lost.

Despite these opportunities for compliance with the State Publications Depository act several agencies and institutions of Higher Education neither responded to our inquiries nor contributed their publications, either in print or digitally, to the Library of Virginia. Following the guidelines in the act, the following were not in compliance in FY 2009:
