Executive Summary

The Governor's Office for Substance Abuse Prevention (GOSAP) is authorized under §2.2-118, *Code of Virginia*, enacted by the 2000 Virginia General Assembly. Responsibilities of GOSAP are "to assist in the coordination of substance abuse prevention activities of the Commonwealth, review substance abuse prevention expenditures by agencies of the Commonwealth, and determine the direction and appropriateness of such expenditures."

GOSAP provides leadership for the GOSAP Collaborative, Virginia's primary vehicle for prevention system planning and collaboration at the state level. The Collaborative, formally established by Governor Kaine in Executive Directive 4, is charged with responsibilities in three areas: 1) collaboration to enhance capacity, improve efficiency and produce results; 2) infrastructure to sustain and integrate prevention practice; and 3) data to target resources and monitor results.

GOSAP and the GOSAP Collaborative have been instrumental in building a more formal state-level prevention infrastructure and in strengthening local capacity to deliver and sustain effective prevention in the future. Significant innovations have included a comprehensive, cross-agency prevention Memorandum of Agreement (MOA) that formalized for the first time a full cross-agency agreement to a uniform set of prevention principles and program standards while providing a framework for continued state-level collaboration. GOSAP and the Collaborative then developed and employed a single competitive application process that allowed community coalitions to apply for four types of existing funding that were aligned to address underage drinking. The cross-agency collaborative approach served as a model for Virginia communities, demonstrating how existing resources can be strategically coordinated and mobilized to address underage drinking, a serious threat to the health and safety of Virginia's youth. The collaborative approach employed by GOSAP and the GOSAP Collaborative to enhance state and local prevention capacity has featured use of the Strategic Prevention Framework (SPF). SPF uses an approach that places a strong emphasis on implementing evidence-based practices while respecting the cultural context and promoting sustainability of prevention programming. It is especially well suited for use in Virginia with its diverse communities and tradition of local autonomy.

Despite budget constraints, federal funding was identified in 2009 to continue three grant programs administered by GOSAP. The Governor's Safe and Drug-Free Schools and Communities Act grants totaling over \$647,000 were awarded in four categories to 22 projects to support youth substance abuse and violence prevention efforts in 35 localities. Evaluations of the projects have produced strong evidence of effectiveness including reductions in risky behavior by program participants, improvements in grades, and reductions in disciplinary referrals and in bullying behaviors. The Governor's Youth Community Service and Civic Engagement Program has provided mini-grants to communities for the purpose of engaging youth at risk for gang involvement with opportunities to perform meaningful service to their communities. To date, well over 1,000 youth participants have provided over 25,000 hours of service to their communities since 2008. The projects have used a positive youth development approach that views

youth as resources to their communities. Findings from the comprehensive cross-site evaluation have reflected strongly pro-social attitudes and bonding with their communities which are important indicators of effectiveness. The “Think! ... Don’t Drink” Underage Drinking Prevention Grant Program awarded grants up to \$10,000 to support underage drinking prevention programs and activities in 22 Virginia localities. Although awards were made in October 2008, activities of many projects continued in 2009.

GOSAP continues to support community prevention efforts by providing valuable resources including the GOSAP Website which serves as a prevention information clearinghouse and the Virginia Community Profile Database, a web-based, interactive tool that provides easy access to a variety of community-level data and facilitates data-driven prevention planning and evaluation. Although fiscal constraints precluded a state prevention conference, strategic support has been provided for training and other activities to build local prevention capacity.

In 2009, Virginia was awarded federal funding through the Substance Abuse and Mental Health Services Administration’s Strategic Prevention Framework State Incentive Grant (SPF.SIG) program to support activities to build a state prevention infrastructure. Implementation of the initiative will provide opportunities for GOSAP and the Collaborative to further strengthen Virginia’s state-level infrastructure and to target parallel development in selected high-need communities. An initial award of \$2.1 million was made in 2009.

During the first year of SPF.SIG, a statewide needs assessment will be conducted, identifying priorities and communities that demonstrate critical need. After the plan is approved and targeted behaviors and/or communities are identified, a means for distributing funds to localities for local level programming will be completed. Sub-grants will build the local infrastructure and implement culturally appropriate programs and strategies designed to decrease underage drinking, substance abuse, and related problem behaviors while improving community well-being. The state-level Community Profiles Database of epidemiological data will continue to be maintained as it is an important resource for data-driven prevention planning.

Having established a more formal prevention infrastructure and foundation for delivering and sustaining effective prevention, GOSAP looks forward to continuing to provide leadership and coordination for the Commonwealth’s prevention activities consistent with its statutory responsibilities.

Report of Activities of the Governor's Office for Substance Abuse Prevention

Statutory Authority

The Governor's Office for Substance Abuse Prevention (GOSAP) is authorized under §2.2-118, *Code of Virginia*, enacted by the 2000 Virginia General Assembly. This annual report of activities is submitted in accordance with statutory requirements for reporting.

The statute establishing GOSAP sets forth the responsibility of the Governor "to administer the substance abuse prevention program within the Commonwealth and to authorize, direct, and coordinate activities of agencies within the Commonwealth in such program." The statute further specifies that "the Governor shall cooperate with federal, state and local agencies, private and public agencies, interested organizations, and individuals in order to prevent substance abuse within the Commonwealth." The responsibilities of the GOSAP are "to assist in the coordination of substance abuse prevention activities of the Commonwealth, review substance abuse prevention expenditures by agencies of the Commonwealth, and determine the direction and appropriateness of such expenditures."

GOSAP Organization

GOSAP is located in the Office of the Secretary of Public Safety, where it operates as a separate entity, but utilizes available research and technology resources. The location provides enhanced visibility and support for prevention strategies and emphasizes the important role of substance abuse prevention in the Commonwealth's overall public safety mission. Marilyn P. Harris serves as GOSAP Director and Deputy Secretary of Public Safety. GOSAP staff members actively participate in state prevention-related planning and work groups to coordinate and leverage resources and to promote evidence-based programming. Overview of GOSAP

In addition to its statutory responsibilities for coordinating substance abuse prevention activities at the state level, GOSAP administers grant programs that directly support local community prevention efforts. Descriptions of the grant programs and the results they are

achieving are included in this report. GOSAP also continues to provide valuable information resources for prevention professionals and the broader community. Key resources are GOSAP's Website which serves as a prevention information clearinghouse and the Virginia Community Profile Database that provides online access to state- and locality-level data for prevention. These resources are described in greater detail in this report.

Prevention Infrastructure Development

A Record of Results through Collaboration

GOSAP and the GOSAP Collaborative have been instrumental in recent years in building a more formal state-level prevention infrastructure and strengthening local capacity to deliver and sustain effective prevention in the future. Consistent with its prevention leadership role, GOSAP in 2002 convened the GOSAP Collaborative which has served as the primary vehicle for prevention system planning and collaborative decision-making at the state level. The Collaborative is composed of leadership representatives from the 13 state agencies that share responsibility for prevention throughout the Commonwealth. By 2004, GOSAP and the Collaborative had overseen the development of a statewide substance abuse prevention plan, initiated the Community Profile Database to make state- and locality-level social indicator data readily accessible online, and re-designed the GOSAP Website to serve as a central clearinghouse for prevention information. Additionally, it developed a best practice model for prevention programming, published the *Common Language* "primer" on prevention terminology and concepts, and held two statewide prevention conferences with overflow attendance.

A significant innovation in establishing a more unified, coherent and collaborative approach to prevention formed from the development of a comprehensive, cross-agency prevention Memorandum of Agreement (MOA) in 2005 that was signed by all 13 of the state agencies and organizations that have responsibility for prevention in Virginia. The MOA formalized for the first time full cross-agency agreement to a uniform set of prevention principles and program standards and has provided a framework for continued state-level collaboration.

In November 2006, the GOSAP Collaborative was formally established in Executive Directive 4 signed by Governor Timothy Kaine. Executive Directive 4 granted the Collaborative powers and duties in three areas: 1) collaboration to enhance capacity, improve efficiency and produce results; 2) infrastructure to sustain and integrate prevention practice; and 3) data to target resources and monitor results. The Director of GOSAP chairs the Collaborative and all agencies in the Commonwealth that are charged with cooperating with the Collaborative and providing information, data, and other requested support. Activities in 2007 focused in large measure on carrying out responsibilities set forth in Executive Directive 4 including a study of the feasibility of a statewide survey of youth that found that the lack of youth survey data constituted an information gap that impeded data-driven management of Virginia's prevention resources

at both the state and local levels. In 2008, the Virginia Department of Health was awarded a grant from the Centers for Disease Control (CDC) to coordinate the implementation of a survey based on a representative sample of youth; the survey was implemented in 2009 and will yield much-needed state-level data. Virginia's first epidemiological profile report on substance use in Virginia was also compiled in 2007 with work continuing in 2008 to produce statewide and city/county profiles. The improved availability of such data promotes cross-agency collaborative efforts and facilitates data-driven decisions to ensure efficient and effective use of resources.

Another significant innovation in strengthening Virginia's prevention infrastructure occurred in 2008 when GOSAP and the Collaborative developed and employed a single competitive application process that allowed community coalitions to apply for four types of existing funding to address underage drinking. Specifically, the GOSAP and the Collaborative simultaneously:

- Aligned four existing sources of funding to make four sources of funding available to support community efforts to prevent and reduce underage drinking;
- Leveraged a broad range of existing resources to create a focus on underage drinking; and,
- Produced Virginia-specific resources designed to support community efforts and to build community capacity to sustain ongoing efforts to prevent and reduce underage drinking.

The approach served as a model for Virginia communities, demonstrating how existing resources can be strategically coordinated and mobilized to prevent and reduce underage drinking.

The collaborative approach employed by GOSAP and the GOSAP Collaborative to enhance state and local prevention capacity has featured use of the Strategic Prevention Framework (SPF), a five-step approach that supports comprehensive assessment, planning, implementation, and evaluation. The approach places a strong emphasis on implementing evidence-based practices while respecting cultural contexts and promoting sustainability of prevention programming and is especially well suited for use in Virginia with its diverse communities and tradition of local autonomy. The framework supports collaboration, capacity development and improvements in effectiveness at both the state and local level and, as such, contributes significantly to Virginia's prevention infrastructure and the integration of prevention practice both horizontally across state agencies and vertically at state and local levels.

In 2009, Virginia was awarded federal funding through Substance Abuse and Mental Health Services Administration's Strategic Prevention Framework State Incentive Grant (SPF.SIG) program to support activities to build state prevention infrastructure, providing resources to build further on the foundation paid by GOSAP and the GOSAP Collaborative. The initiative will further develop state-level infrastructure and target parallel development in selected high-need communities, by employing a SPF designed to prevent the onset and reduce the progression of substance abuse and reduce substance

abuse-related problems in target communities. More detailed information about Virginia's SPF SIG initiative is contained on pages 9 and 10 of this report.

Grant Programs: Supporting Communities, Achieving Results

Despite budget constraints, federal funding was identified in 2009 to continue three grant programs administered by GOSAP: a) the Governor's Safe and Drug-Free Schools and Communities Program, 2) the Governor's Youth Community Service and Civic Engagement Program, and 3) the "Think! . . . Don't Drink" Underage Drinking Prevention Grant Program.

Safe and Drug-Free Schools and Communities Program

The Safe and Drug-Free Schools and Communities Act of 2001 (SDFSCA) is Title IV of the *No Child Left Behind Act of 2001* (NCLB). Under NCLB, a strong emphasis is placed upon well-coordinated activities between each Governor's Office and each state's principal education agency. Consistent with these requirements, GOSAP has worked in partnership with the Virginia Department of Education to develop the SDFSCA portion of Virginia's consolidated application for funding under NCLB. The State Grants portion of the SDFSCA has been recommended for elimination by the President in his FY 2010 budget request. Funding would instead be made available through a competitive process rather than through a state-by-state formula allocation. Numerous national prevention organizations, including the Community Anti-Drug Coalitions of America (CADCA), are continuing to advocate for continuation of the State Grants program.

The Governor's Safe and Drug-Free Schools and Communities Act grants have increased data-driven prevention planning and the use of evidence-based programming throughout Virginia. For 2009-2010, grants totaling over \$647,000 were awarded to 22 projects to support youth substance abuse and violence prevention efforts in 35 localities. Grants are awarded in four categories, with priority given to projects targeting youth at higher risk for substance abuse and other problem behaviors. Appendix A of this report contains a list of projects funded in 2009-2010.

Consistent with its commitment to ongoing quality improvement and local capacity building, GOSAP provides prospective grantees technical assistance through regional workshops that focus on requirements for being awarded one of the competitive grants and on effective strategies for developing grant proposals. Once awarded funding, grantees are provided an orientation workshop and attend mid-year and end-of-year networking workshops. High quality implementation is assured through these workshops as well as ongoing technical assistance, grants management and site visits provided through the Center for School-Community Collaboration at Virginia Commonwealth University. Cross-site evaluations designed to assess implementation and project-specific outcomes are conducted each year.

Evaluations of projects funded in 2008-2009 produced strong evidence of effectiveness. The projects reported reductions in risky behavior by program participants, improvements in behavior and grades, and reductions in disciplinary referrals and in bullying behaviors. The projects also strengthened the capacity of their communities to provide evidence-based programming as a result of the training and expertise developed through the implementation of such programs.

The Governor's Youth Community Service and Civic Engagement Program

The Governor's Youth Community Service and Civic Engagement Program has provided mini-grants to communities for the purpose of engaging youth at risk for gang involvement with opportunities to perform meaningful service to their communities. Competitive grants of \$10,000 were first awarded for calendar year 2007; continuation funding was awarded to 20 localities for 2008 and to 17 localities for 2009. Appendix B of this report contains a list of localities that received funding in 2009.

The projects have used a positive youth development approach to prevention that views youth as resources to their communities. Findings from the comprehensive cross-site evaluation include the following:

- As of 9/30/09, a total 8,426 hours of service have been performed by 473 youth in nearly 100 sites in 2009. Over 8,600 hours of service were performed in 2008 and nearly 9,000 hours were performed in 2007.
- A very broad range of over 120 community agencies and organizations have benefited from the service of youth participants.
- Feedback from over 1,000 youth participants continued to be strongly and consistently positive. Overall, about 90 percent of ratings were positive, serving as a barometer for favorable youth response to community service experiences.
- Ratings associated with longer-term outcomes have reflected strongly pro-social attitudes and bonding with community. Over 90 percent of youth agreed with the statements "I can contribute my time and effort to improve my community," "Volunteering in the community is important," and "I have learned things that will make me more successful in the future. Eighty-seven percent agreed with the statement "It was personally rewarding to give service to my community" and 86 percent reported "Since being in the program, I have more positive goals for my life."

Representatives of community agencies and organizations where service has been performed also view the program quite positively and recognize its value to their organizations and to youth performing service. Representatives reported, "They helped make our event season a success. Without their help, we would have been so far behind on meeting our goals" and "(The program) is a godsend to Meals on Wheels especially during the summer months when so many of our regular drivers go on vacation. We can't imagine functioning in the hot months without them because they've become so reliable and valuable to us."

Prevention Comes First: “Think! ... Don’t Drink”

The “Think! ... Don’t Drink” Underage Drinking Prevention Grant Program, a component of the Governor’s *Prevention Comes First* Initiative, awarded grants of up to \$10,000 to support underage drinking prevention programs and activities in 22 Virginia localities. A list of localities and sponsoring organizations is included as Appendix C of this report. The program was made available, through a single competitive application process, using existing funding from the Departments of Mental Health, Mental Retardation, and Substance Abuse Services, Criminal Justice Services, and Alcohol Beverage Control. Applicants were required:

- To coordinate local resources to implement a comprehensive, multi-strategy approach to underage drinking;
- To use programs and activities that have been demonstrated to be effective in a strategic manner to address locally identified needs; and,
- To make extensive use of free and low-cost informational and programmatic resources that are available.

All GOSAP Collaborative agencies contributed resources to create a focus on underage drinking prevention and support local efforts. Additionally, “Think! ... Don’t Drink” resources were developed including the *Community Guide for Preventing and Reducing Underage Drinking*, the *Parent Guide to Preventing Underage Drinking*, a public service announcement featuring Secretary of Public Safety John W. Marshall that was widely distributed to classrooms throughout the Commonwealth.

Tools and Resources Supporting Community Prevention

GOSAP continues to support community prevention efforts by providing valuable resources on the GOSAP Website which serves as a prevention information clearinghouse. The Website (www.gosap.virginia.gov) offers a calendar of prevention-related training and events with links to sponsoring organizations; links to current prevention funding opportunities through GOSAP Collaborative and other agencies; announcements of prevention-related initiatives and news; and information on GOSAP and its programs and services. The Website also offers downloadable copies of GOSAP publications including the *Community Guide for Preventing and Reducing Underage Drinking*, the *Parent Guide to Preventing Underage Drinking*, the *Parent Guide to Personal Safety for Youth*, *Our Common Language: Quick Guide to Prevention Terminology*, and brochures on inhalant abuse and methamphetamine use. Beyond resources available on the Website, GOSAP maintains contact with prevention practitioners and supporters throughout the state via periodic emails containing important announcements and updates.

A second key GOSAP resource is the Virginia Community Profile Database, a web-based, interactive tool that provides easy access to a variety of community-level data and prevention resources. Prevention practitioners use this resource to access data they use in assessing needs, planning, allocating resources, and monitoring trends to improve results.

The Community Profile Database has greatly facilitated data-driven decisions in prevention practices in Virginia and will continue to be supported through the newly-awarded federal SPF.SIG grant.

Although budget constraints precluded a statewide prevention conference, GOSAP continued its support for training and other resource development in strategic areas. For example, GOSAP:

- Supported the Community Builders Network by providing scholarships for persons in need of assistance to attend;
- Sponsored a Family Impact Seminar focusing on substance abuse prevention policies, programs and strategies for Virginia's youth. Such seminars are designed to connect policymakers and professionals to build research-based family policy;
- Supported statewide training of Department of Juvenile Justice personnel in motivational interviewing;
- Supported training through the Virginia Department of Correction Education (VADCE) and efforts of the Virginia Child Care Resource and Referral Network (VACCRRN) to address the issue of quality care during out-of-school hours; and,
- Continued to actively support the Virginia Interagency Anti-Gang Workgroup and collaborated with the Virginia Department of Health on the development of gang prevention resources.

Future Direction

Strategic Prevention Framework State Incentive Grant (SPF.SIG)

In 2009, Virginia was awarded federal funding through SAMHSA's SPF.SIG program to support activities to build state prevention infrastructure. The grant will support further development of state-level infrastructure and target parallel development in selected high-need communities, by employing a SPF designed to prevent the onset, and reduce the progression, of substance abuse and reduce substance abuse-related problems in target communities.

Efforts to collaborate with local prevention coalitions to implement this initiative are:

- GOSAP will coordinate substance abuse prevention activities across state agencies.
- The GOSAP Collaborative provide ongoing advice and guidance to the project and will assist with development of epidemiological profiles to inform state-level prevention activities and service planning for localities;
- Virginia Commonwealth University will provide expertise and project management with faculty within the School of Education, Center for School-Community Collaboration serving as Evaluator and faculty in the School of Public Health serving as the Epidemiologist;

- The Virginia Department of Behavioral Health and Developmental Services, the single state agency for substance abuse prevention and treatment, will provide staff to serve as the Project Director, as well as fiscal agent, ensuring compliance with federal requirements at both the programmatic and fiscal levels;
- The GOSAP Advisory Council, representing a wide variety of perspectives on prevention from state and local agencies, organizations, coalitions and faith communities, will advise on tools developed and community capacity-building efforts, to ensure that they are relevant and culturally appropriate. It will monitor progress toward implementing each of the five steps of the SPF; and,
- A state level Evidence-based Practices Workgroup (EBP) will be assembled to review local needs assessments, community-based plans, as well as the implementation of evidence-based programs and practices that align with a given plan.

An initial award of \$2.1 million was made from SAMHSA in 2009. During the first year, a statewide needs assessment will be conducted, assessing community needs and assets, identifying priorities and communities that demonstrate critical needs regarding underage drinking, substance abuse, and related problems. After the plan is approved and targeted behaviors and/or communities are identified, a means for distributing funds to localities to target local-level programming will be completed. Sub-grants will be made to build the local infrastructure to identify and address the common set of risk factors that underlie these community problems. By implementing culturally appropriate programs and strategies that research has proven to be effective, and evaluating them for improvement, these localities will decrease underage drinking, substance abuse, and related problem behaviors to improve community well-being. GOSAP Collaborative, Council and EBP members will assist project staff in providing technical assistance and program evaluations for community grantees on an on-going basis throughout the project.

The state-level Community Profiles Database of epidemiological data will continue to be maintained. The improved availability of such data will further promote cross-agency collaborative efforts and facilitate data-driven decisions to ensure efficient and effective use of resources.

Having established a more formal prevention infrastructure and foundation for delivering and sustaining effective prevention, GOSAP looks forward to continuing to provide leadership and coordination for the Commonwealth's prevention activities consistent with its statutory responsibilities.
