In accordance with Chapter 1024, clause 2 of the 2004 Acts of Assembly, below please find information for calendar year 2009 on the number of petitions filed for writs of actual innocence pursuant to Chapter 19.3 of Title 19.2 and the dispositions thereof.

- Two petitions were pending on January 1, 2009.
- Twenty-six petitions were filed in 2009.
- Twenty-three petitions were disposed of in 2009. The dispositions of those cases were as follows:
  - o Twenty-one petitions were summarily dismissed.
  - Two petitions were dismissed following consideration of the Attorney General's response to the petition and petitioner's reply thereto.
- Five petitions were pending as of December 31, 2009. In one of these cases, a writ was granted, petitioner's convictions were vacated, and the matter was remanded to the circuit court to modify the conviction order. However, the court subsequently granted the Commonwealth's petition for rehearing *en banc* and stayed the order granting the writ. The case is scheduled to be reheard before the full Court on January 26, 2010.
