#### Compensation Board Mental Illness in Jails Report (2010)

#### Authority:

Virginia Acts of Assembly, 2010 Session, Chapter 874 §53.1-83.1, §53.1-84 and §53.1-85, Code of Virginia

Item 67.30, Paragraph K. "The Compensation Board shall provide an annual report on the number and diagnoses of inmates with mental illnesses in local and regional jails, the treatment services provided, and expenditures on jail mental health programs. The report shall be prepared in cooperation with the Virginia Sheriff's Association, the Virginia Association of Regional Jails, the Virginia Association of Community Services Boards, and the [Virginia Department of Behavioral Health and Development Services], and shall be coordinated with the data submissions required for the annual jail cost report. Copies of this report shall be provided by November 1 each year to the Governor, Director, Department of Planning and Budget, and the Chairman of the Senate Finance and House Appropriations Committees."

#### **Executive Summary:**

A survey of mental illness in Virginia jails was developed by the Department of Behavioral Health & Development Services (DBHDS) and staff of the Senate Finance Committee and Compensation Board. The Compensation Board posted the mental health survey on its website in August 2010 for completion by Compensation Board funded local and regional jails. With the support of the Virginia Sheriffs' Association and the Virginia Association of Regional Jails, the Compensation Board received completed surveys from 67 out of 68 local and regional jails. No data was received from Newport News City Jail Farm. This jail indicated that all mentally ill offenders are held at the Newport News City Jail. Surveys were received from Petersburg City Jail and Alleghany Regional Jail but were excluded from the cohort of survey jails as they also indicated they do not hold mentally ill offenders. The goal of the survey was to provide information to the Virginia General Assembly, the Compensation Board and the DBHDS regarding jail resource needs for appropriately managing inmates with mental illness. Survey questions directed jail personnel to report data as reflected for the month of July 2010, or for FY2010. The data provided in this report is reflective only of local and state responsible inmates housed in local and regional jails and does not include federal inmates or contract inmates from other states. The data in this report is as reported to the Compensation Board by the local and regional jails in their 2010 mental health survey, submitted as of August 20, 2010. With the exclusion of Newport News City Jail Farm, Petersburg City Jail, and Alleghany Regional Jail, data from 65 out of 68 local and regional jails was used in this report.

#### Population & Demographics in Jails

The Compensation Board provided a mental illness survey for completion by all local and regional jails requesting statistical information for the month of July, 2010, such as screening and assessment, diagnoses, housing, and most serious offense type of mentally ill inmates. The survey also collects data regarding inmates' access to mental health programs and assistance in the facility, including medication and treatment. In addition, the survey is used to determine the providers of screening/assessment and treatment in each facility, whether they are private mental health professionals, Community Services Board (CSB) staff, or jail staff. In addition, jails also report their method of housing data regarding the mentally ill population and the amount of mental health and/or Crisis Intervention Training provided to the jail staff, if any. Lastly, jails are asked to provide the fiscal year cost of all mental health services and medications.

Data gleaned from surveys of 65 out of 68 local and regional jails is included in this report.

Based upon LIDS data for the month of July 2010 there was an Average Daily Population (ADP) of **6,420** State Responsible (SR) and **19,384** Local Responsible (LR) inmates confined in local and regional jails in the Commonwealth of Virginia, not including the **3** jails excluded from this report. A Local Responsible Inmate (LR) is any person arrested on a state warrant and incarcerated in a local correctional facility prior to trial, any person convicted of a misdemeanor offense and sentenced to a term in a local correctional facility, or any person convicted of a felony offense and given an effective sentence of (i) twelve months or less or (ii) less than one year. A State Responsible Inmate (SR) is any person convicted of one or more felony offenses and (a) the sum of consecutive effective sentences for felonies, committed on or after January 1, 1995, is (i) more than twelve months or (ii) one year or more, or (b) the sum of consecutive effective sentences for felonies, committed before January 1, 1995, is more than two years. Information provided in this report does not include inmates held for any federal or out-of-state authority.

Of these **25,804** inmates, **30%** were Pre-Trial and **70%** were Post-Conviction. Pre-trial refers to inmates against whom criminal charges have been brought, held in a local or regional jail awaiting trial. Post-Conviction refers to inmates who have been found guilty of one or more criminal charges, with or without additional pending charges, and are serving sentence in the jail or awaiting transfer to a Department of Corrections (DOC) facility.

The change from 2009 to 2010 has shown an increase in the percentage of post-conviction offenders held in local and regional jails. The number of inmates reported in this year's survey as post-conviction is 13.76% higher than in 2009 (2009 Pre-Trial 43.75%, Post-Conviction 56.24%).

Of these **25,804** inmates, **12.05%** were Female and **87.95%** were Male. Of the Female ADP (**3,110**), **41.96%** were reported in the survey as having a mental illness, and **15.70%** of the Male ADP (**22,694**) were reported in the survey as having a mental illness. Mental illness is defined as inmates who have been diagnosed with schizophrenia or a delusional disorder, bi-polar or major depressive, mild depression, an anxiety disorder, or any other mental illness as set out by the Diagnostic & Statistical Manual of Mental Disorders (DSM-IV-TR), published by the American Psychiatric Association, or those inmates who are suspected of being mentally ill but have received no formal diagnosis. There were a total of **4,867** inmates known or suspected to be mentally ill, **26.81%** were Female and **73.19%** were Male.

#### Mental Illness Statistics

Data in this section is as reported for July, 2010.

Jails were asked to indicate the number of inmates in each mental illness category, as shown in Figure 1.

While an inmate may have multiple diagnoses each inmate is counted only once, in the category of the most serious illness for which they have been diagnosed. Figure 1 reflects the number of mentally ill inmates housed in July, 2010 and the type of disorder.

In addition, **53.22%** of the mentally ill population and **10.04%** of the general population of jails who provided data on the number and diagnoses of inmates with mental illness have been diagnosed as having a <u>serious</u> mental illness. Serious mental illness is defined as a diagnosis of schizophrenia/delusional, bi-polar, or major depressive disorder.


- In addition, there were **90** inmates diagnosed as mentally retarded, exactly half the number of mentally retarded inmates reported in 2009.
- **18.86%** of the local and regional jail inmate population was known or suspected to be mentally ill (not including those inmates diagnosed as mentally retarded).
- As in 2009, a diagnosis of bi-polar/major depressive continues to be by far the most prevalent.

#### Screenings & Assessments

Data in this section is as reported for July, 2010.

**55** out of **65**, or **84.62** % of all reporting jails, conduct a mental health screening for all inmates upon admission to the jail. The type of individual conducting mental health screenings, as well as the screening measure itself, may differ between facilities.

Figure 3: Provider of jail mental health screenings.




Comprehensive mental health assessments of inmates are also conducted, as follows:

- 31 jails, or 48%, conduct assessments on all inmates who receive a positive screening for mental illness.
- 27 jails, or 42%, conduct assessments only on inmates with acute symptoms of mental illness.
- 7 jails, or 11%, do not conduct assessments at all.

As with initial screenings, the type of individual conducting comprehensive mental health assessments, as well as the type of assessment, may differ between facilities. In some jails, comprehensive assessments may be conducted by any of the mental health providers shown in Figure 4.

#### **Housing**

Data in this section is as reflected in July, 2010.

There is not currently a state funded Mental Health Residential Treatment Program operating within jail facilities. The housing of mentally ill inmates may therefore differ from jail to jail.

- **31 out of 65** reporting jails have Mental Health Units or bed areas separate from the General Population. Of these **31** jails, there are **76** beds for Females and **438** beds for Males.
- Jails reported that **973** additional beds would be needed to house all inmates with non-acute mental illness in mental health beds or units.
- Of the 4,867 known mentally ill inmates, 860 were housed in isolation. 33.72% of mentally ill inmates housed in isolated or segregated cells were in jails without a Mental Health Unit.
- **10** jails have noted that they would consider hosting a state-funded Mental Health Residential Treatment Program.

A total of **23** inmates were housed in jails more than 48 hours following the issuance of a court order to a state hospital for psychiatric commitment (Temporary Detention Orders), during the month of July, 2010. This is **42%** less than those reported in 2009 (55 inmates reported).

Note: The Department of Behavioral Health and Development Services (DBHDS) sponsors jail diversion and jail treatment programs in a select number of jails, which include specialized mental health treatment programs and specialized training, but these pilot programs are not considered state funded residential treatment programs for the purposes of this report.

#### Mental Health Treatment Services Provided

Mental health treatment services offered, as well as providers of those services, may differ from jail to jail. Some jails may have a full time psychiatrist or general practice physician (MD) to attend to mental health needs and dispense psychotropic meds; other jails may contract with an outside psychiatrist/general practice physician (MD) to provide services on certain days of each month, etc. Nursing staff may also provide mental health treatment.

#### **Treatment Hours & Providers**

As illustrated in Figures 5, 6, and 7, Community Services Boards (CSB) provide a large portion of mental health treatment in jails. The Virginia Code requires that every locality form their own, or partner with other localities to form a Community Services Board (CSB). The purpose of the Community Services Boards is to facilitate community-based mental health and substance abuse services to citizens, as funding allows. CSB's are licensed by DBHDS and work closely with courts, jails, and human service agencies.

The information provided below is for the month of July, 2010.

• A total of **11,421** treatment hours were provided in **55** of **65** jails. This includes treatment by any provider included in Figure 5.

Figure 6: Hours of Treatment Provided





Figure 7: Providers of Treatment



 There was a decrease in the proportion of overall treatment provided by Community Services Boards (the #1 treatment provider) of 19% from 2009 to 2010. This reduction in treatment provided by CSB's does not appear to have been replaced by a dramatic increase in treatment provided by any one other specific treatment provider; instead there was an increase in the proportions of overall reported treatment by all other providers.

Note: Appomattox County Jail, Botetourt County Jail, Brunswick County Jail, Franklin County Jail, Mecklenburg County Jail, Patrick County Jail, Piedmont Regional Jail, Portsmouth City Jail, Shenandoah County Jail, and Sussex County Jail did not submit responses to the survey question regarding provider of treatment.


#### **Treatment Services**

The following charts represent types of treatments received by inmates during the month of July, 2010. An inmate may have received multiple types of treatment. Treatment may be provided by any of the entities referenced in Figure 7.

**57** of the **65** reporting jails provided data on the number of inmates receiving treatment services in the categories shown below in their facilities. All inmate numbers reflected in Figures 8 and 9 are from an ADP of **23,854**.



#### **Medication**

Some, although not all, inmates with mental illness require the assistance of psychotropic medications. Psychotropic refers to mood altering drugs which affect mental activity, behavior, or perception. Many times these medications are provided and dispensed by the jail. However, as noted in the survey, there are certain medications that some jails do not provide. In certain cases an inmate's medication may be delivered to the jail by a 3<sup>rd</sup> party, such as a physician treating the offender pre-incarceration, or a family member authorized by the jail to bring the necessarily prescribed medication.

Out of the 65 reporting jails, 1 jail did not report on medications dispensed.

Psychotropic medications are broken down into 4 categories: Antipsychotic, Mood Stabilizer/Anticonvulsant, Antidepressant and Antianxiety.

- Antipsychotic medications include drugs such as: Haldol, Zyprexa, Risperdal, Seroquel, Triliafon, Prolixin, Thorazine, Abilify, Geodon, Clozaril
- <u>Mood Stabilizer/Anticonvulsant</u> medications include drugs such as: Depakote, Lithium, Tegretal, Topamax, and Trileptal
- Antidepressant medications include drugs such as: Prozac, Zoloft, Lexapro, Wellbutrin, Paxil, Elavil, Pamelor, and Desyrel
- Antianxiety medications include drugs such as: Ativan, Xanax, Librium and Valium

Data in this section is as reflected in July 2010.

- During this month there were 6,274 prescriptions for psychotropic medications being dispensed in local and regional jails. The number of medications administered may exceed the number of inmates receiving treatment, as an inmate may be taking more than one medication.
- A total of **517** jail inmates with mental illness refused psychotropic medication. This is **11%** of the mentally ill population.

Note: Portsmouth City Jail did not submit data regarding medication dispensed.

Figure 10: Number and Type of Psychotropic Medications Dispensed





Figure 11: Percentage of Psychotropic Medication Dispensed by Type



#### Substance Abuse/Special Education

Data in this section is as reflected in July 2010.

- Of the **4,867** inmates with mental illness, **3,390** had a co-occurring substance use/abuse disorder, or about **69.65%** of the mentally ill jail population.
- Those inmates with co-occurring mental illness and substance use/abuse disorder comprised **13.14%** of the general jail population.
- **6,421** inmates <u>without</u> mental illness were reported to have substance use/abuse disorders, representing about **24.88%** of the jail population.
- As illustrated earlier in Figure 9, 31% of all inmates receiving jail provided treatment services are receiving group substance abuse treatment. This is a 10% increase from 2009.

Federal regulations mandate that all correctional facilities provide access to Special Education for inmates. During the month of July, 2010, **133** inmates were receiving Special Education.

#### Mental Illness & Offense Type

For each inmate identified as mentally ill, jails were asked to note the most serious offense type on which the offender was held during the month of July, 2010. The following are the offense types, listed in order of severity: Felony-Violent, Felony-Drug, Felony-Nonviolent, Misdemeanor-Violent, Misdemeanor-Drug, Misdemeanor-Nonviolent. Most serious offense classification is based on the most serious offense with which an inmate is currently charged, and not necessarily of which the inmate is ultimately convicted.

Prior to the posting of this year's mental health survey, a module was added to the Local Inmate Data System (LIDS) that would allow jails to more easily identify an inmate's most serious offense. This resulted in increased response rates for this question as well as greater accuracy of responses.

Of the **4,867** inmates with mental illness, jails reported Most Serious Offense Type for **95.27%**, or **4,637** of them. Of the inmates for whom Most Serious Offense Type was reported, **77.66%** had Felony Offense(s), and **22.34%** were held on Misdemeanor Offense(s).

Figure 12: Most Serious Offense Type




Figure 13: Mental Illness Categories & Offense Type

#### **Inmate Aggression**

In the month of July, 2010 there were **391** documented incidents of inmate aggression (to include physical or sexual assault and/or threats of violence) toward other inmates or jail staff. Of these incidents, **104** inmate perpetrators had been diagnosed as mentally ill, and **27** victims of inmate aggression had been diagnosed as mentally ill.

#### Jail Staff & Maintenance of Mental Health Data

There is an average of **137** staff members per jail, to include deputies as well as civilian personnel.

- 42 of 65 reporting jails provide mental health training to each new jail officer/deputy prior to his/her initial assignment to the jail. Of these jails there is an average of 8.7 hours of mental health training provided per jail officer/deputy. 7 jails provide 20 hours or greater of mental health training per jail officer/deputy prior to initial assignment.
- 28 of 65 reporting jails require jail officers/deputies to complete additional training in mental health topics annually. Of these jails, jail officers/deputies are required to complete an average of 3.8 hours of training in mental health topics each year.
- 32 of 65 reporting jails have jail officers/deputies who have completed Crisis Intervention Team (CIT) training. Of these jails, an average of 16.2 jail officers/deputies in each jail have completed CIT training. 6 jails reported that at least half of the total staff has completed CIT training.

**13** jails indicated that their jail's electronic inmate management system includes mental health screening items. **1** jail indicated that their electronic inmate management system includes inmate psychiatric diagnoses.

#### **Treatment Expenditures**

The following reflects the cost of all mental health treatment, including medications, as reported by the jails for FY10. Some jails provided estimated or pro-rated annual costs; total figures have not been audited. 8 jails did not report cost information for medications, therefore costs reported are from a mentally ill population of 4,561. 18 jails did not report the cost of mental health services, excluding medications, therefore costs reported are from a mentally ill population of 4,169.

- The total reported cost of all psychotropic medications administered was \$4,245,881.
- The total reported cost of mental health services, excluding medication but including medical doctors and nursing, was \$7,501,240.
- Total cost of Mental Health Treatment was estimated at approximately \$11.7 million in FY10, with 66.07% of these costs funded by the locality.

Note: Amherst County Jail, Appomattox County Jail, Franklin County Jail, Montgomery County, Pittsylvania County Jail, Portsmouth City Jail, Roanoke City Jail, and Shenandoah County Jail, reported a mentally ill population but did not report the cost of medications. With the exception of Portsmouth City Jail, all of the above jails reported that medications were dispensed.

Note: Amherst County Jail, Appomattox County Jail, Charlotte County Jail, Culpeper County Jail, Franklin County Jail, Hampton City Jail, Henry County Jail, Martinsville City Jail, Mecklenburg County Jail, Newport News City Jail, Pamunkey Regional Jail, Piedmont Regional Jail, Pittsylvania County Jail, Portsmouth City Jail, Roanoke City Jail, Shenandoah County Jail, Warren County Jail, and Virginia Beach City Jail reported a mentally ill population but did not report the cost of mental health services.

#### Final Remarks & Future Measures

The Mental Illness in Jails Report was established by the legislature as an annual process to provide comprehensive data regarding mental illness, including diagnoses of inmates, treatment services and expenditures in jails. As the survey and reporting process evolves each year, the Compensation Board continues to take steps to improve the validity and reliability of survey data to the extent possible with a self-report measure. For 2010, fewer changes in survey questions, advance information and communications regarding survey information, and the addition of resource tools in the Local Inmate Data System (LIDS) all provided a smoother data collection and reporting process.

Sheriffs and Jail Superintendents were notified in June, 2010 of survey deadlines and instructions, and were directed to an advance copy of the mental health survey posted to the Compensation Board website. These early communications allowed jail staff to record July, 2010 data during the month of July, providing more time to gather data and shortening actual survey submittal time once the live survey was posted.

After the addition of 15 questions in 2009, no new survey questions were added in 2010. Maintaining consistency in survey questions has in 2010, and will continue in the future to enhance the reliability of survey data submitted. The Compensation Board expects that as survey questions stabilize and jail facilities have a clear understanding of data that they will be consistently asked to provide, necessary data collection procedures will be put in place by the jails to ensure accurate reporting of all survey data.

Additionally for 2010, a module was added to the Local Inmate Data System (LIDS), prior to the posting of the live mental health survey in August, which allowed jails to more easily identify the most serious offense of inmates. The addition of this module, in most cases, significantly reduced the amount of time necessary to respond to the question regarding cross referencing of inmate mental illness diagnoses and most serious offense type, particularly in larger facilities.

It is significant to note that data presented in this report may also assist in research or queries related to the jail mental health diversion and treatment cohort sites sponsored by the Department of Behavioral Health and Development Services (DBHDS). Eighteen local and regional jails partner with local Community Services Boards and receive funding for jail diversion programs and initiatives through DBHDS. The 18 sites are: Alexandria City Jail, Arlington County Jail, Chesterfield County Jail, Fairfax County Jail, Gloucester County Jail, Hampton City Jail, Hampton Roads Regional Jail, Lancaster County Jail, Middle Peninsula Regional Jail, Montgomery County Jail, Newport News City Jail, New River Valley Regional Jail, Northern Neck Regional Jail, Portsmouth City Jail, Rappahannock Regional Jail, Riverside Regional Jail, Virginia Beach City Jail and Western Virginia Regional Jail. These state funds support jail diversion, jail mental health treatment, and the expansion of Crisis Intervention Teams (CIT).

The Compensation Board, with input and assistance from DBHDS, the Virginia Sheriffs' Association and the Virginia Association of Regional Jails, and staff of the Senate Finance Committee will continue to review the survey instrument on an annual basis and make improvements and updates as needed. The Compensation Board, with assistance from DBHDS, will strive to provide better operational definitions for terminology within the survey to better clarify the type of data being requested, thereby increasing consistency and comparability in responses.

Further details of data gleaned from the 2010 mental illness survey and summarized in this report, including the survey instrument developed by DBHDS, staff of the Senate Finance Committee and the Compensation Board, are available in the appendices of this document.
