## Introduction

The Code of Virginia § 42.1-36.1 directs the Librarian of Virginia to submit a report to the Chairmen of the House Committee on Education, the House Committee on Science and Technology, and the Senate Committee on Education and Health that summarizes the acceptable use policies filed with the Librarian.

As indicated in the Code of Virginia, each policy shall contain provisions that

- are designed to prohibit use by library employees and patrons of the library's computer equipment and communication services for sending, receiving, viewing, or downloading illegal material via the Internet,
- ii. seek to prevent access by library patrons under the age of 18 to material that is harmful to juveniles, and
- iii. establish appropriate measures to be taken against persons who violate the policy. This includes the selection, installation, and activation of a technology protection measure to filter or block child pornography, obscenity, and materials deemed harmful to minors.

Following is the report that has been prepared in response to this directive.

## Summary

All of the Acceptable Internet Use Policies clearly state that the library's computer equipment and communication services must not be used to access illegal materials.

In addition to the use of filtering software, policies seek to prevent access by library patrons under the age of 18 to material that is harmful to juveniles. In the majority of policies, at a minimum, written parental permission is required before a library patron under age 18 may use the library's computers. Many require direct parental supervision for library patrons under the age of 12 or 13. Some libraries have installed privacy screens to reduce the possibility of inadvertent exposure to harmful material.

Violations of the Acceptable Internet Use Policy are handled in several different ways, depending on the severity and the frequency of the infraction. Most

policies deny access to the library's computers and the Internet for a limited time for violating the Acceptable Internet Use Policy. If the infraction is illegal, most policies indicate that the offenders will be open to prosecution. Repeated violations of the Acceptable Internet Use Policy will result in permanent ban from the library's computers, from the library, or from both.
