## Dear Chairmen:

Virginia Code § 17.1-507 provides that the Judicial Council shall make a study and report to the Courts of Justice Committees of the House of Delegates and Senate on the number of new circuit court judgeships needed and the circuits for which they should be authorized. As reported last fall, the Judicial Council found the need for six new circuit court judgeships (one each in the Tenth, Fourteenth, Fifteenth, Twenty-sixth, Twenty-seventh and Thirtieth Judicial Circuits). However, due to the economic difficulties faced by the Commonwealth, the Chief Justice did not seek authorization for these new judgeships during the 2009 Session of the General Assembly.

In light of the continuing economic crisis, the Chief Justice did not intend to seek authorization for any new judgeships during the 2010 Session of the General Assembly. Accordingly, no study was conducted in 2009 regarding the need for new circuit court judgeships.
