

# Second Quarterly Report to the Virginia General Assembly on the

Emancipation Proclamation and Freedom Monument

## **Summary**

The Emancipation Proclamation and Freedom Monument Work Group of the Dr. Martin Luther King, Jr. Memorial Commission held its organizational meeting on December 10, 2012, to plan and commence the feasibility study and fundraising required for the construction of a permanent monument celebrating the emancipation of slaves and freedom in commemoration of the 150th anniversary of the signing of the Emancipation Proclamation on January 1, 1863. Funds have been appropriated for this purpose. The Department of General Services is required to provide technical assistance. The MLK Commission submitted its first quarterly report to the General Assembly on the progress made on site selection, project design, projected costs, fund raising, and project finances in January 2013.

## Potential Site Locations, Feasibility Study, Nonprofit Organization

Director of the Department of General Services Richard Sliwoski reviewed the process and procedures for the construction of state monuments and emphasized the need to identify a site before other essential matters can proceed. Among the sites discussed were: Ancarrow Landing, Burial Ground for Negroes, Jackson Ward, Lumpkins Jail Site, Manchester Dock, Monument Avenue, Rocketts Landing, Tredegar, Tredegar Vicinity, Fort Monroe, and other potential sites that may be appropriate. Due to certain limitations, requirements, and political issues the list was narrowed to Jackson Ward, Monument Avenue, and the Tredegar Vicinity (extension of Second Street). An outline of a proposed feasibility study, in cooperation with Department of General Services, for the establishment of the monument in Virginia, will be submitted to the Commission by the staff after the May 22, 2013 meeting. In addition, members appointed to the work group will compose the board of directors for the nonprofit organization needed to conduct the fundraising campaign for the monument. Requisite forms to establish a nonprofit organization for this purpose are being completed and filed with the proper state and federal authorities. Also, at the next meeting on May 22, 2013, the agenda includes items pertaining to a schedule to identify the site for the monument, consensus on the monument's interpretation, development of a case statement, a fundraising campaign and public relations strategy, and issuance of an RFP for the design and selecting a sculptor for the monument. In addition, the group began deliberations regarding the feasibility of an interpretative versus an interactive monument and agreed to continue the discussion at its next meeting.

This summary is the second quarterly report of the Commission. The report will not be filed as a state document.
