Re: Final Report, House Joint Resolution 111

Dear Governor McDonnell and Members of the General Assembly:

As Secretary of the Judicial Council of Virginia, I am pleased to submit this report in response to House Joint Resolution 111, which was agreed to by the General Assembly of Virginia during its 2012 Regular Session.

House Joint Resolution 111 directed the Judicial Council to study the jurisdictional capacity of the Court of Appeals to determine whether its current jurisdiction should be expanded. In accord with the terms of the Resolution, the Judicial Council directed the Office of the Executive Secretary of the Supreme Court to assemble the data necessary in order for the Judicial Council to review the respective caseloads of the Supreme Court of Virginia and the Court of Appeals of Virginia to determine if the quality of appellate review would be better served by expanding the jurisdiction of the Court of Appeals. This caseload data was compiled and provided to both appellate courts.

A detailed review of the data was conducted by the Supreme Court and the Court of Appeals. Based upon this review, it was concluded that the current judicial capacity of the Court of Appeals, to continue quality and timely appellate review, would not be impaired if given additional jurisdiction provided it is given appropriate staffing levels and resources. Any additional jurisdiction assigned to the Court of Appeals that would increase the caseload would require additional resources for optimal functioning of the Court. A copy of the caseload data that was reviewed is enclosed for your reference.

Introduction Since 2003, the Supreme Court (SCV) has experienced a decrease in petition filings. In 2012, there were 2,216 petitions filed, a decrease of 781 or 26.1% from the 2003 filings of 2,997. Although there was a downward trend during this 10-year time frame, there were slight increases between 2005 and 2006 (1.6%) and between 2008 and 2009 (<1.0%). The number of petitions has continued to decrease since 2010. Between 2008 and 2012, there was a decrease of 15.3% in petition filings in the SCV, while there was an increase of 9.1% in cases decided. Preliminary 2013 caseload data show a decrease of 8.4% in new cases. Caseload information for January through the end of November was annualized to compare to 2012 caseload data. This caseload statistical review focuses on caseloads, case types, and caseload mix between 2008 and 2012 in the SCV.





Cases Filed and Decided The table above (Table 1) shows an overview of the case dispositions for the SCV for the past five calendar years, as well as the total cases filed each of those years. In 2012, the SCV recorded 2,216 petitions filed, 117 less than the 2,333 in 2011 and 399 less than the 2,615 in 2008. There were 2,113 decided cases in 2012, a decrease of 345 or 14.0% from the previous year. In 2012, 5.8% of cases that were decided were granted appeal petitions which decreased 19.1% from 2011 and 27.6% from 2008. In 2012, 18.6% of cases that were decided were original jurisdiction petitions. Table 2 shows the different SCV case types. The decreases recorded in SCV case filings were driven by the decrease in criminal petitions. Criminal petitions decreased by 104 or 9.3% from 1,120 in 2011 to 1,016 in 2012. The number of civil petitions remained unchanged between 2011 and 2012. Since 2008, criminal petitions have decreased by 25.3% and civil petitions have increased 5.6%.

Case Filings Mix

Criminal, civil and *Writ of Habeas Corpus* cases constituted the majority or 87.2% of the SCV caseload. The percentage of criminal petitions in 2008 was 52.0%, which fell in 2012 to 45.8%. While the percentage of criminal petitions fell, the percentage of civil petitions increased from 21.7% in 2008 to 27.1% in 2012. *Writ of Habeas Corpus* cases constituted 16.0% and 14.3% in 2008 and 2012, respectively.

Appeal Petitions: Granted Of the appeal petitions granted (123), civil petitions constituted the majority, 72.4% in 2012. In 2012, there was a decrease in civil granted of 12 (11.9%) from 2011 and 19 (17.6%) from 2008. The greatest increase in civil granted cases was between 2009 and 2010 at 35.7% followed by a decrease of 33.6% the following year. Criminal granted in 2012 was 17, a decrease of 33 or 66.0% from 50 in 2008.

Refused In 2012, there were 1,598 cases refused with the majority (62.5%) being criminal in nature. The number of criminal appeals refused decreased 13.1% since 2008, with both civil and *Habeas* appeal refusals increasing 6.1% and 17.0%, respectively.



Original Jurisdiction In 2012, the total number of original jurisdiction cases decided was 392, which is 42 cases or 9.7% less than 2011, and 27 cases or 6.4% less than 2008. Of the 392 cases, 15 or 3.8% were awarded (14 *Writ of Habeas Corpus* and 1 *Writ of Actual Innocence*).



Introduction Since the inception of the Court of Appeals (CAV) in 1985, case filings have increased from 1,641 to 2,356 in 2012, an increase of 43.6%. The highest recorded number of cases filed was in 2001 when there were 3,499 cases filed. Between 2008 and 2012, there was a decrease of 24.2% of total cases filed, and caseloads decreased in the Supreme Court of Virginia (SCV) by 15.3% during the same time frame. While there have been decreases in caseloads in the past five years in the CAV, preliminary 2013 caseload data show an increase of 5.4% in new cases. Caseload information for January through the end of November was annualized to compare to 2012 caseload data. This caseload statistical review focuses on caseloads, case types, and caseload mix between 2008 and 2012.

Cases Filed and Disposed The table above (Table 1) shows an overview of the case filings for the CAV for the past five calendar years. In 2012, the CAV recorded 2,356 case filings, 259 less than the 2,615 in 2011 and 752 less than the 3,108 in 2008. Between 2011 and 2012, the decrease in filings was driven by decreases in all case types except Administrative Agency. Final dispositions totaled 2,475 in 2012, 211 less than the year before and 662 less than 2008. Of the final dispositions, 75.5% were criminal cases. Since 2008, criminal dispositions have decreased 24.2%, while non-criminal decreased 9.8%. During the five years, filings have decreased 24.2% and final dispositions have decreased 21.1%.



Case Filings Mix Between 2008 and 2012, the majority of the cases filed consisted of criminal petitions, domestic relations, and Workers' Compensation Commission cases. The percentage of criminal petitions in 2008 was 78.4%, this fell to 74.3% in 2012. While the percentage of criminal petitions decreased, the combined percentage of domestic relations and Workers' Compensation Commission case filings increased from 14.1% of filings in 2008 to 16.6% in 2012.



Case Filing

Criminal Petitions Of the cases filed, criminal petitions constituted the majority of the caseload, 74.4% in 2012. The greatest decrease in criminal petitions filed was between 2008 and 2009 at 10.0%. In 2012, criminal petitions fell 9.5%; however granted criminal petitions increased 18.6%, increasing from 177 in 2011 to 210 in 2012.

Original Jurisdiction In 2012, the total original jurisdiction cases filed was 39, which is one or 2.5% less than 2012, but 12 or 44.4% more than 2008. Between 2011 and 2012, the number of all case types decreased except Actual Innocence which increased by five or 26.3%.

Appeals of Right In 1985, there were 538 appeals of right and in 2012, there were 540. There was a decrease of 12.6% from last year. Domestic relations cases, Workers' Compensation Commission cases, and the "other" category that includes concealed weapons applications and civil contempt cases had all experienced increases in 2011, but decreased in 2012.

Disposition of Appeals In 1986, the first year detailed disposition data was provided in the State of the Judiciary Report, there were 328 cases involving appeals of right or granted criminal appeals decided by opinion and 386 cases decided by order. Each of the 10 judges averaged 33 opinions and 39 orders, an average of 71 dispositions per judge. In 2012 with 11 judges, the average disposition per judge (70) was 1.5% below the 1986 average. There was an average of 37 opinions per judge and 34 orders per judge in 2012.
