Dear Chairman Jones, Chairman Stosch, and Chairman Colgan:

Enclosed is the report required by the enacted 2014-2016 biennial budget regarding outside counsel utilization by agencies of the executive branch. I trust that you will find it informative. Item 56 #2s in the budget requires this Office to submit a report "detailing expenditures in the prior fiscal year for special outside counsel by any executive branch agencies including "the reasoning why outside counsel is necessary, the hourly rate charged by outside counsel, total expenditures, and funding source." The attached report covers all of the items requested.

As you know, Virginia State Code § 2.2-507 requires that "all legal service in civil matters for the Commonwealth, the Governor, and every state department, institution, division, commission, board, bureau, agency, entity, official, court, or judge, including the conduct of all civil litigation in which any of them are interested, shall be rendered and performed by the Attorney General, except as provided in this chapter and except for any litigation concerning a justice or judge initiated by the Judicial Inquiry and Review Commission." Virginia State Code §§ 2.2-507 and 2.2-510 authorize the Attorney General to engage and manage the engagement of outside counsel in certain circumstances when "it is impracticable or uneconomical for the Attorney General's office to render such service." Accordingly, regarding the budget requirement to provide reasoning for engagement of outside counsel, I note here that, unless otherwise

indicated, the reason for engagements described in the report is that it was "impracticable or uneconomical for the Attorney General's office to render such service."

The exception to that general reason ("impracticable or uneconomical") was the engagement of outside counsel to represent former Governor McDonnell and members of his staff in investigations of certain conduct and related legal proceedings. Those engagements were made by the former Attorney General because of a conflict of interest cited by him as the basis for the engagement.

The most common circumstances that make it either impracticable or uneconomical for this Office to provide legal services and trigger the engagement of outside counsel, are the lack of certain specialized or unique legal expertise among the Office staff, or the lack of legal staff in the geographic location where services are necessary.

The majority of outside counsel work is performed under engagements procured competitively pursuant to "Solicitations for Proposal" (SFPs) where firms bid for the opportunity to provide legal services, resulting in a slate of pre-approved firms. However, selection as a qualified provider under an SFP is not a guarantee of work. This arrangement has existed for many years and essentially places firms on an unpaid retainer for categories of legal work the state agencies know they will likely need. In this report you will find all outside counsel engagements made under each SFP effective during FY '14, the agency receiving services, the amount billed, and the hourly rates established under each SFP. In FY'14, SFP work totaled \$10,600,407.25 compared to approximately \$16,075,288.04 in FY'13, \$11,498,688.25 in FY'12, and \$10,714,552.79 in FY'11.

Outside counsel may also be procured on a "single case appointment" (SCA) basis for one specific transaction, issue or matter not covered by an existing SFP term engagement. The attached report includes data on SCA outside counsel engagements, the agency receiving services, the amount billed, and the hourly rates for each SCA. In FY'14, SCA work totaled \$1,034,006.96, compared to approximately \$1,740,294.77 in FY'13, \$990,964.19 in FY'12, and \$703,414.28 in FY'11.

Once outside counsel is engaged, whether by SFP or SCA, the Office of Attorney General manages the relationship to include establishing the engagement contract terms, negotiating rates, reviewing invoices to ensure compliance with the terms of the engagement, and authorizing payment from the client agency. With specific reference to the budget outside counsel reporting requirements, please note further that, unless otherwise indicated, the legal services described in the report were "paid out of the funds appropriated for the administration of the board, commission, division or department being represented or whose members, officers, inspectors, investigators, or other employees are being represented," as dictated by state law. The sole exception to Office of Attorney General management of an outside counsel relationship in FY '14 was the engagement of counsel to represent former Governor McDonnell and members of his family or staff during the legal investigation(s) and proceedings referenced above. By prior arrangement at the time of engagement, these engagements were reviewed, handled, and paid by the Office of the Governor and are not included in this report.



For your further information, please be advised that I began significant reforms to the outside counsel process this year to improve coordination, oversight, effectiveness, and efficiency of the Commonwealth's use of outside counsel. While there is no reason to believe that any outside counsel has been engaged improperly or has been inappropriately compensated, the nature of the prior record keeping and tracking/accounting procedures has made it extremely difficult to judge the efficacy of the state's outside counsel expenditures or to even prepare this report. That is why we are currently in the process of procuring an electronic case management system that will allow for much more efficient and effective tracking and monitoring of the use of outside counsel and any associated costs. This will move us away from the paper and manual monitoring that has been the norm in the office, and allow us to make data-driven decisions regarding outside counsel.

Upon taking office, I required my Chief Deputy Attorney General to review nearly all uses of outside counsel by executive branch agencies while we developed the office's first written, adopted policy on outside counsel. This policy was implemented in June and is publicly available on my office's website. The policy is administered by the Office of Attorney General's first Compliance and Transparency Counsel who continues the practice of prior review and approval of outside counsel before referral. Other than in exigent circumstances, it requires a documented determination of need be made in writing prior to assignment of a matter to outside counsel, a competitive procurement to ensure that taxpayers are getting maximum value for their dollar, and an objective evaluation process in selecting qualified firms to provide services. Additionally, the policy establishes procedures and includes reforms to the management of outside counsel. Outside counsel generally must coordinate general legal strategy with the office by submission of a case management plan to ensure the Commonwealth's goals are met; budgets will now be uniformly required for engagement; invoices will be even more closely reviewed by the Office of Attorney General and the agency receiving services for appropriateness of charges; and greater restrictions and oversight regarding potential or actual conflicts of interest are in place.

I am proud to lead a team that provides exceptional legal work on such a broad scope of issues, often of great depth, complexity and significance. It is a truly remarkable team. The attorneys in the Office of Attorney General are dedicated professionals who, in many cases, are sacrificing more lucrative opportunities in the private sector to serve our Commonwealth. On the occasions when the people of Virginia are best served by the engagement of outside counsel, I will make sure the Commonwealth gets maximum value for each and every dollar.
