In accordance with Chapter 1024, enactment clause 2, of the 2004 Acts of Assembly, please find below information on the number of petitions for writs of actual innocence filed pursuant to Chapter 19.3 of Title 19.2, and the dispositions thereof, for calendar year 2014.

- Five petitions were pending on January 1, 2014.
- Sixteen petitions were filed in 2014.
- Twenty petitions were disposed of in 2014. The dispositions of those cases were as follows:
 - Seventeen petitions were summarily dismissed.
 - Three petitions were dismissed following consideration of the Attorney General's response to the petition and petitioner's reply thereto, if any.
- One petition was pending as of December 31, 2014.
