Annual Report on Construction Procurement (July 1, 2015 – September 30, 2015)

November 30, 2015

The Department of General Services (DGS) was directed by the legislature to perform a Construction Procurement Survey and provide Quarterly and Annual Construction Procurement Reports as indicated in Chapter 760, 2015 Acts of the Assembly, excerpted below:

4. That all public bodies as defined in § 2.2-4301 of the Code of Virginia, including public institutions of higher education, shall submit a written report to the Director of the Department of General Services (the Director) for any non-transportation-related construction project in excess of \$2 million that was procured by any method other than competitive sealed bidding. Such report shall be in a form and manner prescribed by the Director after consultation with the contractor community and state and local government procurement officials. The report, at a minimum, shall identify the justification for the procurement method chosen and contain such other information deemed necessary or appropriate by the Director, including whether or not the procurement meets the standards as set forth by the Secretary of Administration guidelines. The Director shall (i) report such information quarterly to the Chairmen of the House Committee on General Laws and the Senate Committee on General Laws and Technology and (ii) post such reports on the Department of General Services' central electronic procurement website. In addition, on or before December 1 of each year, the Director shall submit an annual report to the Governor and the Chairmen of the House Committee on General Laws and Senate Committee on General Laws and Technology that includes (a) the Director's evaluation of and findings regarding the methods of procurement used for such construction procured by designbuild or construction management at risk method and (b) any recommendations for the improvement of (1) the method of procuring construction generally and (2) the Virginia Public Procurement Act (§ 2.2-4300 et seq. of the Code of Virginia).

To meet the legislative requirement that the report be created "after consultation with the contractor community and state and local government procurement officials," DGS took the following actions:

- 1. Draft questions were provided to state agencies for comment.
- 2. Draft questions were provided to the Virginia Association of General Contractors, Virginia Associated Builders and Contractors, Virginia American Institute of Architects, American Council

- of Engineering Companies of Virginia, Virginia Municipal League, Virginia Association of Counties, and the Virginia Association of Government Purchasing for comment.
- 3. Draft survey forms were provided to Cities, Counties, and State-authorized Boards, Authorities, and Commissions for comment.

In addition, DGS made significant efforts to identify all public bodies with construction procurement authority. DGS classifies these public bodies as follows:

- State Agencies (including higher education)
- Cities and Counties
- Towns
- State-established Boards, Authorities, & Commissions
- Locally-established Boards, Authorities & Commissions

DGS reviewed the Code of Virginia to identify all Boards, Authorities, and Commissions with construction procurement powers that were established by the General Assembly. In an effort to identify the locally-established Boards, Authorities, and Commissions, DGS sent several requests to the Cities and Counties requesting their assistance in gathering the names and appropriate contact information for these locally-created entities. DGS also worked to identify as many of these local entities as possible, but without confirmation from the localities, it is possible that some of these locally-created entities are not included in the survey.

DGS created a web-based survey through its central electronic procurement website to ensure the efficient and accurate collection of data from the public bodies. Repeated efforts were made to contact the public bodies so they could be registered for access to this online survey, and the reporting deadline was extended to allow additional time for registration and reporting. However, despite continued outreach over a three month period, not all entities registered.

This report addresses projects initiated July 1, 2015 – September 30, 2015 (ie, for Construction Management at Risk and Design-Build procurements, a Request for Proposal was issued between July 1, 2015, and September 30, 2015).

It is important to note that thirty-nine entities report having special construction procurement authority (a listing of these entities is attached):

- Thirty entities reported having special construction procurement authority that allows for alternate procedures that comply with the VPPA.
- Nine entities reported having special construction procurement authority that allows for alternate procedures that vary from the VPPA.

Of the total population identified to complete surveys, 36% completed them (200 of 562). A "report of no activity" was requested in the event that a given entity had no qualifying construction in excess of \$2M; the 36% includes those responding with "reports of no activity." The group which completed the required survey, the 36%, does include many larger state and local entities likely to spend significant amounts on construction.

The overall reporting rates on the survey for the first reporting period (July 1, 2015 – Sep 30, 2015) are:

From those entities that did register and respond to the survey (table immediately above), the following information can be reported on the use of alternate procurement methods:

1. Seven entities utilized construction procurement methods other than competitive sealed bidding on eight projects (one entity reported two such projects).

- 2. Four entities utilized Construction Manager at Risk on five projects (one entity reported two such projects).
- 3. Two entities utilized Design-Build on two projects.
- 4. One entity utilized Energy Savings Contracts on one project.

Reported Use of Construction Manager at Risk (CM@Risk) Procurement:

Entities reported five projects using the CM@Risk method of procurement. Of these five projects, one was \$2-5M, one was \$5-10M, two were \$20-50M, and one was \$50M+. All were procured utilizing a two-step process (ie, Request for Qualifications (RFQ), then RFP) and received two or more proposals. It was determined that sealed bidding was not practical or advantageous on four of the five projects. The justifications provided for utilizing CM@Risk procurement included:

- Complex project
- Constructability review required concurrent with design
- Value engineering required concurrent with design
- Fast tracking to meet owner requirements
- Cost/design control
- Quality control
- Limit owner's risk

One project progressed to the preconstruction phase. For that project, preconstruction services were awarded when the design was 20% complete.

The data provided on some of the reported CM@Risk projects is incomplete or inconsistent: only 3/5 projects included an affirmation regarding the guidelines they utilized, 3/5 provided supporting details for the justification selected, and 3/5 indicated that the procurement justification was included in a combined RFQ/RFP (while 5/5 reported the use of a two-step process). On subsequent quarterly reports, DGS will work with reporting entities to improve the completeness and consistency of the data provided on these reported projects and any new projects initiated after September 30, 2015.

The projects that were procured utilizing CM@Risk were reported as following local guidelines with alternate provisions to the Secretary of Administration's (SOA) Procedures, as following local guidelines consistent with the SOA Procedures, and as following SOA guidelines.

Reported Use of Design-Build (DB) Procurement:

Two entities reported two projects using DB procurement. Both projects had construction costs between \$2-5M, and it was determined that sealed bidding was not practical or advantageous. The projects were procured utilizing a two-step process and received two or more proposals. The justifications listed for utilizing DB procurement included:

- Limit owner's risk
- Single point of contact
- Significant pre-engineered component

The projects that were procured utilizing DB were reported as following local guidelines consistent with the SOA Procedures and as following SOA guidelines.

Reported Use of Energy Savings Contract (ESCO) Procurement:

One entity reported one project using ESCO procurement. The project had construction costs between \$2-7M, and it was determined that sealed bidding was not practical or advantageous. The project was procured based upon negotiations with only one ESCO firm, and the measurement and verification will be done by the ESCO contractor. The justifications listed for utilizing ESCO procurement included:

- Save operating costs
- Address deferred maintenance
- This contract was awarded as authorized in Chapter 6.1 of Title 11 of the Code of Virginia allowing a performance based contract based on a Technical Energy Audit

Reported Use of Job Order Contracting (JOC) or Public-Private Enterprise Application (PPEA):

No entities reported the use of JOC or PPEA.

Overall Recommendations:

There is currently insufficient data to make recommendations for the improvement of either the method of procuring construction or the Virginia Public Procurement Act. It is anticipated that information received for the subsequent annual report (due December 1, 2016) will provide opportunities for recommendations.
