



## EXECUTIVE SUMMARY - STATE BOARD FOR COMMUNITY COLLEGES

January 2015

The State Board for Community Colleges had five new Board members appointed in 2014. The names and appointment dates of these new members are as follows:

Mr. William C. Hall, Jr. – appointed for a one-year term to fill an unexpired term. Appointment is for July 1, 2014 through June 30, 2015.

Ms. Carolyn S. Berkowitz – appointed for a one-year term to fill an unexpired term. Appointment is for July 1, 2014 through June 30, 2015.

Mr. Michael J. Schewel – appointed for a four-year term. Appointment is effective July 1, 2014 through June 30, 2018.

Dr. Thomas M. Brewster – appointed for a four-year term. Appointment is effective July 1, 2014 through June 30, 2018.

Ms. Eleanor B. Saslaw – appointed for a four-year term. Appointment is effective July 1, 2014 through June 30, 2018.
